HOLDING FIRM
ACT SUSTAINED
BY HIGH COURT

Provision Requiring Companies to Register Upheld

IS VICTORY FOR ADMINISTRATION

Law Passed By Congress in 1935 Aimed at What Govt. Described as Abuses

Washington, March 28.—The Supreme Court held constitutional today provisions of the public utility holding act requiring inter-state holding companies to register with the Securities Commission and submit financial statements.

Chief Justice Hughes delivered the decision that represented a victory for the government.

The court affirmed a ruling by the Federal Circuit court at New York upholding the registration requirement. Justice McReynolds dissented, Justices Cardozo and Reed did not participate.

"To escape the penalty and the enforcing provisions of the decree," Hughes said, "all that the defendants have to do is to register with the Commission and assume the obligation to file the described registration statement. All their rights and remedies with respect to other provisions of the statute remain without prejudice."

The litigation directly involved the Electric Bond and Share Company and its 26 subsidiaries. It was picked by the government as a test case.

The utilities contended that the entire act regulating holding companies was at issue. The government successfully asserted other provisions could be tested at the proper time and "under regular judicial procedure."

The holding company act, passed by Congress in 1935 after a bitter contest, would bring under government regulation companies that control billions of dollars in inter-state gas and electric business.

It was aimed at what the Roosevelt administration called abuses, including pyramiding and issuance of securities with fictitious values.

Payments Made To
Many Unemployed

Raleigh, March 28.—A quarter of a million dollars, included in about 21,000 checks, was distributed to unemployed workers in North Carolina last week, bringing the total so far distributed to about \$1,315,000 in about 189,000 checks since the last of January. State Unemployment Compensation Commission officials said.

The central office is rapidly approaching a normal state in check deliveries since provision was made for doubling up in one check the amounts shown in the office to be due any unemployed eligible worker. Except in rare cases, in which there is some trouble in getting the required forms and signatures of the registering workers, the checks are now going out of the office almost as they are due. And these cases in which delay has been caused by some irregularity in the process are being cleared up rapidly.

Through last Friday, the office had distributed 163,058 checks amounting to \$1,290,889.40. The average per worker pay is close to \$7.92.

Error Made in Name
Of Court Defendant

PITT SCHOOLS
GIVEN PRAISE

Findings Reported At Conclusion Health Program

A letter written to his superior by Dr. A. D. Underwood upon the completion of a month-long program in Pitt county containing high praise for Pitt county schools.

The letter was forwarded to D. H. Conley, superintendent of the county system, by Ernest A. Branch, director of the division of oral hygiene.

It follows: "According to my records it has been almost seven years since I first visited Pitt County for the purpose of conducting a Mouth Health Program in the schools and I have returned practically each year since for the same purpose."

While my knowledge of school work and my ability to judge a school is limited there are certain observations I have made during this period of time which I thought you might be interested in knowing. I know you to be interested in school work, not only from a standpoint of good health, but in all of its other phases as well.

When I first came to Pitt County I saw here a school system which would rate well with any system in the state. I came to the conclusion that the patrons of the schools wanted a good school but they were more or less indifferent as to the welfare of the school and what it accomplished. The condition of the teeth and health in general, as well as the attitude of the children towards good health rules, was mediocre.

Since that time there has been much improvement in the attitude of the children towards their schools as well as their teeth and health in general. The amount of dental work needed one has decreased considerably. One can readily see that the teachers are really accomplishing something, not only in the manner of observing good health rules, but you can see these children reflect their appreciation of the good schools they are attending. There has been much done in the way of teaching the county at large to appreciate the schools for surely a child reflects the attitude of his or her parents towards any question.

It has been a pleasure and I am encouraging to have had this opportunity. (Continued on page six)

DEATH CLAIMS
EDW. M. HOUSE
AT AGE OF 79

Was Internationally Known as Advisor To Wilson

PHYSICIANS HAD EXPECTED DEATH

Activity in Democratic Affairs Climaxed By Appointment As Agent to Europe

New York, March 28.—(AP)—Colonel Edward M. House, internationally known as a close advisor to President Woodrow Wilson during the World War era, died today after a long illness. He was 79 years old.

Colonel House's physicians said several weeks ago that he was "failing steadily" and that death was only a matter of time. He was suffering from a complication of ailments and only last week had another relapse.

Only members of his family, including the widow, were with him when he died.

For many years Colonel House was active in affairs of the Democratic party. He climaxed this activity when he became the personal representative of President Wilson to European governments in 1914, 1915 and 1916.

Colonel House was the last survivor of the American signatories of the treaty of Versailles.

To the end he believed in the League of Nations, insisting it held the greatest possibilities for the solution of many of the world's problems.

In 1917 President Wilson appointed Colonel House to gather and organize data to be used at the eventual peace conference and he served as special representative of this country at the inter-allied conference of premiers and foreign ministers held in Paris November 29, 1917 to effect a more complete coordination of the activities of the entire co-belligerents for the prosecution of the war.

He again represented the president on the supreme war council at Versailles, in December 1917, and on October 17, 1918, he was designated to act for the United States in the negotiations of an armistice with the central powers.

LETTER FAILS
ARRIVE IN TIME

GOP Primary Apparently Missed by Only Few Minutes

Raleigh, March 28.—(AP)—North Carolina Republicans apparently missed forcing a state-wide primary June 4 by minutes Saturday when a special delivery registered letter went to the home of Raymond Maxwell, elections board secretary, instead of to his office.

Maxwell said today that the letter contained the pledge and filing fee of John Hoffman of Burlington, who wanted to enter the Republican contest for the nomination to the United States Senate against Charles A. Jones of Lincoln.

The board secretary said he would ask Attorney-General A. F. Sewell to rule on whether Hoffman's name should be placed on the ballot, but felt certain it would be held that he had failed to comply with the requirement to have his pledge and fee in the hands of the elections board by the filing deadline.

The deadline was at 6 o'clock Saturday afternoon and just before that hour Maxwell got a notice that had been left at his home that he had registered mail at the post office. Mrs. Maxwell had been away from the house and the notice said an attempt had been made to deliver the letter at the home.

Maxwell tried to get the letter but the registry window had closed and his mail was in the vault, locked up for the week-end.

As it was, there were 114 qualified filers for congressional and state offices when the deadline passed.

Greenville Attorney, Food Stores Owner Announces

William S. Tyson, Greenville attorney and owner of the Home Grocery stores, today publicly announced his candidacy for the State House of Representatives.

Mr. Tyson was the second to file for one of the two seats allotted the county, John S. Moore of Bethel having announced Saturday.

Mr. Tyson is a native of Greenville and a graduate of the University of North Carolina law school. He has been practicing law 10 years, during which time he served two terms as county solicitor. He also served two years as clerk of the United States House of Representatives committee on accounts.

In addition to his practice of law, Mr. Tyson for some time has been owner and operator of the Home Grocery stores in Greenville.

GROWING WARM

Clark and Paylor Are Seeking Fifth District Solicitorship

With the filing late Saturday of John Hill Paylor for the office of solicitor of the Fifth judicial district, a two-sided contest between two Pitt county men was assured for the post.

D. M. Clark of Greenville had previously filed for renomination and was without opposition until Mr. Paylor filed.

Mr. Paylor, who makes his home in Farmville, served in the State House of Representatives for the past two sessions and had been expected to seek renomination for the legislative position until his announcement Saturday that he would enter the solicitor's race.

Congressman Lindsay Warren will be without opposition in the primary, the expiration for filing having expired without anyone coming out against him.

FINAL BATTLE
APPEARS NEAR
IN SPANISH WAR

Insurgents Pointing To Decisive Victory Over Loyals

ARMY ON MARCH TOWARD LERIDA

Rebels Steadily Press Eastward in Effort to Sever remaining Major Segment

Hendaye, France, March 28.—(AP)—The Spanish insurgent army in Catalonia marched toward the industrial city of Lerida today, pointing for a major battle by which General Franco hopes to win the civil war.

Government troops were in retreat toward the Mediterranean and a climax seemed near after 20 months of conflict.

Insurgent troops were within 15 miles of Lerida and insurgent war planes were bombing it. Lerida is only 54 miles from Barcelona and is on the main highway to that provisional capital of Republican Spain.

Coupled with the Lerida campaign was a series of advances on the entire 135-mile eastern front, stretching from Bortolan, on the far north a short distance from the French frontier, to Morella, on the south.

Each advance was to the east and each moved the insurgent line closer to the Mediterranean.

By this steady press toward the insurgents sought to sever the remaining major segment of Spanish Government territory and thereby force the weakened halves to capitulate.

The insurgents entered Catalonia's northeast corner, in a mass offensive yesterday.

Political Announcements
Principal News Of Week

Reflector Bureau Raleigh, March 28.—Closing of the lists for all statewide races in this year's primary elections was the outstanding event in Raleigh last week.

During the period there were a few surprise entries and a few surprise failures to enter after unofficial announcement; but on the whole the filing came to a close with comparative lack of excitement.

When the list was checked over in the office of Election Board Secretary Raymond C. Maxwell it was found that 99 Democrats and 15 Republicans had paid good money and fully qualified themselves as candidates for the 48 offices which will be voted on in the primaries.

There were more would-be district solicitors than candidates for any other office, but that was natural inasmuch as there are 21 districts in which solicitors will be elected. No less than 37 Democrats and five Republicans seek them.

Superior judgeships came next with 28 Democrats in the running year. Voting being on a statewide for the 12 posts to be contested this scale for these offices, no Republicans offered.

Twenty-seven Democrats and 7 Republicans will engage in scrambles for the eleven congressional seats from North Carolina. Two Democrats and two Republicans will seek two Supreme court places. Two Democrats are entered for the Utility Commissionership. Two Democrats and one Republican are trying for the United States Senate.

The U. S. Senate race in the Democratic primary was left exclusively to incumbent Robert R. Reynolds and Congressman Frank Hancock, when the state board of elections ruled that the Rev. A. A. Johnston, who claims his entry fee was lost in the mails, would have to post \$100 with the board. Loss of his fee was really a great break for the Buncombe man. He may get his money back from the post-office department; he'd have gotten nothing but a headache if he had qualified, and would have been (Continued on page four)

SILVER PRICE
MARKED DOWN

First Change in Treasury Prices in Past Two Years

Washington, March 28.—(AP)—The Treasury reduced today from 45 to 44 cents per ounce its price for foreign produced silver.

The reduction was the first change in the Treasury price for foreign silver in nearly two years, and followed a break of slightly more than a cent in the London silver market today because of fears that the United States' decision to discontinue purchases of Mexican silver might prestage an abandonment of its stabilizing influence on world silver prices.

Heretofore the world's largest customer for silver, the United States Treasury has virtually dictated the value of silver for more than two years.

Previously the announcement of the decision with respect to Mexican silver had been connected principally in speculation by observers with that country's expropriation of American oil property.

Executives of four American oil companies conferred with Secretary of State Hull about the Mexican government's expropriation of oil property valued at more than \$400,000,000.

The oil men asked the official support of the United States government to have the expropriation modified.

Only a few hours earlier the Treasury had announced it would discontinue its purchases of silver produced in Mexico, leading to speculation that this government already was exercising pressure on the Mexican government for reconsideration of its oil decision.

REGIME SET UP
BY JAPAN OVER
NANKING AREA

New Government To Replace Chiang's Administration

TO RESPECT ALL FOREIGN RIGHTS

Dispatches Indicate Japanese Offensive Along Tientsin - Pukow Road Halted

Shanghai, March 28.—(AP)—A new government with Chinese personnel, but dominated by Japanese, was set up today at Nanking, former capital of the Chinese Nationalist regime, to replace General Chiang Kai-Shek's administration.

The new government was described by its sponsors as the "reformed government of the Republic of China."

Japan last week ordered the creation of such a government at Nanking "under the umbrella" of the similar North China regime recently established at Peiping.

Liang Hung-Tze, chairman of the executive Yuan, said the new government would respect "all just and vested foreign rights," but hereafter would not recognize any contracts or treaties made by the Nationalist government at Hankow or by Chinese provincial governments with foreign powers.

General Chiang Kai-Shek has been operating the Nationalist government at Hankow while carrying on the fight against the Japanese invaders.

Dispatches from Hankow said Chinese troops had recaptured Linching, strategic city on the Tientsin-Pukow railway. Chinese military leaders said they were convinced the Japanese offensive down the railway against Suchow had been stopped.

Examinations Set
For Federal Jobs

Raleigh, March 28.—Merit examinations for plans with the Employment Service Division of the Unemployment Compensation Commission will be held at a number of places over the State May 13-14, applications for which will be accepted through April 23. It is announced by R. W. Grunman, South Building, Chapel Hill, who has been designated by the U. S. Employment Service to aid in preparing the examinations.

The examinations this year will be held for positions of field supervisor for the State office, district manager and branch manager, senior and junior interviewers and interviewing clerks. They are open to men and women who have lived in the State six months before filing application. Mr. Grunman announces that minimum requirements of experience and education are required and applicants who meet these will be admitted to the written examinations. Those admitted or rejected will be notified. Personal interviews will be held for those who pass the written tests.

Of the 3,000 or more applying last year, 500 persons were finally placed on the eligible lists, and those have been about exhausted. Those passing the examinations will be placed in positions or will be on the eligible lists for later work.

"Sometimes," began Mr. Grant, "we have some things of value with us for a great period of time that we take for granted we understand what they are."

He emphasized this by saying that frequently for generations ancestors have handed to their descendants traditions that are respected without cause or understanding. "But," said the speaker, "anything we hold dear and sacred should be examined with the purpose of reaching a clear understanding of it."

If the Bible is to hold a definite place in one's affections and if it is to act as a motivating influence, it must be clearly understood. For illustration, Mr. Grant told the story of the two disciples who could not interpret the scripture.

"The Bible," said the speaker, "is not a book of natural science. It has nothing to do with science. It is the words of God spoken through human personalities in their own peculiar style."

If a person is to receive full benefit from the Bible, it is necessary that he have a fair knowledge and a clear understanding of the Book.

"If," concluded Mr. Grant, "a person does not do that, he will find that the Bible will be very dull and it will not give him much food for living."

BEAUTY OR BILLBOARDS ALONG OUR HIGHWAYS?

(Ann Pauline Smith, District Agt., N. S. State College)

Is there no way to build up sentiment against the indiscriminate posting of bills and the dumping of tin cans, rubbish heaps, and old cars along our highways?

Billboard is a common source of ugliness. They range in size from the small ones on boards and trees to the printed signs tacked on telephone poles and trees. Trees are stunted, buildings defaced, and the landscape obscured by them.

Glaring rows of billboards stare at us on all sides. They are seen at every turn. They sprawl across the scenic stretches of country landscapes and the most conspicuous points on the highways are selected for posting bills. Long before we reach a town, we are told where to find places to eat, places to sleep, bargain houses, and what-not.

Property owners permit glaring signs to be painted on barns and billboards to be erected for a small compensation. More often the signs are nailed up without permission from the owner who is not enough interested in the appearance of the property to have them removed. Business interests are defeating their purpose in the type of signs and advertisements posted. If every property owner would have bills removed as soon as the lease is out and refuse to allow new boards of objectionable nature to be erected, half the problem would be solved.

Where billboard advertisement is permitted, well designed boards placed with discrimination, and only with the advice and consent of the supervising landscape architect and district highway supervisor, should be permitted. There is another side to the question. The landscape does not belong to any one person. Every man should have the privilege of enjoying the scenery God has given us and no person or business has the right to obliterate scenic spots by billboards and dump heaps. "Hot-dog stands" and sign-covered filling stations offend good taste and desecrate the roadside beauty which every man should be privileged to enjoy.

Section 151 of the Revenue Act of 1933, Chapter 445 of Public Laws, deals in part with bill boards, providing a tax on them. The enforcement of this law will help to abolish a nuisance which has reflected on public opinion.

Rural Virginia (I am excepting approaches to her towns) is perhaps as free as any other Southern state from billboards. During blossom time and garden week thousands of tourists view the orchards of the Shenandoah Valley and the beautiful country homes without the distraction of the billboard curtain. The Garden Clubs of Virginia have been largely responsible for this.

Sentiment throughout the country against the commercialization of the rural highways is steadily increasing. In North Carolina the Carolina Motor Club, the Garden Clubs, the Federation of Women's Clubs, the Federation of Home Demonstration Clubs are cooperating with the Highway Commission in a state-wide Highway Beautification Plan which will help materially in ridding North Carolina of the "Sign Leprosy."

United efforts on the part of these and other organizations could so arouse public sentiment that motorists would have an opportunity to see North Carolina behind the billboards. As someone has said: "Behind the Alps lies Italy; and lest we forget, behind the billboards lies America."

HOW A NATION MOBILIZES . . . Generals Find New Ways Of 'Getting There Fustest'



- 1.** U. S. Confederate General Nathan Forrest defined strategy as "getting there fustest with the mostest men." But Forrest never dreamed of overnight mobilization of a nation in arms. German generals did. Legend has it that when the Franco-Prussian war broke out in 1870 one of them had only to awake from sleep long enough to tell an aide that orders were in the left-hand drawer. - 2.** By 1914 that way of calling out any army by pre-arrangement was general. - 3.** The generals decided, after polishing off that war, the next time they would have to put industry on a war-time basis quickly to keep the supplies pouring out. WHAT IT MEANS: Mexico's Seizure Of Oil Concessions

Washington, March 28.—(AP)—A revolutionary firecracker whose fuse has been sputtering in Mexico for a generation, has just exploded in the faces of American and British oil companies—and their governments. That's the meaning of President Lazaro Cardenas' decision to expropriate foreign oil holdings and empower native workers to run them in the name of the Mexican government.

The fuse was lighted early in this century when Francisco Madero and a group of revolutionists—or patriots, according to your point of view—promised to make the nation a "Mexico for Mexicans."

Back To The Indians

First, they proposed to give the land back to the Indians. Indians and mestizos (half-breeds) comprise close to 90 per cent of the population.

Next, they promised to kick out the foreigners and take over the vast mineral resources of the country—mostly silver and oil.

The revolutionary cause seemed hopeless in those days. Dictator Porfirio Diaz had been entrenching his ruthless regime for a quarter of a century.

He fostered accumulation of property by a comparatively few families. He invited foreign capital to help him develop the country—in return for rich profits.

Ripe For Revolution

In 1911, the fiery Madero and his revolutionists turned out Diaz, and set themselves to liberating Mexico. But Mexicans of 1911 were not ready for freedom. A successful military conquest and uprisings followed.

Each new president also had to keep a weather eye on the United States. Uncle Sam was policing the Americas, and a revolutionist in bad odor to the north had better look out for rivals who could smuggle in rifles or get money from people who had investments in Mexico.

Moreover, a leader thrust into power by a military faction had to find quick money to run the government and pay off his supporters. The simplest way was to tax landowners and foreign capitalists.

He also needed popularity, and the popular thing was to promise to give the land back to the Indians and drive out the foreigners.

The Dilemma

Here were the horns of a dilemma. If a leader drove out foreigners and gave the land to the people, he faced bankruptcy and intervention by the United States. If he took the taxpayers' and foreigners' money, he faced revolution.

The upheaval was the people continuing to get promises, landowners and foreigners continued to hold their property. In 1917 President Carranza wrote the promises into a new constitution. That, among other things, pledged the government to:

1. Give workers a share in industrial profits and to divide the land among the Indians.
2. Take over the mineral rights in the name of the Mexican people.

Until 1934, however, these still were more or less promises under powerful Plutarco Elias Calles.

In that year, Calles selected Lazaro Cardenas, to become his rubber stamp president.

Much to everybody's surprise, Cardenas was no rubber stamp. He increased the army's pay and pensions, reduced illiteracy, softened the war against the Catholic church, turned the Calles political machine into the Cardenas machine; began to fulfill promises of the 1911 revolution.

Chooses One Horn

Calles called a halt—and found himself a man without a country. Cardenas began turning the landed estates over to the Indians. The departed owner got a promissory note.

Now, when the oil companies refuse to pay labor costs they say would ruin them, Cardenas invokes the expropriation law of 1936, takes over \$400,000,000 worth of property. He says Mexico will pay the owners within 10 years.

Whether Cardenas is risking economic confusion, or bankruptcy, nobody knows.

Likewise, observers here wonder what the United States can do under its new good neighbor policy.

The United States has been buying Mexican silver well above the world price, and pegging the Mexican peso (dollar) with these purchases. That might be used as a threat, but the threat of economic intervention is ticklish, because every nation south of the Rio Grande is watching Uncle Sam.

Meanwhile, Cardenas calls up Mexicans to make sacrifices for "economic liberation." The 1911 revolutionary firecracker has finally exploded.

Hancock closed the week by announcing that W. A. Devin, Jr., of Hickory will manage his campaign. Interest in the so-called race still seemed to be practically non-existent.

Looming as the hottest—at least the wild-st—primary battles were campaigns in the Sixth and Eighth Congressional, Ninth, Fourteenth and Twenty-first Judicial and First, Sixth and Twenty-first Solicitorial districts.

The Sixth's House contest drew eighth Democratic competitors, the Eighth listed five.

Five will contest for Superior court judge in the Ninth, where incumbent N. A. Sinclair is quitting; three will fight it out in each of the Fourteenth and Twenty-first.

Four want to prosecute in the First Solicitorial, three want the job in the Sixth, and five are enter-

ed in the Twenty-first.

In addition to these apparently free-for-all, catch-as-catch-can melees, there are numerous duels in which two bitter and well-matched rivals will bid for popular favor.

Summing the situation up from a statewide standpoint it appears that any heat and fire will have to be provided by the Utility Commission race in which Paul Grady of Kenly will battle incumbent Stanley Winborne. The Reynolds-Hancock thing has so far proved a complete dud so far as general interest goes, though the rivals may be doing a bit of savings in fighting that doesn't show on the surface.

On the other hand there are enough local fights to keep the voters and the political commentators busy from now until primary time, and there undoubtedly will be plenty of fur flying in all directions.

Aside from the political angle, Raleigh had little except routine affairs to talk about.

Washington Daybook

Washington, Probably it was inevitable that the 1939 New York world's fair and Grover Whalen should become involved in international affairs. Now that they have, Mr. Whalen, whose efforts in other fields have been almost Napoleonic in trying to wash his hands of that aspect of fair promotion and allow Secretary of State Hull to bear the brunt.

Mr. Whalen came to Washington to show President Roosevelt some of the plans for spending the \$3,000,000 contributed by the federal government to make a tourists' delight of Flushing Meadows, where the fair is to be. The plans are handsome no end, and so is Mr. Whalen.

After he emerged from the President's office he stopped in the general White House reception room to show the plans to reporters and to explain some of the business about the fair. It was at that point that he discovered Mr. Whalen's interest in international affairs.

Up To Mr. Hull

The Nazi Anschluss was kept a long distance from American shores for the most part, but it reverberated in Flushing Meadows. When Hitler annexed Austria, he liquidated one of Mr. Whalen's most interesting customers. Prior to the Anschluss, Mr. Whalen had promised for 64 nations to prepare exhibits for the fair. Austria, one of the 64, had about it some of the perfume of the Balkans and the Orient and might have been expected to contribute an exotic note the like of which can not come from Germany, even when the Anschluss is included.

For all practical purposes, Mr. Whalen has written Austria off his list although officially he won't take such a telling step as that until Secretary Hull has sanctioned the Anschluss, which he has not yet, not fully.

But that is not all. There is the Spanish affair. Mr. Whalen barely had outlined his fair program than General Franco, head of the insurgents, put in a bid for space.

Man About Manhattan

New York—Gino DiVici, a slim, olive-skinned Italian from the lower East Side, became a bootblack in the vicinity of City Hall last week. He is 14 years old and wants to grow up and become the head of a shipping company. Bootblack, he believes, is an excellent springboard to success if you work at it.

Well, I think he's got something there. The Horatio Alger heroes weren't all shadow-figures. It may surprise you to know that fortunes have been made by men who wield the little flannel rag. New York, after all, is a vain, half-garulous old dude with fine airs and spends an aggregate of \$400,000 a week having its shoes shined. He has approximately 2,000 boys working for him.

In past years the most successful shoeshine kings have been Tony Asti, who gobbled up the concession in the big office buildings, just as corporations now buy the hat checking concessions in hotels and night clubs, and Tony Lauria. Asti is dead now but in his time he was a money titan and owned a string of fine race horses. Lauria was another who carved out a shoeshining empire. He is retired now but he still has a lot of the big dough.

The current Mussolini of bootblackening is Joseph Policastro, who began his career in Brooklyn on less than \$2 capital. He started out with a box slung over his shoulder and worked himself up till he had others working for him. Finally he acquired the rights to a small building and installed half a dozen boys shining shoes for him there. As he grew older he emerged more and more into the big money so that now he never averages less than \$5,000 or \$8,000 a year. This is net, of course.

Joseph thinks a good boy can earn \$25 a week, counting tips, which isn't bad for a youth with a can of black paste.

In the big office buildings there may be 50 or 100 boys making the daily rounds. The thousands of offices each have desks. Behind those desks are men, with shoes to be cleaned. Sometimes they pay a nickel, sometimes a dime or a quarter. It all adds up. It adds, in fact, to nearly \$21,000,000 a year.

But, agrees Joseph, the day of the fabulous fortunes are no more. That is the fortunes of Wall Street proportions that were made before the war. Competition is shrewder and more intelligent, and shoe polish costs more. But he still thinks it is a pretty good business. It took him off the street, gave him a fine income, and made him a friend of trust growers, bankers, opera singers.

And so perhaps young Gino DiVici is on the right track in his quest for success an economic security. On behalf of the Horatio Alger heroes who triumphed over adversity through sheer pluck, ambition, and stick-to-it-iveness, I salute him.

Motorists Inconsistent In Objections To Taxes

Raleigh, March 25—One of the queer phenomena connected with payment of taxes by North Carolina motorists is the noise they make annually before digging up approximately \$8,000,000 with which to pay their registration fees, and the apparent nonchalance with which they hand over \$22,000,000 in round figures, state tax on the gasoline that propels their motor buggies.

It's all in the nature of the taxes, in the opinion of State Senator S. Gilmer Sparger, who points out that the registration fees come due all at once and accordingly each motorist is forced to pay out a considerable lump sum.

Gasoline taxes, on the other hand are paid in units of six cents each time a gallon of the fuel is bought with the result that the payer isn't so intensely aware of the fact that he is paying a tax. It's a sort of sugar coated pill, the secretary of North Carolina's Petroleum Industries Committee says, and therefore just a bit more palatable, despite the obvious fact that during the course of twelve months the average gasoline tax bill is nearly three times as much as the average registration fee.

Mr. Sparger says he has found this one of the chief causes of public indifference toward efforts to reduce the gasoline tax, or at least to secure a state Constitutional amendment forbidding diversion of these funds, once paid, into other than highway funds to be used for highway purposes only.

He believes, however, that the campaign which has taken him into practically every county in the state is fast bearing results. Al-

Cow and Chickens Fostered By FSA

Raleigh, March 28.—Through its control of farming operations and methods of its borrowers, the Farm Security Administration is doing much to encourage the raising and keeping of cows and chickens in North Carolina. Regional Director George S. Mitchell said today.

Statistics from Region Four, which includes the states of North Carolina, Virginia, West Virginia, Kentucky and Tennessee, show that the number of families without cows has been reduced from 7,500 to 1,500 and 13,600 families now own more cows than they did before they came on the program. At the beginning 2,909 families were without chickens, now only 651 have none. Work animals of FSA families have increased from 19,000 to 45,000, Mitchell pointed out.

Commenting on these increases the regional director gave credit very largely to county FSA supervisors, who for the past two years have been helping farmers become self-supporting by means of combined credit and farm advice.
