Launch Strong Attack Against Foes in Lini Area

BITTER BATTLE IS PRECIPITATED

New Incident Turns Attention Of Jap Leaders to Danger of War With Russia

Shanghai, April 18.—(AP)

Japanese launched a strong attack in the Lini sector today, precipitating a major battle in which they apparently were determined to avenge the series of stinging defeats they have suffered recently at the hands of the Chinese in Central China.

Fierce fighting was reported in southeast Shantung province war zone, where Japanese and Chinese have been massing reinforcements and munitions for a decisive engagement.

With the Japanese sworn to revenge the disastrous setbacks a round Tientsin, they were staking their military prestige on the outcome of the battle.

Equally resolute, the Chinese were fighting to break up the Japanese campaign against central China and reconquer all their lost territory.

Striking southward along the Yi river, the Japanese tried to reach the city of Suichow, junction of the Lunghai and Tientsin-Pukow rail ways, 80 miles southwest of Lini.

While opposing armies locked in crucial battle near Lini, severe conflict continued around Yihai and Taoshuang, 70 miles to the west, where Japanese have been driven back to precarious defensive positions.

Tokyo, April 18.—(AP)—A foreign office spokesman asserted today Soviet Russia had detained a Japanese army plane, forced down in Suifenho, north of Vladivostok, last Monday.

Nine planes were patrolling the border and eight returned.

The spokesman did not specify the type of plane, but said the Russians notified Japan that "only one member of the crew was found alive."

Tokyo asked release of the ship to which the Russian reply was a protest against flying over Soviet territory, the Japanese informant said.

The incident is one of a long series which has turned the attention of Japanese leaders and the public increasingly to the danger of war with Russia. There have been persistent rumors, lacking official confirmation, of war preparations along the Manchoukuo-Soviet Siberia border.

Informed Tokyo quarters have heard Japan recently moved some regular army units from China battlefronts to Manchoukuo to man the border.

Final Rites Held For W. B. Brown

Funeral services for W. B. Brown, prominent Greenville man who died suddenly Saturday morning, were conducted at St. Paul's Episcopal church yesterday afternoon. Burial followed in the family plot in the church yard.

Son of the late Dr. W. M. B. and Jane Green Brown, he was a member of one of the county's oldest and most prominent families. Mr. Brown was one of the oldest members of St. Paul's Episcopal church. He was engaged in the mercantile business until a few years ago when he retired.

Surviving are his wife, four children, a twin sister, a brother and four grandchildren.

Negro Injured In Wreck Last Night

Patrolman C. R. Williams today was conducting an investigation into a wreck last night in which four Negroes were injured, one seriously.

The wreck occurred near Ballard's crossroads. It involved two cars, one driven by Jackson, Atkinson, a Greenville negro, who sustained severe cuts and bruises. Three other Negroes in the car with him received lesser injuries.

The other car was driven by Fountain (Doc) O'Neal of near Ballard's crossroads, who was injured slightly.

Patrolman Williams said he had not issued any warrants, pending further investigation.

Grainger To Investigate Electrical Phenomenon

Raleigh, April 18.—J. M. Grainger, engineer for the State Rural Electrification Authority, is planning to investigate reports of an electrical phenomenon on the Lillington-Bunn line with accepted tenants as to be almost freakish.

If results of his investigations, which will be main in conjunction with State College electrical experts, prove the reports to be correct there may be a complete revision of ideas as to the capacity of rural lines to operate multi-horse powered motors.

NON-MILITARY FUNDS SOUGHT FOR WAR DEPT.

Committee Asks Appropriation of \$220,634,725

ABOVE ESTIMATE MADE BY BUREAU

Bill Carries Request of \$94,300,000 For General Rivers and Harbors Work

Washington, April 18.—

(AP)—The House Appropriations committee asked Congress today to appropriate \$220,634,725 for non-military activities of the War Department for the fiscal year beginning July 1.

This total, which includes \$17,000,000 president Roosevelt suggested in a relief message last week for flood control, is \$23,618,838 above the estimate prepared four months ago by the budget bureau.

The bill carries \$94,300,000 for general river and harbor work, compared with \$128,000,000 this year; \$113,000,000 for flood control projects, compared with \$105,000,000 this year and \$10,250,125 for the Panama canal, about \$325,000 less than for this year.

Although the \$220,634,725 total is more than \$25,000,000 above the '38 appropriation, the War Department this year was given \$52,500,000 in relief funds, making the funds available for 1938 actually \$26,401,238 more than the bill proposes for the next year.

The committee recommended \$31,000,000 of the flood control appropriation be spent on the Mississippi river and its tributaries.

HEALTH BOARD MAKES REPORT

Activities of Department Shown for Past Month

Dr. N. Thomas Ennett, Pitt county health officer, today released his report on activities of the department during the past month, as follows:

"The major activities of the Pitt County Health Department for the month of March were: Pre-school Clinics, regular examination of school children, Maternal and Infant Welfare work, Venereal Disease Clinics, Dairy and Calf Inspections and a community sanitation program, that is carrying on an active privy program.

During March there were 99 cases of measles against 140 for February. There were no diphtheria, scarlet fever, whooping cough nor typhoid fever reported. This is the first month since August, 1934, that we have had no diphtheria reported.

"The Health Officer examined 344 school children and 249 pre-school children. Though Dr. Paul Fitzgerald, Secretary of Pitt County Board of Health, the dentists of the county very kindly assisted in the pre-school clinics. This adds to the quality of the pre-school examinations.

The Maternal and Infant Welfare work and the Venereal Disease Clinics continue to grow. The nurses have not only done a large amount of follow-up work in connection with Maternal and Infant Welfare Centers but they have also been active in following up cases of tuberculous (Continued on page six)

UTILITY IS HELD IN STRIKE GRIP

Public Transportation Halted in Columbus, Ohio

Columbus, Ohio, April 18.—(AP)—Negotiations to end a strike of street car and motor bus operators were mixed in an impasse today and thousands of office and factory employees walked or thumbed a ride to work.

Staunchly defending their stands, Carmen's union and officials of the Columbus and Southern Ohio Electric company, operators of the transportation system refused to alter their demands that brought on the shutdown at midnight Saturday.

Ben Marr, president of the utility, said all equipment had been ordered left in the barns, but strikers called a mass meeting for a "demonstration" should restoration of service be tried.

Hugh Friel, U. S. Department of Labor conciliator, announced he had been instructed to offer his services. Marr said the utility could not, under present business conditions, grant a demanded wage increase to 62 and 75 cents an hour.

The present scale calls for \$4 to 63 cents an hour.

Funeral Held For Greenville Woman

A large crowd of friends and relatives attended funeral services yesterday afternoon for Mrs. Maggie Hyman, 60, who died Saturday following three weeks of illness.

Mrs. Hyman, daughter of the late Samuel Richard and Julia Harter Wilson spent her entire life in Pitt county. She was the widow of Ashley Hyman.

Surviving are three daughters, one son, three sisters and two brothers.

RALEIGH LAST WEEK

Raleigh, April 18.—North Carolina's Supreme Court last week set the stage for the biggest mass execution in the state's history—certainly the biggest since 1910 when Central prison here was made site of all legal executions.

In addition this unprecedented event, the week Capitol news was savored with the opening of Frank Hancock's senatorial campaign, two important decisions by the Utility Commission, decision of an election law row, and continuance of a hot local campaign for a tax levy to give Raleigh a nine-month school term.

Governor Clyde R. Hoey who usually furnishes the correspondents much of their news and food for speculation, spent the entire period in the hinterlands, exhorting the virtues of North Carolina to the people at large and, in general, showing himself in his best vein of affability and friendliness.

Just before taking off, the Governor announced that he had allocated \$2,000,000 of highway funds for use on the secondary roads of the state, further stating that there is a \$9,000,000 surplus in the road funds—a statement which was immediately challenged in many quarters which contend that any talk of a real "surplus" is a myth, pure and simple.

Five Must Die—On Wednesday the Supreme court announced it would not grant new trials to five men—four Negroes, one white—condemned to die for criminal assaults. Automatically the death sentences of all became April 29, and unless the Governor interposes either by way of commutation or reprieve, that will truly be "Black Friday" at the Central prison, with the lethal gas chamber emptying and filling again for the greater part of the day.

REPUBLICANS TO LEAD FIGHT ON RELIEF BILL

Program Attacked By Two Prominent Party Leaders

END OF CONGRESS SEEN BY JUNE 1ST

Rivers and Harbors Appropriations Include Fund for Pamlico, Tar Rivers

Washington, April 18.—

(AP)—Republicans took the lead today in denouncing President Roosevelt's \$4,500,000,000 relief recovery program, apparently giving up the strategy by which they sometimes let anti-New Deal Democrats direct the assaults on administration measures.

Republican Chairman John Hamilton and Senator Arthur Vandenberg (R. Mich.), criticized the huge "pump priming" program as unsound in radio speeches last night.

Their outspoken opposition was in contrast to Republican tactics during the Supreme Court fight.

The legislation now being drafted was a major topic for Mr. Roosevelt's weekly conference with his congressional lieutenants this morning.

After the meeting Representative Rayburn of Texas, the House Democratic leader, reiterated a prediction that Congress would adjourn between May 20 and June 1.

Sayburn, Vice President, Garner, and Speaker Bankhead attended the customary Monday conference with the President before he left for his office. Senator Barkley of Kentucky, the senate leader, was out of the city.

Meantime Congressional tax bill conferees, recessing again today with a report of "no progress," called Chairman W. C. Douglass of the Securities Commission to testify tomorrow on proposed special tax treatment for utility holding companies undergoing liquidation.

Other developments: The House Appropriation committee proposed that Congress give the army engineers \$95,300,000 for construction and maintenance of rivers and harbors projects in the country in the year starting next July 1.

Appropriations proposed for new work included: North Carolina: Pamlico and Tar Rivers, \$328,000.

ANOTHER CITY SURE TO FALL

Insurgents Close in on Tortosa from Three Directions

Hendaye, France, April 18.—(AP)—The fall of Tortosa, key city of Southern Catalonia appeared imminent today as General Valino's insurgent army corps closed in on it from three sides.

A semi-circle of insurgent steel converging on a 10-mile radius broke through outlying defenses and forced Spanish government troops back to the Ebro river.

Highly mobile insurgent units fought their way to a coastal city controlling the southern approaches to Tortosa. That little town is on the main Barcelona-Valencia highway.

Farm Income On Decline: Finished Products Jump

Raleigh, April 18.—While consumers are buying the abundant crops that farmers harvested in 1937 at declining prices, they are paying more for many manufactured articles, E. Y. Floyd AAA administrator at State College, said today.

Triple-A figures show that while wholesale prices for agricultural products decreased in recent months and are now some 25 per cent lower than they were twelve months ago, prices for many industrial products are higher than they were early last year.

Farmers are being hit both ways by this change, Floyd pointed out. They must sell what they grow at lowered prices and buy manufactured goods at prices differing widely from those of early 1937.

For instance, he said, farm prices were 22 per cent lower in March, 1938 relative to the price of products

TRUCK DRIVERS OUT ON STRIKE

Easter Deliveries Are Held Up by Rochester Dispute

Rochester, N. Y., April 18.—(AP)—The truck drivers strike that tied up Easter deliveries here entered its third day today with a deadlock on the major issues of hours and wages.

After a Sunday in which representatives of the union and of the Associated Trucking Industry, employers, plotted strategic moves, all police platoons were ordered held in reserve to meet any emergency.

Strikers talked of a move to enlist sympathetic support of union drivers to crippled deliveries of merchandise not yet affected.

The strike was called Friday at midnight by local 118, Brotherhood of Teamsters, Chauffeurs, Stablemen and Helpers, an A. F. of L. affiliate. Between 800 and 1,400 were reported to have walked out when their contract expired that day.

DR. TOWNSEND GIVEN PARDON

President Intervenes To Prevent Serving Jail Sentence

Washington, April 18.—(AP)—President Roosevelt today pardoned Dr. Francis Townsend, old age pension advocate, as he was about to enter the local jail to serve a 30-day sentence for contempt of a House committee.

Townsend had already reported to the district attorney's office and announced he was ready to begin service of the jail sentence when the presidential pardon was announced.

The 71-year-old pension advocate was convicted February 24th, 1937 for walking out on a special committee which was investigating his plan to pay \$200 a month federal pensions to all persons older than 60 years.

FOUNTAIN MAN NEW FOREMAN OF GRAND JURY

Group Selected to Replace Body Recently Ousted

JUDGE FRIZZELLE CONDUCTS COURT

Charges Against Two Officers Included in List of Cases For Grand Jury Action

H. F. Owens of Fountain

was appointed foreman of the new Grand Jury drawn at the opening of a term of Pitt Superior court here this morning to replace one discharged on a technicality by Judge Henry A. Grady at the last session.

The new body will serve only until July and this is the only criminal term scheduled before them.

The Grand Jury is composed of Foreman Owens, Carlton Jackson, W. J. Whitaker, Jack Waters, E. J. Whitehurst, E. W. Wooley, L. W. Andrews, C. L. James, C. E. Case, W. R. Beverly, Arthur Keel, L. O. Gross, J. M. Hobgood, W. H. Wynne, W. C. Whitehurst, E. L. Bell, R. A. Fountain, Jr., and G. T. Stokes.

It was revealed that only one member of the body, Mr. Hobgood, had ever served on a Grand Jury before.

Four men drawn for duty were excused. T. F. Hart was relieved when it was pointed out that the name drawn by the commissioners was L. F. Hart. B. A. Pope, school teacher, was excused because of his duties. John T. Barnhill, who declared he had sold a large amount of fertilizer and was the only person who knew where to deliver it, also was excused by the judge. Rufus L. White's request to be relieved because of a painful carbuncle on his neck, and J. L. Perkins' son was excused when he told the court he operated a filling station and had no one to relieve him.

J. M. Hobgood asked to be released because of pressing business, but following a conference between him and Judge Frizzelle he resumed his seat and was retained as a member of the body.

Judge Frizzelle's charge dealt entirely with the duties of a procedure of action to be followed by the Grand Jury. He explained the course to be followed in considering bills of indictment and stressed the importance of the task they had been chosen to perform. He reminded them that they were pledged to secrecy and added any person inquiring into activities of the body was guilty of the gravest kind of contempt of court. The jurist asked the name of any person inquiring into the work of the body be made known to the court so proper action could be taken.

The presiding judge said he realized the members of the jury had a difficult task and perhaps an unpleasant one, but urged them to carry out their duty with the idea of bringing about justice.

The old Grand Jury was discharged by Judge Grady on motion of counsel for Sheriff S. A. Whitehurst and J. H. Harris, who contended that the county commissioners violated technicalities of the law in drawing names from the box.

Sheriff Whitehurst and Deputy Sheriff Harris were charged with accepting bribes and in addition the sheriff was charged with failure to perform his duties in the bills of indictment returned by the Grand Jury before it was ousted.

Cases for Grand Jury action contained in the calendar for this week's court includes charges against the two officers similar to those brought at the last session. The Grand Jury, however, has not acted on the bills.

With the completion of formalities this morning, the court started its hearings. A note pros with leave was taken in a number of cases by the State.

Funeral Held For Farmer Of County

R. L. Pilgreen, 74, of the Pactolus community died at 10:30 o'clock on Saturday night following a stroke of paralysis suffered Friday.

Funeral services were conducted at the home yesterday afternoon at 3:30 o'clock. Burial was in the Langley cemetery.

How's Your Health?

The great highway menace is not the drunken driver. It's the drinking driver.

He who is visibly drunk and undertakes to pilot an automobile is of course highly prone to "run into trouble." However it is possible that the drunken individual, even though intoxicated, may still be aware of the risk, and refrain from taking the wheel. More likely is the prospect that others, recognizing his condition, will dissuade him, or if necessary restrain him from driving.

It's otherwise with the drinking but not evidently drunken, driver. Having taken but little alcohol, he is likely to be in a gay and lifted mood, have utmost confidence in himself, and believe that he is driving well, when actually he is showing bad judgment and worse coordination.

Fatal accident summaries show that but 7 per cent of the drivers and 11 per cent of the pedestrians involved "had been drinking," or were intoxicated. But these figures are not revealing for they reflect legal rather than physiological definitions of alcoholic intoxication.

Physiologically it has been shown that alcohol and automobiles "are all too likely to get mixed so that it is hard to extricate what remains of the drinking driver and his victims."

An English reports says: "Alcohol in small or moderate amounts has been shown to diminish attention and control, to affect reasoning adversely, to affect adversely the power to make movements dependent upon rapid and accurate coordination, and the ability of the eyes to follow clearly an object nearer and nearer."

"After taking alcohol the automobile driver may believe himself to be driving better but in fact his body works less efficiently. This happens even if alcohol is taken in moderate quantities some hours before driving, and especially on an empty stomach."

Horses And Mules Make Up Most Of Livestock Assets

Figures Compiled by National Association Released Through Division of State Department

Raleigh, April 18—North Carolina's horses and mules constitute by far the greater part of the state's livestock assets, according to figures compiled by the Horse and Mule Association of America and released through the statistical division of the State Department of Agriculture.

There are in the state, in round numbers, 69,000 horses with a value of \$4,603,000, while there are more than four times as many mules, 305,000, whose value runs up to \$55,136,000—giving a combined horse-mule value to the state of \$59,739,000.

Against these figures the state shows 62,000 sheep with a value of \$362,000 and 1,133,000 swine aggregating in value \$11,123,000; so the combined horse-mule valuation is approximately five times that of the sheep-swine combination.

In the state there are 370,000 milch cows, valued at \$14,430,000 and 258,000 other cattle valued at \$4,466,000; so horses and mules exceed the value of the state's milch cows by \$49,309,000 and surpass the value of all other cattle by \$49,273,000.

The association points out that farmers in this state are fortunately situated to use and produce horses and mules. Food is abundant reasonable in cost, pastures can be made available for 9 or 10 months of each year and farms are of moderate size and generally diversified, favoring the use of animal power.

Pastures, the article continues, are the key to success in raising and using horses. A mixture of wheat, oats and barley broadcast in March at the rate of four or five bushels to the acre will make wonderful pasturage in May and June.

"Good, green, rapidly growing pastures develop and maintain horses and mules at low cost—and this enables wise farmers to lower their crop production costs," the story concludes.

Mr. Priestly was represented briefly on Broadway this season with two plays, one of which was called an artistic triumph but failed to survive the public's apathy. The other, "Time And The Conways," was so unbelievably dull that most of the playgoers walked out or went to sleep.

Both of these plays had good ideas but were handled so heavily that, from box-office angle they never had a chance to succeed. Irrespective of what London thinks of him and the honors he has won in letters, it is my opinion that he can't write entertainingly enough to succeed as a playwright on the New York stage. He simply is too heavy-footed and dull.

His article purports to analyze the New York stage, which he finds cynical, trashy and ill-mannered. To arrive at this conclusion he completely ignores the successful plays of this season most of which his own countrymen have hailed and points to two hold-overs from last year as being the sum and total of what Broadway likes.

The plays he mentions are "The Women," now in its second year, and "You Can't Take It With You," a Pulitzer prize winner also in its second year and one of the big money-makers in Broadway history. He is correct when he says New York likes these plays. But he is scarcely adequate as a critic and he is certainly less than honest as a reporter when he holds up two comedies, which he dislikes, as representative of the whole New York theatre.

Mr. Priestly, more in sorrow than anger, deplores the plight of the poor Manhattan critics who "drag themselves off to the theatre nearly every night in the week, bored and grumbling, and are in no condition to appreciate the subtleties of dramatic art."

Subtleties of what art? That dull stuff he packed into "Time And The Conways," which in most ob servers, inspired one long, bored yawn, three acts long.

Sorrowing further after the wretches who observe the New York drama professionally, Mr. Priestly adds: "What they demand from the stage is a series of electric shocks, scenes that are tougher and tougher, comedy that is wilder and wilder, wisecracks that are more and more daring."

Finally he likens his writings to rare old liquor brandy which is unappreciated by New Yorkers because their palates have been impaired by constant usage of cheap bootleg whiskey and firewater. New York's trash theatricals, he says, are like shots in the arm to jaded reviewers who must have something explosive to keep them awake.

Perhaps New York could use an occasional dram of honest liquor but in the case of Mr. Priestly's brandy, I fear a little of the grape has turned sour. After all, two Broadway floppers do not add up to honey and cream.

Rails Get Rate Boost, Greyhound A Franchise
The Utility Commission broke into the headlines with a decision that railroads will be allowed to raise their interstate freight rates in about the proportion recently allowed by the I. C. C. for interstate rates. Later in the week a Commission order gave the Greyhound lines the much sought-after Lexington-Raleigh franchise, a row which had called into action almost a score of the state's leading lawyers (and politicians). This gave the Greyhound its first east-west route from one end of Tar Heel to the other (Wilmington-Boone).

Strawberries, No Cream or Gravy
The Unemployment Commission ruled during the week that strawberry picking is "suitable" employment for many unemployed workers who are entitled to compensation checks; and further ruled that if these workers do not accept strawberry-picking jobs when offered, they shall receive no cream or gravy in the form of compensation checks. The ruling leaves it up to deputies to determine in each instance whether or not the employment offered is "suitable."

School Election Nears in Raleigh
Registration for Raleigh's third school supplement election closed Saturday, with more voters on the books than for either of the first two. The question is whether the city shall levy a 17 cent ad valorem tax to give the city a nine-months school. No organized opposition has appeared to the poll which will be held April 25.

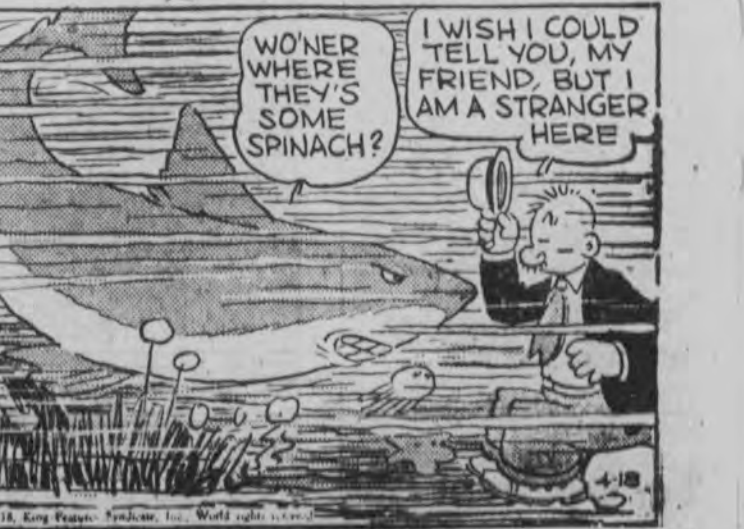
