FDR TO TALK ON ANTI-TRUST LAW REVISIONS

President To Send Message to Congress By Next Friday

CRUISE PLANNED OFF CHARLESTON

Also Admits that He Has a Desire to Visit West Coast of South America

Washington, April 22.—(AP)—President Roosevelt said today he would send his message to Congress in revising the anti-trust laws before next Friday.

On that date he plans to leave the capital for a short cruise off Charleston, S. C.

In connection with proposed anti-trust legislation, the President said he had discussed monopolies with Senator Borah (R-Idaho), at a luncheon conference yesterday. He and the Senator, Mr. Roosevelt added, agreed substantially on everything.

The President, talking to reporters at his press conference, said his monopoly message would be the second of two communications he will send Congress next week.

He said he expected his message about reciprocal Federal-State taxation of salaries of public officials and of future issues of state and Federal bonds would be dispatched to Congress Monday.

The question of reports that he was planning a trip to Chile was raised and the chief executive said that for years he had wanted to visit the west coast of South America.

President Roosevelt defined one of the prime purposes of the neutrality act, meanwhile, as being to prevent this country from penalizing one warring nation and so favoring another.

He declared the law had been satisfactorily applied in so far as possible.

Other developments: The House Labor Committee recommended enactment of its revised wage-hour bill to prevent a "vicious spiral of deflation" which, it said, "may threaten the foundations of government itself."

Officials of the Securities Commission and the RFC reported that business men were responding in increasing numbers to the administration's lending proposals.

Testify Whitney Sought Make Loan

New York, April 22.—(AP)—Two members of the New York Stock Exchange testified today at a Securities and Exchange Commission hearing that Richard Whitney tried to borrow \$200,000 from them a few weeks before his brokerage firm crashed on March 8.

At the conclusion of today's hearing the investigation will be adjourned until Tuesday in Washington, when partners of J. P. Morgan and Company will be called.

The brokers who testified today were Henry W. Bull, a partner in Winthrop-Mitchell and Company since April 15, and Nelson Asiel, senior partner of Asiel and Company. Each testified Whitney offered 3,900 shares of Distilled Liquor Corporation as collateral.

Asiel said he talked to Whitney about two weeks before March 2nd and told him at that time it was not the policy of his firm to lend money. He was mildly surprised, he said, by Whitney's request because their firms were competitors, but accepted the situation because "we had worked together as kids, side by side for 25 years and we had worked on committees together."

On March 2, Asiel said, Whitney tried to make a personal loan of \$50,000 to \$100,000. Asiel said to refuse because, he said, he had "no free cash." He added he had "full confidence" in Whitney and had heard no rumors that Whitney was trying to borrow from other sources.

Bull said Whitney approached him on February 16 and 17. Bull told Whitney he did not like the collateral offered and needed to conserve his capital.

City Court Session To Start At 9 A. M.

Judge W. A. Darden announced today that court sessions would be started each Monday and Friday at 9 o'clock.

Only two cases were heard at this morning's session of the tribunal. W. H. Dail, convicted of crashing a red light, was taxed with the costs of court. The defendant appealed to Superior court.

Herbert Fleming, Negro, was taxed with the costs upon conviction of violating a traffic law.

LANDON FLAYS RELIEF PLANS

Calls on Congress To Halt Government Spending

Topeka, Kan., April 22.—(AP)—Alf M. Landon called upon "an articulate citizenry" today to make it clear to Congress that this huge appropriation proposed in President Roosevelt's new recovery program must be met by adequate tax provisions.

The 1936 Republican Presidential nominee in an address prepared for delivery to the Optimist club said the President's proposal has ended the period of uncertainty "as to the government's fiscal policy."

We are again upon an inflationary course," he said.

If every time there is a recession in business the only way out that a government can find is a further huge expenditure program to be applied on top of expenditures already too great, then we shall go bankrupt.

If the government spends money it must collect revenues to match the expenditures.

"It is not yet too late to pull up and save ourselves and pay our honest debts. We can pay the public debt of these United States if we are honest and economical. But we will have to economize, we will have to stop our spendthrift course."

The nation's hope, he said, "lies in Congress, backed by an articulate citizenry, to continue to take action and assume leadership."

Reynolds and Hancock Pleased With Keynote

Raleigh, April 22.—Selection of Congressman Lindsay Warren as keynote for the Democratic state convention here May 16 is pleasing to both Senator Robert R. Reynolds and his primary opponent, Congressman Frank Hancock, according to telegraphic statements from both candidates.

Which indicates that Warren must be truly a neutral in the fight between "Our Bob" and "Friendly Frank."

In reply to a request from this bureau for statements on the Warren selection, Senator Reynolds told at some length why he regards the First district Congressman as exactly the man for the place. Representative Hancock was very brief in his reply, but just as emphatic in expressing his approval.

Senator Reynolds wired: "Selection of Lindsay Warren as keynote for the Democratic state convention is a most happy choice."

Soviet State Set Up in Province By Chinese Reds

Shanghai, April 22.—(AP)—Japan is sacrificing much of the Hoppeh province area she won early in the war to throw more troops into the central China front.

The greatest concentration of Chinese forces since fighting started July 7, 1937, and continuing guerrilla raids against Japanese outposts have created for the Japanese a critical situation.

The fighting is centered in southeastern Shanling, and along the Peiping-Suiyuan railway.

Forced to muster every available man since the sharp defeat at Tai-erchwang, first major loss in modern Japanese military history, the high command was said today to be withdrawing garrisons from Hoppeh between the two railways.

Chinese reds already have set up a Soviet state in the area with an army of several hundred thousand troops and it now seems likely all of central Hoppeh soon may be under their domination. Japanese still retain first control of Peiping and Tientsin, major cities they won shortly after the conflict started more than nine months ago.

The Chinese, with more than 200,000 troops said to have reinforced the central front army within the past three weeks, were establishing a new defense line today crescent shaped to the west, south and east of Lin.

J. Frank Harrington, veteran clerk of court here, had as his guests today clerks from two nearby counties.

The visitors explained they were on unofficial business and were just stopping a while to pay a friendly call.

ASKS TEST OF STAPLE IN N. C.

Would Determine If Cotton Not Suitable For Blankets

Raleigh, April 22.—(AP)—Agriculture Commissioner Keer Scott said today he would request the department a test farm division to make an immediate investigation to determine why North Carolina cotton can not be economically used instead of Indian cotton in blanket manufacture.

A shipment of 12,000 bales of Indian cotton is in a Richmond, Va., warehouse for shipment to a blanket-maker at Asheville. Officials of the company getting the staple said it was used because it made blankets "more nearly resembling wool" than was possible with domestic staple.

"If this is true," said Scott, "then the forces of research in North Carolina must turn their attention to the development of a staple that will meet the manufacturers' demand."

It may not be sound economics to place a barrier in the way of foreign growers, but we must give our own growers protection and the benefit of our research agencies to combat the necessity of continuing our present emergency farm program payments and eventually reach the goal of self-supporting agriculture.

Scott said the importation of cotton from India into this state, which last year saw 11 per cent, or \$20,000,000, of the farmers' total cash income come from cotton, but emphasized the state's need for one of the four regional research laboratories to be located by the federal government to find new uses for cotton and other products.

SHERIFF ASKS ANOTHER TERM

Announces Candidacy Subject to June 4th Primary

S. A. Whitehurst today announced his candidacy for renomination as Sheriff of Pitt county.

Sheriff Whitehurst started the duties of the office by appointment in 1936 and has won at each primary since. He was named in July, 1926, to fill the unexpired term of A. C. Jackson. He ran in the general elections in November of that year and was elected.

Each two years since he has been successful in primaries and elections.

"In addition, Lindsay Warren is an organizer of no small ability and his keynote address is certain to be a call for Democratic solidarity in the state and an appeal for the best in real Americanism."

LOYALISTS IN EASTERN SPAIN CHECK REBELS

No Ground is Believed To Have Been Gained in 36 Hours

ALSO HALTED IN MOUNTAIN AREAS

Government Troops Reported Successful in Counter Attacks at Strategic Points

Hendaye, France, April 22.—(AP)—The Government, almost two to one superiority in man power, apparently has halted the insurgent advance in Eastern Spain.

The latest communique issued by the insurgent headquarters, which for days has detailed a long list of captured towns, spoke merely in general terms of a "continued advance" down the coastal road.

The terse communique, however, placed the insurgent's Southern column still in the vicinity of Alcala e Chivert, which was reported captured 36 hours before.

A similar impasse seems to have been reached all the way to the Pyrenees frontier, where for the last two days the insurgents have been taking "complete possession" of the Aran valley.

Along the 10 miles of the 190-mile front—from Gandesa North to Sort—the militiamen have held firmly for more than a week. At two strategic points the government reported counter attacks had reduced insurgent bridgeheads.

During the month since the insurgent attacks developed in Catalonia general Franco's troops have penetrated an average of only 18 miles within the province, about one seventh of its breadth.

TASTE STRONG FOR BEVERAGE

Agrees, However, To Abstain Rather Than Serve Time

Roland Cannon, Ayden white man convicted of driving drunk in Superior court yesterday afternoon, advised the court he preferred to serve a road sentence to signing an agreement to refrain from drinking intoxicating liquors for five years, but later changed his mind and paid a \$50 fine and costs of court and agreed to the terms of the judgment.

After his conviction Judge Frizzelle offered the defendant his preference of a road sentence or the fine with the agreement he would abstain from liquor. He replied he would take the term. His wife and others conferred with him, however, and he reversed his decision.

The case was hard fought and consumed much of the afternoon session.

Lola Badger tendered a plea of guilty to assault with a deadly weapon and was sentenced to a two-year term.

Court was not in session this morning. Judge J. Paul Frizzelle having appeared on a church meeting program at Ayden, but hearings were resumed in the afternoon.

Norfolk Southern R. R. Curtails Service May 1

Utilities Commission Allows Petition Of Line

Raleigh, April 22.—(AP)—The Utilities commission authorized the Norfolk Southern railroad company today to discontinue all passenger service May 1, except on its line from Charlotte through Raleigh to Norfolk, Va.

The order was the most sweeping ever issued involving stoppage of passenger service in the state, said Commissioner Stanley Winborne. A petition is pending also to stop service from Charlotte to Raleigh. "It is distasteful to allow discontinuance of service of any utility which might inconvenience a North Carolina citizen," said Winborne, "but when, as in the present case, it is shown that only very few citizens use the utility and it operates at a heavy financial loss there is no alternative."

The specific passenger service to be dropped, from operating as "mixed trains" of freight and passenger coaches is: between Bridgeton and Oriental; between Edenton and the Virginia line en route to Suffolk, Va.; between Fayetteville and Vain; between Mackey and Columbia; between Aberdeen and Asheville; between Pinetown and Belhaven; and between Marsden and New Bern.

It was set forth the Marsden-New Bern discontinuance was granted "without prejudice to the rights of any party as to their liability under any contract" in view of the objection of the Atlantic and North Carolina railroad that the withdrawal would affect contracts for maintenance of the passenger station.

Judge Paul Frizzelle Attends Church Meet

The term of Pitt Superior court being conducted here this week was in recess this morning while J. Paul Frizzelle, presiding over the session, attended a district meeting of the Methodist church in Ayden.

Judge Frizzelle was scheduled to appear on the program and starting of the day's session was postponed until 2:30 p. m.

Judge Frizzelle next week will go to a Southern meeting of the church to be held in Birmingham, Ala. He also is scheduled to appear on the program there.

Judge G. Vernon Couper of Kingston will preside over the term of court here next week.

1937 Liquor Laws To Get Supreme Court Ruling

Raleigh, April 22.—North Carolina's Supreme court will soon be called on to make its first interpretation of the liquor laws enacted by the 1937 General Assembly.

Oddly enough, the case will find a member of the House who voted against the county control ABC plan arguing that the laws as enacted were a complete change in North Carolina's policy of dealing with intoxicants and therefore repealed practically every restrictive provision of the existing (Turlington) act.

The case, State vs. M. W. Epps, will come up as a "pauper" appeal from Scotland county, with Representative Jennings King representing the appellant. It will be the first criminal case on the calendar to be called during the week of May 3rd.

In his brief, which goes exhaustively into the question from every angle, Representative King poses the paramount question: "Was the ABC law of 1937 a complete change in the state's policy with reference to intoxicating liquors or was it merely an amendment or exception to existing laws?"

Here for the filing of his brief, the Scotland county legislator expressed the opinion that his client will win if the Supreme Court Justice hold that the 1937 laws represent a complete change in policy. Otherwise, he admits, his plea will fall on deaf ears.

The appeal will come before the court on what is technically called a motion in arrest of judgment, the appellant's counsel arguing that no judgment should be pronounced against Epps because he was tried upon an indictment which does not allege facts sufficient to amount to a criminal offense. The motion was not made in the lower court, counsel says, but authorities are cited to sustain him in making it in. (Continued on page six)

NATION-WIDE COUNTERFEIT RING EXPOSED

"Bugs" Moran, Former Gangster Chief, Caught in Trap

FIND CHECKS ON ONE PERSON HELD

Believed More Than \$1,000,000 in Counterfeit Travel Checks Printed

Chicago, April 22.—(AP)—George "Bugs" Moran, prohibition era gangster chief, and five other persons were seized here today by police investigating a nationwide plot to counterfeit travelers' checks.

Three Chicago men accused of being members of a counterfeiting ring were arrested at Pittsburgh last night.

Police of the State's Attorney's office, who made the arrest here, expressed the opinion as much as one million dollars in counterfeit American Express company checks had been printed for distribution on principal cities of the nation.

Moran, seven of whose henchmen were machine-gunned to death in the St. Valentine's Day massacre, was held at the detective bureau during the night. He and others denied being involved in a counterfeiting ring.

Assistant State's Attorney Robert Wright announced these seized here included Frank Parker, airplane pilot known as the "flying bootlegger" in prohibition days; Walter Nolan, an employee of a coin vending machine company; Marie Ribble, Loren Gant and a woman whose name was not divulged.

Lieut. Thomas Kelley, chief investigator for the state's attorney's office here, said Parker had \$2,000 in checks in his possession when he was seized.

Confesses Trying To Extort Ransom

Trenton, N. J., April 22.—(AP)—Stanley Thomas Jaskosky, 19, of Newark admitted in Federal court today he attempted to extort ransom from the father of 13-year old Peter Levine, New Rochelle, N. Y., school boy who disappeared February 24.

"I'm sorry for the boy, that's all," Jaskosky told Judge Philip Forman as he pleaded to an indictment charging he sent three threatening letters to Murray Levine.

The indictment charged that the first note demanded \$30,000. It alleged Jaskosky later wrote a second letter instructing the father to take an airplane from Patterson, fly low over Staten Island and drop \$60,000 at the sign of a white cross on the ground.

The third letter asked that \$30,000 be delivered at Newark for the return of the boy, the indictment alleged.

Deferring sentence, Forman ordered that Jaskosky be given a thorough psychiatric examination.

Federal agents announced meanwhile from Chicago that the arrest of Charles Lavender, 36 on charges of attempting to extort \$30,000 from Murray Levine.

D. M. Ladd, agent in charge of the Chicago office of the FBI, said Lavender "undoubtedly" had no connection with the kidnapping of the boy.

John Allen Fornes Claimed By Death

John Allen Fornes, 59, died yesterday afternoon at 5 o'clock at the home of his niece, Mrs. Tum Edwards of near Clovintown. He had been in declining health from a stroke of paralysis Tuesday.

The funeral cortege will leave Williams Funeral Home at 2 o'clock Friday for the Adams Cemetery near Shelmerline where final rites will be conducted by Rev. J. G. Spivey, Holiness minister of Greenville.

Mr. Fornes was a life long resident of the Shelmerline community.

Surviving are two brothers, H. D. of Greenville and J. G. Fornes, of the Epsworth community in Craven county; also one sister Mrs. Elma Fornes, Beaufort county.

Re-crossing the Pacific by plane, the camera halts briefly at Manila, where the American commercial interest is dominant and the National City plays a prominent part in the financing of island trade in which sugar cane and pineapples are leading items.

The final section of the film deals with Latin America, mining and oil in Mexico, sugar in Cuba, run in Puerto Rico, bananas in Haiti, shipping at Panama, coffee and rubber in Brazil, cattle and wheat in Uruguay and the Argentine. Through-out the view of metropolitan and rural life in Central and South America runs the theme of American enterprise and American banking adapted to local customs and local needs.

A notable shot, taken by members of the bank's overseas staff, shows the plane winging its way across the Andes to Chile where the stakes of American investors is exceptionally large. Starting with the nitrate industry of this republic, the march of trade moves up the west coast through Lima and the tin mines of Bolivia, the gold mines and cocoa industry of Colombia to the oil fields of Venezuela, the rich product of which have enabled that country to pay off its entire national debt.

A large part of the film, particularly those sections showing local customs and the bank's branches, seventy-two of which are pictured, was taken by staff members of the National City Bank.

This picture will be shown at the Pitt Theatre Saturday morning at 11 o'clock, and will be free to the public. This is the last day of World Trade Week which is sponsored by the local chapter of the A. A. U. W. and organizations affiliated with the Greenville Council for Peace Action.

Washington Tulip Festival Parade.
(By Edw. W. Hearne)
Soon after the wee hours of dawn had opened their eyes and smiled approvingly—assuring many thousands of Eastern North Carolinians that rain would not mar the morning session of the Tulip Festival—the streets of Washington, N. C., began to buzz with out-of-town-ers arriving to witness the tulip parade. Practically every citizen of Washington from the age of three months to eighty years was attired in Dutch costume. For blocks and blocks, along Main street the populace gathered in these quaint costumes—Dutch mothers in wooden shoes pushing babes, clad in tiny Dutch ensembles, in perambulators covered in artificial tulips (for Mother Nature had plucked the real tulips by sending an early spring). Hundreds of tiny tots from two to six years of age hobbled back and forth—in their wooden shoes—across the blocked off street, awaiting the parade—while scores of grandmothers, from sixty to eighty years of age, gaily attired in costumes ranging from delicate pastel shades to vivid rich hues, sat along the curb—making a scene resplendent in colors that could only be equalled by one of God's woodland masterpieces.

Practically all of the store windows were decorated, or painted, in appropriate Holland scenes by Jessie Giles, noted local artist. Dutch scenes, covering entire plate glass windows, that would have the walls of any art museum—bouquets of tulips tied in gay ribbons painted on other windows—while on others, at the bottom, were rows of tulips painted so naturally that one felt as though they could really pluck them. One outstanding window was that of the R. P. Fowle store—dressed and sponsored by the Reading Blount Chapter of the D. A. R. Out in a green field stood a windmill in blue and white—a tiny Dutch boy and girl overlooking the scene

—a large mirrored plaque representing a body of water on one side with a sail boat on it—while the Dutch family stood along the water's edge. Another attractive window was the George Washington Drug Co., which was designed, painted and erected by Miss Lindy Moore Etheridge, another local artist. In the background was the hand painted, and constructed windmill, about four feet high, whose sails turned electrically—artificial grass covered the floor of the window and miniature hand painted tulips grew in profusion. Sitting among the tulips was a tiny replica of "Snow White."

Promptly at 11 a. m., the three or more mile parade reached Market and Main streets and proceeded up Main street. There were eight splendid bands ranging from the Salvation Army Band to the Wake Forest musicians. The Edenton band was outstanding in colorful costumes and counter marching. The Belhaven band clad in red and white Dutch costumes, drew much applause as they strutted, by playing "When You Were a Tulip and I Wore a Big Red Rose." Hundreds of children from the various county schools proved that they too, could "go Holland." More than 35 beautiful floats caused the throngs along the route of march to gasp and cheer.

—floats that would be a credit to any Mardi Gras New Orleans ever witnessed. We were the judges we would probably give credit as mentioned in line: First, the Harris Hardware Co., a huge float of white and yellow crepe paper—Dutch boys and girls standing on a dias while others stood about elsewhere. We were so spellbound by this masterpiece that we called upon Mr. Jesse Harrington to extend congratulations and learned that, at wholesale price, over \$60 worth of crepe paper was used, and weeks of labor, in building this work of art. Second, the Aurora float—a tremendous ship.

Holland blue and white paper with a large shell of canopied blue which held "The Little Dutch Maid." Third, the Washington Book Club float—at the front end was an open book whose pages were about 6 by 10 feet. On one page was a Holland scene painted in oils which formed a background for a Dutch girl holding a bouquet of tulips. On the lawn in front was "Snow White" surrounded by "The Seven Dwarfs." (This Walt Disney feature was at the Turnage Theatre for the occasion). Fourth, the D. A. R. float—a huge trellis at the front covered with rambler roses beneath which sat young men and women in

LABORATORY RATS USE EITHER PAW TO REACH FOOD

Albuquerque, N. M. (AP)—The discovery that rats, like human beings, are right or left "handed" and ambidextrous has led to a series of interesting experiments at the University of New Mexico. The discovery was made by Dr. George M. Peterson, professor of psychology, and an assistant, who observed that certain rats used in a psychology laboratory always used the left paw in reaching thru a cage for food.

An apparatus was constructed in which the rats could obtain food only by manipulating a lever. The rats quickly learned to do this. Some always used the left paw. Others used the right.

Dr. Peterson says there is no difference in the mechanism of the nervous system of rats and men.

WHAT IT MEANS:

The Railroad Crisis

By MORGAN M. BEATTY
AP Feature Service Writer

Washington—If you can't make head or tail of that railroad crisis the President tossed to Congress the other day, console yourself.

Some of the world's ablest financiers and the cream of railroad genius have been trying to solve the railroad crisis after another for more than a hundred years.

It's a wonder the railroads are still with us.

They have competed with each other ruthlessly; they have been hit by competition from buses, automobiles, trucks, airplanes, pipe lines and electric power lines.

They have been in seven financial panics since 1891, with investors bearing the brunt each time. They have a bad regulation—good, bad and indifferent—from 48 states and the Federal government.

Through the years, taxes and labor costs have soared; today the railroads are paying annually \$240,000,000 in taxes, \$2,000,000,000 in wages.

Why They Survived

The railroads have survived and held their place as a basic industry, still as important as its recent rival, the automobile for these reasons:

1. The American public needed rapid transportation to develop this young and amazingly rich nation.

2. Railroad inventive genius constantly figured out ways to cut costs and increase safety and comfort. The first steel rails cost \$218 a ton. The Bessemer steel process had brought rails to \$28 a ton by 1914. The Westinghouse air brake brought trains under scientific control for the first time. Block signals reduced accidents. Pullman cars changed night travel from nightmare to comfort.

3. Railroad workers and management produced the genius and organization to operate the largest railroad network on the earth with speed and efficiency.

Solutions Proposed

Three ways have been proposed to save the railroads. There are arguments against all three.

1. Voluntary consolidation, with government supervision over all from portation.

Consolidation would eliminate the waste of duplicate lines and labor costs, and keep buses, planes, etc., in fair competitive positions.

But who will pay off the investors in scrapped railroads? With few takers now, where are the railroads to find new investors to finance new ones? How about the communities that would be cut off from railroad connections? What are you going to do with the thousands of workers who would have to be discharged? And what if the railroads just won't consolidate?

2. Consolidation under government compulsion.

Here you have all the difficulties brought up in plan No. 1, and the added barrier of the Constitution, which says you can't deprive a man—meaning also a corporation—of his—or its—property without due process of law. An act of Congress is not necessarily due process—at least, not until the whole fight

would be threshed out in the courts for several years.

3. Government ownership.

The railroads represent an investment, according to government figures, of some \$25,000,000,000. The people and corporations who now have their money in railroads would have to be paid if the government took them over. Part of this payment and the railroad debts as well would have to become a public debt, and the national budget is already carrying a depression burden.

Then, too, government ownership has never been a long-term paying investment in any country. The federal government sank something like a billion dollars into its operation of the railroads in this country during the World war.

But Crisis Continues

Yes, the railroad crisis is still with us, and will be the next time you pick up a paper. But meanwhile, Congress will have to find a temporary solution, or else the railroads will face the wringer in the midst of a recession. That probably means government loans to buy equipment and pay bills—for the time being.

Then, when economic skies are a little clearer and the 1938 Congressional elections are out of the way, the government may tackle the railroad crisis in earnest.

Washington—Don't come crying
around a few years from now and
say you weren't told. You are now
being told—in the words of Sen-
ator Ashurst of Arizona:

"Taxes will be, to say the least,
moderately heavy during the life-
time of all persons now in exist-
ence. Taxes may be reduced only
by reducing expenditures. The rem-
edy for heavy taxes is somewhat
within the hands of the taxpayers
themselves. If and when taxpayers
quit the practice of telegraphing
Congress for more appropriation,
and begin instead to telegraph Con-
gress to vote against appropria-
tions, Congress will grant relief
from heavy taxes."

"But I do not entirely agree.
There are in this world some
that may not be repealed, and
the law of the survival of the
fittest, the law of supply and
demand, the law of compensation,
the law of reactions. Even if Con-
gress should refuse to grant relief
from excessive taxes, the law of
reactions would ultimately do its
effect work."

"As a rapidly running river
creates obstructions for itself, like-
wise an era of prodigal expendi-
tures will be followed by econ-
omy to the point of parsimony."

"I therefore declare to the Sen-
ate, as I said last autumn in my
addresses to various civic organi-
zations, you are wise in getting
money from Uncle Sam's treasury
while the getting is good; for un-
der the law of reactions, this prodigal
era in due time will be followed
by a regime that will make Calvin
Coolidge look like a spendthrift."
(Laughter.)

Raleigh, April 22.—Estimated cost
of building construction work in 21
of the state's cities was practically
double in March what it had been
in the previous month, with March
projects estimated to cost \$1,852,381
against \$926,574 for February, an
increase of 99.9 per cent.

March construction values were
only 5.8 per cent under those for the
corresponding month of 1937, and
in number of projects this March
exceeded last by 652 to 618. Chief
drop in estimated value was in res-
idential buildings, the 240 for March,
1938, costing \$755,632 against \$860,-
124 for two fewer residences in
March of last year.

Figures were released today by
the North Carolina Department of
Labor.

Leonard Store Seen As Method To Raise Funds

Reflector Bureau:
By HENRY AVERILL
Raleigh (April 21)—J. Paul Leonard, secretary of the North Carolina Fair Tax Association, has followed his announced intention to open a "sales taxless" store with an appeal to "Members of the Fair Tax Association and Subscribers to Special Fund" for "immediate help in putting our finances in proper condition."

This is exactly in line with the forecast of this bureau at the time the store opening was announced, and goes far toward confirming an impression that Mr. Leonard's proposed store is more in the interests of publicity and fund solicitation than any real desire to test the constitutionality of the sales tax law.

In his letter, mimeographed on paper of the "Community Variety Store, J. Paul Leonard, Owner, 136 Lockland Avenue, Winston-Salem," Leonard flatly states "I must have funds next week for myself and our attorneys. Others will take over when I get the store started, then I'll be on the go. I can't believe you will let me down at a time like this."

The letter is dated April 16 and is marked "Confidential."

It begins with a description of Mr. Leonard's "mixed emotions" on receipt of messages about the store opening. He complains "I am being misquoted, misrepresented, misunderstood and virtually slandered—but I thank God and thank a million to you who have written—I am also getting credit for courage."

Speaking of his announcement of the store opening he said: "Although we were not quite ready financially to take action, so little time remains for legislative candidates to file, I felt we could not delay."

In the next paragraph he complains that "I have sensed in different sections of the State indications of some force trying to destroy my usefulness as your spokesman."

"But I never fear the truth," he continues, "No matter what you read or hear, please keep these facts in mind: First—I am in dead earnest, am honest, and sincere. Second—The only statement I authorized, and the only quotations are contained in the reprint on the back of this stationery. (Copy of a special dispatch to the Statesville Record). Third—I am by no means getting rich. You of the executive board know that although my salary was fixed at \$200 a month with traveling expenses, I have never drawn as much as \$2,000 in any one year, the average salary for the period of my existence as your secretary being \$147.50 per month."

The last paragraph contains the appeal for funds:

"But I must appeal now for your immediate help in putting our finances in proper condition. Too many of you who have not paid your dues this year—others who have signed pledges for dues and to the special fund—are taking the attitude 'Let George do it now—I'll help later.' I know business is bad—that money is 'tight.' So let's spread the load. Send what you can personally, then go out and get your neighbors to do likewise. There are suggestions that a field man be employed, but a good man does not seem to be available. And, too, it was agreed that we should carry on the spirit of patriotism and good sportsmanship. Just give one hour to making calls for your association. It will get results. I know—it's been tried."

How's Your Health?

Is there a cure for alcoholic addiction?

Well, it's hard to say. Much depends on what you have in mind. If by a cure you mean a specific remedy in the form of a drug or medication, then the answer is "no." We cannot cure alcoholic addiction by giving the addict any substance.

If you intend to ask whether any individuals addicted to alcohol have ever been cured, then the answer is "yes." Many such cases are known.

What means then were employed? Practically every variety! Religious exhortation, fright, persuasion, punishment, shame and what not. But this won't help much if you have a case in mind, and want to know what to do about it.

Frankly, we cannot offer any specific counsel. At best we can only analyze the problem, and show how complex it is.

It is essential to understand exactly what we mean by alcoholic addiction. The man who drinks habitually, but neither gets drunk nor suffers because of his drinking in his personal or business life, is not an alcoholic addict, in our sense of the word. There are many people in many parts of the world to whom the daily consumption of alcohol in some form or other is as commonplace a habit as bathing is to the average American. And the individual who occasionally becomes drunk is not to be considered an addict either.

The type of person we have in mind uses alcohol to escape life's responsibilities. He drinks to excess because of what seems to him an inescapable compulsion to do so. He doesn't really enjoy alcohol. Frequently, and with some sincerity, he protests that he hates it, that he loathes getting drunk and loathes himself because of it.

And yet, periodically, despite the promises and all, such an individual drops all restraints, drinks beyond measure and reason, and suffers the consequences.

The second addict, as a psychiatrist said, "suffers from an irresistible impulse to throw away all obligations and opportunities and brings his house of cards tumbling down about his head by getting drunk."

It is this compulsion to self-destruction that distinguishes the drinker from the alcohol addict.

FIVE MARKERS TO BE ERECTED

More Historical Sites in State to be Designated

Raleigh, April 21—Legends for five additional historical markers have been completed and the markers will be erected in various sections of the state in the very near future, R. Bruce Etheridge, director of the Department of Conservation and Development, said today.

Continuation of the work of marking spots of historical interest a work in which three departments of the state government co-operate was made possible by Governor Clyde R. Hoey, who made funds available, Mr. Etheridge said.

Acting with the advice of a committee of historians from the state's "Big Five" colleges, Dr. C. C. Crittenden, secretary of the North Carolina Historical Commission, prepared legends on the five markers. The State Highway and Public Works Commission co-operates by financing the program and erecting the markers along highways of the state.

The new markers now being cast by the foundry are:

G-10. To be erected in Hillsboro. "Francis Nash, Patriot General in American revolution was mortally wounded at Germantown, 1777. His home stood nearby."

G-11. To be erected in Hillsboro: "Thomas Ruffin, Chief Justice of North Carolina Supreme Court, 1833-52, noted jurist, agriculturalist, is buried 3-10 mile east."

H-11. "Andrew Johnson, the house in which the 17th President of the United States was born, 1808, stands 200 yards south. (To be erected near State College in Raleigh.)"

L-11. "Andrew Jackson, Seventh President of the United States was born a few miles southwest of this spot, March 15, 1767. (To be erected near Waxhaw in Union County.)"

Q-4. "Judaculla Rock, large rock covered with well preserved Indian pictures of unknown origin. 3 1/2 miles S. E. (to be placed at East Lenoir, Jackson county.)"

1837 LIQUOR LAWS TO GET SUPREME COURT RULING

(Continued from page one) Supreme Court for the first time.

The King brief argues that under 1837 liquor laws the possession of any quantity of tax paid alcoholic beverages at any place is lawful (2) the possession of any quantity of non-tax paid liquor however small is unlawful and (3) the essentials of the crime of unlawful possession must be both alleged and proved by the state, which allegation are (2) that the alcoholic beverages were not tax paid and (b) that the defendant was in actual or constructive possession of them, and (4) the possession of alcoholic beverages in a container which does not bear either a federal or a county ABC stamp shall constitute prima facie evidence that the possession is unlawful.

It is contended that the indictment on which Epps was tried does not affirmatively allege any of these essential facts, but is nothing but the old "blanket" printed form ad-

mittedly good under the Turlington rule that the possession of any quantity of liquor was of itself unlawful except in the home and for the use of the owner and his bona fide guests.

On the question of "Possession for the purpose of sale," it is argued that since the possession of tax paid liquor in any quantity and at any place is now entirely lawful, it follows that section providing that possession of any quantity shall constitute prima facie evidence of the purpose of sale is repealed. Likewise, the brief argues, the one-gallon presumption of purpose of sale is repealed.

"It can hardly be said that a statute which makes possession lawful does not repeal a prior act making such possession evidence of an unlawful transaction." (The Attorney General's office, in advisory opinions, has contended that the "gallon presumption" of the Turlington Act is still in effect.)

It is contended that the Epps indictment charged none of these essentials affirmatively.

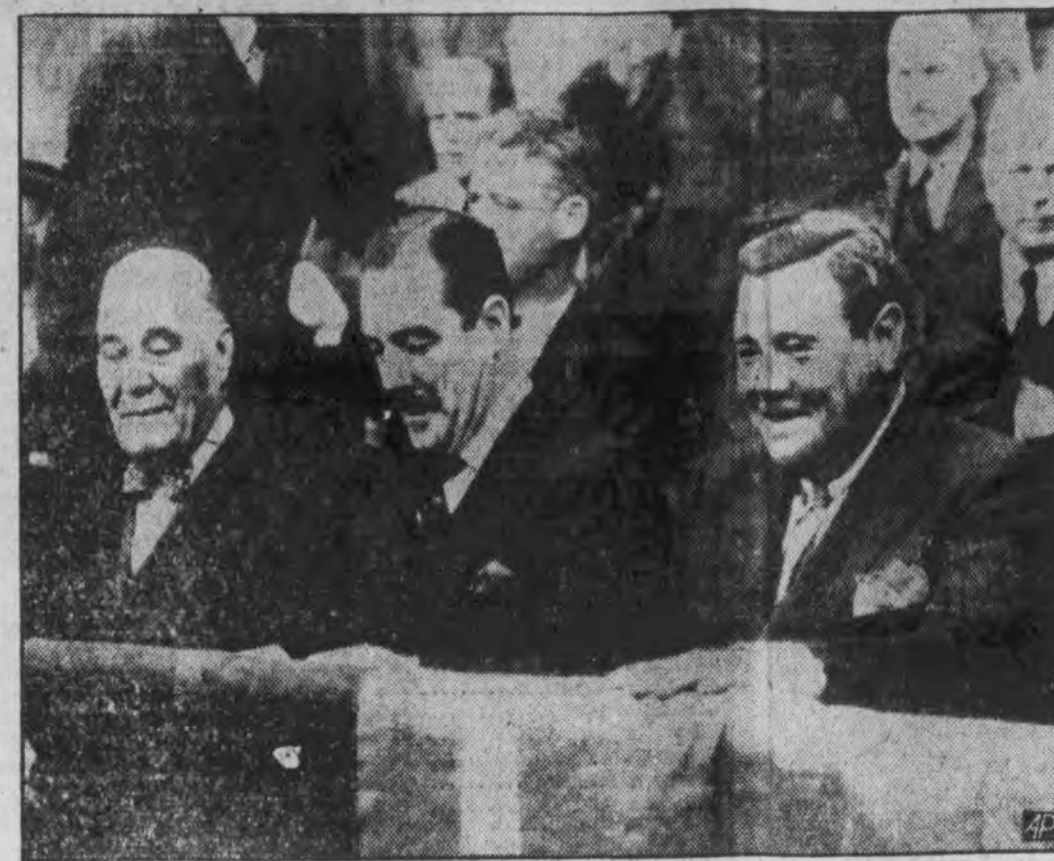

Hollywood—Have you a little "cycle" in your mind—the kind that Hollywood right now would give its eye teeth for? For the first time in years, the town is drifting into that most uncomfortable state of being "cyclical." It's practically out loud for a major trend in production. It needs a new merry-go-round to ride, a different bandwagon to hop upon, a new leader in the game of following leader.

There is always of course, the first and longest-lived of the "cycles." That's the movie western. It has gone on thru the years from movie infancy, now and again given glorified treatment which Sonja Henie results in a "Covered Wagon," a "Big Trail" or a "Wells Fargo." But the western by now is a staple product, not a trend. Gangster Cycle

Hollywood would be happy if it had a "cycle" just one-half as profitable as the one set in motion by "The Doodway to Hell" and "Public Enemy," seven years ago. What a merry ride the movie-makers took on that one! All they had to do was gather some plug-uglies, give 'em machine guns, and let 'em start firing. But the gangster business long since went into a decline. Only occasionally now can it be refurbished from a different angle.

Musicals? They're always with us, but they're not going to be with us in such numbers as they were in the past. They had a brief flurry in the early talkies, suddenly became as popular as plague, and revived only with "42nd Street." Now Zanuck has spoken: He is going to make only the big-star specials, the Sonja Henie, Ritz Bros., Shirley Temple, Cantor numbers. Musicals just for music and dancing are out. Jack Warner also has spoken: He is going to keep on making them, and making them good.

But the backstage musical—well, what else can they do with that one?

And there isn't much blood left in the turnips of insane comedy. "My Man Godfrey" was a Godsend, and the nutty business has flourished overlong. But there, too, what else can they do now? Unless they make pictures that are plain silly—without trying to be?

None In Sight

The sea cycle had a long and honorable career also. "Mutiny on the Bounty" started that and then

Wake Forest's Jim Denning sat down Tom Burnette, Bissette, Craver and Grubb without a single hit in the contest played at Chapel Hill last week, while the Heel hurler, Daffy Parker, whitewashed Dave Fuller, Bill Eustler and Bill Sweet, and don't think for a minute that these boys have forgotten the drubbing.

Besides the natural spirit of competition that exists between the two clubs which is sufficient within itself to create a first rate baseball game, there is the added strategem of two of the cleverest college coaches in the country—Bunn Hearne of North Carolina and John Caddell of Wake Forest. Both these men are veterans of the game and employ something more than power to win their ball games.

It Costs To Raise A "Derby" Horse

By J. R. ANDERSON

Louisville (AP)—After the Kentucky Derby here May 7, somebody in the grandstand is likely to say of the winning horse's owner:

"Isn't that tough—winning \$50,000 (more or less) in two minutes (or more). Gosh, I wish I was the owner, what I could do with that much dough."

(The Derby prize is \$50,000 added. If 15 horses go to the post this year, first place will net the owner \$49,750. The derby distance of a mile and a quarter has never been run in less than 2:01 4-5.)

To the grandstander, the Derby gold might seem like a slick way of grabbing a modest corner on coin in a quick, easy fashion, but wait, let's hear the other side of the story.

Long, Tough Trail

It's a long, tough trail to a Derby victory with many a disappointment and plenty of purse-snapping, take it from little Rosie Goose, veteran trainer and former jockey.

What does it cost to prepare a horse for the Derby?

Goose shook his head and said: "Horse racing is a tough racket and it's plenty costly. You only hear about the winners. But there are a lot of losers.

"There are 103 horses nominated for this year's Derby. Only one can win. The winning owner makes some money, but think of the many who don't get a cent."

Just what does it cost to prepare a horse for the Derby?

"Well," said the sharp-featured, bespectacled Goose, who piloted Donerail to victory in 1913, "that's a hard question, but off-hand I'd say approximately \$2,500."

That figure, Goose said, includes a four-month period from January 7 to May 7.

He broke down the estimate like this:

Trainer at \$300 a month, \$1,200; exercise boy at \$90 a month, \$360; rubber at \$60 a month, \$240; feed at \$1 day, \$120 approximately; stall rent at Churchill Downs at \$3 monthly, \$12; drugs and veterinary care, \$7 a month, \$28; plates at \$5 a month, \$20. It costs \$25 to nominate a thoroughbred for the Derby and \$500 more to start him. This brings the total to \$2,405.

The owner likely would have several other horses in his stable. This would increase the running expense.

In addition there are (1) the original cost of the horse, if he was purchased at an auction for several thousand dollars; (2) caring for him for the two years before he starts prepping for the race; (3) traveling expenses and (4) equipment costs.

Little Profit

If the horse is successful as a two-year-old he may earn his keep, maybe more.

But, for example, if the horse had

not earned a cent up to the Derby and won, the owners profit would be small. Out of the \$50,000 he must pay a 10 per cent bonus each

to the trainer and jockey, in addition to money presents to other members of the stable. Also the owner probably would have paid a retaining fee of approximately \$500 to engage a jockey.

Some winning owners, said Roscoe "would give it all away."

"I should say not," answered Goose. "That's what they spend thousands of dollars to win."

"Horse racing is an expensive game," he reiterated. "It's like owning a yacht. If you have to ask the price, you can't afford one."

"I guess that's why horse racing is called the sport of kings."

REVIEWS WORK OF 4-H CLUBS

Many Outstanding
Activities Undertak-
en Last Year

Raleigh, April 21—Increased in-
terest and activities made 1937 from
many standpoints the best North
Carolina 4-H Club year on record.
L. R. Harrell, club leader at State
College, declared today.

In reviewing the year, Harrell
pointed to the larger percentage of
farm boys and girls completing
project demonstrations. These pro-
jects included poultry, pigs, calves,
sheep, and farm crops as well as
home beautification, clothing, and
canning.

Records on these projects proved
that the type and scope of the
demonstrations were broader than
ever before, Harrell said. This prob-
ably accounted for the largest number
of completions on record.

Among the more outstanding ac-
tivities of the year were the 4-H
Short Course at State College, the Wil-
derness Conference, numerous achieve-
ment day programs, and 4-H
camp.

At the end of 1937, the total num-
ber of farm boys and girls enrolled
in the work was 32,165. At the
close of 1938, the total was 31,500.

An attendance record for the an-
nual 4-H Short Course was hung up
last summer when 963 boys and
girls from all sections of the State
gathered in Raleigh for the meet-
ing.

The Older Youth Conference was
held for the first time last year and
was designed for young men and
women too old for regular club work
and too young to join adults clubs
Over 100 attended.

Robin Hood Farms Projects Started In Moore County

Unique Project in Vocational Train-
ing Undertaken by Division of
N. C. State College

Raleigh, April 22—Recording of
documents at Carthage this week

operation of a unique project in
vocational training, known as the
Robin Hood Farms. Dean J. W.
Harrison, State College said today.

A 2,000 acre Manice Farm six

as their school work is completed with-
in the next few weeks.

Robin Hood Farms constitute a

man and farm operator.

The principal training will be in
farming and allied activities ap-
propriate to the Sandhills coun-
try. Dean Harrison expressed
heartily commendation of the plan.
There will be no charge for tuition
or living expenses, each student
paying his training and sustenance
through production of marketable
products.

establishment and operation in-
cludes George Rose Pou, State Auditor
and Thad Eure, Secretary of State.

The special issue will be on sale
at Dayton, Ohio, home of the
Wright Brothers, and the St. Peters-
burg, Fla., where the first passeng-
er plane flight was made, the day
before the general sale in other post
offices.

In design, this stamp will symbo-
lize air mail and will be highly
prized by the many collectors of
stamps in the United States and
over the world. The stamp will be
of six-cent denomination. It will
be in blue and red. The design will
include an eagle with wings spread
in flight, bearing a shield, olive
branch, and arrows in his talons.

On May 19, a dozen or more pri-
vate planes in North Carolina will
take to the air for special air mail
pick-up schedules, feeding the mail
into regular air mail lines. Such a
program will also take place in
every state in the Union under the
general direction of Postmaster

REPUBLICANS BUSY IN WEST

Seeking To Increase
Representatives In
Assembly

Raleigh, April 20.—Hopeful that
1938 will bring them better luck than
the last three or four election years,
Republicans throughout the west-
ern sector of North Carolina are
preparing to make vigorous efforts
to increase their representation in
the General Assembly and to gain
control of local offices now held by
Democrats in many traditionally O.
O. P. units.

There apparently is no real basis
for Republican claims that any
Democrat is in danger of losing in
a state-wide race, but there is much
sincere confidence that the G.O.P.
will do better than the eight Repre-
sentatives and two State Senators
it had in the 1937 legislature.

This confidence is based on belief
that things had about reached rock
bottom in 1936 and that there just
isn't any lower for Republican hopes
to fall. Too, minority party leaders
profess to see the political tide run-
ning away from the New Deal and
they hope to benefit thereby.

As a result there are numerous
counties in which real scraps are
underway for nomination by the
Republicans. Most G.O.P. nominees
are chosen by the convention, rather
than by the primary system, and
last week at least five county con-
ventions chose full slates to oppose
Democrats this fall.

In Buncombe, Republicans named
Halsey B. Leavitt, who represent-
ed Buncombe in the 1929 House, for
the State Senate, and chose John
L. Lawrence and Clyde S. Reed for
the House.

Other legislative G.O.P. nominees
chosen were: Polk, J. H. Gibbs,
Mill Sprinks, for the House; Chero-
kee, Clyde H. Jerrett of Andrews,
for the House; Haywood, I. H. Pow-
ell, Canton, for the Senate, and L.
S. Stamey, Clyde, for the House;
Rutherford, Mack Saunders for the
Senate, Y. L. McCordwell for the
House. In Henderson, Brownlow
Jackson is being groomed for the
House.

Dr. Ennett, when asked his opin-
ion of the value of such an insti-
tute, stated, "In our war on disease
I regard the teacher, who is daily
on the firing line, as the key per-
son in any Health Program. The
teacher that understands the signifi-
cance of the common physical de-
fects of the school child, such as
eye strain, ear disease, diseased ton-
sils, dental decay, etc; informed as
to various measures in Preventive
Medicine such as vaccination; and
prepared to teach positive health
through good health habits and by
correlating health instruction along
with the regular school work, can
do more than the Health Depart-
ment and the Home combined to
promote Public Health—for in all
too many instances the child must
teach the parent."
