FACE OPPOSITIONFive Candidates Out
For House of Representatives;
two Seeking Senate Seat

Only a few candidates for county offices were without opposition three hours before the deadline for filing with the County Board of Elections, this afternoon at six o'clock, a check of Chairman J. H. Harrell's books revealed.

W. O. Jolly of Ayden, this morning announced for the office of commissioner from the fifth district. Frank M. Kilpatrick, the incumbent, previously had stated his intention of seeking the seat for another term.

With only a few hours to go, no candidate had filed for the office of constable in several townships. Neither did it appear that each township would have an opportunity to vote on two justices of peace, the number allowed for each sub-division.

At least two candidates are out for four of the five seats on the Board of County Commissioners.

Veteran Clerk of Superior Court, J. Frank Harrington, is without opposition, barring last-minute filers. So were Coroner A. A. Ellwanger and County Court Solicitor Charles Whedbee.

Two candidates had announced for treasurer, three for sheriff, three for county judge, five for the state House of Representatives, two for State Senate and one for the County Board of Education.

Associate Justice
George W. Connor
Dies From Attack

Member of Supreme Court for Past 14 Years
Succumbs Suddenly at Home in Raleigh;
Funeral Sunday Afternoon

Raleigh, April 23.—(AP)—Associate Judge George W. Connor of the North Carolina Supreme Court, died suddenly of a heart attack at his home this morning.

Judge Connor, 65, and a native of Wilson had been a member of the Supreme court 14 years and before that served 11 years on the Superior court bench. He was speaker of the House of Representatives in 1913 and Representative from Wilson county in the 1909 and 1911 legislatures also.

Funeral services will be conducted at the home, 825 Holt drive, at 3 o'clock tomorrow afternoon, tomorrow afternoon by the Rev. James Dick, rector of the Good Shepherd Episcopal church, of which Judge Connor was a member.

Interment will follow in the Connor plot at Wilson.

Last year Judge Connor was ill several months, but he had been in better health recently, sat with this court this week and worked at his office yesterday.

Colonel J. W. Harrelson, a son-in-law, said Judge Connor suffered a set-back last night and his condition caused "alarm" but this morning the jurist got up, read his paper and seemed to be feeling better before the fatal attack came at 9 o'clock.

Last year Judge Connor started a new six-year term to which he was elected in 1936.

Judge Connor was the son of Judge Henry G. and Mrs. Kate Whitfield Connor. His father served also on the Superior and Supreme court benches and then as Judge of United States District court.

After his graduation from the University of North Carolina in 1892 the Judge became principal of the Goldsboro high school and two years later became school superintendent at Wilson.

In 1899 he secured his law license and started a career which followed that of his father.

BRITAIN TREATS

Removal of the freight rate differentials favoring the Virginia port over North Carolina is the realization of about three years' intensive efforts, Mr. Dossier said.

In addition, the rail official declared, there is a "strong probability" that Morehead will be made a regular port of call by at least two large steamship lines with which negotiations are in progress. The lines, he said, are "definitely interested" and favorable action is expected from them.

Asserts Business Sentiment
Becoming
More Skeptical

Washington, April 23.—(AP)—The United States Chamber of Commerce today criticized public spending as a method of stimulating recovery.

"Business sentiment, to the extent that it is measurable, becomes more and more skeptical of the new 'pump priming' program," the Chamber said in a formal statement.

The organization also suggested revision of the Labor Relations act should be included in any legislative program to fight the recession.

The Chamber declared its skepticism of spending was "born of experience."

Meanwhile approval of a modified undistributed profits tax by a Senate-House committee brought prediction from foes of the levy that it would be an issue in the forthcoming congressional elections.

Two conservative Democrats of the conference group, Senator Walsh of Massachusetts, and Senator George of Georgia, said in a joint statement a provision limiting the levy to two years would "permit the country to pass upon this question in the next election of members of Congress."

They were joined in the thought that the tax would be an issue in the congressional campaigns by a Republican member of the conference committee, Senator Vandenberg of Michigan.

Bodies of 22 Men Are
Brought from Fiery
Furnace

19 OTHER MINERS
BELIEVED DEAD

Explosion Thought to
Have Been Caused
by Dust Wreck Operations of Red Jacket Mine, One of Largest in Buchanan County

Grundy, Va., April 23.—(AP)—Bodies of 22 men had been brought from the fiery pit of the explosion-wrecked Red Jacket mine today and a final death toll of 41 miners was indicated. Nineteen missing men were believed dead.

Progress of the rescue squads slowed down materially when they entered the A shaft, where the last two bodies were found, burned almost beyond recognition. Debris from falling slate and coal and intense heat made the labor of the rescue workers difficult.

With 400 rescue workers present from three states, 30-minute shifts were being used because of the heat in the mine.

Tired workers were being served sandwiches as they came up from the scene of their rescue efforts deep under Keen mountain. Many had been there since early last night.

Payrolls of the mine indicated there were 21 workers in A shaft, leaving 19 unaccounted for. Of the 22 bodies recovered so far, three were found at the mine entrance, where the explosion struck with volcanic force and 17 were in the B section, now completely explored.

All but four of the bodies had been identified. Friends and relatives had been unable to identify two of the bodies found at the entrance and two found in the A, or main section.

M. Keadle, vice president of the Red Jacket company, said the air had been cleared in all shafts and rescue workers to clear their way through them, but scant hope was held for any of those in the mine.

All of the miners were white men.

BLUE MOLD ON SPREAD IN N.C.

Find Heavy Infection Throughout Entire Old Belt

Raleigh, April 23—Blue mold, a deadly fungus of tobacco plant beds, is rapidly spreading throughout the entire Old Belt, North Carolina Department of Agriculture authorities said today.

E. G. Moss, assistant director in charge of the Department's Tobacco Test Farm at Oxford, said that while he was "not alarmed," not more than five per cent of the farmers in the infected area were using sprays or gas recommended by the department.

Notwithstanding the heavy infection, he said farmers generally have planted from 25 to 50 per cent more seed beds this season in an effort to obtain sufficient plants to produce a high quality crop.

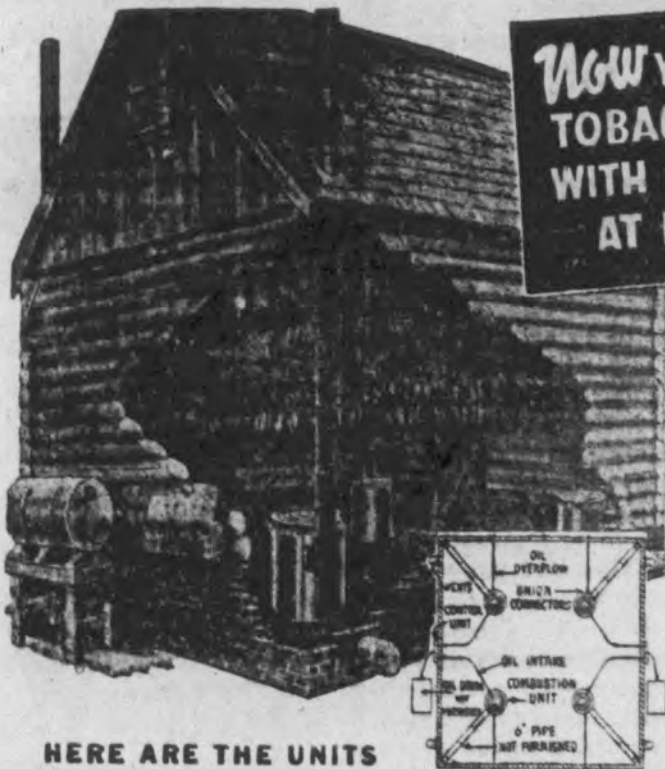

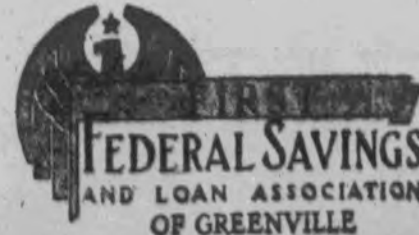

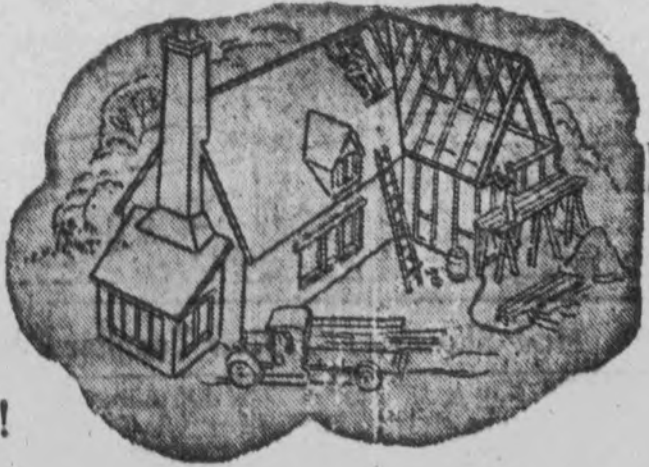

Washington Daybook

By Preston Grover

Washington—One of the prob-
lems faced by the State Depart-
ment and public figures in extend-
ing relief to German and Austrian
refugees is to avoid raising an anti-
Semitic feeling in those countries
which now do not have it.

From one viewpoint it is strictly
a relief problem, but those hand-
ling it have been confronted at
all times with its social and politi-
cal aspects.

For instance, it is reported here
that many "Aryan" Germans have
been prevented from entering this
country in recent years because
they were unable to solve either
the complexity of getting out of
Germany or of getting into the
United States.

What, then, might be the effect
of having boatloads of Jewish re-
fugees arrive in the United States
and perhaps in South and Central
American countries with all inter-
ference cleared out of the way?

One source interested in the re-
lief movement said it would be no
kindness to the Jews in the long
run to give them temporary relief
from Germany and Austria only
at the expense of creating new
centers of anti-Semitism in other
parts of the world.

Difficult At Both Ends

Here is a sample of the difficul-
ties both refugee and ordinary em-
igrants face. When a citizen of
Germany leaves that country to
take up residence abroad—in other
words to emigrate—he must pay to
Germany a tax of 50 per cent of
all he owns. In addition, he can
take out the remainder only in
small portions over many months.

Much of that is prompted by
Germany's monetary stringencies,
but the net result is a restraint
upon emigration. A further re-
straint is that most countries, in-
cluding the United States, require
emigrants to have either enough
money of their own to get a start
in their new home, or to have re-
latives and friends able and willing
to keep them from becoming
public charges.

In one way, of course, the prob-
lem of the refugee is different
from that of the ordinary emi-
grant. The present crop of re-
fugees, predominantly Jews, no
longer feels happy or even safe in
Austria and Germany. They feel
they have to get out, restrictions
or no restrictions.

One of the relief proposals is
to raise enough money to give
each refugee the sum he needs to
permit him to move into another
land.

Quotas Not Filled

This consideration has guided
refugee organizations in other na-
tions as well as the United States
in avoiding any implication that
the laws are going to be stretched
to permit refugees to flow across the
borders. Talk of asking Congress to
increase the present German-Austrian
emigrant quota fixed by law has
quieted. At present the quota per-
mits 25,957 annually from Germany
and 1,413 from Austria. Last year
only 48 per cent of the German
quota was filled and only 50 per
cent of the Austrian quota.

So far this year there has been
no striking increase. Emigration
from Germany to the United States
during the 1937 fiscal year ran
about a thousand a month. The
average for the first seven months
of the 1938 fiscal year is 1,266
a month.

So careful is the State Depart-
ment to avoid an appearance of
stretching the law to aid the re-
fugees that it declines to say whether
consuls in Germany and Austria
will be urged to give precedence
to refugees in filling the quotas.

Raleigh, April 23.—Senate Ma-
jority Leader Albert Barkley of
Kentucky has come into North
Carolina, spoken his little piece
and departed and it now remains
to be seen whether his trip can be
used as political ammunition by
either Barkley's colleague, Robert
R. Reynolds or the Reynolds op-
ponent, Frank Hancock.

Press reports of the Warsaw ad-
dress of the Blue Grass legislator
indicate no effort on his part to
boost Reynolds' stock, unless the
fact that he accompanied "Our
Bob" to the party can be taken as
such a boost.

It seems that the Democratic
Senate leader used much of the po-
litical sense with which he must
have been endowed in order for
him to attain the position he now
holds. He confined himself, if news
reports are all-inclusive, to laud-
atory remarks about numerous
North Carolina ex's like F. M. Sim-
mons, the late Lee Overman and
to present day personages like Gov-
ernor Clyde R. Hoey and "Farmer
Bob" Doughton who are not per-
sonally concerned in any current cam-
paign.

As of which looks like a pretty
good display of common sense.
Even the feeblest chirp for Rey-
nolds would have sent the Hancock
forces into paroxysms of rage at
the "interference" of a "turner"
in the sacred affairs of the Old
North State whose citizens—"God
save 'em" if they have votes—can
take care of their own business.

Obviously, if Barkley isn't
Reynolds he ought to be taken
and shot for gross ingratitude
in view of the Reynolds support for
party leadership against veteran
Harrison—a vote which, in-
doubtedly isn't going to do Bob
one of good in his primary campaign
in this state where Harrison is
openly regarded as one of the
standing Democrats of the old
Southern school.

Major Edney Ridge, over in Guil-
ford—in fact all over the Sixth
district—is making the welkin ring
in his Hosannas for Roosevelt
Labor with a capital "L". His
is the only candidacy in the
state so far as your correspondent
knows, which has been pitched
as a "red-in-the-face" brand of
Deafism; and it will be in-
teresting to watch the progress and
out of this type campaign.

There are thousands of textile
employees in the Sixth, in ad-
dition to numbers of tobacco fac-
tory workers and other horny hand-
ed sons of toil. Wherefore it may
be that the siren notes of the
eloquent Major will swell to a rou-
morous chorus of votes in the June
primary.

Forecasters of the Sixth district
results are warned, even from this
distance, not to overlook the Ridge
candidate in making up their minds
which "horse" to back in the politi-
cal chase.

Nobody can say that the Farm
Security Administration isn't going
to make it as easy as possible for
Farm Tenant borrowers to pay
back the money that puts them in
the landowner class.

The press release announcing
first loan to a Negro in the United
States (Nat Williamson, 48-year old
Guilford share cropper's the lucky
man) states that the loan is for no
less than 40 years with interest
at 3 per cent. A variable payment
plan is provided so that lighter pay-
ments are made in poor crop years,
the difference being made up in
good years.

After today there'll be no specu-
lation over who is going to run for
what county and legislative offices
in North Carolina. Henceforth the
issue will be joined and it will be a
question of who can win at the
polls, not who is going to toss a
hat into the ring. This correspond-
ent forecasts a bumper crop of
House candidates, with at least 300
such aspirants over the state.

may well mark the beginning of a
real business revival. Certainly, if
the President is to avoid severe
defeats in the Fall Congressional
elections, good business must return
not later than September. Every
day that people continue in the
present mood actually means that
he is sinking deeper into the mire.

Barometers Making The Turn
The President, however, is cheer-
ed by the following summary of
leading barometers:

1. Steel operations have improved
since the December low of 19 per
cent of capacity. They are now
above 30 per cent, based almost en-
tirely on business from millvillan-
eous sources such as machine
tools, tin containers, and the like,
rather than from the major cus-
tomers—automobiles and railroads.

2. Building is making progress.
The new P. H. A. rules have stimu-
lated great interest in homes. Ma-
terial prices have dipped and, if
labor costs also come down, home-
building this Spring may even beat
out the 1937 figures.

3. Power consumption, a very
sensitive index of business activity
in this electrical age, hit a low in
late March and is now slowly push-
ing ahead. The gap between the
1937 and 1938 figures has been gradu-
ally narrowing.

4. Cotton textile activity has been
sluggish for a month but it is now
resuming the rattle which started
earlier in the year. Dismissing in-
ventories all along the line have
forced orders back to the mills. Mil-

activity is 10 per cent above the
low.

Auto Assemblies Higher

5. Automobile output is running
several thousand cars higher each
week than a month ago. The man-
ufacturers' policy of restricted out-
put, plus a seasonal upturn in re-
tail sales, have now speeded-up the
assembly lines. A price out, how-
ever, would be the best tonic for
this industry right now.

6. Retail trade, due to the late
Easter, is running less than 10 per
cent under last year's post-Easter
figures. A month ago the spread
was 20 per cent. And remember,
that retail prices are now 6 per
cent less than their 1937 high.
Hence, unit sales are not more than
8 per cent lower than a year ago.

7. Commodity and Security prices
are at a level where they are at-
tracting the attention of genuine
purchasers. Stocks of selected, well
managed companies are on the bar-
gain counters. Bond prices have
lost all they gained in 1936 and
1937. Raw materials are cheap.

8. Bank deposits, the first indica-
tor to start downward a year ago
—have been expanding since early
December. Moreover, last year at
this time the Administration was
tightening credit to prevent a
"boom." Today it is doing every-
thing in its power to make credit
extra-easy.

Spring Outlook More Cheerful
As a result of these indications,
the President is apparently con-
vinced that now is the time to aid
the modest natural improvement
by vigorous pump-priming. His
gigantic spending plan will stimu-
late business over the near-term.
While the skies have by no means
suddenly cleared by the develop-
ments of the past two weeks the
outlook is better today than a
month ago. We have had periods
of bad business before. Each time
when conditions looked the worst
we were right on bottom. Just as
Winter inevitably turns into Spring
so bad times inevitably turn into
good times. This has never failed
—and I doubt if it ever will.

I am convinced that before the
year is over, New York sentiment
will be far different than it is to-
day. The stock market will again
be boiling. Wall Street will again
be as sure that depressions are over
as today it is convinced that the
end of the world is in sight. When
a man is flat on his back, there is
only one way he can look—that is
upward.

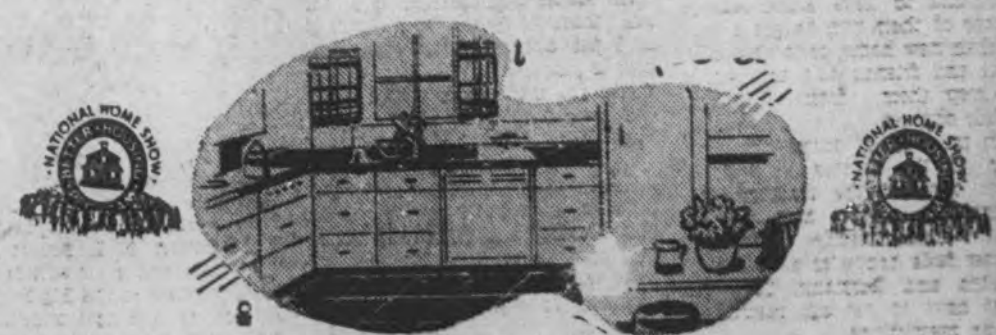

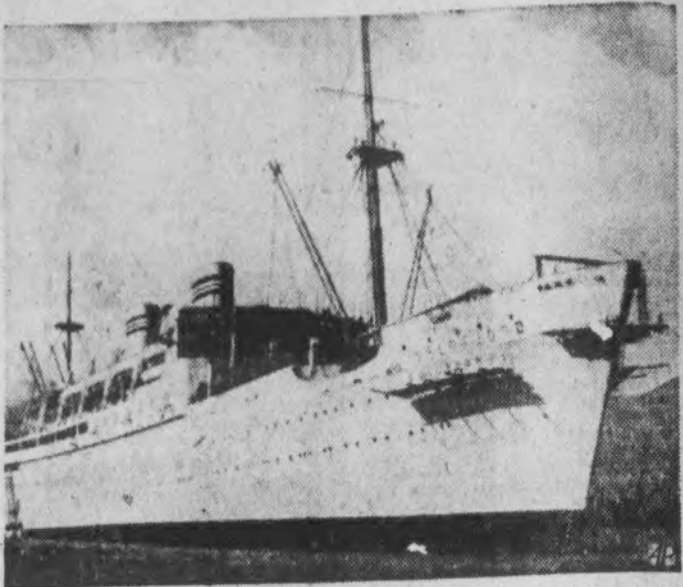

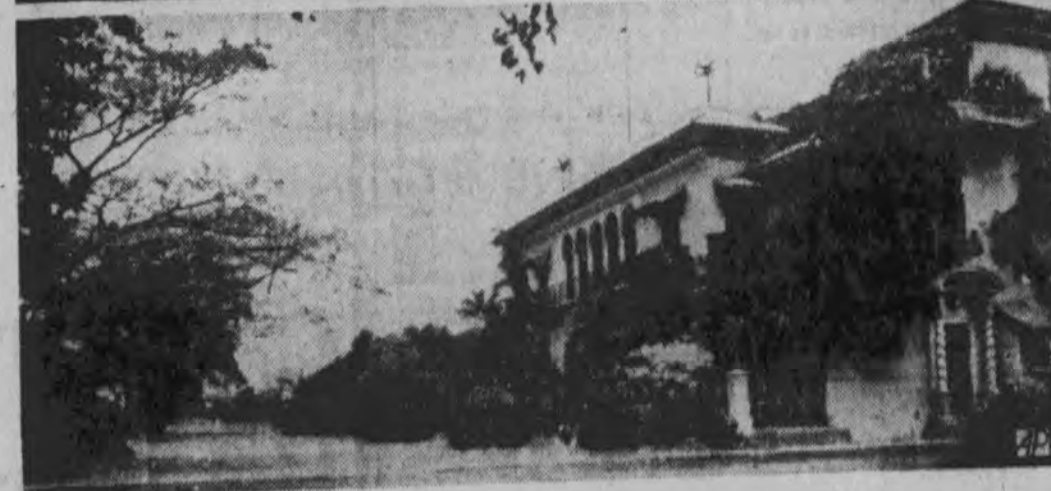

MANY YOUTHS WORK IN STATE

First Survey Ever Made Shows 12,269 On Full Time

Raleigh, April 23.—(AP)—Labor Commissioner A. L. Fletcher reported today that 12,269 full-time and 5,937 part-time child labor work permits were issued in this state for boys and girls between 12 and 17 years of age between July 1, 1937 and January 1, 1938.

The report was the first of its type prepared, Fletcher said. "I had no idea there were that many boys and girls working," he commented.

The textile industry gave regular employment to 4,016 white and 22 Negro boys and to 3,496 white and seven Negro girls, Fletcher said. In the mercantile trade 2,553 children were worked full time with 449 employed in lumber and lumber products industries, 138 in the tobacco industry, 201 in miscellaneous manufacture and 474 telegraph messenger boys. There were 45 full time golf caddies given child labor permits.
