WAGNER LABOR ACT ASSAILED BY G-M PREXY

Declared Drawback To Good Industrial Relations

SAYS EMPLOYER UNREPRESENTED

Automobile Manufacturer's Speech Came on Heels of Attack on Act by Sen. Burke

Washington, May 4. — (AP) — William Knudsen, president of General Motors Corporation, told the United States Chamber of Commerce today the Wagner labor act is "the largest drawback to good industrial relations."

Discussing the strikes that have tied up his company's plants at various times in recent months, Knudsen said in a prepared address:

"The National Labor Relations Board set up to administer the act makes no pretense even of paying any attention to the employer's side of the case."

"He can only be heard when he goes that there is no record of a single decision where he had a ghost of a show, so what?"

"The automobile manufacturer's speech renewed an attack on the labor board that started yesterday, when Senator Burke (D-Neb.) addressing the labor section of the Chamber of Commerce convention, demanded that the members of the labor board resign. He proposed that a new board be appointed to represent the viewpoints of labor, management and the public."

The labor section, after hearing Burke, adopted a resolution asking an investigation by Congress of the "effects" and administration of the Wagner act, which created the board as a means of assuring workers of the right of collective bargaining.

More And Better Trout Objective Of State Division

Fishing Season to Open on May 10 for All Fresh Water Fish Except Small Mouth Bass

Reflector Bureau. Raleigh, May 4.—Practically on the eve of the opening of trout fishing in many of its game refuges, the division of game and inland fisheries of the Department of Conservation and Development announced a definite objective of "more vigorous and mature trout for North Carolinians and their guests."

The trout fishing season will open in Mt. Mitchell, Daniel Boone, and Sherwood Forest state game refuges May 7 and 8. On May 10 the general state fishing season will open for all warm water fish except small mouth bass. May 16 to August 31, the fishing season will be open to the principal streams of the Great Smoky Mountains National Park, though their tributaries will be closed.

May 20-22 trout fishing will be permitted in Pisgah National Forest Game preserve near Asheville, where there will again be open fishing on June 3 to 5.

In furtherance of the more and better trout objective J. D. Chalk, state game and inland fisheries commissioner, announced today that C. W. Burnham, supervising fish culturist, will be transferred from his station at the Frank Stedman State fish hatchery, near Fayetteville, for several months.

Mr. Burnham, who served for many years in the capacity of fish culturist with the U. S. Bureau of Fisheries, will assist the superintendents of the various mountain hatcheries to produce a crop of trout and other fish to restock the mountain waters.

For several years, more of the annual crop of fish produced at the hatcheries have been held in rearing ponds and now most of these young hopefuls are brought to the fingerling stage before being placed in their new homes. The policy of rearing the fish is being expanded, Chalk said, to bring considerable number to legal size.

PLEAD GUILTY IN PITT COURT

Two Negroes Admit Drawing Benefits While Employed

Two Greenville Negroes charged with obtaining money through misrepresentation by swearing to fraudulent statements to get unemployment compensation benefits pleaded guilty in County court here yesterday afternoon and were given 30-day road sentences, suspended upon payment to the commission the sums they had received.

Fennon Dawson and Julius White were the Negroes facing the charge. They admitted their guilt, but declared they did not know what they were swearing to when they told commission attaches they had no other source of revenue.

The Negroes were unable to repay the sums and left at noon today for the road camp to start their terms. Fennon was alleged to have fraudulently received \$25 and White \$41.

They were arrested here several weeks ago when S. T. Cherry, field investigator for the Compensation commission, uncovered evidence against the Negroes showing that they were employed and receiving benefit checks at the same time.

Work Continues On Ten Blue Ridge Parkway Links

Raleigh, May 4.—Work on ten new links of the Blue Ridge Parkway will be continued this season. Federal road engineers announce, bringing nearer realization of the once vague dream of connecting Shenandoah and Smoky National Parks with a super mountain highway.

At the same time, plans for five "recreational areas" along the parkway were revealed. These recreational areas will be miniature parks in themselves, and will afford vacationists stopping, resting, and playing facilities on the 500 mile drive from park to park.

At present, about 135 miles of the parkway is graded, 55 miles in Virginia and 80 miles in North Carolina, which is open to travel, though not yet surfaced. The ten new links will add 106 miles to the system, 47 miles in Virginia and 59 miles in North Carolina.

The five roadside parks now planned will be at Bluff's Cumberland Knob, Rocky Knob, Smart

May Make Changes In Value of French Franc

Paris, May 4. — (AP) — Officials said today that conversations had been started among the United States, France and Great Britain looking toward amendment of their accord of October, 1936, for monetary stabilization.

Bankers said they believed the talks were designed to facilitate a new readjustment downward of the value of the franc.

They said the stabilization of the franc at about 35 to the dollar (28 cents to the franc) and 175 to the English pound was under consideration.

The conversations, which were originated by France, had a prelude in last week's visit to London by Premier Daladier and Foreign Minister Bonnet.

This, officials declared, was followed by talks at the treasury in Washington among Secretary Morgenthau, French Ambassador St. Quentin and British Ambassador Lindsay.

If the conversations succeed, officials said, there will be a declaration of new monetary policy by the three powers, accompanied by (Continued on page two)

DEMPSEY CASE GETS STARTED

Federal Agent Accused of Accepting Bribes

Raleigh, May 4. — (AP) — W. A. Harris of Elizabeth City, an admitted ex-bootlegger and ex-convict, testified in United States District Court today that he had paid money to J. C. Dempsey of Wilson, Federal alcoholic tax unit investigator, in return of a promise for "protection."

Harris said he worked with special agents of the intelligence division of the alcoholic tax unit during his negotiations with Dempsey. Dempsey, a former State Senator, was indicted by the grand jury yesterday on charges that he took bribes of \$25, \$50 and \$75.

Harris testified he had had a series of transactions with Dempsey between August, 1937, and April, 1938. He said the final transaction took place in a hotel here several weeks ago when he testified, he gave Dempsey \$25 in marked money.

The investigator pleaded innocent when arraigned. At the start of his testimony Harris said he had formerly been a bootlegger at Elizabeth City and had twice been convicted in Federal court there and also admitted serving a term in a Federal prison.

Huge Paper Plant Going To Brevard

Brevard, May 4. — (AP) — Ecusta Paper Corporation of Delaware and New York, announced here today it planned to erect a \$2,000,000 plant for the manufacture of fine French cigarette paper on Davidson river, near Brevard.

Needs to 225 acres of land will be recorded in Transylvania county court house tomorrow. Engineers are on the proposed plant site making surveys for 13 buildings to be used in manufacturing the cigarette paper.

The plant when in operation, the announcement said, will employ 300 to 400 persons. Construction engineers will use 200 to 300 men when the projects gets underway.

CHINESE SCORE FURTHER GAINS AGAINST JAPS

Offensive Reported to Have Smashed Nippon Lines

CLAIM TURN IN CONFLICT'S TIDE

Second Great Offensive by Japs to Wipe Out Previous Defeat Declared Checked

Shanghai, May 4. — (AP) — A general Chinese offensive all along the South Shantung front was declared by the Chinese command to have smashed through the center of the Japanese line at Taierchwang today and to have advanced 12 miles.

Chinese advance guards fought forward five miles in a night battle, adding these gains to the seven miles they rolled back and buckled up the Japanese lines in the first assault yesterday.

The field commanders of General Chiang Kai-Shek declared the tide of war was turning in their favor. His high command, hopefully awaiting bulletins from the front said they expected an epochal Japanese defeat similar to that which tumbled the divisions of Nippon at Taierchwang a month ago.

The second great Japanese offensive through Shantung province, this time greatly reinforced to wipe out the previous defeat, was definitely checked, they declared. Japanese army spokesmen were silent.

Chinese sources estimated the weary outnumbered Japanese army had lost 34,000 men, killed in fighting in recent days about Tancheng and Pihlsen, on the south and east side of the salient of which Taierchwang formed the west side.

There was no way, however, of verifying these estimates from neutral sources.

Church Court Upholds Decision On Unification

Foes of Plan Fail To Make Known Aims Immediately

Birmingham, Ala., May 4. — In the face of "secession" threats, the judicial council of the Methodist Episcopal Church, South, ruled today a conference approved plan to unify American Methodism.

The nine-member "supreme court" of the Southern denomination ruled the quadrennial conference now in session was within its rights in voting the Southern church into a tripartite union to create a new church of some 8,000,000 members.

The council decision removed the last ecclesiastical barrier to the unification and leaders of the opposition did not say immediately whether they would follow a previously indicated plan to carry the fight to civil courts.

Anti-unificationists who raised again the Negro question that split the church in 1844, contended that the merger violates the laws of religion.

ADVANCE MOVE TO FORCE VOTE ON LABOR BILL

Speaker Bankhead Predicts Success for Petition Plan

PREPARE OFFER PETITION FRIDAY

Senate Foes of Wage-Hour Bill, Meantime Map strategy in case of House Victory

Washington, May 4. — (AP) — Speaker Bankhead predicted today a majority of the House members would sign a petition to force floor consideration of the administration-supported wage-hour bill.

"On the basis of information I have received, I think there will be a majority of the members who will sign the petition," Bankhead told newsmen.

Chairman Norton (D-N. J.), of the House Labor Committee, will file the petition Friday. She said she believed 218 members, a majority, would sign it in time for the controversial legislation to be called up for debate May 23.

The House Rules Committee refused last week to grant legislative right-of-way to the measure and Mrs. Norton said she "reluctantly" would be compelled to resort to the petition to obtain action this session.

A similar bill was brought before the House by petition in December, but was recommended to the Labor committee.

While developments pointed to possible House action on the measure, its Senate foes discussed precautionary strategy for blocking the bill should it win House approval.

Other developments: The Senate Agriculture Committee, conducting an inquiry into the operations of the American Cotton Cooperative Association, heard from one of its members that L. Westbrooke, a committee investigator, was formerly employed by the cooperatives.

During questioning of Murray Steward, government cotton expert, about his former employment by the cooperative, Senator Ellender (D-La.), said "it can be shown that Mr. Westbrooke was once employed by the A.C.C.A."

Plans To Prevent Invasion Of N. C. By Peach Mosaic

Although Nothing Alarming About Situation, Precaution Taken Saves \$2,300,000 Crop

Raleigh, May 4. — Believing in the old saying about the ounce of prevention which is worth sixteen times that much cure, North Carolina and Federal agricultural authorities are moving to prevent an invasion of this state by "peach mosaic," a relatively new but very destructive tree disease.

With this prevention motive in mind, J. A. Harris of the State Department of Agriculture's entomology staff, is now en route to New Mexico to study the disease and learn methods of control.

After a month in the western state Harris will come back to North Carolina to make a survey of Tar Heel peach orchards to determine whether "peach mosaic" does occur here and whether there is any real danger of this spread.

There is nothing in the least alarming about the situation, according to C. H. Brannon, chief of the entomology division, but no precautions are going to be left unattended to preserve the state's peach crop which is valued at \$2,300,000 annually.

"Growers are really lucky that the Federal government takes so much interest in training one of our entomologists in methods of control, quarantine procedure and identification work," Brannon said.

Expenses of the Harris trip are to be paid by the United States Department of Agriculture.

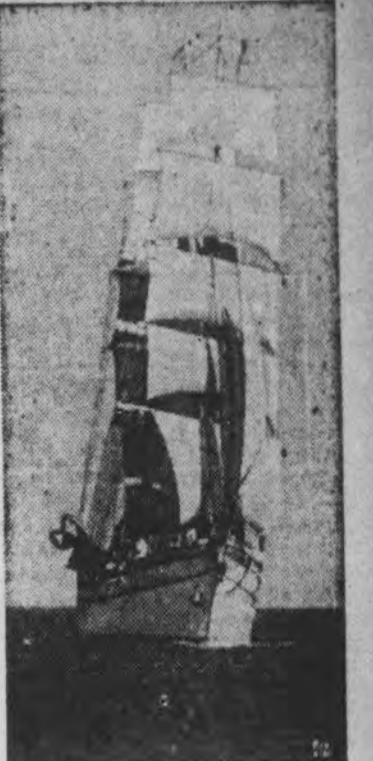

Washington Daybook

Washington—Whether through
pam or principle, Congress has
always fought shy of making its
own salaries subject to state taxes.
And the members are not throw-
ing bouquets at that part of the
President's plan to end exemptions.
Within the last few days the
House again rejected a proposal to
permit the District of Columbia
tax congressional and other fed-
eral salaries. They know there is
no question about a District of Co-
lumbia income tax on federal salar-
ies being constitutional, because
Congress itself fixes the amount of
the District tax.

"If you are going to have our
salaries taxed by the states," says
Representative Short of Missouri,
"you are going to have Missouri
taxing us perhaps 20 per cent, Iowa
10 per cent and Maine none."

But Representative Celler of
New York worries about another
phase: "The Supreme Court," he
says, "has found that the power to
tax is the power to destroy, and if
the federal government were em-
powered to tax willy-nilly the se-
curities of states and municipali-
ties it would have power to de-
stroy them."

On that subject, however, the
late Justice Holmes said:
"The power to tax is not the
power to destroy while this court
sits."

Boys Will Be Boys

This town is full of high school
seniors from a dozen states here-
abouts. Bus loads of them come in
for a sort of graduation frolic clad
in sweaters and high school letters.
They travel in mob formation and
eat in the same way, sometimes
taking over a whole dining room
in some of the smaller hotels. One
crowd started off dinner in a local
cave while a school yell. We yelled,
too. Damn it, why not?

The group medical association
which started here in the Home
Owners' Loan Corporation has

and Anti-Sales Tax Leader J. B.
Vogler, one of the 1937 incumbents
and one of his colleagues, E. L.
Mayhew, are joined by nine other
Democrats to make it an eleven-
way scramble for 3 seats.

Nash—Only county with 2 seats
and only two candidates—Bill Pen-
ner, who wants to be Speaker, and
Claude Abernethy.

Orange—Strictly a University af-
fair, with two pro's out for the
House—Roland McClamrock and
Raymond F. Stainback. Last time
the county sent a minister.

Pamlico—More candidates for
the one seat than in any other in
the state. Seven are running, in-
cluding one woman, Mrs. O. C.
Daniels.

Perquimans—In 1937 Tom Brown
was sergeant-at-arms and tried to
keep the representatives in their
seats. Now he wants one of his
own to sit in. He is running
against the incumbent J. T. Ben-
ton.

Richmond—Three are after this
seat, but neither present Represen-
tative Bob McNair nor Thomas H.
Leath is going to be gentleman
enough to give it up voluntarily to
Mrs. Archie McDougald, of Ham-
let.

Rowan: Walter (Pete) Murphy,
Old Roman of the House, wants to
come back again. So does his 1937
colleague Young promising George
Uzzell. They face a real challenge
from Harold Q. Sides and A. A.
Hurley who have come out on a
"dry" platform. Both Murphy and
Uzzell were for ABC county op-
tion.

Sampson—Enoch Wilson, 1937
Representative, had to promise he's
switch to the dry side of the fence
in order to get the Democratic nom-
ination. He has no primary op-
position, but at that is no heavy
favorite to beat Republican James
B. Barefoot in November.

Wake—Three who sat for the
county in 1937 liked it well enough
to try again, but they have six oth-
ers who'd like to oust them.

Warren—John Kerr, Jr., son of
the Second District Congressman,
gets in here without any opposition,
primary or in the general election.

Washington—Carl Bailey filed
for the nomination very late Sat-
urday deadline day. Early Monday
morning he told the election board
he wanted "out" thus making about
the shortest House campaign on
record. Four other deserving Demo-
crats hope to prove they are—
three will not.

Wilkes—Three Republicans are
looking for the nomination of their
party in Wilkes, and the one an-
nounced Democrat used to be sher-
iff of the county when he called
himself a Republican. Two years
ago the Demo. either beat the G.
O. P's or counted them out of the
county commissioner majority, so
there'll likely be a hot time here
in November.

days. Only volcanic gases have the
power. But mining engineers have
found a use for them.

W. H. Emmons, director of the
Minnesota geological survey, ex-
plains them in a report to the Amer-
ican Society of Mining and Metal-
lurgical Engineers.

Where there are diatremes is a
good place to look for mineral
wealth. There is gold in them there
diatremes, literally. There also is
silver, tin, bismuth, copper, zinc,
lead and other metals.

Into the holes after the gases
blew through, seeped many differ-
ent minerals in liquid form. In
some instances, geologists think,
the minerals even were deposited as
gases.

The power behind the gas has
been computed. One source is the
cooling of silicate and water, un-
derground. A drop of 80 degrees
figures to make enough gas to lift
a mile thickness of granite.

Hollywood

Sights And Sounds

By Robbin Coons

Hollywood—"Four Men and a Prayer"

It sounds notes reminiscent of "Beau Geste" and again of "The Three Musketeers" but winds up on its own power as a pretty good movie.

The four men are George Sanders, David Niven, William Henry and the new English young man, Richard Greene. The prayer is not, as one might assume, the beautiful and heavily wardrobe Loretta Young, but an earnest resolve to "get" the intriguers who discredited and later murdered the boys' army officer father (C. Aubrey Smith).

Jumping back and forth from England to America to India to South America to Egypt, the story packs a great deal more power and suspense in its early and middle stages than at the end. But it offers excitement enough, and there is a good deal of light comedy supplied by Niven, Bill Henry and Miss Young. Director John Ford seldom lets Loretta or her wardrobe hide the adventurous aspects of his tale, and he presents one whole of a sequence in which J. Edward Bromberg shows the kind of acting Hollywood isn't using enough.

The new boy, Greene, was taken to the ladies' hearts for his looks as well as capable performance, but in the acting department George Sanders is the stand-out, with David Niven uncommonly good in a blend of serious and comic characterization.

More Melodrama

"Stolen Heaven" is unusual in its combination of classical music with a fast cops-and-robbers melodrama. Gene Raymond and Olive Brada play the jewel thieves who, making their escape from pursuing police, seek refuge in a woodland home which turns out to be the abode of an aged concert pianist (Lewis Stone). Over Olive's soft-hearted objections, Gene persuades the faltering old man to stage a comeback, a plan which would give Gene and company a chance at money to make good their escape.

Director Andrew L. Stone's use of music—Liszt, Chopin, et al.—to further his story is interesting. Miss Brada acts more like Snow White than a tough adventures, but she has charm and slings and dances well.

A Musical

"Doctor Rhythm," one suspects on sober reflection, is really not Bing Crosby's best picture but it seems so at very frequent intervals in its running. Based on an O. Henreid story, "The Badge of Policeman O'Roon," it sometimes forsakes plausibility for convenience as when a hunted crook (Fred Keating) appears at a policeman's benefit to get the girl (Mary Carlisle) whom he doesn't really love. This makes it possible for O'Roon (Andy Devine) and the young doctor masquerading as O'Roon (Bing) to capture him in a garish finish.

Frank Tuttle's clever direction helps, but what sets "Doctor Rhythm" apart for us is the distinctive comedy of Beatrice Lillie, here making a triumphant return to pictures where once, nine years ago, nobody understood her. When Miss Lillie goes shopping for "two dozen double damask dinner napkins," and the clerk is Franklin Pangborn, the house is likely to react as the preview audience did, with sustained hysteria.

BOARD FORCED LAY OFF MANY

Unemployment Compensation Commission Budget Cut

Raleigh, May 4.—Reduction of personnel of the N. C. Unemployment Compensation Commission was started as of May 1, to meet the budget requirements of the Washington offices of the Social Security Board, from the maximum number of employees which reached 634 in March and April, Chairman Charles G. Powell said today.

The hope of the commission is to eliminate at least one, and probably later two of the late night shifts which have been in operation since January. The commission has three shifts, working 24 hours a day, for about four months, the hours having been from 7 a. m. to 3 p. m., from 3 p. m. to 11 p. m., and from 11 p. m. to 7 a. m. Eventually, the hope is to eliminate all late shifts so the workers can work normal hours, 9 to 5 in winter and 8:30 to 4:30 in summer.

The maximum of 634 included 472 in the central office in Raleigh and 162 attached to the field offices of the State Employment Service Division. Included in the 634 were about 175 who were put on the payroll as temporary employees in January and February, in order to help the commission catch up with the huge number of claims filed. Since the commission has been up or "current," except in a comparative small number of irregular claims, and has figured the fourth quarter earnings of all covered employees, the number of workers in the office can be gradually reduced.

In the numbers of workers for the commission, Wake county led with 157 at the peak, many of the temporary employees, put on for a month or two, having been in that number. Pitt county had 21 employees, Johnston, 20; Granville, 17; Durham, 16; Halifax and Nash, 15 each; Guilford and Wayne, 14 each; Buncombe, Craven, Franklin, Mecklenburg and New Hanover, 12 each, and Beaufort, Chatham and Cleveland, 10 each.

On file in the office are 3,075 applications for jobs with the commission, of which 814 are from Wake county. Several other counties have from 50 to 90 on file. Pitt county, the records show, had 21 employees of the commission, either in the central or field offices, and had 84 applications of residents of the county on file in the office.
