Rome, May 6.—(AP)—The next European war—if it comes—will be largely a struggle with chemicals, flames and artillery, if Premier Mussolini's line-up of armed forces today honoring Reichsfuehrer Hitler was an indication.

Also it will be the "totalitarian war" of which the late Master strategists, General E. Ludendorff wrote meaning that women and children would be quite as much drafted into service as men.

Mussolini showed his guest a whole chemical regiment that sent a shudder through the mass of spectators. The soldiers looked like beings from another planet in their gas masks.

Among their equipment were tanks and tubes and compressed air containers.

Besides Hitler and his entourage of High Nazis, Mussolini's guests included two former kings, Alfonso of Spain and Amanullah of Afghanistan.

The review included small boys, girls in black uniforms and various other fascist formations.

An interesting phase of the display was the jaunty march-post of Alpine troops with their rucksacks and skis. Among them one could detect many a Teutonic face from South Tyrol.

Both Hitler and Mussolini burst into smiles soon afterwards as several picturesque troops trotted by on the run, their hands playing as the musicians trotted along.

Dempsey Freed Of
Bribery Charges

Raleigh, May 6.—Major James C. Dempsey, former legislator from Waco, stood acquitted today of accepting bribes in his capacity as Alcohol Tax Unit investigator.

A jury in Federal court here last night found him innocent after deliberating six hours.

He was accused of taking \$150 in marked money from W. A. "Punk" Harris, ex-convict of Elizabeth City and from John L. Latham, agent of the Federal Intelligence Unit, Internal Revenue Bureau. The two had posed as bootleggers in an attempt to trap Dempsey, an inspector general in the North Carolina National Guard.

On the stand yesterday Dempsey declared that he knew undercover men were on his trail long before they arrested him. He said he wanted the "pleasure" of catching them first.

City Manager Form Of
Government SuggestedACT PROVOKES
CONGRESS ROWBailey Says Farmers
Think There Was
"Bad Faith"

Washington, May 6.—(AP)—Proposed changes in the new farm act have led to a congressional dispute over how well farmers understood the consequences when they voted two months ago to comply with the cotton and tobacco provisions.

Senator Vandenberg (R-Mich.), asked sponsors of the relatively minor amendments repeatedly as to whether the farmers were not "misled" in agreeing to the acreage and poundage restrictions.

Hotly, Senator Bailey (D-N. C.) put in:

"I am not saying there was misrepresentation. The farmers are saying 'we were persuaded to vote for this, with assurances, none of which are being made good.' I am not charging anyone with bad faith, but the farmers think there was bad faith."

Senators George (D-Ga.) and Smith (D-S. C.), declared the Agriculture Department misconstrued the act in basing tobacco allotments on acreage instead of poundage. They sponsored an amendment to correct this phase of the administration.

Two Men Held In
Highway Fatality

Salisbury, May 6.—(AP)—State Patrolman W. S. McKinney said today he had detained for questioning Al J. Tilley and Julian Tuck, both of Kannapolis, in connection with the automobile death early today of Mrs. T. E. Smith on the main highway between Kannapolis.

McKinney, who said that Tilley and Tuck were being held pending an investigation, asserted that Mrs. Smith's automobile was struck by a car "owned by Tilley" which came from a side road. He said the occupants of that car, whom he did not name, left the machine.

Warns Farmers Against
Efforts Evade Control

Reflector Bureau.
Raleigh, May 6.—E. F. Arnold, secretary of the North Carolina Farm Bureau Federation, today warned farmers that attempts to evade tobacco control regulations will inevitably fail and that such attempts are, in reality, nothing more than advice to "go back to the bankruptcy conditions of 1932."

He said that he cannot, of course, speak for federal authorities, but added that his knowledge of enforcement machinery is such as to convince him that efforts to avoid the control tax regulations are doomed to failure. His organization was extremely active in its advocacy of tobacco control and Mr. Arnold believes it should issue a warning to farmers who, he contends, are being misled by opponents of the control measures.

His statement follows: "The tobacco acreage of every farm will be measured whether the grower complies or not before marketing cards are issued to growers. In this way the Federal government will know approximately the number of pounds each grower has produced in excess of his allotment. Growers who do not market their surplus tobacco in the usual way and pay the required tax will be checked by the Revenue Department in every way possible to prevent tax evasion.

Mayor Blount Asks
Aldermen to Study
Plan

Possibility of the adoption of the city manager form of government for Greenville was brought to the attention of members of the Board of Aldermen in regular monthly session last night by Mayor M. K. Blount.

The mayor asked the members to make a study of the plan of government and declared that he, himself, would continue to investigate the set-up with the possibility of adopting it for Greenville.

Mayor Blount declared that in order to effect economies and plans for the future of Greenville the government should be placed on a business basis.

He recalled that many other progressive cities were turning to the manager form of government and asked the members to familiarize themselves with the plan.

"At the present time many improvements are being made and the federal government has spent considerable amounts in the past year," he declared, adding, "the city can no longer continue to issue bonds and keep its tax rate down."

"By expert management of city offices the tax rate should be reduced from its present level," he said.

"The management of a city requires the services of a full-time man, trained in municipal business," he continued.

Wilson and Rocky Mount in this immediate vicinity have adopted the city manager form of government, while most all of the larger cities in the state are operated under a manager.

Although last night was the first public mention of the movement to change the form of government, it apparently has the support of a number of officials as well as citizens.

At last night's meeting the board voted to consider the possibility of attempting to secure three legislative acts affecting Greenville. One would provide the candidates for city office be declared elected without the expense of a primary where there is no opposition. Another provided for the city to have jurisdiction over new streets within a certain distance outside the limits so that when and if the territory is taken into the limits the streets will conform to standard regulations. The third would provide for five members on the Water & Light Commission, which board at the present is composed of three members.

London and Paris
Decide on Action
To Stave Off War

Reported To Have Agreed to Urge Czechoslovakia Give Hitler Free Hand and Also to Have Dispatched Warning to Berlin

Paris, May 6.—(AP)—France and Great Britain, fearful of a German-Italian "deal," to give Adolf Hitler a free hand in Czechoslovakia, have decided on an immediate joint appeal to Praha and warning to Berlin, French Foreign Office sources said today.

These sources asserted London and Paris had decided to urge Czechoslovakia to make urgent concessions to her Nazi minority and to warn Germany against committing any "action of violence" against the Central European Republic.

The representations, it was said, will be made within the next 24 hours—while Hitler and Benito Mussolini are conferring in Rome during Hitler's state visit to Italy.

Foreign office circles said the decision came after receipt of diplomatic dispatches from Rome reporting that the Italian and German General staffs were studying a plan of action should France and Great Britain "react" after a German coup in Czechoslovakia.

The Paris Bourse reflected uncertainty over the Hitler-Mussolini talks. Government bonds lost a substantial part of yesterday's gains and industrial issues fell.

Joint Franco-British representations in an effort to wipe out a threat of European war will follow decisions made by the French and British ministers at their London meeting a week ago to arrange a common front on defense and foreign policy.

Sir Henderson, British Ambassador at Berlin, will see Field Marshal Goerring, Number two Nazi and acting Chancellor during Hitler's absence in Italy, today, it was said.

French and British Ministers in Prague will call at the same time on the Czech foreign office.

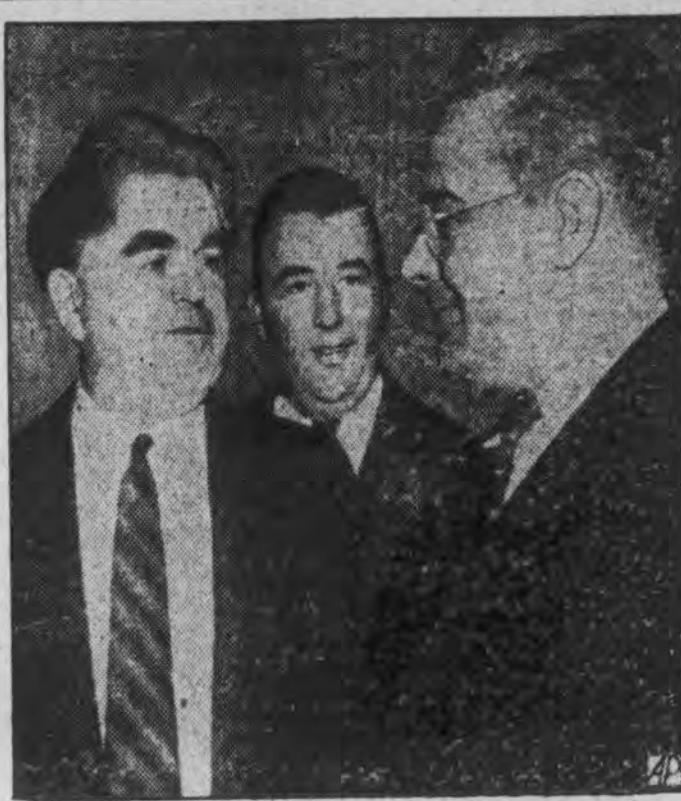

Plans Being Mapped For
State Party ConventionCongressman Lindsay
Warren Likely To
Be Chairman

Raleigh, May 6.—(AP)—Chairman Gregg Cherry of the State Democratic executive committee said today plans had been practically completed for the biennial State Democratic convention here May 18.

The party plan of organization permits 3,614 delegates, the largest number in the State's history.

Cherry conferred with Governor Hoy while here.

No decision has been announced as to permanent chairman of the convention, but there were indications it might be Congressman Lindsay Warren of Washington, who will keynote the party powwow.

Tomorrow precinct meetings of Democrats will be held in each locality of the state to select delegates to county conventions to be held May 14. The county meetings will name delegates to come here.

The permanent organization committee nominates the permanent chairman for the convention, but wishes of the Governor usually are followed.

English Nobleman
Dies At Age of 69

London, May 6.—(AP)—The ninth Duke of Devonshire, towering master of one of England's greatest feudal families, died today at the age of 69 within the historic walls of his principal seat, Chatsworth House, where Mary Queen of Scots once was imprisoned.

Statesman-sportsman, he was a former Governor General of Canada and one of the wealthiest land owners in England.

The origins of his line are lost in England antiquity. One of his ancestors was Sir John Cavendish, a chief justice who in 1381 was beheaded by Insurgent Peasants led by Jack Straw and Watt Tyler, who revolted against the poll tax.

Big stolid, but keen and resolute the Duke—Victor Christian William Cavendish—spent his last years passionately hating automobiles.

Revolutionary struggles in 1848 completely destroyed the effectiveness of the Holy Alliance, formed 33 years earlier.

Supreme Court To Decide
Status Of Women Jurors

Raleigh, May 6.—North Carolina's Supreme Court will next week hear oral argument in the first case ever to come before it offering a chance to determine and define, once and for all, the status of women as jurors in this state.

Ben Sims was convicted of first degree murder in Guilford county. In apt time at his trial, his counsel moved to quash the indictment against him because women had been systematically and purposely excluded from the list of grand jurors drawn for the term at which he was indicted.

His motion was overruled and action of the court in this respect is assigned as reversible error, counsel contending that under the North Carolina Constitution no jury from which women have been purposely excluded has been drawn in accordance with "the law of the land."

And so unless the court finds no other point upon which to decide the case, the oft-bruited question of woman's eligibility and status as jurors will be answered at last.

Recently Attorney General A. A. F. Seawell (now a member of the Supreme Court), ruled that women are eligible to serve as jurors, but there has never been a case before now in which the question "must they be included on all jury lists?" has been raised.

Brief of Sims' counsel described their contention thus:

"The position of the defendant is that the grand jury which returned the bill of indictment was not legally constituted and consequently could not return a legal bill of indictment. That is to say, if women

218TH MEMBER
SIGNS PETITION

Washington, May 6.—(AP)—House members completed a petition today to force House consideration of the revised wage-hour bill.

The 28th signature was affixed less than three hours after the petition was filed.

Representative Mounton (D-La.), was the 218th signer.

A mad scramble followed filing of the petition to force a House vote on the bill.

Sponsors of the petition said there were 188 signatures on the petition within 30 minutes.

Members jostled each other and snatched after the document.

The petition was filed by Chairman Norton of the House Labor Committee as soon as the House convened. The petition must have 218 signatures to give the measure a new House test.

On several occasions the members, trying to affix their signatures, threatened to tear the paper apart.

Estimated 30,000
Will Draw Old Age
Benefits By July

Seek to Hold Down Number Drawing Checks So Those on List Will Receive Enough to Really Aid

Reflector Bureau.
Raleigh, May 6.—Assignment of portion of the burden of providing Old Age assistance to the counties is largely responsible for the fact that North Carolina's list of those above 65 receiving this aid will not go beyond 30,000 by July, end of the fiscal year, Nathan Yelton, in charge of administration of the Old Age Assistance and Aid to Dependent Children in the state, said today.

This 30,000 is likely to be the maximum number of those to receive assistance, he said, as it is the policy of the administrative authorities to hold down the list in order that those who are getting assistance may get enough each month to be of some real benefit to them.

"If we increase the number on the list until each gets practically nothing at all per month, then nothing constructive has been accomplished," Mr. Yelton said.

In April the average monthly Old Age Assistance check was \$9.42 for each of the approximately 23,000 who received them.

The number receiving assistance and the amount each is getting run just about according to estimates made when the program was set up. It was estimated that the average monthly assistance check would be about \$10 and it is Mr. Yelton's aim not to let it fall far below that figure.

He said that county officials and welfare boards have been cooperating well in the program, and there has been almost no "padding" of the assistance list. This he attributes largely to the fact that the counties pay one-fourth of the total cost of the program, with another quarter coming from the State and half from the Federal government.

Already counties have begun to ask for increases in their lists for 1938-40, however. For example, the Mecklenburg county board came over in a body recently and asked that their county be allotted approximately 200 more Old Age assistance and 150 aid to dependent children beneficiaries.

The striking quality of Miss Dragonette's voice is not volume, but sweetness and purity.

This quality showed at its best, perhaps, in her second and third groups of selections. The second included Schubert's "Wienlied," a cradle song that she gave in the soft light tones it needed, and a German number "Mit Einer Wasserlilie," also clear and lovely in tone.

The dramatic "Le Jardinier du Roi" of the third group was beautifully done, also, with a light, lilting quality brought out in it.

However, obviously most liked by the audience were the radio favorites of the last group, "Alice Blue Gown" having to be repeated, so enthusiastically was it received.

The pianist, Celius Dougherty, who contributed to the program by his accompaniment, played also the Bach "Choral Prelude," a Debussy number, beautifully soft and meditative, and Ravel's "Imperatrice des Pagodes."

Many of the student body are describing Miss Dragonette's program as the best of the year. They were pleased by both her lovely voice and her gracious and charming personality.

Though Miss Dragonette has been on a concert tour since November, she came here direct from New York, making a special trip to fill her engagement at East Carolina Teachers College.

On her latest concert appearance in Rochester, N. Y., on April 30, this singer drew the crowd away from a tennis match between the famous stars Perry and Vines, leaving them to play before empty seats while just across the street she sang to a house with even standing room taken.

Miss Dragonette's last concert of the season will be given in Lake-wood, N. J., on May 15. After that, she said, she plans to return to the air.

When asked about the recent report of her marriage, the singer answered that it was not true, but added with a smile that she was not "a gin marriage," at all and referred her interviewer to her "lyric answer to the broadcaster of the report, Walter Winchell. Truckers Of N. C. Aided By New Law In South Carolina

Statute Recently Enacted Fixes the Width and Weight of All Trucks Operating in That State

Reflector Bureau.
Raleigh, May 6.—Almost half of North Carolina's more than 57,000 trucks were affected by and their owners are profiting from South Carolina's new size and weight law which became effective last Saturday, according to Miss Frances Johnson, secretary of the North Carolina Truck Owners Association.

The South Carolina law was changed so as to allow operation of trucks 96 inches wide of a gross weight up to 40,000 pounds. Previously the S. C. statute had banned trucks wider than 90 inches of gross weight of more than 20,000 pounds.

The change in regulations, however, had the practical effect, Miss Johnson said, of limiting, rather than increasing width and weight in the Palmetto state, for until the recent United States Supreme Court decision the old statute had been practically ignored, with the result that trucks of all widths and weights were operating without interruption.

Governor Olin D. Johnson signed the new bill only after thorough consideration. He was urged by Governor Clyde R. Hoey to allow the new statute to become operative, according to reliable information, the North Carolina executive taking an interest in the matter because of the great number of North Carolina trucks affected.

Miss Johnson pointed out that practically all North Carolina trucks operating from Florida, mostly carrying fruit, have to pass through South Carolina going and coming; as do all those handling loads out of Atlanta, the biggest shipping center of the South.

In addition practically all North Carolina bottling concerns get their bottles at Laurens, S. C., and practically every truck owned and operated by these bottlers is in excess of the old South Carolina rule.

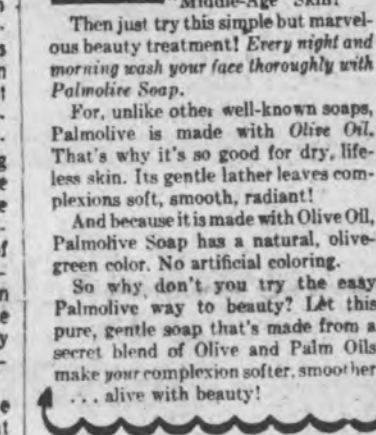

ever—Vote RIGHT, REGARDLESS
of what others think or say.

SHORT SHOTS

By HENRY AVERILL

Raleigh, May 6—Your correspond-
ent noted the other day a pic-
ture of State Senator E. C. Gregory
of Rowan with a line under it af-
firming that the senator is assur-
ed of an important committee
chairmanship "because of his sen-
iority."

While that is perhaps true in the
main, it might not be amiss to
call attention to the fact that the
General Assembly does not operate
on the strict rules of seniority which
govern the Federal Congress. In the
Congress a member gets on a com-
mittee, rises in order thereon sim-
ply through the length of time he
serves on it if he lives long enough
and his party has a majority he
will get to be chairman.

That sort of thing isn't true of
the North Carolina legislature in
either branch. Committee chair-
man and members are named each
time by the Speaker in the House
and the Lieutenant Governor in the
Senate and it sometimes comes to
pass that even after a legislator
becomes chairman of an important
and influential group he may be
ousted therefor at the very next
session just because the presiding
officer happens to belong to an
opposing faction, or even because
the P. O. doesn't like the color of
his hair.

Ask Senator Lee L. Gravelly about
that. The Nash law maker headed
the Appropriations group in the
1935 Senate, came back again in
1937 and found himself put at the
head of Conservation and Develop-
ment—an important committee, to
be sure, but not in the same class
with either Appropriations or Fi-
nance, the two big committee plum-
p. It seems that Gravelly didn't sup-
port Lieutenant Governor Wilkins
P. Horton in the 1936 primaries.
And so it isn't at all certain that
Gregory or anybody else will get
any particular chairmanship of
committee post because of "senior-
ity."

While on the subject of commit-
tees, particularly Finance and Ap-
propriations, it may be something
like counting quints before Mrs.
Dionne goes to the hospital, but it
looks like Senator W. B. Rodman,
Jr., of the Second District, for one
or the other of these spots—prob-
ably Finance.

Of course the Senator From
Beaufort is only one of three can-
didates for the two posts from his
district, but it's all but certain
he'll be back. In the 1937 session
he was given a Finance membership,
though a freshman legislator, and
before anyone realized it he was
doing most of the leading on the
group, of which Senator E. V.
Webb, Jr., was chairman.

He has the ability—showed it be-
fore—and his politics are "right" so
far as Lieutenant Governor Horton
and the State Administration go.
If he isn't the 1939 Finance chair-
man it will likely be because he
doesn't want the job, and there
seems small chance of that.

As for the appropriations spot,
many are talking of Harrison New-
man, New Hanover veteran who
gets to the Senate only every other
year because of his District's
gentleman's agreement. Of course
you can find many down about Wil-
mington who think Emmett Bellamy
may upset Harrison' little red wag-
on, but assuming that Newman
gets by his local opposition and
comes to Raleigh in January in an
official capacity, he's as good a bet
as any for the Appropriations chair-
man.

In 1939 he was Finance head and
that was a tough time and job.
Previously he had headed the same
group in the House, which puts
him way out in front in the mat-
ter of experience.

SIX-FOOT CHORUS GIRLS HAVE NO JOB WORRIES



Little chorus girls are cute, big ones in demand. Here are both kinds—little Ginger Johnston, Corpus Christi, Tex., and Mona Lisa (really Marguerite Joyce), Waco, Tex. Mona (or Marguerite) is 6 feet 1 1/2 inches tall. They're on a chorus bound for London.

(AP Feature Service Writer)
New York.—In the night club and theater chorus business, all tall girls work.

Not only is 6-foot height an advantage to a chorus girl, but the demand for really tall chorines far exceeds the supply.

The reason is that tall girls are more stunning on the stage than short ones, say chorus directors. They wear clothes better, are more graceful, and are more commanding in appearance. Their duties rarely involve real dancing, but by weaving through rhythmic dance patterns, they lend glamor to the chorus numbers.

Chorus equity estimates there are 5,000 girls in the United States capable of stepping into chorus jobs with probably 1,000 of them living in New York City. Yet Georgie Hale, producer and dance director, seeking six-footers for a chorus to send to London, could find only four.

Height's Not All
There are only 18 chorus girls in New York six feet tall or taller," Hale says, "and they are constantly employed."

"Of course, it takes more than stature. Beauty and good figures are requisites, but if a tall girl is sufficiently endowed, she won't have to worry."

Last year he sent a chorus of 16 abroad. The girls were all about five feet, three inches tall. Both on the continent and in London, the only complaints were that the girls were too short.

"Englishmen like 'em tall," says Hale, "because the tall American show girl sets a mark that the Britisher would like to have his ladies shoot at. Most English women are tall, you know, but those with grace and beauty are the exceptions, not the rule."

Big And Little
This year Hale's chorus is composed of eight girls of average height and four who are six feet or more.

The four are: Bunny Waters, Santa Monica, Calif., "the tallest showgirl in New York," 6 feet 2 1/2 inches, two years in the chorus and "never out of a job yet."

Anita Arden, Brooklyn, 6 feet, 2 inches, who started work in Billy Rose's "Jumbo" three years ago and has worked steadily in choruses ever since.

Mona Lisa, whose real name is Marguerite Joyce, Waco, Tex., 6 feet 1 1/2 inches, with Rose's "Casa Manana" show in Fort Worth and

(Continued from page one) troil of mosquitoes it will be found necessary to screen (using 16 to 20 mesh) doors and windows not forgetting the fireplace. "Chemical sprays" said Mr. Welch, "are useful only as a temporary relief. It is understood that the City of Greenville is now trying to get Malaria drainage work done thru the WPA. Mr. Welch states that he has conferred with Dr. N. Thomas Ennett, Pitt County Health Officer, in connection with the local mosquito problem and that the Health Officer respectfully requests that all property owners immediately open chokes up gutters and eliminate other breeding places of the premises by cutting thick weeds, disposing of old cans, pieces of broken pottery, etc., which may be holding water and act as breeding places for mosquitoes.

(Continued from page one) are eligible for jury service in North Carolina and they are purposely excluded from the jury list from which the grand jury in the instant case was drawn, then the jury was not drawn in accordance with the law of the land. Consequently the bill of indictment was void in all respects and any action taken thereunder being in violation of North Carolina constitution, were of no effect whatsoever. "It must be admitted that insofar as the practice of this State is concerned there is unbroken precedent for the exclusion of women from jury lists. Yet such precedent should not deter this Court in determining the question at this time."
