OUSTER PROCEEDINGS STARTED AGAINST SHERIFF

WOULD PERMIT QUICK ACTION ON LABOR BILL

Rules Body Chairman Suggests Bill Be Expedited

PRESENTS MOVE TO WAIVE RULES

Bankhead Feels Certain House Will Pass Bill Practically As Drawn

Washington, May 9.—(AP)—Chairman O'Connor (D-N. Y.), of the Rules Committee, proposed today that the House expedite action on the controverted wage-hour bill.

The House has signed up a petition to force action on the legislation, but under existing rules it can not come up before May 23.

O'Connor introduced the resolution to waive the rules and permit the petition to be called up at any time.

He said if the House leadership desired to advance the date of consideration he would "make every effort to prevail upon a majority of the committee on rules to report out the resolution," waiting the rules.

Speaker Bankhead said "Of course the President is very anxious to get the bill passed before we adjourn."

Bankhead said he was convinced the House would pass the wage-hour bill, probably without any substantial amendment.

He said monopoly legislation and reciprocal taxation by the States and Federal government of one another's securities were in the same category.

One of the major measures on the legislative program advanced a step today when the Senate approved the conference report on the tax revision bill.

Joseph Davies of the District of Columbia, present ambassador to Russia, was nominated by President Roosevelt, meanwhile, to be ambassador to Belgium.

Patrolmen C. R. Williams today reported the arrest of a man charged with hitting and killing a woman in connection with a wreck yesterday afternoon on a dirt road between Laurel and Stokes.

The man was arrested in Murfreesboro after an auto had been sent out over the police radio station. His name was not known by Patrolman Williams, although a check showed the car involved in the hit-and-run wreck was registered in the name of Jimmie Core of Palmyra, Wyatt Highsmith of Greenville, police said, was operator of the other car involved. No one was injured, but Highsmith's car was damaged.

Native Of County Dies At Age Of 70

Chapel Hill, May 9.—(AP)—Funeral services were conducted here today for William Stanley Bernard, 38 years a member of the faculty of the University of North Carolina, who died Saturday night of a heart attack.

Dr. Bernard would have been 71 years old Sept. 15.

The services were conducted by Rev. Alfred S. Lawrence, pastor of the Episcopal church. Burial was in the Chapel Hill cemetery.

Dr. Bernard was born in Greenville, the son of Dr. William Augustus Bernard, a surgeon-captain in the Confederate army, and Mary Anne (Smith) Bernard. He is survived by a daughter, Mary Stanley Bernard, 16, and a stepdaughter, Mrs. Lawrence London of Chapel Hill. Mrs. Bernard died several years ago.

Department Announces Twelve Summer Schools

Raleigh, May 9.—Twelve summer school sessions have been announced by the state department of Public Instruction for this summer.

These announcements bring to the fore the fact that the development of resort and recreational facilities has been paralleled by a steady increase in summer school enrollment, a fact which is now regarded by school authorities as more than a coincidence.

It is noticeable that in almost all the places chosen for summer school sessions, there are also recreational and resort developments.

For this summer Eastern Carolina will have summer school sessions at Eastern Carolina Teachers College, Greenville, beginning June 9, with the second term starting July 21, while Wake Forest and Meredith combined summer school will begin at Wake Forest June 8. There will be only one term, State College's summer school unit will begin its terms June 13 and July 22.

Fuehrer Surveys Renaissance Beauty of Florence

Florence, Italy, May 9.—(AP)—Adolf Hitler, homeward bound from his triumphal visit to Rome, arrived here this afternoon for a hasty survey of Florence's renaissance beauty.

The Fuehrer's own sleek 12-car streamlined train, in which he has traveled exclusively since his departure a week ago, slid into Florence's new station at 2 p. m.

Bombing planes, roaring above the station and a cheering crowd maintained the military note which has dominated the German dictator's entertainment in Italy.

Premier Mussolini, who preceded Hitler to Florence after bidding him farewell at Rome this morning, was on the station platform to welcome him here.

Rome, May 9.—(AP)—German's Fuehrer Hitler hurried away from Rome today with fresh assurances of Italian friendship and high fascists indicated this included a pledge by Premier Mussolini to let him have a free hand in Czechoslovakia, so far as Italy is concerned.

Session Would Delay Part of Rapprochement Plan

MANY COUNTRIES DESIRE SESSION

Latest French-British Plan Would Not Provide Vote on Recognition of Italy

Geneva, May 9.—(AP)—The unexpected growth of a movement to call the League of Nations assembly into session ahead of schedule today threatened to wreck the French-British "realistic" policy of opening the way for recognition of Italy's conquest of Ethiopia.

This would seriously delay an essential part of French-British rapprochement with Italy.

Both British Foreign Secretary Viscount Halifax and French Foreign Minister Bonnet, in private talks with other delegates in connection with today's opening of the session of the League council, urged them to speed action to free league members to recognize Italy's sovereignty over Haile Selassie's old domain.

Halifax and Bonnet wanted public discussion of their "do as you please" proposal to start tomorrow if possible.

A campaign to call the full League membership into session was reported being actively pushed by different reasons by Columbia, Chile and Mexico, encouraged by Soviet Russia, China, New Zealand and Bolivia, members of the 14-member council.

FORD WINS IN COURT DISPUTE

NLRB Forbidden To Withdraw Records In Case

Covington, Ky., May 9.—(AP)—The Ford Motor company won in United States Circuit court today an amendment order forbidding the National Labor Relations board from withdrawing records of its case against the company.

The effect of the decision, said chief Ford counsel Frederick Wood of New York, would be to prevent the labor board from vacating its order of last December 22 and would permit hearing of the case before the court.

Wood asserted in oral argument preceding the court's action "it was perfectly obvious" that the board, if permitted to withdraw its records of the case, did not intend to give a "full and free hearing" of the case before an announced intention of producing new findings.

JAPAN FORCED ALTER COURSE REACH SUCHOW

Stalled in Drive From North, Turn Now to New Thrusts

CLAIM PROGRESS IN NEW ATTEMPT

Nippon Foreign Minister, Meanwhile, Talks of non-Aggression Pact with U.S.

Shanghai, May 9.—(AP)—Stalled in their desperate and costly effort to reach Suchow from the north, the Japanese today reported rapid progress for two secondary thrusts from the south toward that nerve center at the Central China battle area.

Japanese dispatches declared two columns driving northward thru Central Anhwei province along the highway from Pengpu had captured a point 85 miles southwest of Suchow after a desperate battle.

Another column moving up the Tientsin Pukow railway was approaching a point 70 miles south of Suchow, said a Japanese army spokesman. This force had gained 20 miles in 48 hours.

Suchow is the prize for which Japan and China have been contending near five months.

But the Japanese could report no progress for their primary offensive in southern Shantung province.

Tokyo, May 9.—(AP)—Foreign Minister Hirota interviewed today by the Associated Press, said that fears of the United States worried "not a few" Japanese and posed the question of a non-aggression pact. (Continued on page five)

WOULD RETAIN EMBARGO ACT

Prefers Not to Lift Ban on Arms Shipments to Spain

Washington, May 9.—(AP)—President Roosevelt's first post-vacation conference with congressional leaders produced a small indication today the administration will not support efforts to lift the embargo on arms shipments to Spain.

Rep. Rayburn of Texas, House Democratic leader, said after the conference he was firmly opposed to modification at this time of the neutrality act as applied to the Spanish civil war.

The Texas said in response to questions that the Nye resolution which would lift the arms embargo was mentioned "incidentally," he said he would not attempt to speak for the President on his subject, but as for himself he was opposed to changing the present policy. (Continued on page six)

Picket, Two Policemen Hurt In Detroit Strike

Internal Strife Among Workers Chief Problem

Detroit, May 9.—(AP)—Two policemen and a picket were injured when police and pickets clashed at the gates of the Michigan Steel Casting Company.

Police said about 65 pickets were parading before the gates when J. W. Johnson, a company salesman, tried to make his way through the line. Sixteen police took part in the melee.

Edgar Plinterman, company president, said "the plant is in full operation" and declared all but 35 of its 125 employees were at work.

The UAWA, affiliated with the CIO, called the strike April 19 after union officials said, the company announced a 10 per cent wage cut.

Meanwhile factionalism within the UAWA was foremost among a half dozen problems before a meeting of its international executive board.

What for months has been a rivalry between two groups of the CIO union appeared to have undergone a realignment that finds the membership divided under the leadership of three influential UAWA officials. (Continued from page one)

State Patrol Facilities Inadequate For Mileage

Reflector Bureau. Raleigh, May 9.—North Carolina's State Highway Patrolmen compare favorably with the entire country insofar as motor vehicles and motor vehicle drivers per officer are concerned, but when it comes to highway mileage which must be patrolled by each, this state's force appears inadequate in comparison with the force maintained in many of the more populous sections.

Figures compiled by the National Highway Users Conference show that North Carolina's 120 patrolmen have an average of something like 5,000 registered cars per officer, there are approximately 600,000 motor vehicles registered in the state, and about 8,000 drivers per man based on an estimated 900,000 to 1,000,000 drivers in North Carolina.

According to the conference figures, the country's patrolmen are outnumbered about 7,000 to 1 by persons who drive motor vehicles and 4,600 to 1 by registered motor vehicles—figures which are only slightly below the North Carolina averages.

But when miles of highway per patrolman are the question, there's an entirely different answer. For example Pennsylvania has only about 35,000 miles of state highway, but its patrol numbers 1,600; while North Carolina's 59,000 miles of state roads must be ridden by a meagre 120 officers. Even little Rhode Island, with almost no mileage outside urban centers, has no less than 69 patrolmen.

An interesting angle of the national patrol summary is the fact that North Carolina's patrol is unique in being under direction of the State Revenue Department. Not another of the total of 47 state patrolmen is under that branch of the state government. In two states, Alabama and Pennsylvania, the patrol composes an entirely separate and distinct department of its own.

All states except Florida have patrolmen, the Alligator State having abolished its patrol in 1937.

JUDGE DENIES REQUEST FOR TRIAL BY JURY

Petition Charges Misconduct, Maladministration, Extortion

COMMISSIONERS BROUGHT ACTION

Whitehurst Declares Charges Brought In Bad faith at Instance of ABC Chairman

Judge G. V. Cowper, in Pitt Superior Court here this afternoon, began hearing witnesses on a petition of members of the Pitt County Board of County Commissioners, as individuals, requesting that the jurist oust Sheriff S. A. Whitehurst for "willful misconduct, maladministration, corruption and extortion, and acts amounting in law to felonious crime."

The charges in their entirety were denied by the sheriff on the ground that they were "untrue and maliciously false" and that "the proceeding was instituted in bad faith by the commissioners on an at the instance of the chairman of the ABC board."

The petition was filed before Judge Cowper during the term of court two weeks ago and was set as the first order of business for the term which opened here this morning. In the meantime the petitioners were ordered to furnish a copy of the complaint, together with a bill of particulars, to defense counsel and special officers were appointed for the serving of process in connection with all cases which had a bearing on charges against the sheriff, and for the present term of court.

Prior to the reading of the petition this morning, Judge Albion Dunn, of defense counsel, made a motion for the trial of the petition by jury, but Judge Cowper overruled the request and ordered the hearing to begin. Judge Dunn then made a motion to strike out sections 12 and 13 of the petition, which referred to the quashing of previous true bills of indictment when Judge Henry A. Grady ruled that the grand jury hearing the matter was illegally drawn. Jesse Jones of Kinston, for the petitioners, contended that sections 12 and 13 were placed in the petition to show bad faith on the part of the sheriff, who had knowledge of the manner in which this and previous jurors had been drawn, but kept silent and permitted other people to be tried and convicted and made complaint only when his own liberty was at stake as a result of action by the grand jury.

Judge Cowper ruled that he would permit the sections to remain in the complaint only for the purpose of giving the petitioners an opportunity of establishing "bad faith" on the part of the sheriff.

Both on the motions for trial by jury and to strike out the sections pertaining to the grand jury defense counsel made note of exceptions to Judge Cowper's ruling.

The petition, read by Mr. Jones, charged the sheriff with failure and refusal to account to the county for fees, commissions or other emoluments. (Continued on page five)

Tuberculosis Clinic In County.
J. Herbert Waldrop, president of the Pitt County Tuberculosis Association, when seen this morning, expressed great interest in the Tuberculosis Clinic now being held in Pitt county, and called attention to the fact that the Pitt County Tuberculosis Association is sponsoring this clinic just as the association always sponsors the Seal sale.

He declared that even though the death rate has been greatly reduced in the past few years tuberculosis is still a serious public health problem, and cited the fact that it is the chief cause of death between the ages of 19 and 35.

Mr. Waldrop said he had been advised by Dr. N. Thomas Ennett, local health officer, that clinics this year would be held at the following points in the county: Farmville, Bethel, Grimesland, Ayden and Greenville, and that X-ray, through the Christmas Seal sale fund would be free to all who desired it.

With the clinics scattered throughout the county and with free X-ray available, Mr. Waldrop declared that there could be little excuse for delay in diagnosis, and added that all physicians agreed that early tuberculosis is nearly always curable, while late tuberculosis is seldom curable.

Mr. Waldrop said that he wanted to take this opportunity to thank, on behalf of the Pitt County Tuberculosis Association, all the citizens who so generously supported the Christmas Seal sale since it is the funds from this sale that has made the clinic possible.

New Physical Education Courses.
A course in Playground Supervision and one in Test and Measurements in Physical Education are two courses scheduled to be offered by the Physical Education department of East Carolina Teachers College this summer that are attracting much attention. These will be given during the first term, June 10 to July 20.

Physical Education courses for the second term, July 21 to August 27, Officiating Team Sports and Contests, and Scouting Activities and Camp Guidance, are also expected to draw a large number of students.

In the last-named course, actual experience will be given in the various duties and skills necessary to successful camp management. This will be done through week-end camps that will serve as a sort of laboratory.

Coach J. D. Alexander, who has his M.A. degree from the University of Iowa, and is nearing completion of his Ph.D. in Physical Education at Peabody College, Nashville, Tenn., will give the courses.

A large enrollment for the work of both terms is anticipated.

Washington Daybook

By Preston Graver

Washington—How much is a billion dollars? Senator Bulow of South Dakota, a shy and humble man, asked the question in the Senate when he arose for one of his almost-never speeches. He opposed the billion dollar naval bill. He was sure the Germans were not going to invade the United States—at least for a while.

"It may be said that we are in danger from Hitler," he said. "I am of German descent. My father and mother came from Germany. I want to assure the Senate that God is not going to let Hitler come over here and take us until he gets through taking the rest of Europe. That task is going to take him quite some time."

But let us get back to the billion. "When I first came to the Senate," said Bulow, "I heard reference to a billion dollars. I did not know what the Senators were talking about."

Then I got a notion that perhaps while I was in the Senate, I ought to get for myself a billion dollars, and I started to figure to see just how long I would have to be here in order to get a billion dollars. I soon discovered that I would have to be re-elected before that was brought about. (Laughter.)

"I went home and got myself re-elected, and then did some more figuring, and when I got through I discovered that I would have to be re-elected 100,000 years before I would get a billion dollars. That was somewhat disturbing. It was discouraging. I was afraid some Republican would beat me before that time elapsed." (Laughter.)

Perish the Thought
While the Senate laughed, Mr. Bulow got his breath and went right on:

"This morning I received a letter from a constituent of mine who apparently is very strong for the pending naval bill, and he wants me to vote for it. He said we needed what was provided for in the bill, and he said, 'In order to get the money you can just reduce your salary as Senator. You are getting too much money.' (Laughter.)

"Perhaps that is correct, but when we figure it out, all the salaries which have been paid for 150 years to all the Senators who have served in this body would just about make a start and when we come to make the calculation, we find that a billion dollars would pay all the Senators in this body for a thousand years and longer. (1,041 years, eight months, to be exact.) It is a tremendous sum."

Sizable Displacement, Too
Just to help out, we will add that a billion dollar, allowing one ounce to the dollar, would weigh 31,250 tons, a little less than one of the battleships now being built.

But then again, the national income is something around a billion dollars a week and President Roosevelt says the country won't really be prosperous until it ticks off about a billion dollars a week.

Raleigh, May 9.—While the Speaker of the 1939 House has been very much in the limelight with at least three candidates (Victor Bryant of Durham, Libby Ward of Craven, and Bill Fenner of Nash) creating some excitement in the public prints, very little has been said about the post of President Pro Tem of the 1939 Senate.

Last time Senator Hall Johnston, of Buncombe, now a Superior court judge, was named. This time the post would, if the rotation procedure was followed go East, though there seems to be no real rule along this line.

First Easterner to be mentioned in connection with the place is Senator W. I. Halstead of the First District, whose chief claim to public attention in the 1937 Senate was his introduction of a bill authorizing a \$25,000,000 bond issue for improvement and maintenance of secondary roads.

Halstead has no opposition in his district and if he so desires can devote his entire time to his Pro Tem candidacy, if indeed he really has the bee in his bonnet.

Westerner most in the conversation about the man who will preside in the Senate when Lieutenant Governor Horton takes a day off is Senator Thomas J. Gold, of High Point. He is a veteran member and if he goes after the place could gather more than moderate support. He must, first of all, get himself elected as he has an opponent in the primary.

Both Halstead and Gold voted for the ABC county option bill without a state referendum, when the matter was before the 1937 Senate.

The West hasn't even a feminine candidate for the Senate this year. The East has two—Mrs. J. J. Purdy of Pamlico who is given almost no chance at all to defeat either Senator W. B. Rodman, Jr., or D. Bradford Fearing of Dare; and Mrs. Frank Andrews of Wayne who is said to be giving Senator Edgar Nain quite a head.

Commissioner of Revenue Allen J. Maxwell is acting more and more like a candidate for governor in 1940. He is jockeying for opportunity to get out in the hinterlands and shake hands with the folks who vote. He's bound's celebration of the Greyhound's celebration of the Boone-Wilmington line opening.

Reports are that the Gaston battle for House seats is a hot one. C. E. Hamilton, the only candidate from Gastonia proper, is almost conceded one of the county's two seats with Dave Dellinger (Gregg Cherry's 1937 colleague) and N. B. Kendrick battling hard for the other.

Current issue of "North Carolina Today" has on its covers what are said to be the first example of four-color work printed by offset method. The covers show the tact and diplomacy of the Advertising Division with the far East represented by Miss Katherine Meier of Wilmington on the Beach at Wrightsville on the front and the far West (in the person of Chief Standing Deer, champion archer of the Cherokees) on the back.

The Supreme court will hear oral argument in two capital cases this week—State vs. Feyd and State vs. Sims, both from Guilford.

Feyd, a Negro, was convicted of first degree burglary—Sims of first degree murder.

Major Edney Ridge, of Guilford is doing his best to make political capital out of the victory of Senator Claude Pepper in Florida. The Major is making his loyalty to the New Deal and to President Roosevelt the main issue in Sixth District Congressional race.

State Convention To Be Asked Endorse Farm Act

Reflector Bureau
Raleigh, May 7.—At least one issue sure to meet with stern opposition in some quarters is certain to be shoved under the nose of the Democratic state convention here May 18—endorsement of the Federal Administration's agricultural policies and the recently enacted crop control feature which was so sweepingly approved by this state's farmers in referendum elections by cotton and tobacco growers.

The plank of endorsement is coming from the North Carolina Farm Bureau Federation, the big farm group which practically wrote the tobacco and cotton sections of the control acts and which conducted such an aggressive campaign for its approval.

The opposition is coming from the partisans of North Carolina's senator, Josiah W. Bailey, who opposed the bill in Congress and who is still opposing any and all efforts to amend and liberalize the existing bills.

Whether or not the fight will get to the floor of the convention is a different thing. The convention machinery, as always, will be completely controlled by capable and practical politicians who hate squabbles over platform planks worse than the Devil hates holy water.

The convention personnel, too, will be composed almost in toto of this same sort of practical politicians who are all solicitude for the feelings of other politicians, even if they do not always agree with the views of these others.

Hence it is entirely possible, even probable, that there will be no floor fireworks or any loud public explosion; and there isn't any great chance of any platform plank highly obnoxious to Senator Bailey, or to any other leading politician, for that matter.

But just the same, there is going to be an effort made to get a crop control plank into the platform, its backers feeling that it would be highly inconsistent for the dominant party of this dominantly agricultural state, to omit endorsing its national administration on this question.

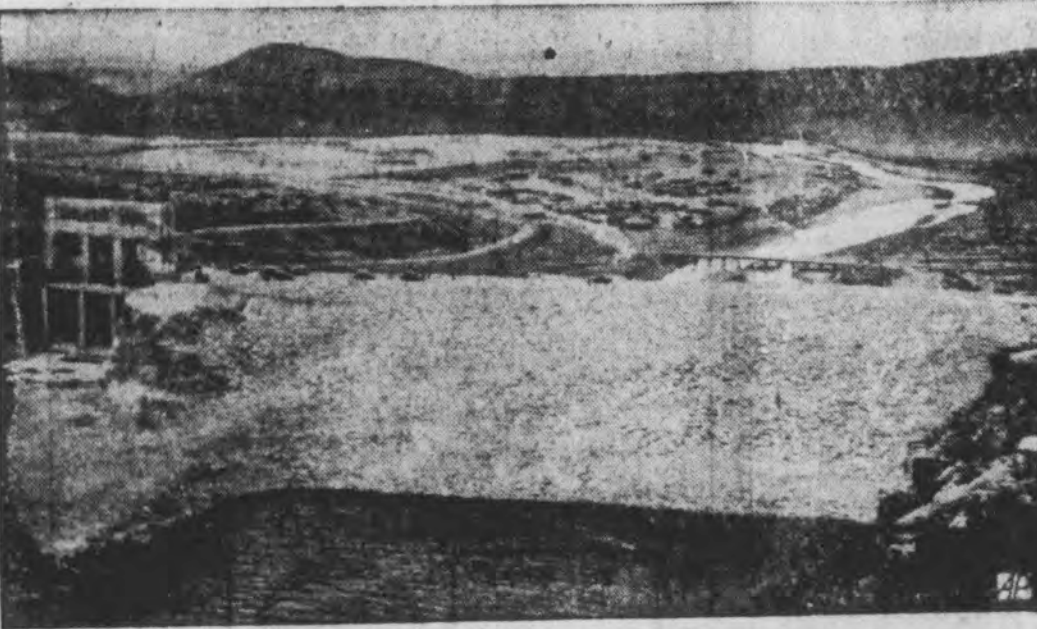

ments of any other kind collected or supposed to be collected by his office, declaring that same constituted a misdemeanor.

The complaint further charged the sheriff with failure to serve process coming to his hands and particularly wilfully and habitually failing and refusing to serve process and capias issued in connection with the violation of prohibition laws prior to and following the legislative enactment of the ABC system. It contended that the officer failed or refused to search premises where he knew, or had reasonable grounds to believe illicit liquor was stored or possessed for the purpose of sale.

The petition likewise charged that "on several occasions, since he entered the duties of Sheriff of Pitt county he corruptly conspired with notorious bootleggers in said county and extended to them a protection of his office in exchange in some instances for money and in some for illicit liquor, and further agreed to serve as stool pigeon for said bootleggers and keep them advised concerning activities of Federal prohibition enforcement and revenue officers who might be operating in Pitt county, and on numerous occasions made special trips in person or through his deputy, J. H. Harris, to homes of notorious bootleggers in Pitt county and advised them of the presence in Greenville of Federal prohibition and revenue officers and counseled them to remove illicit liquor from their premises, as to make impossible their discovery by the Federal agents."

The sheriff was likewise charged with having instigated a plan to thwart the efforts of officers employed by the ABC board and with instigating a mass meeting for this purpose held in the court house on February 9, presided over by D. M. Williford, member of the sheriff's counsel.

Another section charged the sheriff with undertaking to influence and in some instances bribe state's witnesses whose names appeared on the indictment against him in an effort to have the grand jury return not true bills and that certain witnesses had their board bill at a local cafe paid from funds provided by the sheriff.

In answer to the charges set forth in the petition, Mr. Williford de-

nied in its entirety every charge or allegation of misconduct or willful refusal or failure to perform duties on the part of the sheriff, and declared that the officer had at no time had any demands made upon him for any funds alleged to be due by him to the county and that he had been and still was ready to make settlement of any such accounts as audits might reveal were due the county by his department.

Referring to the allegations of any willful misconduct, maladministration, etc., in office, the answer declared that they are all "untrue, denied and falaciously false. And further answering the defendant expressly denies that the proceeding has been instituted in good faith at the instance of any good citizens of Pitt county, but the whole procedure has originated in bad faith out of the Board of County Commissioners, and at the instance of the chairman of the ABC board of Pitt county, who have instituted this procedure for the sole purpose of injuring, damaging, humiliating and coercing this defendant, and for the purpose of attempting to deprive him of his office to which he has been elected and repeatedly re-elected by the good citizens of the county of Pitt. That the petitioners well know or could have known by the exercise of reasonable diligence, that since the defendant has occupied the office as Sheriff of Pitt county he has always been diligent and alert in the interest of law and order in said county, and has always labored to the end that lawlessness would be suppressed, and that criminals would be brought to trial, all of which will be disclosed by a casual examination of the records of the office of the Clerk of Superior court of Pitt county and allegation, insinuation or implication to the contrary, is without foundation, false in fact, and made in bad faith."

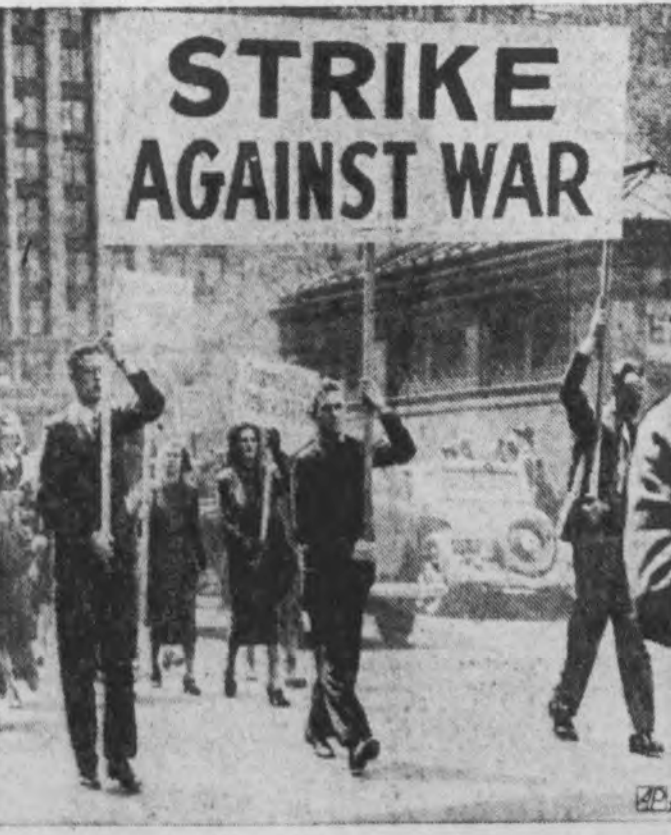

Hendays, France, May 9.—(AP)—Government counter-attacks and continued rainy weather slowed, but failed to halt, the insurgent drive on Valencia today.

Barcelona dispatches said Government militiamen, although forced to retreat at most point along the battle front from Teruel to the Mediterranean, had preserved their lines by orderly retreat and were as strong as ever.

The counter-attacks were made in three sectors where the insurgents broke through and threaten-

ed to exploit their gains in a general advance. By counter-attacking, the Government prevented its retreat from degenerating into a rout. Government communiques indicated some positions had been recaptured at isolated points.
