

BEGIN WORK ON UNIQUE FARMS

Robin Hood Planta- tions to be in Oper- ation Shortly

Raleigh, May 9.—The Hood Farms are due to be in operation soon through action of a group of leading North Carolina citizens who have taken the first steps in providing a 200 acre farm for the purpose.

Among those present were Thaddeus, Secretary of State; Kerr, Commissioner of Agriculture; E. Brown, State Vocational Director; Col. John W. Harrelson, Dean State College; I. O. Schaub, North Carolina Director Extension; Dr. J. O. Henry Highsmith, State Director High Schools; John Parks, Publisher Raleigh Times; Frank Jeter, Editor Extension News; Dr. Clarence Poe, Editor Progressive Farmer; T. L. Vaughn and D. F. Russell, President and Secretary-Treasurer respectively of Robin Hood Farms.

As a luncheon in the Hotel Sir Walter, they selected a group of elite citizens throughout the state, accepted as leaders, who will be invited to serve on a special advisory committee to aid in establishing unique vocational training project, calculated eventually to develop useful citizens and to contribute substantially to North Carolina's material wealth.

The name of the project is Robin Hood Farms. It is located near thehurst, and is dedicated to the making of efficient and upright North Carolina citizens from young men without means. The property covers 2275 acres, with 700 acres cleared for cultivation.

Conceived by T. L. Vaughn, a former business man of Winston-Salem, Robin Hood Farms are designed to furnish without charge a means where boys over high school age may learn practical farming.

Man About Manhattan

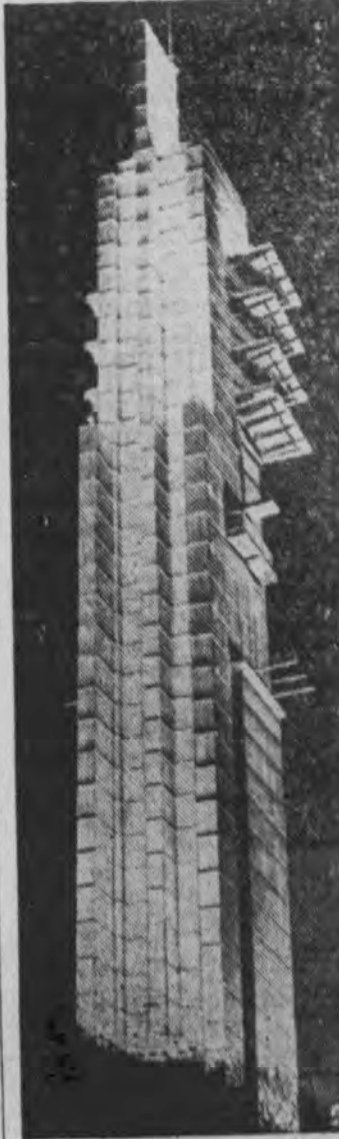

Census Report Shows Big

PART TIME FARMER INCREASE

Publication of a special Census Bureau study, "Part-time Farming in the United States," has resulted in hundreds of requests for this report which reveals that nearly 2,000,000 farm operators find it necessary to supplement their agricultural income by work off the farms.

As the families of part-time farmers are larger in size than the general average, there is a total population of between nine and ten million represented by this segment of our population. Since the farms are smaller in size and as they usually have somewhat less livestock, other members, as well as the head of the family, find work at occupations other than farming.

The back-to-the-land movement as well as the stay-on-the-land tendency of industrial workers have been aided by improved roads and increased use of automobiles. Distance is now measured in terms of minutes rather than miles. The search for greater security may be seen from the relatively large number of owners and former city dwellers among this type of farm operators, and their increase since 1930.

that following the Sheriff's visits his father would hide all his liquor and that shortly thereafter there would be a raid by the Federal officers. On one occasion, he said, Whitehurst himself helped his father hide the liquor in the fields before Federal officers raided.

On cross examination the witness could not remember dates including the years in which the instances referred to transpired. He admitted that he had first been questioned about the case by Nels and Beaman who came to Arapahoe to see him and that they furnished his transportation to Greenville and that his meals were being furnished him at the Dixie cafe. He denied, however, that he was paid for his affidavit or his testimony.

The third witness was Mrs. L. C. Wiggins, of Arapahoe, daughter of the late Jesse Smith. She testified that before her father's death she saw Sheriff Whitehurst visit him on several occasions. On one

occasion, she said, Sheriff Whitehurst was accompanied by other officers who came to raid and that the sheriff entered the field first and stood over five gallons of liquor, not concealing it from the other officers and sent them to other parts of the field to search. She also testified that on one occasion one o'clock she saw Sheriff Whitehurst and her father pulling a drag over the front yard of the home to wipe out car tracks because so many purchasers of liquor had visited the home during Christmas eve night. Following each of the Sheriff's visits, she said, her father would immediately hide his whiskey and soon thereafter there would be a raid by Federal officers.

On cross examination she testified that she was first questioned about the case by Nels and Beaman when they visited her at Arapahoe. She also admitted that she was furnished transportation to Greenville and was being given her meals at Dixie cafe.

The fourth witness was Alton Smith, a son of Jesse Smith. He testified that he accompanied his sister on the Christmas morning when they saw the Sheriff and their father dragging the front yard to cover the tire tracks. He also testified to having seen Whitehurst visit his father on other occasions and following each visit there would be a raid by Federal officers. On one occasion, he said, the Federal officers staged their raid only a few minutes after the Sheriff's departure.

On cross examination he stated that his affidavit was likewise obtained by Nels and Beaman. He said that he had been brought to Greenville from Arapahoe and that his expenses at the Greenville hotel had been paid while he was here. He stated that during his present stay in Greenville, he too was receiving his meals at Dixie cafe without expenses to himself. He likewise was unable to attach a date as to which Christmas it was that he and his sister saw his father and the Sheriff dragging the front yard.

The last witness on the stand yesterday afternoon was Noah Jones, of Tarboro. Jones testified that in 1931 he lived with Jesse Smith for four months. He said he saw Whitehurst visit Smith on several occasions and saw Smith give Whitehurst money. On one occasion, he said, Whitehurst was accompanied by other officers and they made a search but found no liquor.

On cross examination he stated that he had been brought to Greenville in connection with the case by Beaman, who had paid him approximately \$9.00 including his travel expenses and board. Questioned by defense counsel as to a letter he had written Sheriff Whitehurst to the effect that the prosecution had found that he (Jones) could do them no good, he denied that he had written such a letter. He stated that he could not read nor write and that he had requested a friend of his to write Sher-

iff Whitehurst a letter about getting the county to send him his pay for appearing here as a witness before the grand jury. When questioned as to whether or not he had signed an affidavit in the case he declared that he had signed some kind of an affidavit for Nels White and David Tripp but that Tripp had told him it was something about collecting some insurance on a policy carried by Jesse Smith.

This morning's first witness was Earl D. Smith, of Washington, son of the late Jesse Smith. The witness testified that he had seen Sheriff Whitehurst visit his father on one occasion but that he knew nothing of any transactions between the sheriff and his father nor had he ever seen his father give the sheriff any money.

On cross examination he stated that he was in Plymouth when Thomas E. Beaman came for him and left \$2.00 to pay his fare to Greenville to appear before the grand jury. He stated that when he got to Greenville Beaman gave him \$5.00 and told him if he would testify against Sheriff Whitehurst, he (Beaman) would give him money and a job. He said he had made a sworn statement before Assistant Clerk of Court E. F. Tucker to the effect that he had seen his father pay money to Sheriff Whitehurst on three different occasions, but that the said sworn statement was untrue in its entirety.

As today's second witness the state recalled Charles R. Smith who was the first witness to take the stand yesterday. Smith's testimony was to the effect that he operated a filling station across the river where he sold whiskey in 1932 and that Sheriff Whitehurst endeavored on several occasions to get him to testify that he had paid bribes to Thomas E. Beaman for Federal protection. He said he denied that he had ever paid such bribes and then Deputy Sheriff Harris came to him to get him to make such a statement. Again he denied that he had ever made such payments to Beaman and shortly thereafter his place was raided by Harris and he was indicted for selling liquor. The witness testified that both the Sheriff and Harris told him he would get out lighter in court if he would testify against Beaman. He said Harris told him if he did not testify against Beaman, he (Harris) would try to see to it that he was sent to the roads. On cross examination he admitted that he had been engaged in the liquor business and filling station business in this county and had been arrested by the Sheriff's officers several times and convicted twice.

C. O. Speight testified that four or five years ago he was engaged in the manufacture of liquor and that on one occasion he was raided by Deputy Sheriff Harris and Jim Jones, who took several wrenches and an axe from his still. He said he came to town and asked the Sheriff about them and he was told to

go see Harris about them. He said Harris sent him to Jim Jones and he recovered his lost tools. Asked on cross examination if he had ever been prosecuted for making liquor he declared that he always managed to be absent from his stills at the time of raids but that he had been raided several times and had his plants destroyed. Asked if he had had advance notice of raids he said he had not.

J. W. Thompson, of Stokes county, former Federal prohibition agent who operated in this territory, testified that on one occasion in company with three other men including Jim Jones, he raided the Jesse Smith place and found no liquor. He testified that on the way to the stage the raid, the car in which he and his companions met an automobile between the hard-surfaced highway and the Smith home and that as they passed Jones remarked "There goes the Sheriff."

On cross examination he was asked if he always found liquor when he went on raids and he said he frequently did not. He also testified that in company with Deputy Sheriff Harris and upon information furnished by Harris he had made one raid in this county in which liquor was found and a party arrested.

**RAIDS AIMED AT
CHINESE DEFENSE**

Jap Warships, Planes
Also Wage Intensive
Bombardment On
Gateway to Coast

Shanghai, May 11.—(AP)—Chinese reported today 4,000 houses had been damaged and 300 civilians killed and wounded in an air attack on Suchow, base of the huge Chinese army defending the Lung hai railway.

More than 300 bombs were said to have been dropped on the city, leaving sections of it burning fiercely. Japanese said large stores of military supplies had been limited. Japanese warships and planes also continued intensive bombardment of Amoy, gateway to Fukien province on the south china coast, where the U. S. gunboat Asheville and the British destroyer Diana stood by ready to evacuate Americans and Britons if necessary.

Fires were reported spreading through Amoy while 30 foreigners including 15 American missionaries watched and in comparatively safety from an island nearby.

The United States destroyer Edsall, ordered from Tsingtao to Amoy was due at Shanghai tomorrow for quick refueling. The destroyer Marblehead, en route from Manila to Hongkong, also was ordered to Amoy. Japanese marines occupied a section of the city had been reported after bitter street fighting. All hospitals were said to be filled to capacity as a result of the heavy firing from both sides.

A Japanese spokesman said 24 Chinese planes had tried to bomb Japanese warships off Amoy at the mouth of the Canton river, but had been driven off before they did any damage.

**Farmville Listed
For New Building**

Washington, May 11.—(AP)—The House appropriation committee in sending the new spending-lending program to Congress included 24 North Carolina postoffices in the list of projects eligible for construction under the proposed \$80,000,000 for new Federal buildings.

The committee explained the postmaster general and secretary of the treasury would select from the list the projects actually to be constructed and added the new building program is not confined to the 1,694 projects on the list, with an estimated total cost of \$71,436,000.

North Carolina projects listed and estimated cost of each include: Asheville, \$70,000; Farmville, \$70,000; Oxford, \$95,000; Plymouth, \$75,000; Scotland Neck, \$70,000.

**Says Woman Slain
By Hired Killers**

Canton, Ohio, May 11.—(AP)—The suicide note of Miss Theresa Ludwig says hired killers shot to death Mrs. D. S. Cable, a reliable source reported today.

The note was declared to set \$200 as the price paid for the shotgun blast which killed the Canton contractor's wife in March, 1937. Prosecutor Bathelme, who said he probably would make public later the letter's text, meanwhile was questioning a man who was quizzed, then released soon after the killing.

Miss Ludwig, 46-year-old divorcee who for several years was Cable's mistress, left the note when she committed suicide Monday in Cincinnati, Ohio.

In a brief statement, the first she had made since her daughter disappeared from a family picnic last Sunday while picking flowers, the mother said:

"I want notice given that anybody who has her should return her to any American Legion post anywhere, or bring her home. No questions will be asked."

The kidnap theory came after a fruitless search of the woods in which she disappeared and reports from Thomas, West Va., that a girl wearing clothes similar to Marjorie's, was brought there Monday by an unidentified man.

State Trooper Minnick of Thomas, said the man stopped in the evening at a hotel, took the girl to a room without eating, and left early the next day without giving his name.

Paul Valentine of Parsons, West Va., a hotel guest, said he was awakened by the girl's sobs and saw her in a dim hallway with a man. She wore a red hat, blue dress and had dark hair. She appeared to be three or four years old, he said.

**Court Likely To Evade

Raleigh, May 11.—The Supreme Court heard argument about the status of women as jurors in North Carolina, but when the argument was completed it appeared likely that the issue will not be determined in the court's decision of the case in point.

In the first place it seemed not at all unlikely that the court will grant a new trial to Ben Sims, Guilford Negro, under sentence of death for first degree murder, because the trial judge failed to instruct the jury that evidence of good character is a substantive defense to a felony accusation. Except for the fact that defense counsel at the trial failed specifically to request such a charge, there would be no doubt about the granting of a new trial. It seems however, there is a conflict of views as to whether the judge is obliged to give such an instruction of his own motion.

Of course, if a new trial is granted on other grounds there will be no decision of the Constitutional point raised as to service of women on juries; as the court never goes out

**Branded by Republican
Party as Threat
To Solvency**

Washington, May 11.—(AP)—Republicans attacked the administration's lending-spending program as a "threat to national solvency" today while a Democrat declared it was "much better" than any previous relief measure.

The Republican attack centered around an appropriation committee minority report. The report distributed to the press by the Republican National Committee referred to current business conditions as a "Roosevelt depression."

The House approved a Senate-House conference report meanwhile on the administration's billion dollar naval expansion program, overriding a brief outburst of minority opposition.

The measure, as revised in the conference, would authorize building 46 warships, 26 auxiliary vessels and one experimental ship at a total estimated cost of \$1,990,656,000. The compromise must be approved by the Senate before the legislation is ready for President Roosevelt's signature.

Other developments: A high administration official said that the President had decided to appoint John Hanes assistant secretary of the Treasury, but it was not known whether Hanes would accept the position.

The White House said President Roosevelt was powerless to settle the controversy over the sale of helium to Germany growing out of the refusal of Secretary Ickes to approve a sale contract without guarantees against its use in foreign military operations.

In Cyclone Time Try a Hitch
Topeka, Kas. (AP)—If a tornado or cyclone catches you too far from the nearest cyclone cellar, make a dash and jump into a ditch or depression.

That is the advice of S. D. Flora, federal meteorologist for Kansas.

A storm cellar or cave is the safest refuge, he says, but it's any port in a piraie "blow" and a depression in the ground where a person may lie flat usually brings the refugee through alive.

Com. Hood Reports
On Audit of Late
Cutlar Lee

Raleigh, May 11.—(AP)—Banking Commissioner Gurney Hood announced the total shortage of the late Cutlar Lee, former Bank of Fremont president of Fremont was \$57,196.10.

Hood said the amount was shown by a recent examination and audit. Lee, he said, committed suicide some time ago.

Hood's statement added: "In September, 1937, a shortage of \$2,498.77 was discovered in the accounts of John H. Hayes, then cashier of the Bank of Fremont. He was arrested, stayed in jail until the November term of court, was tried and was either placed on probation or his sentence was suspended. An additional shortage of \$3,370.64 has been found in his account."

Help of Federal Government in Grading Sought

Raleigh, May 11.—(AP)—Federal and State officials opened conferences here today from which it is hoped, Agriculture Department officials said, will come a system for "more equitable distribution of hog profits."

Kerr Scott, agriculture commissioner, asked Federal authorities for aid, and men from the U. S. Bureau of Agricultural Economics were sent here. "The conference," said Scott, "is designed to secure the help of the Federal government in grading hogs on a soft and oily basis as the present system is unfair to the buyer and seller. Now swine are graded by the representatives of buyers who obviously have a financial interest in the transaction."

**Direct Appeal In
Levine Abduction**

Last week Murray Levine, father of 12-year-old Peter Levine, who was kidnapped from his New Rochelle, N. **SEVERAL REBELS
KILLED IN RIOTS**

Short-Lived Uprising
Declared Have Been
Inspired by Outlawed
Green Shirts

Rio de Janeiro, Brazil, May 11.—(AP)—President Vargas, pistol in hand, personally led defenders of the presidential palace today as government forces swiftly smothered a fascist revolt against his authoritarian regime.

An undetermined number of rebels were killed or wounded and hundreds were arrested.

The short-lived uprising inspired by the outlawed Integralist (Green Shirts) faction, flared and died in the heart of the capital, where street disorders and futile assaults on public buildings marked its ineffective course. Martial law was decreed effective at noon today.

Police declared they had advance knowledge of the plotted rebellion and said they had even slipped agents into the ranks of the Integralist to follow more closely progress of the scheme to overthrow Vargas, ruler of Brazil since his seizure of power in his coup of November 10, 1937.

Authorities said Admiral Tavares had been arrested as a participant in the uprising.

A gun fight at the presidential palace between the besieging Fakists and Vargas' household staff highlighted the abortive rebellion.

The minister of war, General Dutra, was wounded slightly.

The rebels made an attack on the Pan-American airport near the center of Rio de Janeiro, but were beaten off.

The only brief measure of success the Green Shirts had was at the naval arsenal which was captured and held briefly.

Then a bayonet charge by a force of marines brought rebel surrender at that point and the rebellion collapsed.

**Cold Reception Awaits
Former King Of Kings**

Haile Selassie Rushes
To Geneva To Make
Appeal

Geneva, May 11.—(AP)—A cold reception awaited Ethiopia's titular King of Kings today at Geneva while England and France drove their plans through the League of Nations council to make peace with her Italian conquerors.

With the exiled emperor, Haile Selassie, on his way from London to make a dramatic personal fight against the two powers who were his leading champions three years ago, his advisors fought for delay with complicated questions of procedure.

Meanwhile, Chile's Ambassador to London, A. Edward warned the council Chile might quit the league carrying other nations with her unless action was taken on her demand for covenant reform.

He said the only way to bring the league back to full vigor was to cut out dead articles of the covenant and draw new ones. His speech was devoted to defense of Chile's plan, which was supported by Peru at last February's meeting of the committee of twenty-eight named to consider the league reforms.

Switzerland's demand for neutrality was presented by her delegate at the opening of the public meeting of the council.

Prosecution Attempts
to Show Sheriff Failed
to Turn Over
Money to County

The Sheriff Whitehurst ouster proceedings in progress here since Monday, swung into the third phase of the petition's charges this morning when clerks of court from several counties testified as to process from their counties served through the office of the sheriff of Pitt County.

This testimony was in connection with audits to be presented by the petitioners to support a charge that the sheriff failed or refused to turn over to the county funds and fees received by his office that belonged to the county. Total fees on the process covered by the three court clerks who testified this morning approximated \$75 to \$80 and extended over a period of ten years. In instances that paid checks were presented to show payment to the sheriff for services of the papers, the checks had been endorsed by the sheriff to the order of the county treasurer and deposited by the treasurer. The morning's proceedings also included one witness, a former prohibition officer, whose testimony was for the purpose of showing neglect of duty by the sheriff as it applied to enforcement of the prohibition laws.

Testimony Monday afternoon and yesterday morning dealt with the phase of the petition that charged the sheriff with accepting bribes from the late Jesse Smith for "protection" of Smith's bootlegging activities. Yesterday afternoon the testimony of witnesses dealt with the failure of the sheriff to perform the duties of his office as it pertained to bootlegging and other crimes in this county. While the petition contains charges of other instances of bribery and failure of the sheriff to perform his duties, the prosecution this morning switched its attention to the matter of alleged failure or refusal to turn over fees to the county, in order that the clerks of court here for the hearing might complete their testimony and return home.

Witnesses yesterday afternoon and this morning testified as follows:

On cross examination yesterday afternoon A. A. Nelms, detective employed by A. S. Batson, testified that he had known Batson since the summer of 1932. Replying to questions of defense counsel he denied any knowledge of Batson ever being engaged in the liquor business or having ever been convicted for any crime. E. Beaman when he went to Goldsboro last November to call on Beaman for the purpose of getting information from him. He further testified that Beaman, J. D. Tripp, Charles B. Smith and others had traveled to various points to get information and affidavits in his investigation of the sheriff's office. He declared that in no instance had anyone been offered any remuneration for a statement or affidavit.

W. C. Jones, who resides on the north side of the river only short distances from the Herbert Cox Filling Station, the Teel Camps and the home of the late Jesse Smith was placed on the stand to testify as to the general reputation of these places and that his purpose to close them up but his proposed testimony being hearsay was not admitted and he was permitted to retire without cross examination.

S. I. Dudley, also a resident of the north side of the river a short distance from Greenville, testified that about three years ago he had brought to the attention of Sheriff Whitehurst that the Herbert Cox filling station was being operated as a blind tiger and gambling joint and that the sheriff had promised him that he would look into the matter. Dudley testified that the next time he saw Cox he later was mad with him and would not speak to him. "It was about three years ago that I talked to the sheriff," he said, "but Cox's place did not improve until the ABC board raids last fall."

On cross examination he denied knowledge of the fact that more than a year ago Sheriff Whitehurst raided Cox's place and seized thirteen pints of liquor and brought Cox into court.

J. E. Winslow, of this city, testified that last fall tobacco was

Inter Se Club.
In her paper on "House Planning" Mrs. M. K. Blount stated at the meeting of the Inter Se Book Club Tuesday that good taste alone will dictate the right and appropriate thing in planning a home.

In introducing the paper, Mrs. Blount defined architecture as the art of so building as to apply beauty and utility. The end of architecture is to arrange the plan, masses and enrichments of a structure in such a way as to impart to it interest, beauty, grandeur, utility, and power without sacrificing convenience.

After exhibiting pictures of house exteriors, Mrs. Blount discussed architectural details involved in the entrance, the inside finish, the stairways, the closets and wardrobes, and the serving pantry of a well-planned home. Doorways are focal points and should have an interest and importance in proportion to the size and pretentiousness of the house.

Since inside finish is largely a matter of character, it should be of the same character as the rest of the house. The plan of the stairs is properly controlled by the plan of the house, or at least that part of the house immediately related to it. Whether closets or wardrobes are to be used, they should be thought of in the earliest stages of planning a house. The serving pantry should have combined in it the good proportion and beauty of the master portion of the house and the convenience and practicability of the service portion.

stolen from his farm across the river and that the men who stole the tobacco were arrested in Robertsonville but when returned to this county they were freed without any trial.

On cross examination Mr. Winslow admitted that the first information that led to recovery of his tobacco came through Sheriff Whitehurst, who notified C. T. Fleming, foreman of the Winslow farm, that the tobacco had been taken to Robertsonville.

C. T. Fleming then testified that on a night last November he was advised by Sheriff Whitehurst that tobacco believed to be stolen from the Winslow farm had been taken to a warehouse in Robertsonville. He said he advised Mr. Winslow and then went to Robertsonville and located the tobacco. The next day he was accompanied to Robertsonville by A. L. Tucker, another Winslow employee, and they located two of the men who had taken the tobacco to the warehouse. The men admitted the theft of the tobacco and at the request of Fleming and Tucker the Robertsonville police arrested them. Fleming said that upon his return to the city Winslow told him and Tucker to go to see the sheriff and tell him what had happened and he would look after the matter. He said his knowledge no one had asked for a warrant for the men.

noon liquor was still being sold in the neighborhood unlicensed.

On cross examination she denied that her testimony had been solicited, but declared that she had been informed by a relative that if she wanted to stop the liquor selling to report the matter to the ABC board, so yesterday she visited the ABC office in the court house and made her complaint and was ordered to appear in court today as a witness. While she testified that liquor was being sold freely in her neighborhood she admitted that she had not witnessed the actual sale herself.

R. L. White, employee of A. S. Batson during the ABC clean-up campaign in this county last fall, testified that he went with A. A. Nelms to visit several persons to get information and affidavits and witnessed the signing of several affidavits procured by Nelms. He said he was present when affidavits and statements were procured from Noah Jones of Tarboro, Mr. and Mrs. J. D. Tripp, J. T. Tripp and Mrs. Beulah Green. He declared that in no instance was anyone offered any inducement to make a statement or sign an affidavit.

On cross examination he said that he left the Batson employ before Christmas but that Batson was paying him while he was here as a witness at this time. Replying to questions of defense counsel, he said that Thomas E. Beaman was not working for Batson at the time he (White) left the Batson employ before Christmas.

On re-direct examination he stated that last fall after the undercover campaign had been completed he and Batson went to see the sheriff to seek his help and the sheriff told them that all their work seemed to be completed with the exception of serving the papers and that he would help in that.

The final witness of yesterday afternoon's session was Charles O'H. Horne, chairman of the Pitt County Alcoholic Beverage Control Board since its establishment in the summer of 1935. He testified that shortly after the board was established Sheriff Whitehurst asked him who was going to handle the enforcement funds designated by the legislature in the ABC act and stated that he felt as the highest elected officer in the county and the chief law enforcement officer, he should be the one to look after it. Horne said he told the sheriff he did not know what the procedure would be but that he would let him know just as soon as the board could get its stores in operation and have time to go into other matters. He said he told the sheriff he was sure that the ABC board would cooperate with him and would want his cooperation. The matter was later taken up with the board, he said, and it was found that under the law the fund could not be turned over to the sheriff. The sheriff was advised of this fact but was informed that the board wished to cooperate in every way with his office in any way possible. He testified that sometime later the sheriff informed him that he had expended the sum of \$167.72 from his own pockets in efforts to apprehend bootleggers and moonshiners and requested that the board reimburse him for these expenditures. His board, he said, passed a resolution that the sheriff be paid and that after some controversy with the Board of Commissioners over the matter, the item was paid.

Mr. Horne said a short time later his board employed D. M. Sellers as special investigator but that Sellers was without police authority and therefore the information gained through this source proved of little or no use to the board. He said that Sheriff Whitehurst said he could not deputize Sellers and use him in his organization, and the board finding itself without any means to enforce the law, discontinued the special investigator.

In the fall of 1936, the board recommended to the sheriff that J. M. Ward be employed and deputized as special enforcement officer but the sheriff refused to deputize Ward. Horne said. Then the sheriff advised the ABC board that if the board would furnish him two officers he would clean up the county to their entire satisfaction, and the board, complying with the request, the sheriff deputized J. L. Taylor and L. B. Tucker for this work. Horne said that these officers worked about three months under the sheriff and that they made satisfactory progress considering the short time worked.

When the 1937 legislature enacted laws making it possible for the ABC boards to employ their own officers with police power, Horne said, his board employed Taylor, who had worked the fall before under the sheriff, and J. M. Ward, previously recommended to the sheriff by the board. These officers made good progress in their work, he said, but the board, under the advice of the State Board, deemed it advisable to stage an undercover clean-up campaign in the county.

Horne said that when an undercover man was here making the survey he was using a Negro, Julius Price, as stool-pigeon, and that it came to his attention that the sheriff's officers were about to arrest Price on a liquor charge. He said he went to the sheriff and told him of the undercover survey and requested that he have his officers "lay-off" Price until the work could be completed. He said Sheriff Whitehurst told him that kind of person would get perjured testimony and that he would not have his officers "lay-off" Price. Price was arrested shortly thereafter, and Horne as chairman of the ABC board, stood his bond in order that he might be free to continue to aid the undercover agent. Horne testified that the sheriff did nothing to aid in the clean-up campaign.

On cross examination Horne denied that he had knowledge of any success of the Godwin-Heath campaign for which the board paid Sheriff Whitehurst \$167.72. He denied any personal desire or activity to get this sheriff out of office and also denied that he had resented A. S. Batson, undercover agent, for his failure to get enough on the sheriff to remove him from office. He admitted that the Taylor-Tucker campaign under the sheriff's direction did get some results and that during their campaign frequent reports of their activities were made to his board.

it is one of the type of issues which may flame up high during the legislative session next year.

Authority for this exemption was voted by the people in the fall of 1936 and its advocates are yelling loudly for the law makers to follow the "mandate" of the electorate. County governing authorities are unanimously and everlastingly opposed to it and it would take a real political miracle to put it over yet some are likely to ride the issue right into the legislature.

As for diversion, here's a question that is going to be heard from now on. The North Carolina Petroleum Industries Committee (oil lobby you) has organized in every county of the state and is dishing the doctrine of No Diversion into every ear. It's a siren song and seems to be generally regarded as sound in principle; but whether or not the Legislature will submit an Anti-Diversion Constitutional amendment to the voters remains to be seen. Out loud, at least, there are no defenders of diversion in theory, even its strongest advocates present it only as a disagreeable necessity.

Governor Clyde R. Hove and Superintendent of Public Instruction Clyde Erwin are battling hard for a Twelfth Grade in North Carolina's public schools. There is no organized opposition and the only thing which can possibly defeat the pro-

le is a vote of the legislature, which is always controversial matter; the legislature. What will be done about increasing them depends far more on economic conditions next January than on anything said or done now.

A committee appointed by Governor Hove at the instance of the last General Assembly has been studying the matter of establishing a State Department of Justice, and will report its findings before the meeting of the next. Then there will be quite a fight about establishing one and about what its powers shall be, if it is established.

Feature of the new intangibles tax policy, no yield anything like the \$2,000,000 estimated while the 1937 Assembly was in session, has already brought a howl for return of this taxing privilege and its resulting revenues to counties and cities, which this year got but half the receipts.

The new taxes and the innovation of giving the state half of their yield were put over last time only because it was thought that the local units would receive as much for their half as they had previously received from the whole.

Now the League of Municipalities and the Association of County Commissioners are calling for the return of these tax revenues.

A complete overhauling of the present method of selecting Justices of the Peace has been proposed and has received the endorsement of the Bar Association. Grave abuses have attended the custom of appointing J. P.'s by legislative fiat but it still remains to be seen whether or not members of the General Assembly are going to allow one of their best methods of rewarding friends by appointment as J. P.'s to be taken away from them by their own act.

In the last legislature there was quite a movement to repeal present tax provisions which allow exemption of revenue-producing property owned by religious, charitable and fraternal organizations, even where the property is rented in direct competition with individuals who have to pay the taxes. The movement, in the final showdown, got nowhere at all, but it is likely to make a return appearance next January in graver form.

Many candidates for the Assembly are being sounded out on their position on these many and varied issues, and almost every one of them there is some organization.

In addition to all these issues there will also be labor regulations (hours, wages, etc.), bond issues for highway purposes, and other old familiar questions to plague the legislative mind.

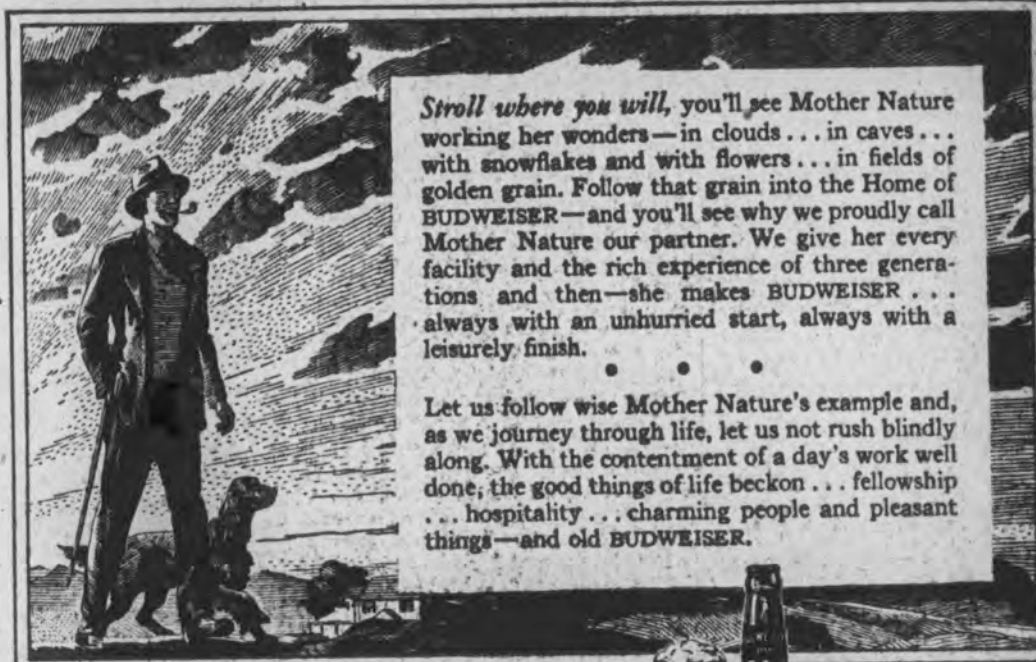

Washington Daybook

By PRESTON GROVER

Washington—Helium is an in-
ert gas that neither burns nor explodes
but it has heated up a controversy
nevertheless, between placid Sec-
retary of State Hull and the so-
called Secretary of the German Em-
bassy is something of a bewildered
bystander.

To begin at the beginning, the
United States is the world's No. 1
helium producer. We almost have
a monopoly. The center of the
business is Amarillo, Tex. It comes
up in wells with gas and oil.

While it won't lift as much as
hydrogen when used in balloons
and zeppelins, neither does it ex-
plode if a lightning bolt strikes it.

When the German zeppelin Hin-
denburg burned last year as it
moved into Lakehurst's naval air-
station, its inflammable hydrogen
killed 33 persons. In a sympathetic
mood, Congress authorized the
sale of helium to foreign countries
provided it first was determined
that the shipment would not be-
come a factor of "military im-
portance." Of course Germany was
the only nation wanting much of
it for airships and soon completed
negotiations with the State De-
partment for about 36 million cu-
bic feet to be delivered in the next
two years.

Germany set about reconstruct-
ing its new giant zeppelin to adapt
it to helium and the Navy gave
implied approval by extending to
Germany again the permission to
use Lakehurst for a landing field.

He Doesn't Like Hitler
All this went on without Ickes
being taken into consideration. But
as Secretary of the Interior he is
in charge of the Bureau of Mines,
to which control of helium was as-
signed, and he considered it his
job to determine whether helium
was of military importance to Ger-
many.

Ickes in several speeches has
made it plain he dislikes Hitler.
He has left no brick unthrown.
When he found reasons for refus-
ing to ship the helium, observers
promptly traced the delay to Ickes
dislike of Dr. Goebbels, regardless
of whether that was just to Ickes.
Publicly, Ickes explained 6,000-
000 cubic feet of helium would fill
a zeppelin, so why should Ger-
many want 36 million? Also he
pointed to testimony of General
Westover, chief of the Air Corps,
before a House committee. The
General had said the Army learned
during the World War that it had
been Germany's intention to
send a zeppelin on a raid over New
York.

On that basis, Ickes refused to
let loose a cupful of helium. Count
Ekener, the famed zeppelin com-
mander, started from Germany to
make a personal appeal, but Ickes
was unshaken. He said he would
be glad to meet him, but could not
permit personal considerations to
influence his decision. He has
asked the Navy and State Depart-
ment for more information.

What—No Beer?
Meantime the German Em-
bassy called off its annual book
party for the press and others, let-
ting it be known that it did not
wish to appear to be using sub-
versive influences. A few thought
it looked more like retaliation. Oth-
ers hinted it was helium retaliation
when Germany suspended pay-
ments on Austrian bonds owned in
the United States.

The State Department hides its
displeasure as best it can after
being put in the position of welch-
ing on an agreement to permit
helium shipments. Ickes, on the
other hand, seems to enjoy the sit-
uation.

A current surmise is that the
President will intervene and Ger-
many will get at least part of the
helium it wants.

SHORT SHOTS

By HENRY AVERILL

Raleigh, May 11.—State Treasurer
Charles M. Johnson has issued a
statement opposing, in theory, Pres-
ident Roosevelt's proposal to remove
by legislation the tax exempt fea-
tures now possessed by Federal,
State, county and municipal bonds
from all future issues.

But, just as was forecast some
time ago by this bureau, he says in
effect that North Carolina just isn't
interested—we aren't going to issue
any bonds or do any borrowing in
the near future.

"From the best information I
could get, such a bill will hardly be
passed at this session, but it will be
done in the near future," said the
Treasurer in his statement.

"I see no reason why the State
of North Carolina or any of its local
units should borrow much money
for several years to come. We are
paying our debts instead of creating
new ones and we shall continue to
do so.

"We have approximately \$16,000-
000 of North Carolina bonds now in
our Sinking Fund and the local units
in the state have approximately
\$12,000,000, making a total of \$28-
000,000. If the bill passes we could
sell those bonds and purchase new
issues of United States government
or other state bonds at a much lower
price and therefore be able to make
a very fine profit, since the new
bonds would not be taxable in the
hands of the State of North Car-
olina or its subdivisions."

Justice Heriot Clarkson, the Su-
preme Court's oldest member, just
simply will have his little joke, even
in the midst of solemn court proced-
ure. While Sidney J. Stern, young
Guilford lawyer, was arguing that
women are not only eligible to serve,
but must serve on North Carolina
juries, the point was raised whether
the term "men" in a section of the
Constitution was meant in a generic
or narrow sense.

"The term 'men' must include
women," said the Justice with a
perfectly straight face. "Because we
know that men embrace women."

First case argued before the Su-
preme Court by Harry McMullan in
his new capacity as Attorney Gen-
eral, was the Sims case in which the
contention was that not to include
women on North Carolina juries is
to deny defendants "due process of
law."

A Robeson county lawyer was tel-
ling the Supreme Court just how
much land he owns and how he
loves to "mess around" on it, and
what a fine farmer he is.

"Of course, I don't get much time
to give to it and I don't do much
of the work myself," he was saying.
"Then you're an agriculturist,
not a farmer," smiled Chief Justice
Walter P. Stacy.

From all indications, Utility Com-
missioner Stanley Winborne is going
to devote considerable of his time
between now and June 4th to a
rousing campaign for his reelection.
To date he has stuck pretty close
to his office, with only a trip or two
here and there; but from now on
it's likely to be different.

The Commissioner obviously does
not fear the candidacy of Paul
Grady of Kenly, but he isn't going
to take any chance of losing because
of over-confidence and failure to
put out an effort.

An experienced political observer,
just back from a trip through the
western half of the state, tells your
correspondent that Libby Ward,
Craven's Representative, is making
surprising progress in his campaign
for Speakership of the 1939 House.
Libby, this fellow says, made
friends, even among the adminis-
tration followers by his show of in-
dependence in the 1937 House when
he kicked over the traces on the
question of counties bearing any
share of the Social Security burden.

STATES RULES FOR BENEFITS

Beneficiary Must Re-
port Earnings, Ac-
cept Work

Raleigh, May 10.—Two things we
will require of claimants for bene-
fits under the State Unemployment
Compensation Act are that they re-
port in full any earnings during
the week for which they are con-
tinuing their claims, and that they
take any suitable work offered them," said Chairman Charles G.
Powell today.

"We have been holding hearings
in the strawberry area and have de-
prived claimants of benefits tem-
porarily because they refused to
accept such work was held suitable for
them," said Mr. Powell. "The same
policy will hold in farm and other
seasonable work, such as picking
of dewberries, gathering potatoes, work
in tobacco, or any other kind of
work. Naturally, we do not require
a bookkeeper to dig ditches, or a
clerk to pick berries, but when work
is suitable, in line with the claim-
ant's former work and pay, then he
must take the job, or the commis-
sion will have to penalize him."

"Also, we have to invoke the law
and now have several claimants on
the roads or under suspended sen-
tences, for failing to report earn-
ings in weeks when they filed con-
tinued claims, or reported earnings
less than their actual earnings. A
few claimants may get by with such
reporting for a time, but their viola-
tions will get them finally. They
will be caught in the end for vio-

lating the act," Chairman Powell
said.

MUCH COVERED BY PROBATION

State Law Made Applicable to All Offenders

Raleigh, May 10.—North Carolina's probation law, which was put into effect November 1, 1937 after enactment by the legislature of last year, has been made applicable to all sorts of offenders; all sorts of offenses and under many and various conditions, according to the first summary of activities issued recently by Director J. H. Sample.

Outstanding, perhaps, in the report is the economic advantage of the system shown by the fact that probationers are accurately found to have earned a grand total of \$24,493.13 during the period November 1 to March 31, 1938 covered by the report.

These earnings do not include 127 farmers whose income is seasonal, 17 students who were not employed, 20 housewives and domestic workers with no salaries or cash earnings.

This left 378 probationers to work a total of 17,231 days or 56.7 per cent of the total possible working days for them.

Meanwhile the living expenses of the probationers and 752 known dependents (71 partially and 681 wholly dependent) were \$19,735.79; leaving a surplus of nearly \$5,000 in earnings over living expenses.

The 542 probation cases came almost equally from the Superior courts and from courts of inferior rank, with 284 from the former and 258 from general county and recorder courts.

Probation was applied in the case of white prisoners much more often than for Negroes, the report showed, with 403 white males and 22 white females, against 83 Negro males. Two male Indians were put on probation and the race was not stated in 14 cases.

Of the probationers, 286 had been convicted for the first time, 116 had one former conviction, 38 had 2, 19 had 3, 10 had 4, 8 had five, one had 6, and 11 others had more than six previous convictions, one as many as 27.

When the conventional number of speeches are made the entire series will be played consecutively at each end, and two boards of judges will determine the winner.

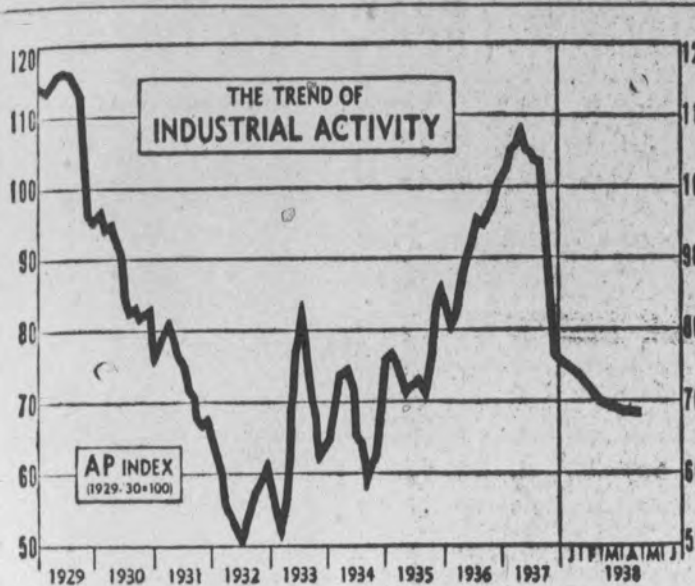

New York.—(AP)—Industrial activity dipped slightly during April as the above chart indicates. The Associated Press seasonally adjusted index dropped to 68.3 per cent of the 1929-30 average from 68.6 last month and 105.5 a year ago. This was the smallest monthly decline since the recession got under way last fall.
