DEFEAT MOVE LIFT EMBARGO AGAINST SPAIN

Nye Resolution Tabled by 17-1 Vote of Committee

AGREE HOWEVER TO HEAR AUTHOR

Sen. Pittman, Out of Capital, to be Given Opportunity Make Statement Later

Washington, May 13. — (AP)—The Senate Foreign Relations Committee voted 17 to one today to table the Nye resolution which would lift the embargo on United States shipments of arms to the Spanish government. It acted after Secretary Hull opposed action at this time.

Chairman Pittman (D-Nev.) of the Foreign Relations committee said the committee's action meant action on the Nye resolution had been "postponed indefinitely." This usually is tantamount to killing a resolution.

It was not immediately disclosed which member of the Foreign Relations group voted against delaying action.

Pittman said he had arranged to permit Senator Nye (R-ND), who now is out of the city, to appear before the committee next week to make any statement he wishes on behalf of the resolution.

The Nevada Senator asserted, however, it was highly unlikely the committee would reconsider its action.

Secretary Hull had told the Senate committee in a communication today that "from the standpoint of the best interests of the United States and the circumstances which now prevail, I would not feel justified in recommending affirmative action on the resolution under consideration."

Annual Meet Held by Home B. and L.

The Home Building and Loan Association of this city held its 32nd annual shareholders meeting at the Sheppard Memorial Library on May 10th, at eight o'clock.

Dr. L. C. Skinner, president, presided over the meeting. After the roll was called it was ascertained that \$972,000 worth of stock was represented either in person or by proxy. The president called on J. J. White, secretary-treasurer, to make his annual report.

Mr. White reported that the association showed an increase in assets of over \$125,000 during the last twelve months, after having paid out to shareholders in maturities \$121,500. The report also showed that the association loaned to shareholders during the last twelve months \$234,000. The surplus of the association was increased \$12,500 after shareholders were paid \$22,510 in dividends during the year 1937.

The president called on several shareholders that were present to make short talks. Following these talks the shareholders elected the directors as follows:

Immediately following the shareholders meeting the board of directors met and elected the following officers for the ensuing year: Dr. L. C. Skinner, president; Dr. J. C. Greene, vice-president; J. J. White, secretary and treasurer, and W. W. Lee, assistant secretary and treasurer.

CHURCH UNION BEING SHAPED

Most Far- Reaching Movement Since the Reformation

Utrecht, The Netherlands May 13. (AP)—An historic church document aimed at the most far-reaching union of Christian churches since the reformation emerged from a world conference of churchmen representing 130 protestant denominations.

The document is the draft of a constitution approved unanimously by 75 delegates from 20 nations, including the United States, for the first world council of churches in history.

It will be submitted at once to all participating churches by the Archbishop of York, who presided at the five day conference adjourning today.

An accompanying letter will ask the churches to unite in the organization for "the fellowship of churches which accept our Lord Jesus Christ as God and Savior" and send delegates to the proposed council meeting.

Delegates here represented directly about 32 denominations—and spoke also as the elected representatives of 130 protestant bodies. A council meeting every five years and an annual meeting of a central committee would be open to all Christian churches.

The Roman Catholic church, however, has taken no steps to participate in the movement.

The council assembly would consist of 450 members. There would be 90 delegates to the central committee, including 18 from the United States and Canada, of whom five would be lay delegates.

Because of his long work toward formation of the council, the Archbishop of York was considered almost certain to be elected its first president.

TRUCK DRIVER WRECK VICTIM

Gastonia Man Burned To Death After Collision

Laurinburg, May 13.—(AP)—A truck driver identified by papers in his pocket as Edward R. Huddleston, or Judy Huddleston, 29, of Gastonia, was burned to death when two gasoline trucks collided on a bridge at the Ida mills, six miles north of here early today.

Huddleston's truck, westbound from Wilmington with 4,000 gallons of gasoline, caught fire almost instantly. The driver's body was later pulled from the water near the bridge.

The other truck, driven by Thomas Booser of Charlotte, exploded, but the driver escaped without serious injury.

CHINESE WAR BABIES NAMED FOR STRIFE

Hankow, China. —(AP)—Hostilities may be over by the time they grow up but, thanks to their patriotic names, many Chinese children of the new generation will never be allowed to forget that they came into the world as war babies.

"Born-at-War-Outbreak" is one of the names given infants who arrived during the early days of the struggle. Other children must go through life answering to such names as "Resist Japan" and "Remember Peiping." For girls babies "Battlefield Flower" is popular.

JAPS STRIKING ALONG LUNG'Y

Predict Fall of Central Front Lifeline By Dawn

Shanghai, May 14. (Saturday)—(AP)—A Japanese army spokesman predicted early today the east-west Lungshai railroad, China's lifeline on the central front, would be cut before dawn.

Japanese dispatches from the front said a vanguard was striking swiftly through the darkness within a few miles of the Lungshai to cut the month-long bloody race to cut the railroad and close Japan's net around China's armies.

Shock troops attacking north through Honan province were said to have crossed the border into Kiangsu and to have reached a point 13 miles west of Suchow, the goal of Japan's campaign.

Japanese warplanes loosed many tons of explosives yesterday (Friday) on the central China front in an effort to speed the advance of a dozen Japanese columns boring steadily toward the vital Lungshai railway from the north and south.

Hardest hit by the bombardments was a point 45 miles south of Suchow on the Tientsin-Pukow railway, where the Japanese made three smashing raids.

Further to the west Japanese warplanes leveled the Chinese defenses at Yungcheng, enabling Japan's troops to capture the city and placing them in a position to advance on Tangshan, Lungshai railway station. (Continued on page six)

LIGHT DOCKET IN CITY COURT

Only 6 Cases Brought Before Judge Darden Today

Judge W. A. Darden disposed of a comparatively light docket in City Recorder's court this morning only six cases having been heard at the session.

Jim Thorne, Negro, was convicted of drunkenness and assault and was given a 30-day road sentence, suspended upon payment of the court costs.

Reuben Vines, Negro, convicted of drunkenness and indecent exposure, was given a 30-day road sentence, suspended upon condition he pay a five dollar fine and court costs and remain of good behavior for one year.

Charges of assault with a deadly weapon against Mildred Nymman Gaidilia Hyman and Kenneth Hyman were dismissed.

Bernie Hardee, white man was convicted of drunkenness and was ordered to pay the costs of court.

A charge of engaging in disorderly conduct and using profane and vulgar language was dismissed against Thurman Matthews, but James Sharp, indicted jointly with Matthews, was convicted and given a 30-day sentence, suspended upon payment of costs. Both defendants were Negroes.

Joe Dupree, Negro, was convicted of drunkenness and given a 30-day road sentence, suspended upon payment of court costs.

RECESS TAKEN IN WHITEHURST OUSTER TRIAL

Today's Session Taken Up with Evidence By Auditor

CASE TO REQUIRE SOME TIME YET

Evidence Presented Today Intended To show Sheriff Collected Excess Jail Fees

Judge G. Vernon Cowper, presiding over the proceedings in the petition of B. M. Lewis, Roy T. Cox, David T. House, L. Walter Cherry and Frank M. Kilpatrick, members of the Board of County Commissioners, seeking to oust Sheriff S. A. Whitehurst from office, recessed court this afternoon until Monday morning.

The hearing got under way here last Monday morning and when the week-end recess was taken this afternoon only a portion of the evidence of the petitioners had been presented, indicating that the hearing would be a long drawn out affair.

In the petition the sheriff is charged with misconduct and maladministration of the affairs of his office, failure or refusal to turn over to the county certain fees belonging to the county, extortion and bribery, collecting fees from the county for board of prisoners in the county jail after they had been transferred to other penal institutions and with protecting bootleggers and giving them advance notice of raids by Federal officers. The petition was read at the opening session of the hearing Monday morning and the sheriff's answer to the same was that the charges were untrue and denied, were "maliciously false" and a concocted scheme to embarrass him and destroy the confidence of the people of the county in him.

Monday afternoon and Tuesday was taken up with witnesses testifying on the bribery angle of the case, a portion of Wednesday was taken up with witnesses whose testimony pertained to the failure of the sheriff to carry out the duties of his office as it applied to the arrest of bootleggers and other law-breakers. Since Wednesday afternoon the time has been consumed with the presentation of documents and records as exhibits upon which the testimony of auditors will tend to show the sheriff's failure to turn over fees to the county and his overcharge against the county for feeding prisoners confined in the county jail.

Today's only witness to take the stand was L. R. Ausbon, public accountant in the employ of Williams and Wall, public accountants, who have made recent audits of the (Continued on page six)

Belgium Cabinet Resigns In Face Of Tax Problems

Government Sought To Levy Additional Taxes

CATHOLICS BALK AT HIGHER LEVY

Cabinet Succeeding that of Paul von Zeeland Been in Office Only Five Months

Brussels, May 13.—(AP)—The Belgian Cabinet, headed by Premier Paul Janson, resigned today after five and a half months in office.

The cabinet was formed November 24, 1937, succeeding that of Paul von Zeeland.

The resignation was due to differences over the government's tax proposals, designed to balance the budget.

The cabinet was a coalition of Janson's own Liberal party Socialists and the Catholic party.

The present crisis, threatening for some time, came to a head when Catholic ministers refused to participate further in the government.

Catholic members of the Chamber of Deputies Finance committee had opposed government plans for higher taxes, maintaining economic should be effected first.

The Catholic party is second largest in the Chamber, where Socialists rank first in number of seats.

Von Zeeland Resigned October 25 to defend himself as a private citizen against charges of his political enemies concerning administration of the national bank when he had been its vice governor five years before.

Janson, upon taking office, outlined a program of far-reaching internal reform and declared his government would continue Belgium's middle-of-the-road course in European politics.

Seek Remove Exemption From N. C. Property Tax

Raleigh, May 13.—A definite and determined effort will be made in the next General Assembly to make mandatory the taxing of revenue-producing property owned by religious, charitable and fraternal organizations; but prospects for success of such a drive are none too bright.

Reason for this skepticism lies in the organized and always-effective opposition sure to develop from the organizations which would be affected.

In the 1937 General Assembly an amendment was introduced to the Machinery Act which would have had the effect of doing away with the current exemption of this revenue-producing property; but the amendment was beaten overwhelmingly, 57 to 25, when strong pressure was brought to bear on House members.

The pressure was applied very notably, according to authentic reports, by representatives of Duke University, and of the Odd Fellows in Raleigh, where the I. O. O. F. where

SPANISH CITY AGAIN BOMBED

Barcelona Subjected To Two Attacks in 19 Hours

Barcelona, May 13 (AP)—Bombed twice in 19 hours, this capital of Government Spain today counted 60 dead and about 150 wounded as the cost of a new wave of insurgent aerial attacks.

A dozen persons were killed and 40 injured this morning when six Junkers swept in from the Mediterranean at about 16,000 feet, split into two groups and bombed the southern part of the city.

Many bombs fell into the sea, but caused casualties even there. About 20 men and women, gathering mussels, were wounded.

The small craters left in Barcelona streets indicated the bombs were not so large as those used in the fierce attacks which took hundreds of lives in March.

An unfinished concrete building used as an air attack refuge was struck. The explosion ripped the reinforced concrete, killing one and injuring others of the group that had sought safety there. The raid was quickly over and even before signals ended the alarm, people resumed working, strolling or drinking in the cafes.

Meanwhile Hendaye, France, reported that the wings of the Insurgent advance that has conquered nearly 600 miles of territory in three days were linked as General Franco's troops forced their way into the outskirts of Foranete.

General Miaja's Government militiamen retreated slowly into the hills, leaving a network of secondary roads from Tuel to the Mediterranean as a crescent-shaped insurgent front.

SENATE SENDS NAVY MEASURE TO PRESIDENT

Congressional Action Completed on Billion Dollar Bill

PENDING SINCE LAST FEBRUARY

President, Meantime, Expresses Hope Of Preventing any Further Depressions

Washington, May 13. — (AP)—The Senate passed and sent to the White House today the administration's billion dollar naval expansion bill.

The measure, pending in Congress since February, authorizes construction of 46 new fighting ships, 26 auxiliaries and 950 airplanes. Funds to carry out the program are to be appropriated later.

Separate bills originally were passed by both chambers. A joint committee worked out a compromise carrying authorizations estimated at \$1,090,000,000 and this was approved in the House by a 67 to 31 vote Wednesday.

Three new battleships and two 20,000 ton aircraft carriers are provided by the compromise bill.

President Roosevelt expressed the hope, meanwhile, that Congress in its coming anti-monopoly study would cover methods of preventing future depressions through avoidance of unabsorbed inventories and unwarranted high prices in some commodities.

He made this remark in denying that his administration's original lending and spending program was a failure.

Asked at a press conference whether he had any definite program to combat surplus inventories and high prices, the President said he had not, but this was part of the anti-trust study he recommended to Congress.

Other developments: Senator King (D-Utah), told the Senate he would ask shortly a congressional investigation of the administration of relief under Harry Hopkins, WPA administration.

King made this statement after Senator McCarran (D-Nev.), said "No one dares to ask any investigation" of WPA.

The President nominated Harry Slattery of South Carolina, today to be Undersecretary of the Interior, succeeding Charles West.

Appointment of Slattery, now a personal assistant to Secretary Ickes, in the Interior Department, went to the Senate shortly after the White House announced West's resignation.

State's Forestry Division is Praised By U. S. Inspector

North Carolina Found to be Protecting Largest Number Acres With Least Expenditures

Reflector Bureau.

Raleigh, May 13.—Recent inspection of the forestry division of the Department of Conservation and Development brought praise for the personnel from inspectors sent into the state by the United States Forest Service.

"It is very apparent that forest fire law enforcement in North Carolina is being exceptionally well handled and that the program is producing fine results," said the inspector.

The periodic U. S. inspections are made to check up on how the federal allotments for forestry work are being spent, according to Assistant State Forester W. C. McCormick, in charge of forest fire control.

At present more than 13,500,000 acres of forest land in this state are being protected under the cooperative forest fire program. There are 58 counties in the program, which is one of cooperation and participation by federal, state and county authorities. Expenses are shared jointly.

More counties are now anxious to cooperate, said McCormick, but there are at present no state and federal funds available for taking on any additions. There are a good many private cooperative protective associations participating in the program.

The state is now protecting a larger number of acres with less money than in any other southern state, and the per acre cost of the program is the lowest, with the exception of Alabama and Mississippi.

Estimates are that the cost of protecting forest lands in North Carolina is something like three-tenths of a cent per acre, on a basis of the state appropriation for the purpose.

For the past few months the forest fire situation has been near a crisis on account of the unusually dry season. Forest wardens have been forced to work indefatigably in order to keep losses and burned-over areas from reaching new highs.

HINTS TO HOUSEWIVES

Want to use up leftover Easter eggs? Stuff them with any of the following: sardines, caviar, cream cheese, grated cheese, chopped ham or tongue, chutney or pickle relish; chopped olives, cooked fish catsup or chili sauce. Remove and mash the yolks with a fork. Add seasonings, a bit of salad dressing and one of the chopped foods mentioned. Roughly refill the egg cases and chill. Garnish with parsley, cream, pimiento strips, olive quarters or paprika.

Use fruit juices to cut the excess fatty taste of baked pork or ham. A ten-pound ham needs two cups of grape juice mixed with a third of a cup each of pineapple, orange and lemon juices. Bake every fifteen minutes.

Make a trayful of Easter eggs out of cake for the buffet table. Cut two-inch squares of yellow cake. Roll each square first in faintly-tinted frosting, then in coconut. Allow the eggs to set on waxed paper.

Scrambled eggs, served with browned sausages poured over cooked noodles, make a tempting main dish for luncheon or supper. The combination is quickly prepared, filling and economical.

Flour and sugar are very sensitive to moisture. They should be stored in covered containers and kept in a dry place.

If your custard recipe calls for a third of a cup of granulated sugar, substitute the same amount of brown or maple sugar or a fourth of a cup of honey for the sugar.

PEACE COUNCIL HOLDS SESSION

Regular Meeting Held At the Presbyterian Church Study

The Greenville Council for Peace Action held its regular meeting last night in the study of the First Presbyterian Church, with the Rev. R. C. Grady presiding. There were present representatives from all but two of the organizations associated with the Peace Council.

Announcements were made of material available from the National Peace Conference of which the local council is a member, and from the Southern Council of International Relations with which the Greenville council is affiliated. The most important business of the evening was the discussion and adoption of a constitution, part of which follows:

Preamble: Confronted by powerful forces that are leading the world toward another great war, the Greenville people and organizations working for national and international peace, realize as never before that they must more effectively coordinate their efforts.

Objectives:—The objectives of the Greenville Peace Council shall be to coordinate with the Peace activities of its members; to discover and enlist groups not active in the Peace Movement; to undertake joint projects for peace education and peace action.

The Council will not commit all or any of the member organizations to any peace policy unless express consent has been given; but it will seek so far as possible to assist the peace activity of any member organization if such assistance is requested; at the request of any member organization which is seeking to promote some specific peace project the Council will call the attention of the other member organizations to the endeavor; and further, when ever any special peace project or effort is proposed to the Council, it will, if the executive committee approves, endeavor to ascertain what member organizations are in agreement, and then will seek to coordinate and develop procedure so that common action may be taken.

Membership:—The Council is intended to be definitely representative in character. Any group or organization which has as one of its purposes the promotion of peace and international understanding and good-will shall be eligible to membership.

The present membership of the Council comprises the A. A. U. W., Rotary and Kiwanis Clubs, Junior and Senior Woman's Clubs, P. T. A.'s of all the Greenville schools, the Greenville Ministerial Association, and the women's organizations of the churches.

WHAT IT MEANS:

The New Third Party

Washington—Ask young Bob La Follette what this new National Progressive party is all about, and he tells you it is primarily a personal invitation to Mr. Liberal Voter who doesn't feel at home with the Democrats and Republicans. No disgruntled Socialists or Communists need apply.

Senator Bob La Follette and his brother, Governor Phil, co-founders of the party, are practical politicians; they know the radical stamp is no good for all-around vote getting anywhere in the United States.

Then ask Young Bob why the baby party was launched at this particular time, and you'll get a lot of interesting reasons that haven't yet appeared on the record.

"Fact is," explains Young Bob seriously, "a real American liberal is not getting a square deal from either of the major political parties right now. The conservative wings of both the Democratic and Republican parties are play-

ing hob with President Roosevelt's progressive 1936 platform. The Democratic party in particular is divided, and the program the party pledged itself to carry out is in danger.

'Sabotage' By Conservatives

Young Bob tells you he thinks a majority of voters in this country approved the Roosevelt 1936 platform when they re-elected the New Deal President. He believes the conservatives are sabotaging the program—the same conservatives who pledged themselves to carry it out.

"We are assuming," he goes on, "that the majority still wants a liberal, progressive program and they want it as soon as they can get it. We simply are offering them the opportunity to get the job done."

"Only the broadest outline of a platform has been presented. Details, candidates—all of that comes later, depending on the support we get. Principles we have stated. The program itself must come to us from the people who want this party."

Puts It Up To Voters

Young B. takes off his horn-rimmed glasses. He looks for all the world like a business man discussing a sales campaign—not at all like a spell-binder trying to work up the emotions of voters.

"The demand for this party is right here," he says, waving his hand toward the Senate. "It has been growing for a long time. Why, in my 13 years on Capitol Hill, I have seen one single strictly party vote. Ask any Congress-

man what his politics is, he won't tell you he's a Democrat or a Republican, he'll tell you what kind of a Democrat or Republican he is. When parties get that way, they are no longer hanging together.

"But you can't expect a new political party to grow like Topsy. Somebody must express the principles. Somebody has to write a general outline. We have only made a beginning. We have no specific campaigns in mind. We don't have our eyes glued on 1938 '40 or even '44. We are not hooked up to any time schedule. We hope and believe that a majority of the voters want to express themselves and feel that their vote will count."

So says Senator Bob, the progressives who supported Roosevelt in 1936 are still for Roosevelt. They merely are against the Democratic party. They think it is killing the Roosevelt program.

You feel the new Progressive party would like to run Roosevelt for President in 1940—if he wants to take the chance. But Young Bob won't talk names and dates. He is appealing to a broad band of voters and he does not want to give any liberal a reason not to look into the new party plans.

Party A Perennial

This movement really is the third appearance of a progressive party that began stirring the sod back in 1910, when such Republicans as old Fighting Bob La Follette, George Norris, William E. Borah and Hiram Johnson were throwing political monkey wrenches into their own party's machinery.

In those days, Theodore Roosevelt, for one, and Woodrow Wilson, for another, saw the ideals of these men making an impression on a broad section of the nation's voters.

Roosevelt warned the Republicans, and Wilson warned the Democrats. Roosevelt was willing to lead the Republicans into progressive channels, and Wilson was a candidate for President under the banners of the "new freedom."

The Democrats heeded Wilson, but the Republicans rejected Roosevelt, so he ran as the head of the won, and the combined vote of the two "progressive" candidates, Wilson and Roosevelt, was more than 7,000,000 ahead of the regular Republican Taft.

Then came the war and its aftermath of confusing economic ups and downs. It was not until 1924 that the genuine progressive movement put in its second appearance. This time, old Fighting Bob scorned the two major parties, and carried the banner alone. He polled 5,000,000 votes—a mere drop in the bucket.

In 1938 political confusion comes again. The American Labor party has real strength in New York state. Straw polls indicate Roosevelt popularity falling off slightly in the Far West and South. And here comes that same old progressive movement poking its head above the surface, headed by the one of old Fighting Bob.

It looks as though the progressive movement is a perennial—and a hardy perennial at that.

The watcher outside stared intently, and fondled the gun in a

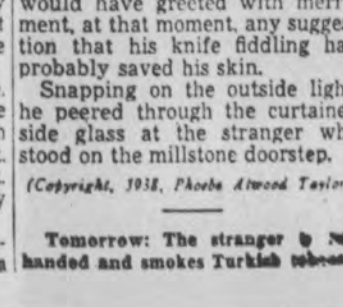
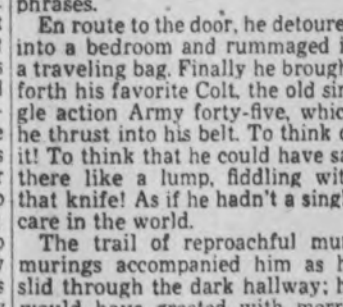
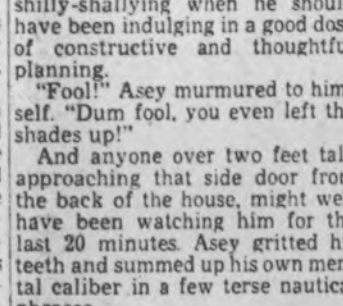
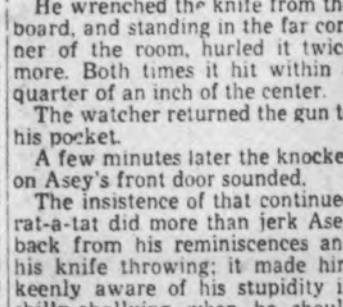
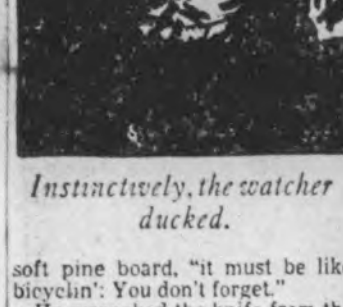
hip pocket. Actually neither Asey nor the girl had to be killed. Asey would be put out of business, and—well, if there were trouble with the girl—

another 13-year-old white girl.

A decision in the Smith mercy
appeal is due almost any day now.
Another officially unconfirmed
angle is the suggestion that in the
event Smith is granted clemency by
commutation to life imprisonment
he be made the subject of a steriliza-
tion operation.

Hollywood Sights And Sounds

Hollywood—For a long time now scenes. Hollywood's air pictures have been aiming at the thrills and excitement of "Wings," a silent film of eleven years ago. The target of future aerial dramas will have to be "Test Pilot."

This new one from the Metro lot is a dramatic account of the life of a man engaged in one of the world's most hazardous and spectacular occupations today—the daredevil who tries out new flying models from the factory to see how safe they are and just what performance they'll give.

Clarkable is the test pilot of the story, Spencer Tracy his mechanic, Lionel Barrymore their boss—and Myrna Loy the Kansas girl and able love-at-first-sight when he crashes on her farm during a cross-country speed test. Here are three academy award winners and a girl rated by many as top favorite among the stars, and in "Test Pilot" they have a vehicle which might do well enough without them but with them is sure to win high favor.

Plenty Of Humor

The story resolves itself (after what seemed to me an off-key beginning with Miss Loy a bit on the "Thin Man" side of glibness) into a conflict between the tester's wife and the fatal fascination of the sky—and this, aided by passages of superb dialogue, is splendidly and movingly presented. Especially admirable in the screen play by Vincent Lawrence and Waldemar Young, and in Victor Fleming's direction, is the absence of anticipated clichés: Tracy, the quiet pal, does not fall in love with able's wife; the picture, although spotted with natural humor, never once halts for obvious "comedy relief;" in the climactic test flight the little wife does NOT go aloft with the men.

In the acting department Gable romps away with first place in the spotlighted role, but Tracy when his part permits, more than justifies that academy Oscar. Barrymore shines too in his few big scenes, and Miss Loy (who probably won't ever win an Oscar) does very well in this fast company, and that patented charm of hers is potent. In lesser roles Marjorie Main, Gloria Holden and Ted Pearson (as Myrna's "nice boy friend" in Kansas) have brilliant

Experts Keep Eye On Referendum of Potato Producers

Desire to Know If Opposition to Tobacco and Cotton Control Has Changed Farmer Attitude

Reflector Bureau.
Raleigh, May 13.—Experts are watching closely the potato referendum Friday and Saturday to see if opposition to cotton and tobacco quotas, has affected materially the attitude of Eastern North Carolina spud growers.

This vote will mark the third time the AAA has been before Tar Heel farmers this year. Tremendous majorities were given control forces in the blue-cured tobacco and cotton referenda on March 12, almost 10 "aye" votes being cast for every "no" vote. In the burley tobacco referendum, Western Carolina growers gave marketing quotas a majority of about two and one-half to one.

Now, a month after burley growers voted, potato growers will be given an opportunity to have the AAA regulate the marketing of their spuds. Ballot boxes in the thirty counties affected will be open from 9 a. m. to 5 p. m., in most cases, although the local committees can open the polls earlier and keep operating until 7 p. m., if necessary. Where cotton and tobacco farmers voted on the control of their

plantings, potato producers will ballot on restricted marketing. If the marketing agreement is approved by two-thirds or more of the farmers voting, then potatoes grading less than U. S. No. 2 will be withheld from interstate shipment. Also spuds of less than one and one-half inch in diameter will be ruled out. By so regulating the handling of potatoes in interstate commerce, only the better grades will be marketed, thus paving the way for better returns to producers. If prices still are unsatisfactory, there may be further limitations on the shipments of other small and inferior quality potatoes if recommended by the local committee and approved by the Secretary of Agriculture.

records of the sheriff's office, Ausbon's testimony pertained to the charge that the sheriff, acting as county jailer, had overcharged and received from the county the sum of \$254.05 for boarding prisoners after they had been transferred to state prison or to prison camps. The alleged overcharges cover more than a hundred prisoners and charge that the sheriff collected board for a total of 759 days in all ranging from one day to 39 on the various prisoners. Of the 759 days covered prisoners from the days overcharge, 562 covered prisoners from the county court and 197 days prisoners from the Superior court.

The defense counsel entered objection to Ausbon's testimony on the ground that the petition of charges against the sheriff were as Sheriff of Pitt County and that the matters involved in the testimony concerned his conduct as county jailer through a contract with the county commissioners. Cowper overruled the objection and admitted the testimony out advised counsel that statutory background must be provided if he was to permit the testimony to remain in the record.

Only one witness was heard during yesterday afternoon. The witness was Mrs. Mary G. Goldsborough, principal clerk of the penal division of the State Highway and Public Works Commission. Her testimony dealt with the dates of admission of certain prisoners from this county into the prison camps of the state prison division.
