Poppy Day Next Saturday.
More than 37,000 new names will be on the roll of America's dead defenders on Memorial Day this year, according to Mrs. Luther Bowling, rehabilitation chairman of Post No. 39 Unit of the American Legion Auxiliary. During the past year, World War veterans have been dying at the rate of 103 per day, Mrs. Bowling pointed out, meaning that 37,895 have passed on since last Memorial Day.

"This heavy death rate among men who served in the World War has placed an increased burden upon The American Legion and Auxiliary, and has enlarged the need for Poppy Day contributions," said Mrs. Bowling. "The money received for memorial poppies on Poppy Day next Saturday will form the principal source of support for the Legion and Auxiliary welfare activities during the year.

"Alas to every veteran now dying leaves a widow and children. Unless legal proof of a disability received in the service amounting to twenty per cent or more had been established by the veteran, no government aid is available for the widow and children. The Legion and Auxiliary must step in with emergency aid, if the family is without means, and strive to keep the home together.

"For every veteran who dies, several are stricken down with disabilities. The government provides hospital care for all, when hospital beds are available but other forms of aid are restricted and again the Legion and Auxiliary must meet the needs. Poppy making provides employment for many disabled men without compensation. The Poppy Day funds make it possible for the Legion and Auxiliary to bring relief to thousands of disabled veterans and their families every year.

"Right here in Greenville we have many men, women and children who are still paying the price of the World War in suffering and hardship. The money contributed for poppies will be for them. If everyone understands the need, there will be no one without a poppy on Poppy Day."

Labor Group Gives Boost To Reynolds

County Non-Partisan Leaguer Endorses Incumbent Over Hancock For Election to Senate

The Mecklenburg County Labor's Non-Partisan League took its first political plunge yesterday by endorsing Robert R. Reynolds for re-election to the United States Senate.

Announcement that Senator Reynolds had been endorsed by the league over his opponent in the Democratic primary, Congressman Frank Hancock, was announced yesterday by C. W. Danenburg, president of the Mecklenburg League.

Indorsement of Labor's Non-Partisan League should mean approximately 5,000 votes, according to Mr. Danenburg. "We do not claim that many members," he said, "but we believe that to be a conservative figure for the membership, members of their families, and friends who will follow their lead when it comes time to go to the polls."

The indorsement of Senator Reynolds was decided upon after a thorough study of the records of both Congressman Hancock and Senator Reynolds, according to Mr. Danenburg.

"There were two important issues which Mr. Hancock evaded by voting a general pair," he said. "They were the red rider amendment and the bill to reduce naval appropriations. On another issue of vital importance, the wages and hours bill, Mr. Hancock voted to recommend, which was equivalent to voting against it."

"Mr. Hancock also voted to repeal the tax salary publicity bill, no doubt believing the public has no right to know of the fabulous salaries paid to corporation officers."

"Our congressman evidently does not believe in low rent and housing, as he voted against these bills also. For these reasons, Labor's Non-Partisan League believes that it would not be to the best interest of the people of this State to elevate Mr. Hancock to the United States Senate."

"In contrast with Congressman Hancock, Senator Reynolds' record is one of consistent support of those progressive measures which the public is now demanding. These include increased relief, slum clearance, low-rent housing, and other similar laws."

Man About Manhattan

New York—It is a pity that so little employment for second grade actors and actresses will accrue from the wholesale production of plays during the annual summer theatrical season, now under way. All along the Atlantic seaboard from Ogunquit, Me. to Cienny, Md. playhouses are being renovated, fresh mazdas placed in marquee, and preparations made to welcome the stars and "name" players of the theater who will come for a week, as "guests," to be featured and feted.

But the minor players, the "second" men and bit players of the theater, with rare exceptions, will remain in New York—just hoping and looking ahead to September.

For the summer season provides little beyond: (A), a chance for a star to spend a few exhilarating days at a pleasant resort. (B), an opportunity for playwrights to try out new dramas, and (C), a come-on for people who like week-end drives or over-night trips throughout the eastern states.

It works like this: A Hollywood star, anxious for a little "audience reaction," will agree to come east for one-tenth her film salary to star for a week in a new show. All right, you say, but what about the

eight or ten other people in the cast? Actors are required for these. In a measure that is true, but they are not enlisted from the rank and file Broadway casting offices. They are lured by pretty debutantes who are eager to work for the "experience," or at most a nominal fee. The supporting cast invariably is replete with semi-pros.

One undeniable advantage of the summer "stock" season, as it is called, is the chance for playwrights to place their new dramas under the audience microscope. A summer production enables the author and his advisers to sit back and criticize it from a seat in the audience. The piece then can be edited, even entirely rewritten in time for a premiere on Broadway

in the fall. This "laboratory" test has saved some inherently "fine" plays.

And so things are happening along the grassy trail which leads from Skowhegan to Providence to Westport to Suffern to O'Leary and points east, west and south.

Suffern, New York, is a famous summer theatrical point, for Helen Hayes generally makes a guest appearance there. Erin O'Brien Moore, beginning at Providence will make practically a tour of the summer circuit. Katharine Cornell, Kate Hepburn and Ann Harding are others who like an occasional week in a "name" role in the seaboard centers.

It must be admitted that the best playwrights are often represented just as the best in the big time performers are on the marquee. I have seen Eugene O'Neill, Maxwell Anderson, Robert Sherwood, and other leading dramatists represented in summer stock. Which is swell for them, swell for the stars who play those meaty roles, and swell for the audience. But it would be swell if it helped the ones who aren't quite stars, the guys back on Broadway pounding the pavements and looking for jobs.

Misbranded Feeds Taken Off Market

Raleigh, May 25—More than a dozen misbranded feeds have been taken off the market by the North Carolina Department of Agriculture during the past two weeks "in the interest of protection for the livestock men of the state."

"A stricter enforcement of the State's feeding-stuffs law has been made possible by an increased personnel and the addition of up-to-date equipment," D. S. Coltrane, assistant to Commissioner of Agriculture W. Kerr Scott, said.

"In most cases, violation of the feed law has been unintentional. But manufacturers have been warned and future violations will bring about further cancellations of brands and prosecutions, if necessary," he added. The Department has ordered feed manufacturers to "cease selling feeding-stuffs that contain ingredients with little or no feeding value."

Washington Daybook

Washington—Just about the time the hard-knuckled boys get out their football togs for spring practice, the U. S. Supreme Court takes over the case to decide whether the game is an integral and essential part of a college education.

It has taken a long time to get the issue to court but, at last, a decision may be made any day now.

Developed in this country more than a half century ago, the game and its tax exemptions tangled with the law only in 1934 when the U. S. collector of internal revenue tried to collect a 10 per cent gate tax on University of Georgia and Georgia Tech games.

Barely had the case hit the Supreme Court than 11 other states joined in the fight. Knocking a 10 per cent cut out of the annual football income would hit school athletic budgets a stinging lick, especially in those colleges which expect at least one annual game with an attendance of 80,000 to 100,000 and gate receipts of \$200,000 or so.

They Go Places

All 12 states united in denying that universities and colleges "inaugurated and continued to carry on inter-collegiate athletics for the purpose of providing entertainment for the general public or with an intention to invade the field of private business."

The government suggested that football money had built some powerfully expensive stadiums, but the colleges retorted: "The recent development of professional football shows that the private amusement business is rather tending to invade the field formerly reserved for the universities and colleges."

The colleges quoted sports writer Hugh Fullerton of Chicago and Coach Fritz Crisler of Michigan on the importance of football. Lawyers for Georgia U. and Tech cited a study of college graduates to prove a whole series of things about athletes.

They make their way to bigger cities than the common run of students, buy bigger insurance policies, own bigger and better automobiles. They tend to get into salary brackets above \$10,000 a year, with football and basketball players outdoing track stars.

Enter the Constitution

U. S. Circuit Court agreed with the colleges that football is an important part of education and thus as essential function of government but Circuit Judge Joseph C. Hutcheson of Houston, Tex., dissented so hotly that the government adopted most of his argument on appeal to the Supreme Court.

The government contended it was the spectators and not the colleges who paid the taxes and therefore the colleges had no right to withhold the money from the treasury.

Not only is athletics inessential to a college, the government contended, but it isn't even run by the colleges. It pointed out that an athletic association at the Georgia colleges hired the coaches, paid rent on the field and even supplied the schools with money for scholarships with no government suggestion.

The colleges contended that the framers of the Constitution left the states free to provide public education as a government function, but the treasury lawyers ironically replied: "We hazard the statement that the members of the Constitutional Convention would doubt that 22 men playing a game with a ball constituted an essential governmental function."

"And we do not conceive that the sovereign functions of the State of Georgia are in any sense dependent on the success of the (college) football team."

SHORT SHOTS

Reflector Bureau. Raleigh, May 25.—There isn't much talk about them, because they are scattered all over and not concentrated right here in Raleigh, but the lobbyists of all sorts, shapes and descriptions are practically as busy and energetic right now as they will be during the General Assembly session which will convene next January.

In fact, most of the lobbying organizations are smart enough to realize that there's more truth than epigram in the old saw about the ounce of prevention; wherefore they are bestirring themselves in frantic efforts to keep out of the legislature such fellows as they know will be hostile to their pet projects and are initiating a whole dam full of beavers in working for political aspirants of their choice.

If you don't think these are the facts, just make a survey of the situation and note the number of questionnaires being fired at prospective House and Senate members, and mark the earnestness with which they are being besieged by well known lobbyists for the various and sundry interests which keep lobbyists on tap year in and year out.

Just a few of the "lobbies" now active are oil, insurance, power, school teachers, labor and railroad.

Commissioner of Labor A. L. Fletcher isn't in the least alarmed by prospects for passage of the current Wage and Hour bill in Congress. In fact, the Major believes that the greatest curse of the South today is the number of "cheap labor" industries operating within its borders.

He points out that such industries as cannot pay \$11 per week to employees have small right to exist. Under the present W. and H. measure that's what the minimum weekly wage would be at 25 cents an hour and 44 hours for the week.

If Major Edney Ridge hasn't done anything else over in the Sixth District he has forced at least one of his opponents to take notice of the New Deal issue the hard-hitting former officer has raised.

Says J. O. Atkinson, Jr. of Greensboro. "Those who are familiar with my record know where I stand. As I have often stated, I repeat that I have always supported President Roosevelt in his efforts to carry out the principles of the Democratic party."

Robeson is a great county, according to prideful W. K. Bethune of Lumberton. Words almost fail him as he superlatives his home county in these phrases:

"Why if you took all the cotton raised in Robeson and made it into a sheet, it would wrap up North Carolina and South America and lap over on the shores of Asia and Africa.

"If you put all the hogs in Robeson in one big hog, he'd root a ditch as big as the Panama Canal and equal so loud that all the coconuts would be shaken off the trees in Brazil."

"If you put all the mules in Robeson in one big mule, he'd kick the spots off the sun.

"And if you rolled all the tobacco raised in Robeson in one big cigar, it would reach to the moon and the man in the moon could puff a stream of smoke that would make the Milky Way look like skim milk."

Common stockholders of the Tide Water Power Company were scared the other day they'd lose control of the company as result of its passing up a dividend on its preferred stock; but a look at the Utility Commissioner's records here shows there's no reason for such worry.

Preferred stock holders take over the T.W.P. only when the "passed dividends shall amount to more than the par value of the stock" which means that the company could pass fourteen annual 7 per cent dividends and still have one more to go before the p.a. holders could take over.

COPS' ART MAGAZINE IS FOR THEM ONLY

Paris.—(AP)—There's a magazine in Paris called "Art and Police," but it can't be found on barber shop tables. It's written by and for Paris policemen and it's very serious indeed.

Some 30 years ago a number of the city's notoriously "tough" cops admitted to each other that they liked art galleries, concerts—and even ballet dancing.

They formed a Police Artistic Association—then a sort of protective association against any fellow policeman who made any insulting comments about "sissies."

Now the association has nearly a thousand members and publishes "Art and Police" to keep them abreast of what's going on in the art world including exhibitions of paintings by policemen-artists, concerts by policemen-musicians—but no ballet-dancing policemen.
