HOLLOWELL ON STAND IN CASE OUST SHERIFF

Prosecution Expected To Rest at 4 o'clock

RETURN AUDITOR FOR QUESTIONING

Prosecution Recalls Hollowell to Stand After Cross-Examination Completed

D. R. Hollowell, auditor, who took the stand in the Whitehurst ouster hearing here, was still undergoing cross examination at four o'clock this afternoon.

At noon yesterday it was thought that the examination would be completed and the prosecution would rest its case prior to yesterday evening's recess, but lengthy questioning as to details contained in the audits prolonged the cross examination into this afternoon's session.

Shortly after the afternoon session began the defense ended its cross examination, but the prosecution immediately returned the witness to the stand for re-direct examination of more than an hour, which was followed by additional cross examination by the defense.

Whether the final cross examination would be completed and the case rested before the end of today's session was problematical shortly after four o'clock this afternoon.

During the noon recess, Judge G. Vernon Cooper, hearing the case, indicated that if the prosecution did not rest this afternoon he might hold sessions again tomorrow if indications were that the case could be rested at that time.

Post Commanders Invited To Attend Training Program

North Carolina Employment Service To Conduct Experiment in Sanford Saturday, May 28th

Raleigh, May 27.—At the invitation of the North Carolina Employment Service many American Legion post commanders and Employment officers are expected to attend the In-Service Training Program of the N.C.E.S. at Sanford, at Sanford, May 28.

This session is to be for groups in the Sanford area, and if it proves of interest enough to the Legion officials, invitations will be extended to attend other area meetings throughout the state.

Commander Burrell Correll of the Raleigh Post said today that Post Employment Manager Hubert P. Williams will likely represent the capital city veterans at the meeting. The commander said he will not be able to attend himself, but expressed deep interest in the plan for full cooperation between the service and the Legion.

The purpose of the meeting, according to Director R. Mayne Albright of the N.C.E.S., is to bring together members of the Legion, on whose shoulders rests the problem of employment for veterans and managers of the Employment Service, to the end that both groups may, if possible, consolidate their efforts in behalf of veterans.

The census of unemployed veterans complete, veteran organizations are getting their plans under way for a vigorous program of firm visiting as the second stage of their campaign employment among their members.

Commander Correll said the problem is a very grave one, but added that it is being attacked vigorously by the Raleigh Post and other Legion groups.

ASSEMBLY FOR CHURCH UNION

Presbyterian Church of U. S. A. Votes for Proposal

Philadelphia, May 27.—(AP)—The General Assembly of the Presbyterian Church of the U. S. A. accepted today the invitation of the Protestant Episcopal church to "achieve organization between our respective churches."

The assembly adopted a resolution declaring "its earnest and prayerful purpose to co-operate with the Protestant Episcopal Church in U. S. A. in the study and formation of such plans as may make possible the union contemplated."

The invitation was extended to the Presbyterians by the Rev. James DeWolfe Perry, Presiding Bishop of the Protestant Episcopal church, on action taken at the latter church's general conference in Cincinnati in October, 1937.

The assembly also approved a proposal for a World Council of Churches, launched at a world conference at Edinburgh, Scotland, last summer. The Rev. Dr. L. S. Mudge, stated clerk of the assembly, had asked the Presbyterians to become the first denomination formally to sanction the project.

"Let us keep Presbyterianism in the van and make it the leading church in the world in unification of protestantism," he said.

She also suffered a possible fracture of the jaw and several teeth were knocked out. She was taken to a hospital in Kinston.

Mrs. Hardee was alone when the wreck occurred, but it was explained she started to pass a car and either had hit the car or the abutment. The car was badly damaged.

Seeks To Enjoin Commission Firm From Operations

State Attorney General Asks Action by New York Supreme Court against Paine, Webber & Company on Grounds of Alleged Frauds against Public

New York, May 27.—(AP)—State Attorney General John Bennett, Jr., today asked in State Supreme Court that all partners of the New York Stock Exchange firm of Paine, Webber and Company, a leading commission house with offices in 19 cities, be forever enjoined from engaging in the securities business in New York State on the ground of alleged frauds against the public.

Bennett, in allegations sworn to by his assistant, John O'Hanlon, accused the defendant partners of Paine, Webber and Company of employing fraudulent practices upon the state and upon the public in connection with substitution of "unmarketable" securities of "little or no value" for diversified portfolios of a number of investment trusts in which the public invested over \$16,000,000.

Nineteen persons and four corporations were named as defendants in addition to the Paine, Webber group.

In the last six months, according to O'Hanlon's supporting affidavits operations involved, "at least six investment trusts representing an aggregate public investment of over \$15,000,000."

These trusts, he said, were First Income Trading Corporation, Continental Securities Corporation, Reynolds Investing Company Inc., Insurances Corporation of Delaware, Bond and Share Trading Corporation, and Bureau Incorporated.

Pending hearing on Bennett's application for a permanent injunction against all of the defendants, Supreme Court Justice Samuel Roseman today issued a three-fold restraining order and set June 7 as the date for a hearing to show why temporary and permanent injunctions should not be issued restraining all defendants from engaging in the securities business in New York.

DATES SET FOR VACCINATIONS

Clinics to be Conducted in More Than 60 Pitt Centers

Typhoid and diphtheria vaccination clinics will be conducted in more than 60 centers in the county, schedules released by Dr. N. Thomas Ennett, Health Officer, revealed today.

In addition, vaccinations will be given at the health offices here each Wednesday afternoon and Saturday morning for Greenville people. The health department also has arranged to conduct clinics at three centers in the city for colored citizens.

Dr. Ennett declared that all children need diphtheria vaccination by the time they are one year old. The typhoid vaccinations will be given free, but persons being vaccinated for diphtheria are expected to pay ten cents for the vaccine. It was explained, however, that any person unable to pay the fee will be given the vaccination free.

Three groups will conduct clinics simultaneously throughout the county this year. The schedule for each follows:

President Harrison Thanks Those Who Aided Campaign

J. Nat Harrison, president of the Greenville Chamber of Commerce, this afternoon expressed his thanks to all those who helped make the one-day drive the success that it was.

Mr. Harrison expressed his thanks to workers and members and also to the press. "Those persons who helped in the campaign by becoming members have my heartiest thanks and I also appreciate the efforts of the workers who provided business and professional men with an opportunity to become members of the organization," declared President Harrison.

A permanent membership committee of the Chamber of Commerce will be designated in the near future, who with a full-time executive secretary, will carry on the work of securing every member possible.

It is not planned to conduct membership campaigns annually, but it will be the task of the executive secretary and the membership committee to see that memberships are renewed each year.

A committee composed of C. W. Howard, chairman, J. H. Blount, J. B. Kittrell, G. V. Smith and J. J. White, has been named to select an executive secretary.

It is the announced purpose of the committee to secure a man with wide Chamber of Commerce experience.

EIGHTY INJURED IN AKRON STRIKE RIOT

Akron, Ohio, May 27.—(AP)—More than 100 policemen, rifles and tear gas guns in hand, forged a ring of peace around the sprawling plants of Goodyear Tire and Rubber company today in the wake of night-long rioting and sniping in which at least 80 persons were injured.

The disorders which reached their height at midnight when police unveiled nightsticks and tossed tear and nauseating gases into the crowd of 3,000 strike pickets and sympathizers, tapered off by hour until at dawn only a few score curious persons remained at the scene.

Police reported several hundred workers of the 8 a. m. shift which ordinarily includes about 2,000 men,

TAX MEASURE BECOMES LAW AT MIDNIGHT

President Neither To Veto Nor Sign the Revenue Bill

EXPLAINS STAND IN WEST VA. TALK

First Time Such a Course Taken By Roosevelt During His Stay in Office

Arthurdale Homesteads, West Va., May 27.—(AP)—President Roosevelt announced at the Arthurdale Homesteads school commencement exercises today that he would permit the \$5,000,000,000 tax bill to become law without his signature.

"If I sign the bill," Mr. Roosevelt said in his address to the Arthurdale homesteaders and to the nation over the radio, "—and I have until midnight to sign it—many people will think I approve the abandonment of an important principle of American taxation."

"If I veto the bill it will prevent many of the desirable features of it from going into effect. "Therefore, for the first time since I have been President, I am going to take the third course which is open to me. I am going to let the act go into effect at midnight tonight without my approval."

The President said he was permitting the tax measure to become law in that way to call attention to "unwise parts" of the bill. The measure, which thus becomes law, contains a remnant of the undistributed profits tax, recommended by Mr. Roosevelt and condemned by business. It completely overhauls former capital gains taxes —also attacked by business—by substituting flat rates for a graduated scale.

Gets Thirty Years For Killing Officer

Wentworth, May 27.—(AP)—Judge Hoyle Sink sentenced Reuben Bennett, 39-year-old Spry textile worker, today to serve 29 to 30 years in the state penitentiary after a Superior court jury convicted him of second degree murder in the slaying of Policeman Leonard Clark March 10.

The jury returned the verdict early today.

The case went to the jury late yesterday and Judge Sink ordered the jury locked up in a hotel for the night. Clark was shot to death when he went to the Bennett home to arrest Bennett on a charge preferred by his wife.

A.E. Morgan Apparently Ignores Removal Order

Addresses Roosevelt Appointee as "Vice Chairman"

Washington, May 27.—(AP)—Dr. A. E. Morgan apparently declined today to recognize the validity of President Roosevelt's order removing him from the chairmanship of the Tennessee Valley Authority.

Reopening his bitter public feud with his antagonists on the TVA board, the Ohio engineer addressed a letter to H. A. Morgan as "Vice-Chairman the Tennessee Valley Authority," despite the fact President Roosevelt had designated H. A. Morgan chairman.

The letter was inspired by H. A. Morgan's criticism of a congressional investigating committee's hearing Wednesday and yesterday of the charges and counter-charges which Directors H. A. Morgan and David Lilienthal, on the one hand, and A. E. Morgan, on the other, have exchanged.

POPPY SALE IN CITY STARTED

Miss Mariah Graham Given Honor Of First Purchase

Miss Mariah Graham, instructor at East Carolina Teachers College, had the honor of being the first person in Pitt county to buy a poppy, as the American Legion Auxiliary prepared to observe the annual event tomorrow.

Because of her faithful service to the Auxiliary, Miss Graham was allowed to purchase a poppy one day before the campaign officially opens.

Mrs. D. M. Clark is in charge of the sale in Greenville. Chairmen in other Pitt county towns included Mrs. J. W. Rook, Bethel, Mrs. Grady Dixon, Ayden, Mrs. Asa Jones, Winterville. Chairmen at the remaining Pitt towns were not known here.

Mrs. Clark urged every true American to buy and wear a poppy tomorrow in honor of the soldiers who were killed in the World War. Members of the Auxiliary and others will be on the streets early tomorrow morning to give every person an opportunity to buy one of the little red blossoms.

The poppies, crepe paper replicas of the wild poppies of France and Belgium which bloomed along the battle fronts, were made by disabled veterans in government hospitals.

ANTI-AIRCRAFT GUNS IN PLACE

Vigorous Protest Is Assured When Identity of Planes Which Bombed Cerbere Railway Terminal is Determined; Ships Unofficially Identified as Spanish Rebels

Cerbere, France, May 27.—(AP)—Anti-aircraft guns were wheeled into position today to protect this frontier town from repetition of last night's air attack.

The Mayor of Cerbere had telegraphed Premier Daladier that "the population protests against insufficient measures taken to protect it against Italo-German aviation."

Reassured by arrival of anti-aircraft batteries, the inhabitants of Cerbere came out of hiding. Many of the 2,000 residents had huddled in underground refuges while eight war planes bombed Cerbere's railway terminal.

The planes were identified unofficially as Spanish insurgents. From Paris, Navy Minister Cespinocha ordered destroyers of the Mediterranean fleet to cruise off Cerbere to help repel any new attacks.

The foreign office spokesman said a "thorough" investigation of the bombing had been ordered and France would protest vigorously when the nationality of the bombers was determined.

Village authorities rushed the citizens to safety last night in the yards long that connects Cerbere with the neighboring Spanish town Port Bou.

Not a single bomb, however struck Port Bou, although for the forty-first time it was insurgent aviators' objective.

Mrs. Flynn was born in Virginia, October 17th, 1856, daughter of the late George Washington and Martha Carr Crumpler. She spent most of her life in Fayette and was for many years a member of the Christian Church of that place.

The funeral service will leave Williams Funeral Home Sunday and proceed to Fayette, where the funeral services will be held from the graveside by Rev. Edward Sawyer, pastor of the Belhaven Methodist Church.

Surviving are three sons, C. S. Flynn of Winterville, G. O. Flynn of Greenville, Route four, and W. L. Flynn of Washington, N. C.; one daughter, Mrs. N. H. Buttry of Washington, N. C.; 18 grandchildren and 10 great-grandchildren. Grandsons will serve as active pall bearers.

## Hollywood Sights And Sounds

Hollywood—Scarcely cheerful reports from the Hollywood economic front lately would seem to indicate a general state of doldrums and a sorry outlook for the year's screenings, but here and there is brightness, bigness, and even a nostalgic touch of the colossal.

"Marie Antoinette"—about \$2,000,000 worth—is completed but can scarcely be counted as this was ready to go before the monetary scare set in. But Metro is linking approximately a million in "The Great Waltz," elaborately costumed and staged version of the musical play, based on the life of Johann Strauss. 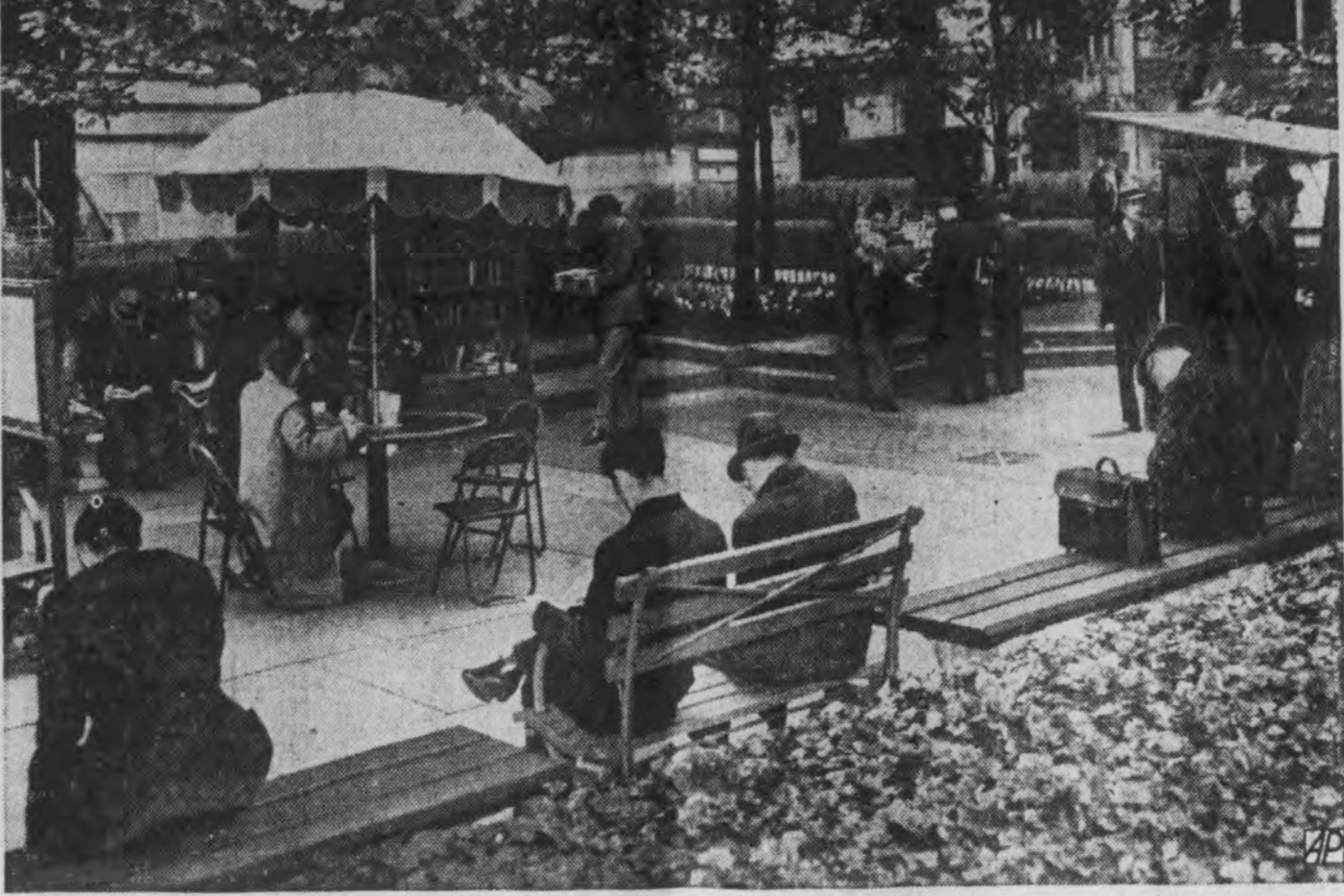

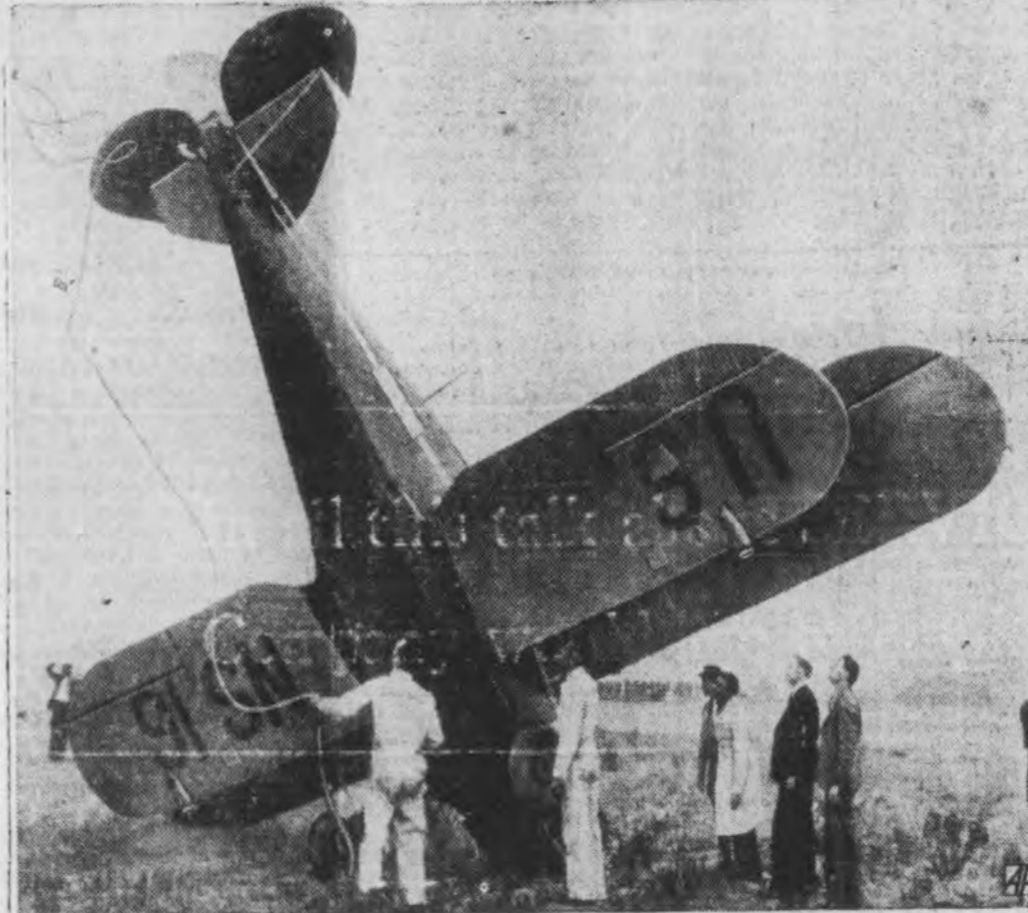

Reflector Bureau.  
 Raleigh, May 27.—Louis H. Wil-  
 son, agriculture department editor,  
 and "Mosky" Carroll, afternoon  
 newspaper reporter, were chewing  
 the fat in Louis' office yesterday.

The Utility Commission is going

**Picking The 'Wrong Horse'**  
 A half dozen years after the Hav-  
 ana treaty was drawn up, Brazil  
 had a revolution. In keeping with its  
 agreement, the United States gov-  
 ernment, with Henry Stimson as  
 Secretary of State, permitted arms  
 to move to the government forces.  
 By the time they reached there, the  
 rebels had won. They took over the  
 shipment of arms intended for the  
 other side.

Stimson was dubbed "Wrong  
 Horse" Henry for presumably  
 backing the wrong side. There are  
 good sources here who say he knew  
 the rebels would win but was de-  
 termined to respect the treaty re-  
 gardless.

The rebels didn't kick too much  
 because they suspected the time  
 would come when they would  
 want the treaty lived up to in the  
 same way. Those rebels are now  
 the government.

The Constitution provides that  
 a treaty shall become the "supreme  
 law of the land" but the same  
 status is enjoyed by an act of Con-  
 gress such as the neutrality act.

One high source "gave the opin-  
 ion that in event of a civil war in  
 Mexico the President would be  
 morally obligated under the treaty  
 to permit arms to go to Cardenas  
 (in spite of oil land seizures),  
 even though it meant ignoring the  
 neutrality act.

The first Englishman to hold the

 was created marquis of Dublin by  
 Richard II in 1385.

**POPPIES IN BLOOM**

Poppies were blooming today at  
 the headquarters of Post No. 39  
 unit of the American Legion Aux-  
 iliary at Hill Home's Drug Store  
 as the little red memorial flowers  
 which the people of Greenville will  
 wear in honor of the World War  
 dead on Poppy Day, May 28th, were  
 being unpacked. The poppies were  
 received from Oteen hospital where  
 they were made by disabled vet-  
 erans for the Auxiliary.

The poppies are crepe paper re-  
 plicas of the wild poppies of France  
 and Belgium which bloomed along  
 the World War battlefield and  
 which inspired the famous poem,  
 "In Flanders Field." More than  
 ten million of them have been  
 made this year by disabled veter-  
 ans working in government hospi-  
 tals and in convalescent work  
 rooms maintained by the Auxil-  
 iary. Poppies for the state of

North Carolina have been made at  
 the Oteen work room, under the  
 direction of the Rehabilitation de-  
 partment of the Auxiliary.

"Each flower has been shaped  
 painstakingly by the hands of  
 some disabled veteran," said Mrs.  
 D. M. Clark, chairman of the Amer-  
 ican Legion Auxiliary Poppy Day  
 Sale, as she examined the mem-  
 orial blooms. "The poppy work is a  
 real boon to these men as it is  
 the only form of employment open  
 to them. Only men receiving little  
 or no government compensation  
 are given the work, with preference  
 going to those who have families  
 to support.

"For making the poppies and at-  
 taching the official American Leg-  
 ion and Auxiliary label, the veter-  
 ans are paid by the Auxiliary,  
 they being the only paid workers  
 in the whole poppy program. The  
 Auxiliary supplies the materials  
 and advances the money to pay  
 the men as the poppies are pro-  
 duced. Approximately \$100,000 in  
 earnings goes into the empty pocket-  
 ets of these veterans each year,  
 and in addition, hundreds of  
 thousands of dollars are raised for  
 Auxiliary welfare work."

**Washington Daybook**

Washington—Just as news of possible revolution in Mexico comes dribbling into the United States, the attention of the State Department and the Senate foreign relations committee is called to a section of "the neutrality act that has a capacity to gum up operation of the "good neighbor" policy.

In 1928 President Coolidge went to Havana with all the pomp and fanfare that could be attained to Mr. Coolidge (and he wouldn't allow much) There a solemn covenant was drawn up among the American republics by which all agreed that if a revolution should break out in any one, the others would refuse to ship arms to the rebels. Arms would be shipped only to the government forces, Mexico signed it. So did the United States and most others.

The idea was to preserve peace and discourage any one nation from precipitating or aiding a revolution in any of the others.

**There Is The Rub**

But last spring, in its hasty effort to legislate an embargo against arms shipments to Spain Congress enacted a neutrality measure providing that in event of a serious civil war in some foreign country, the United States would refuse to ship arms there. Much discretion is allowed the President to determine whether the civil war is dangerous to the peace and security of the United States. He is obligated to impose the embargo only if the shipment of arms threatens to involve the United States in the fray or to endanger its peace and security.

But if the civil war gets bad, he has to stop shipments of arms to both sides, rebels or government. And that, so authorities on foreign affairs here say, appears to be in conflict with the Havana treaty which pledged the nations to help each other suppress civil wars.

Of course a way out was provided each nation. If any nation decides the rebel outbreak is justified it may "recognize" the rebel group as a legitimate belligerent and so ship arms or not, as it chooses.

Now if a civil war should break out in Mexico the United States would be confronted at once with a double question:

Should it abide by the treaty and help out the Cardenas government? Or should it abide by the neutrality act and refuse aid to either side?

# Ross-Armstrong Bout Postponed

## Welterweight Title at Stake in Ross-Armstrong Fight

New York, May 28.—(AP)—The scheduled 15-round welterweight championship bout between Barney Ross, champion, and Henry Armstrong, again was postponed today until Monday night.

By ALAN GOULD

New York, May 27.—(AP)—The Weather Man, as he had predicted, yesterday scored the first punch of the outdoor fist season. His conservative forecast of "showers" was fulfilled by a deluge that washed out last night's 15-round welterweight title match between Henry Armstrong, Negro challenger and Barney Ross, the champion.

Promoter Mike Jacobs, after holding out until three hours of heavy rain had drenched the scene of impending conflict in Madison Square Garden's Long Island City bowl, postponed the fight until tonight. If another delay is necessitated by the weather, the show probably will be re-scheduled for Monday night.

The postponement came after the weighing in ceremonies, at which Ross scaled 141½ and Armstrong 136½, thereby fulfilling the special weight agreements for this unprecedented match between the respective titleholders of the welter and feather crowns, however, as to what will happen when the fighters report at the State Athletic Commission at noon today for re-examination.

It is a commission rule that fighters need not weigh-in again, unless a bout is postponed 48 hours or more, but Brig. Gen. John J. Phelan, the chairman, pulled a rule change out of his hat by announcing the principals would be required to step on the scales again. This drew a prompt squawk from Armstrong's manager, Eddie Mead, who insisted his man already had lived up to the agreement to make not less than 136 and, therefore, would not weigh in again unless there's another postponement.

The idea behind Mead's objection is not only based on the previously understood regulations, but on a desire to trim two or three pounds off his fighter's surplus. Armstrong's best fighting weight is around 133. He agreed to make 136 to his rival's maximum of 142, so that the Negro would be over the lightweight class limit.

Gen. Phelan finally pacified all concerned by saying he would decide what, if anything, would be done today noon outside of the formality of re-examination. There appeared no prospect of any hitch arising over the issue of another weighing-in, particularly since the Ross camp was willing to accept any procedure decided on.

Ross the betting favorite, professed no concern over the coupling of the postponement with the hobnob that has pursued defending titleholders in the garden bowl. Barney figured in one of the longest fight delays on record, due to bad weather. That was in September, 1934, when he lost the welter title to Jimmy McLarnin, in their second match after a delay of 11 days from the original date. No champion has defended his crown successfully in the garden bowl.

Armstrong went through a six-round workout yesterday afternoon, but Ross, who has appeared to some observers to be finely drawn, took the advantage of an extra day's rest.

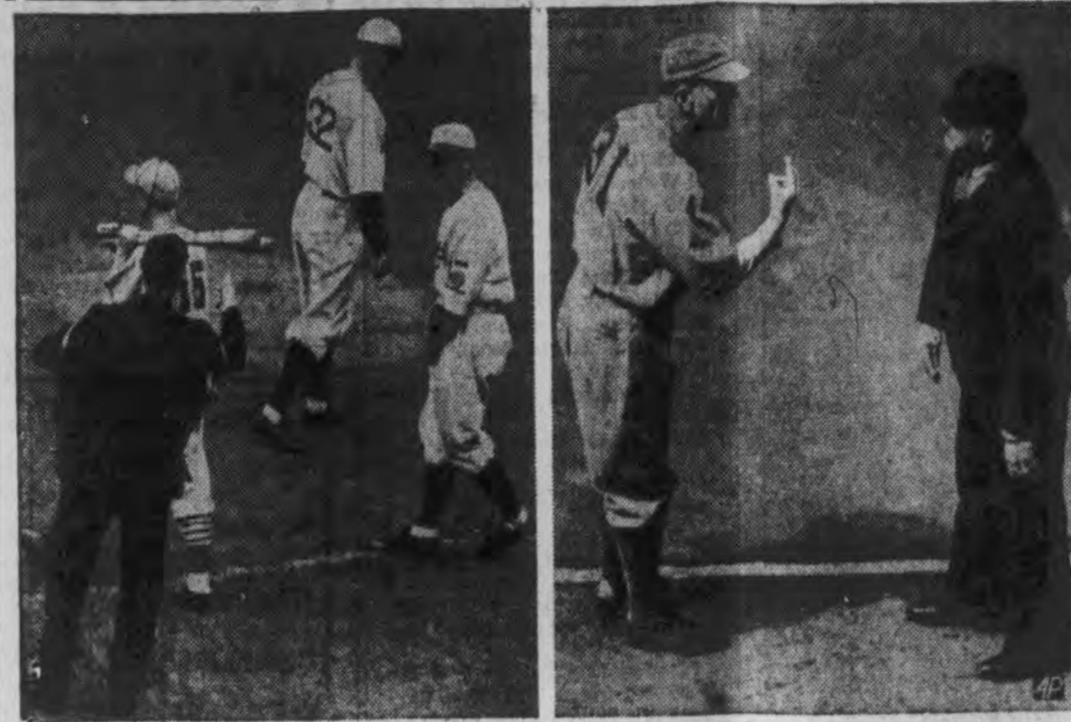

### Farm Cash Income Of \$271,132,000 In State Last Year

Tobacco Far Ahead with 674,000 Acres Harvested Producing Total of \$95,530,000 Pounds

Reflector Bureau.  
Raleigh, May 27.—North Carolina ranked thirteenth in total cash income of its farmers, which reached \$271,132,000, the State Department of Agriculture's statistics division reports.  
The state ranked as follows, in various phases, according to W. H. Rhodes, chief statistician:  
First: Tobacco, with 674,000 acres harvested and 95,530,000 pounds, putting the state at the top in both acreage and production.  
Third: Cash income from crops—\$232,850,000.  
Third: Total number of farms—309,967 (1935 farm census).  
Eighth: Acreage of all truck crops for market—52,720 acres.  
Ninth: Cotton—Growers harvested 1,101,000 acres producing 775,000 bales. Acres planted reached 1,109,000.  
Eleventh: AAA or conservation payments, with \$12,282,000 paid to growers.  
Seventeenth: Corn, both production and acreage with 45,357,000 bushels from 2,326,000 acres.  
Seventeenth: Acreage of all truck crops—559,390 acres.  
Twentieth: Acreage in cultivation—6,592,000 acres.  
Twentieth: Cash income from all truck crops—\$4,290,000.  
Twenty-sixth: Acreage of all truck crops for canning and manufacture—6,670 acres.  
Twenty-ninth: Hay 995,000 acres.  
Thirty-second: Hay—855,000 tons produced.  
Thirty-eighth: Cash income from livestock and livestock products, with a total of \$26,000,000.  
With a total of 2,360,429 people living "in the country" the state's rural population comprises 74.5 per cent of the total.

**TAX MEASURE BECOMES LAW AT MIDNIGHT**

Noting that the legislation retained the principle of the undistributed profits tax, the President said: "The penalty for withholding dividends to stockholders is so small—only two and a half per cent at the most—that it is doubtful whether it will wholly eliminate the old tax avoidance practices of the past."  
As to the adoption of the flat rate capital gains tax, the President asserted: "The abandonment of the principle of progressive tax payments in accordance with capacity to pay may encourage a small amount of capital to go into productive enterprises, but chiefly it will help those who make large profits in buying and selling existing stocks."

**MINER 'FISHES' GOLD FROM BERING SANDS THROUGH HOLE IN ICE**  
Nome, Alaska, (AP)—An enterprising operator has "fished" successfully for gold through holes chopped in thick ice of the Bering sea.  
Howard Lyng, former legislator and member of the territorial welfare board, told how Joe Sullivan, old time miner, conducted the first productive venture in extracting gold from Bering sea sands.  
The mining innovation was undertaken 1,000 feet from the beach through a large hole cut in the ice near Bluff, 52 miles down the coast from Nome. Dirt was hauled from the ocean bed in a three and a half foot bucket, "high-lined" to the beach and dumped.  
After 30 days' work the dump was sluiced" and Lyng said Sullivan brought \$200,000 in gold into Nome.  
Sullivan is repeating the operation, and others are expected to try the same system.

Most of the prospective House members of the joint conference committee, on the other hand, are expected to fight pay concession.  
Other developments:  
Senator Byrd (D-Va.) proposed elimination of the \$965,000,000 PWA fund in the administration's relief and public works bill.  
Byrd described the PWA allotment as "pump priming" and said it would constitute a heavy and unnecessary drain on the treasury.  
Experiences show, he said, that "pump priming will not bring prosperity."
