SEN. BARKLEY STATES VIEWS OF ROOSEVELT

Says FDR Would Not Lend to Private Utility Competitors

PROPOSAL WOULD RESTRICT POWER

Secretary Morgenthau Says President Should Have Unlimited Authority

Washington, June 2.—(AP)—Majority Leader Barkley told the Senate today President Roosevelt does not want to use government funds for building public utility plants competing with privately owned systems until private utilities have been given an opportunity to sell their holdings at a "reasonable price."

Barkley's statement came during Senate debate on a proposal to forbid the use of PWA funds for construction of plants which would compete with privately owned systems.

The restriction was recommended by the Senate Appropriations Committee as an amendment to the administration's \$3,000,000,000 lending-spending measure.

If the restriction of PWA allotments is eliminated, Barkley asserted, it is "authorized to say" that the President would not allocate funds for building public systems unless municipalities have "in good faith made an offer to purchase the existing private plant."

Earlier Secretary Morgenthau said Congress should give the President virtually unlimited authority to determine how funds should be spent in the new relief public works program.

Meanwhile Commissioner George Payne of the Communications Commission, charging that the commission has been "susceptible to outside pressure," asked the House Rules Committee to authorize a congressional investigation of the radio industry.

"Some of the lawyers who practice before the commission," Payne said, "have become arrogant and are in the habit of commanding, rather than asking or pleading."

"The influence and pressure are altogether too great."

Other developments included: Secretary Morgenthau announced the Treasury would borrow "no new money" in its June 15 financing operations.

Borrowing money the next few months, he explained, will be confined to replacing and refunding security securities.

Because of \$1,400,000,000 obtained by devaluation of gold in April, the Treasury needs no new cash at the present time.

No Effort Made Detain Frenchman

Cherbourg, France, June 2.—(AP)—French police made no effort to detain W. C. Gudenberg, wanted in New York as a witness in the American government investigation of activities of foreign spies, when he arrived here today aboard the liner Hamburg.

A special French police agent accompanied the American consul aboard the liner to see the captain and established Gudenberg's presence. The captain declared Gudenberg would be handed over to German police as a stowaway when the liner arrived at Hamburg, its home port.

The Surete Nationale in Paris announced the American government had made no request for an effort to detain Gudenberg, who left New York without a passport.

Japan Promises Probe Of Charges Americans Denied Civilian Rights In China

Nippon Government Assures U. S. Commission Will Be Named to Make Immediate Investigation Of Incident Which Provoked Second Protest

Tokyo, June 2.—(AP)—Japan assured the United States today that a commission would be dispatched immediately to China to investigate what Washington had protested was interference with American rights in Japanese occupied territory.

The commission would include a colonel representing the army staff and two foreign office officials.

The director of the American section of the foreign office, S. Yoshizawa, who announced the inquiry promised to expedite return of American missionaries and business men to their posts.

Eugene Dooman, counselor of the United States Embassy, conferred with Yoshizawa after delivery of Washington's second protest on this subject.

The note, published yesterday in Washington, charged that Americans had been barred from returning to business places and mission stations in various parts of the lower Yangtze valley and were "deprived even casual access to their properties."

Meantime Shanghai reported war planes of the army of Nippon again spread a trail of destruction through towns and villages about the Lunghai railway and Japanese said this enabled their columns to make important gains.

The Japanese announced they had occupied a corner of Kihsein, 20 miles south of Lanseng, after an hour's fight.

For two weeks the Japanese have been fighting for staunchly defended villages about Lanseng, railway station on the Lunghai, whence they hope to turn southward in a mass offensive against Hankow, China's provisional capital.

Washington, June 2.—(AP)—Japan agreed today to meet almost all demands for restitution of American property in China and for the right of unhindered return of Americans to their posts there.

The State Department on the basis of telegrams from the American Consul General at Shanghai, announced that:

The Japanese restored to the American Southern Baptist Mission yesterday their high school properties in the Chapel district of Shanghai.

The Japanese military authorities have agreed to the return of American missionaries to Nanking and have issued 10 passes for this purpose.

ABSOLVED IN FATAL WRECK

Thomas Etheridge, Jr., Killed in Auto-Motorcycle Collision

A coroner's inquest this morning found that Thomas Etheridge Jr., 24, who was connected with the Rainbow cleaners here, came to his death as a result of a wreck between a motorcycle he was riding and an automobile driven by Tyree Stokes, 19-year-old student of Grimesland, but failed to place blame for the accident.

Etheridge died at a filling station a short distance from the scene of the wreck, one mile East of Grimesland where the old road crosses with the new highway. Etheridge was coming to Greenville from Washington on his motorcycle when he collided head-on with the automobile. Stokes was not injured in the wreck.

Funeral services for Etheridge will be conducted Friday morning at 11 o'clock from Williams Funeral Home by the Rev. C. B. Mashburn, Christian minister of Farmville, assisted by the Rev. T. M. Grant, pastor of Jarvis Memorial Methodist Church of Greenville. Burial will be in Greenwood cemetery.

Examiner Believes Youth Decapitated

New Rochelle, N. Y., June 2.—(AP)—Revising an original police theory, Dr. Amos Squire, Westchester county medical examiner, said today he was convinced kidnappers decapitated 12-year-old Peter Levine before dumping his body into Long Island Sound.

Dr. Squire said checks of 1,200 drowning cases had failed to disclose a single instance in which a head had become detached from a body by natural causes after immersion of one three months.

Police and federal agents, still without a tangible clue to the identity of the slayer, continued dragging wreckage of the sound near the place where the boy's torso drifted ashore last Sunday.

Commander Advises Knowledge Modern Civilization

TALK INCLUDES POLITICAL TWIST

Recalls that Theodore Roosevelt had Trouble with Coalition of Congressmen

Annapolis, Md., June 2.—(AP)—President Roosevelt advised the Naval Academy's graduating midshipmen today to acquire a well-rounded knowledge of "modern civilization" in addition to their training as officers of the navy.

"That applies," the President said, to all of world thought and world problems, but it applies, of course, with special emphasis to the thought and problems of our own nation."

The President stood before the white-bloused graduates as their commander-in-chief and told them they would never "reach the top and stay at the top" unless they became well-rounded in their knowledge of all factors of civilization "that lie outside of your own special profession."

He gave this a political twist when he recalled an incident in a conversation he once had with President Theodore Roosevelt.

He related that a conservation bill, strongly recommended by Theodore Roosevelt, had been defeated in Congress by a coalition of members who saw no special advantage to their own congressional districts.

"I wish," the present chief executive quoted Teddy Roosevelt as saying "we could have a constitutional amendment requiring that no person could run for Congress unless he had visited everyone of the 48 states in the union."

Charlotte, June 2.—(AP)—A. A. Allen, an officer deputized to patrol mill property, was fined \$10 and costs in City police court today after Judge Frank Sims, Jr., found him guilty of striking O. T. Dewese, a CIO official, in a disturbance along a strike picket line at the Highland Park mill here Monday.

The strike began after the mill announced resumption of operation at a reduced wage scale after temporary shutdown caused by lack of orders.

CHIEF OF FBI AIDING IN CASE

Hoover Takes Charge of Florida Kidnaping Probe

Princeton, Fla., June 2.—(AP)—Edgar Hoover, Chief of the FBI, took charge of the James B. Cash Jr., kidnaping case today, while small boats and divers augmented a huge posse combing this area in the rain for a trace of the five-year-old victim.

Arriving at Miami from Washington, Hoover hastened immediately to the FBI office, where agents have been questioning several suspects for 24 hours. He refused, like his subordinates, to discuss the case. He indicated he expected to be here several days.

Hundreds of men in khaki uniforms and hunting dogs, many with pistols at their belts, assembled at dawn and were taken out in farm trucks to the sectors assigned for the second day of the search.

The hunt was extended northward through palmetto thickets, weed and flat truck farm lands.

The senior Cash and his wife remained secluded in their frame apartment building, although the father came to the door to receive three telegrams.

It was learned that the anguished mother, who had been prostrate with grief, finally was sleeping.

The augmented searching force took the field at dawn, concentrating on areas north of the Cash home. The country southward was combed yesterday.

The Federal men centered efforts on tracking down the abductors, who accepted a \$10,000 ransom payment without returning the victim.

In their custody were several persons, no one outside knew exactly how many, and a number of clues.

Fines Of \$360,000 Put On Oil Firms

Madison, Wis., June 2.—(AP)—Federal Judge Patrick Stone today assessed fines of \$360,000 and \$25,000 costs against 13 major oil companies and 11 of their officials on charges of illegally fixing a margin of profit for independent, wholesale gasoline jobbers in the mid-west.

The judge accepted the defendants' pleas of nolle contendere by which they were willing to accept penalties without standing trial.

Eight other companies and a like number of officials refused to enter nolle contendere pleas, will go on trial in Madison September 26.

In the case of each company and individual whose pleas were accepted, the court imposed a fine of \$15,000. The costs of \$25,000 are to be split among the defendants.

The companies entering pleas were the Socony-Vacuum Oil Co., Inc., Adams Oil Co., Standard Oil Co., Cities Service Co., Empire Oil and Refining Co., Continental Oil Co., Pure Oil Co., Shell Petroleum Corp., Sinclair Refining Co., Mid-Continent Petroleum Corp., Phillips Petroleum Co., Ohio Oil Co., and Skelly Oil Co.

Delegation Asked Support Measure

Raleigh, June 2.—(AP)—Attorney General Harry McMillan wrote the members of the North Carolina Congressional delegation today asking them to support a bill to prohibit collection of federal income taxes on state and local public employees for salaries back to 1936.

McMillan said Senator Lonergan (D-Conn.) had introduced such a measure.

McMillan had been informed that a U. S. Supreme court decision last week in the case of the New York port authority had left the way open for the treasury to levy income taxes on state workers, heretofore regarded as excepted for all years back to 1936. The proposed bill would permit such levies only after May 23, 1938.

State Shows Progress In Industrial Construction

Reflector Bureau

Raleigh, June 2—New industrial construction in North Carolina during the first four months of 1938 was more than half as much as during the entire year 1937, the Department of Conservation and Development announced today, as the first year of a definite program of advertising and promotion neared an end.

The number of new industries locating in the state has also shown a decided increase, according to information supplied by J. T. Anderson, Industrial Engineer. Fifteen full-fashioned hosiery mills located in North Carolina in a single month this spring, Anderson said, while only 30 such mills located in the state during 1937.

Figures compiled by Anderson's office show total construction in North Carolina during the first four months of 1938 totaling \$27,038,000, of which industrial construction accounted for \$7,296,000.

"Naturally we are gratified at the acceleration of industrial expansion," Anderson said in releasing the figures. "However, the Division of Commerce and Industry is making no promiscuous bids for new enterprises. We are making haste slowly, checking each prospect just as closely as he is checking us, before moving to lend him our services. The experience of other states with fly-by-night manufacturers who are looking for a soft spot to land is being utilized in this campaign. We believe it is a sound policy to protect a community against a manufacturer with a bad record just as we attempt to introduce to a community a valuable prospect."

North Carolina's bid for the attention of industry is being based upon a conservative and a long look to the future, Anderson said.

The two-year advertising program has three phases—industrial, tourist and agricultural.

day in hot weather. The best time is while the hens are turned out of the laying house.

When gathered in wire baskets and allowed to cool overnight in the baskets, or spread out in trays, eggs will keep better and have a better flavor than if placed in cartons as soon as they are gathered.

Eggs being held for market

should be stored in a cool, moist well ventilated cellar or basement, or in a cool room where they will be protected from extreme heat or cold.

It is best not to store eggs in a room with fish, onions, or other products that give off strong odors.

Some poultrymen have made good use of caves dug in hillsides in storing their eggs. The caves

should be well ventilated.

An iceless cooler which can be made at home at practically no cost will also serve the purpose. The cooler consists of a rack covered with burlap, with the ends of the burlap in a pan of water on top of the rack.

If possible, turn the eggs to mark et twice a week. They can be marketed once a week, but it is better not to market eggs that are more than a week old.

An Open Letter to County Commissioners

In regards the article entitled "Statement from the Pitt County Board of Commissioners to Citizens of Pitt County," I would like to ask the Commissioners a few questions as a means of getting an explanation of the things brought out in this statement in Thursday's, May 26th issue, of The Reflector.

In reading these statements one would think The Board would like for the public to know the truth, since that was the thought that motivated the publishing of these statements; and truth, honesty and a desire for fair play was the motive for their actions in this most expensive action brought in this county. Then I say, please explain to the public why, above everything else, you wanted to get Sam Whitehurst out of the Sheriff's office? If it was the safety of our Democratic Government you feared, then why didn't you go about the job in a democratic way, if it was the safety of the money in Pitt County Treasury, then please tell me why you are using many times more money to throw him out than you even claim that he has taken or failed to turn over to the County Treasury? Is it true that the same auditors who did this special audit, do your annual auditing? If this is true, why the extra expense of auditing just a few months after your last year's audit was made, and a short while before the next audit is due? Were they more efficient at this time or did you make the mistake in contracting them? And did you have the Sheriff under bond? If so, why SPEND the county's good money to collect or oust him just at Primary time? Boys, doesn't this look suspicious? If the recommendations to investigate came from the parties mentioned, then why didn't you start in Greenville, the center of our population, and the homes of most of the parties composing these organizations. It all was brought out in your Courts or our Courts the fact that most of the crimes committed in the special term of Court held in the fall of last year originated in Greenville. The prostitutes picked up were taken from her hotels or streets. If that is true, then why was your investigation centered on one officer? Surely you are not condemning him for conditions in Greenville and the other towns that have their own officers?

You mentioned something brought out from Grand Jury investigations. Have we had an investigation by any Grand Jury? Or did we have a bill presented by our Solicitor and States witnesses heard? Some of you are college men. Would you call that a Grand Jury investigation?

Then you mention the undercover work. Just which were you speaking of, the undercover work done by you or by Mr. Batson and his co-workers? I guess you would have us believe that the citizenship of Pitt recommended the hiring of Batson. But didn't you say on the stand that Mr. Batson made the survey and recommended that you hire him to clear up the conditions in Pitt County and you did so at a contract for \$40.00 per day. Is that right? If so, were you keeping faith with the people of Pitt? Would you say the public feels proud of the fact that Pitt County has gone so low that people like Mr. Batson had to come in and clean up us? Would you say we have gotten to that point in our social life? If so, was S. A. Whitehurst responsible? Don't you think if this condition exists, there are others in the County that have been paid for services not rendered?

Now as to the results of the undercover work, you claim an increase in sales of A. B. C. liquor. You were honest in this too, I guess. If so, please make your average from two separate months, say April of '37 and April of '38, and don't take a period from September to March, which every citizen knows is the season for business in Pitt County. Then, if your statement is true, please explain where Mr. Batson got all the A. B. C. whiskey he presented to the court as evidence against bootleggers? And if these bootleggers were put out of business and they had bought their supplies from our stores, who took their places, and how could destroying the customers make an increase?

Then, Gentlemen, you come out and claim the honor for all the work or improvements made in Pitt County since '32. If you deserve it, why? How many of you have served since '32? Why are you asking for the honor of things done before you entered office? But if you had been in office, and since you have been in office, what have you done as to collecting taxes or raising money to pay Pitt County's debts? Have you provided any special source of income or means whereby taxes have been raised? Or is it true people were able to pay taxes, and all the job was to have them to spend them?

Please tell the people you serve what part of the \$747,304.10 that you boast as improvement for the county that you are responsible for? You said there was no increase in debts. Please tell the public by what means these schools were built. You boasted of several school buildings. Would you say they were built and paid in cash out of Pitt's Treasury from money collected by you? Or were they paid for by the Federal Government and now being paid by taxes from each community in which the schools serve? Or did Uncle Sam give us the money; if so, we are due a refund.

Then there was a little matter of libraries you asked to consider, you as being responsible for the increase in numbers of volumes in our school libraries. I am acquainted only with the condition in Grimesland School. If the money to pay for the books in our library came from the County fund, the P. T. A. is entitled to a refund, also for the equipment in the vocational department. The schools of Pitt County are suffering today for lack of equipment and supplies, while you are spending thousands of dollars to Mr. Batson and his bunch to do the job that we people elected a man to do, and whom we feel has done it well. You are also spending the people's money in a civil action to oust S. A. Whitehurst by showing him short when you know you do not have to spend a cent to collect any shortage in his account. Aren't you mistaken in your efforts or duties as Commissioners, or are you sure there was no selfish motive back of all this stink you and the A. B. C. Board have raised, or would you want the people to see that your vision as business men was so blurred by selfish motives that you employ a man on his own recommendation at a sum so large the public gets it confused with weekly payments instead of daily payments.

Then you say you have kept the faith. That reminds me of Peter when his Lord was taken by the Roman soldiers and Peter denied his Lord. It looks to me as though you have denied all of us, the people who elected you two years ago, the people who had confidence in you. You have branded us to the whole state as people you could not trust. You kept the public in ignorance of your plans until you had Mr. Batson and his men in the county and contracted to pay him out of the county's money a tremendous sum. Out of all of the people in Pitt County there was no one you could trust. And in all of the Campaign to clean up, how many men or citizens of Pitt were employed? Would you say you did not trust them? You have said so in actions; now you ask the same people to trust you and elect you again. I hope they show you how much they appreciate the trust you have honored them with. It may be possible you did not think we people in Pitt were competent of looking after our affairs so you imported some one else to do the job. And you brought in Mr. Batson, White, Tripp, Strickland and Beaman. And I know you are proud of the fact, and we people are proud of the fact that as citizens of this great county we have come to this disgrace.

It seems to me that you gentlemen in your statements have tried to take every honor for every improvement in Pitt County. I didn't feel that you would do that but neither did I feel that you would do other things that have been done. In the members of the Board whom I knew personally, I had the utmost confidence; and if, as you say, you are honest, then give the people credit for at least having just a bit of common sense.

The matter of S. A. Whitehurst and his candidacy for Sheriff of Pitt County is his and the people's affair, not mine. I have never asked him for any favors; I have worked with him a good bit and found him to be clean and honest to every one, and I admire him. But I do want fair play in every walk of life, and I can't see any honest reason for the things that have been done in our County, nor anything brought out that justifies the wholesale spending of the County's money.

Another thing I noticed in your statement. You mentioned the increase in the number of high schools in the County, are you asking credit for that? If so, what part does the Board of Education, the County Superintendent, the Principals and Teachers have? Also what part do we poor ignorant people in each community play in the set up of our County affairs?

Gentlemen, you said you wanted to be honest with the people. If that is true, come out and tell them you realize you have made a mess of the County affairs and you would like to have an opportunity to correct the mess that you have made. The people would have more respect for you than they have when you come with claims for honors for things done by others.

You contend that your actions looking to a clean up were prompted by recommendation of the Greenville Ministerial Association. If you want to be fair with the people, why have you not made public the attitude of the Greenville Ministerial Association as contained in a letter to the Chairman of the A. B. C. Board, from which I quote as follows:

"The members of this Association express their regret that the recently conducted so-called 'Vice Crusade,' planned to wipe out the most flagrant violations of law and order, have, so far, resulted in little more than the arrest and convictions of bootleggers, comparatively small illicit manufacturers of liquor, prostitutes, purveyors, etc., and has not located and prosecuted, as we had been led to expect, the larger interests and more powerful forces directing these violations which are disturbing law and order in our community."

MANY VISITORS ARE EXPECTED

Millions Slated Visit Venerable Smokies This Year

Raleigh, June 1.—At least a million people are expected to visit the

BIGGER-BETTER



Great Smokies this summer, according to Department of Conservation and Development estimates, but these venerable peaks are probably not getting in the least excited about it.

Certainly they are old enough to maintain perfect sang froid about the whole affair, as geologists say they are among the oldest mountains in the world—much older in fact than the Alps or the Pyrenees. By comparison the Rockies are mere babes-in-arms.

They are being made more and more accessible by completion of more links in the Blue Ridge Parkway, but those interested in development of the Smokies National Park as a real mecca for tourists are watching closely action of Congress on federal appropriations for roads. There seems quite a chance that these grants will be much smaller than had been hoped.

That some progress is being made, however, was recalled by recent award of a \$367,843 contract to Nello Deer, Inc., of Durham, for construction of 8.9 miles of the parkway in Mitchell and McDowell counties.

The Great Smokies offer visitors many rare attractions. For those who enjoy fishing there are 600 miles of streams where speckled, brook and rainbow trout abound; the first two varieties in the upper reaches and the rainbow species anywhere between the 2,500 and 4,000 foot elevation mark.

No hunting is permitted in the park area, and never will be, since one of the objectives of the national park service is the preservation of the wildlife.

The Great Smokies form a veritable paradise for those interested in trees, since there are 140 different species within the park—the largest number of any similar area in the world. There are only 65 native species of trees in all of Central Europe, and only 75 different species in the Shenandoah National Park area in Virginia.

Washington Daybook

By Preston Grover

Washington—In politics there is
more than one way to butter a p-
tato and thus it is that friends of
Representative Jerry O'Connell of
Montana believe he has received the
"White House nod" to run against
Senator Wheeler in 1940.

It came about this way.
One of the choice pieces of fed-
eral spending in the west is Fort
Peck reservoir on the Missouri
river in Montana, called by scou-
ters the "coolest duck pond in the
world." New towns have been
built up around it, an agricultural
development is in prospect and
besides that it helps open the Mis-
souri to navigation.

Early in 1937 O'Connell intro-
duced a bill to authorize spending
\$5,000,000 to install power works
at the dam. Part of the power
would be used to pump irrigation
water to tracts now desert. The
bill made only random progress.

The Way Of A Bill
Some weeks later Senator Wheel-
er introduced a similar bill in the
Senate and it made more rapid
progress. It passed the Senate and
Wheeler, who has campaigned long
and often and is rarely caught with
his hands in his pockets, promptly
sent telegrams out to Montana to
announce his success in getting the
bill through the Senate. These
things may sound casual to the
layman but to the politician such
an opportunity is like a summer
rain on his crop of votes.

The bill went over to the House
and O'Connell got busy. By a leg-
islative maneuver as simple as
cracking peanuts he had the Wheel-
er bill trimmed down until nothing
much was left but the page num-
bers. O'Connell's own bill then was
substituted for it, revised to suit
the administration and the War
Department, the latter being in
charge of the reservoir building.
In that form it passed but
Wheeler let no grass grow under
his typewriter before sending out
telegrams to Montana reporting
that the bill had passed the House.
Again when the President signed
the bill Senator Wheeler sent out
telegrams and Montana was glad

Answer To Letter of Mr. J. C. Lanier, In Farmville Enterprise Of May 27th

Fountain, N. C., June 2, 1938

MR. J. C. LANIER, Atty.,
GREENVILLE, N. C.
DEAR SIR—

The question of whether or not I received assist-
ance in drafting my reply to your letter is immaterial
to the farmers and voters; they are interested, how-
ever, in your confession that you have in the past
fought farm programs sponsored by the Department
of Agriculture in cooperation with the farmers. This
is important information to tobacco growers in North
Carolina. You will recall that you stated in your origi-
nal letter to me that you had been for farm programs
since 1933.

I suppose you were ashamed and embarrassed to
such an extent that you felt constrained not to confess
to the fact that you are a supporter of Senator Josiah
W. Bailey and that your election to the Senate would
put you in a position to assist him more effectively in
the fight against the New Deal Administration.

Your confession that you were employed by to-
bacco companies to have the tobacco scrap law de-
clared unconstitutional is also important news to the
growers of Pitt County. In this connection, I wish to
call to the attention of yourself and the voters of Pitt
County some inconsistencies in this statement.

You state that the law did not prevent the toba-
cco companies from getting a single pound of scrap
tobacco and that they got this scrap tobacco \$50,000
cheaper because of the law. If this is true then why
would they try to have it declared unconstitutional?

ceiving it from other interests, who will naturally ex-
pect cooperation from you in their behalf.

I think your letter to me published in the Farm-
ville Enterprise has made it clear to the voters of Pitt
County who would control your thinking and action
as a State Senator.

Mr. Lanier, the reason the farmers of Pitt County
are not going to send you to the State Senate is that
they fear you would become a wooden dummy, danc-
ing to the strings of the corporate interests of the State
of North Carolina. You have demonstrated the fact
that you can not and will not work with the farmers
of the state for their best interests.

Your letter clearly demonstrates that you are
temperamentally unfit to represent the people of Pitt
County in the State Senate. Your connection with
other interests would naturally influence you to pur-

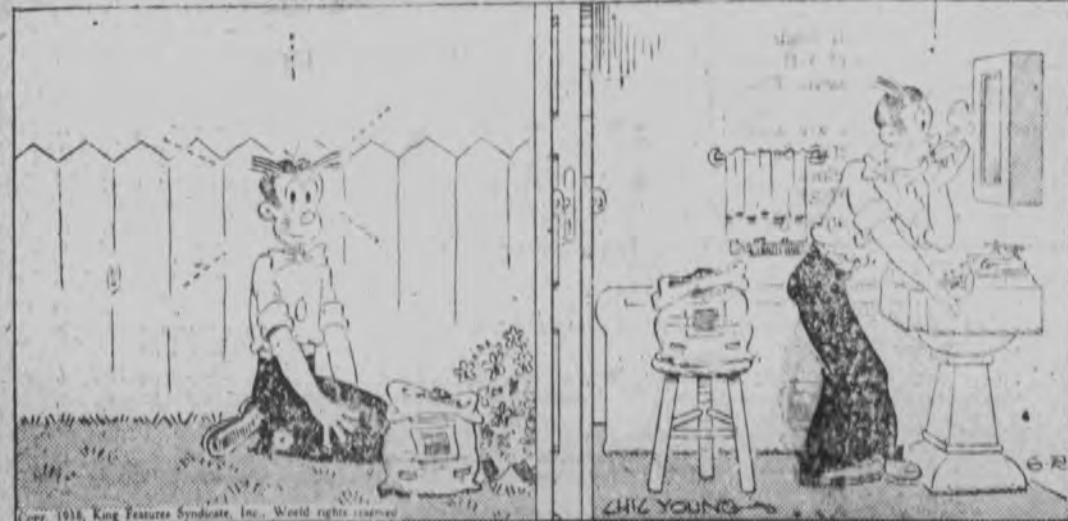

SUBMITTS PLAN TO ALL STATES

Worked out for Workers in More Than One State

Raleigh, June 1.—A plan for handling claims for unemployed workers who have worked in more than one state through registration in one state has been worked out and submitted to the 48 states and three Federal units which have laws dealing with unemployment compensation. Chairman Charles G. Powell, of the N. C. Unemployment Compensation Commission, announces. All states are expected to enter into the plan and thus make handling of such claims simple.

The plan calls for registration of the claimant in the state in which he resides at the time of filing the claim, and filing continued claims weekly on special forms. The claimant is to exhaust wage credits in the state in which he files the claim, and then the benefit payments are charged against the state in which he first accumulated credits, then are charged to the second state, then the third, and so on.

For example, if a worker established credits for three or four months early in 1937, then worked in Virginia the next three or four months, then in Maryland for a few months, and then worked in District of Columbia for a few months, establishing wage credits in all of those states, and if he then became unemployed in the District of Columbia and continued to reside there, he would file his claim in the District. He would use up his credits in the District first, then he would be paid by the states of North Carolina, Virginia and Maryland, in order of the employment, under the plan adopted.

This will simplify payments of workers who have worked in several states, a process which had not been worked out satisfactorily until this plan had been arranged.

TREATING WITH HEAT

Diathermy is simply a form of treatment employing heat. The word itself means local elevation of temperature in the tissues produced by a special form of high-frequency current.

In times past the sun and hot water were the common sources of the heat energy used in treatment. More recently various types of electrical apparatus have been developed. The latest is the short wave diathermy machine.

This instrument is essentially a small broadcasting station. The electrical energy it transmits, instead of being spread over a wide field through antennae, as with broadcasting stations, is usually confined to condenser plates.

Between these plates, but not in contact with them, is placed the part of the body to be treated. The patient becomes part of the radio circuit.

When tissues are exposed to the radio waves produced by the short wave diathermy machines, they become heated. This production of local, deep (in contrast to superficial) heat has been found valuable in many conditions.

Numerous claims have been made, mainly by the vendors of "home diathermy machines," as to the wonder-working effects of diathermy. Practically all such claims are unfounded. Diathermy is a valuable form of treatment provided it is administered in suitable cases by those experts in applying it.

There are some advantages to both the long and the short wave forms of diathermy. Which will serve best in a given condition can be determined by the physician in charge.

As to "home diathermy machines"—unless the apparatus has been ordered by your physician, who has given you clear and specific instruction on its use, don't buy or use one.

The heating effects of the "home type" of diathermy machine are no greater nor better than those to be gained from a hot water bag, electric heating pad or common electric light bulb. Besides, these truly "home instruments" cost less and are safe to use.

Scott To Present Farm Problem To Legislature

Raleigh, June 2.—When the 1938 General Assembly meets, the North Carolina Department of Agriculture plans to bring to its attention the vital importance of working out a coordinated, well balanced program of improving the services rendered farmers in marketing their crops, Commissioner W. Kerr Scott told this bureau's representative today.

"President Roosevelt says that a third of the Nation is ill-clothed and a third of the Nation is ill-fed, and yet North Carolina must call upon the Federal Surplus Commodity Corporation virtually every month to obtain help needed on chaotic, badly demoralized markets," said Mr. Scott in stressing the pressing importance of the subject.

"The challenge to North Carolina agricultural planning is the fact that of \$19,000,000 spent annually for farm production, control and for all agricultural purposes, less than \$100,000 of one half of one per cent is spent for marketing," he added.

To teach farmers to increase their yields and quality of crops and then fail to furnish them the information and assistance needed properly to market their products is not sound economics," he said.

He predicted that it is but a matter of time when North Carolina will drastically cut its tobacco and cotton acreage—acres which will revert to forest crops, pasturage poultry and livestock—and will demand the best marketing program that can be given.

He cited specific products and the great need for some marketing program for them:

Poultry—North Carolina produces less than 35 per cent of its eggs. This field is practically untouched.

Tobacco—Farmers received about 60 per cent of their cash farm income from this crop and yet only one marketing specialist is now doing grading work for the department. Forty "pin-hookers" operated in Winston-Salem last season, many buyers walked off the floor at Asheville when they found tobacco so jumbled they could not determine its value. This is a marketing problem.

Cotton—Cotton seed has become nearly as valuable as cotton. It should be bought on a grade basis like cotton, but the seeds from 752,000 bales were sold last year without benefit of market information by a cotton-growing state in which it cost 123 cents to grow a pound of cotton that sold for less than ten cents.

Fort Bragg Making Preparations For C. M. T. C.

Fort Bragg, June 1.—Preparations are rapidly being completed for the reception on June 16th of approximately 850 young men at Fort Bragg, N. C., for a month's training with the Citizens Military Training Camp. A great deal of interest has been shown this year by the return of a large number of men who have attended camp at Fort Bragg in previous years.

Extensive plans are being made to

make this year's camp both beneficial and pleasant for the trainees.

The camp will be organized as a regiment of light artillery consisting of two battalions of three batteries each. The batteries will be equipped with the "French 75" gun, one of the finest weapons in use during the world war. Supervised athletics will be held for all men in camp and numerous competitions will be held in such sports as swimming, boxing, tennis, baseball, volleyball, and track.

The camp area is under the command of Brigadier General William Bryden who has recently succeeded General McGloskey to the command of Fort Bragg. Lieutenant Colonel Donald M. Beere, 4th Field Artillery, will be camp commander and, under his direction, a small group of regular army officers and enlisted men will carry on the administrative functions of the camp, while instruction in military subjects will be given chiefly by officers of the 316th, 317th and 218th Field Artillery.

MANY TESTIFY CHARACTER OF SHERIFF GOOD

(Continued from page one)
Tucker said that he had not been working but a few days when ABC Chairman Horne, in conversation with him, complained that since the ABC board was paying the special officers the officers headquarters should be in the ABC office instead of in the sheriff's office. Tucker said that on several occasions Horne made this statement to him. He said that while he and Taylor were working under this arrangement that the sheriff personally and both his other deputies aided in every possible way in breaking up bootlegging in the county, many times all the officers working on the same case and at other times one of the deputies working with him and another with Taylor. Asked on cross examination if he was entirely under the sheriff and if all orders came from the sheriff he stated that he was under orders of both the sheriff and Chairman Horne and investigated any leads or reports brought to his attention by either. During his entire four years of deputy sheriff under Whitehurst, prior to becoming an ABC officer, Tucker said, Whitehurst was ever vigilant in his efforts to break up bootlegging.

D. M. Clark, of this city, solicitor of the Fifth Judicial District, described the sheriff as the best sheriff in North Carolina and declaring that the members of the board of commissioners were honorable men, he expressed the opinion that they must have been hypnotized or badly misled or ill-advised to bring such an action as this present hearing against Sheriff Whitehurst. The solicitor stated that as mayor of Greenville in 1921 he employed Whitehurst as a member of the Greenville police force and that he received an anonymous letter to the effect that Whitehurst had been fired as Chief of Police of Ayden for drunkenness. Clark declared he investigated the matter thoroughly and found it to be untrue.

Testifying that Whitehurst was outstanding as a sheriff, John Robert Meyers Case, Willie Tate case, Pulley case and other important cases in this county as outstanding instances of the sheriff's ability and efficiency as an investigator.

Referring to the matter of uncollected bills of costs and court times he said that especially during the depression the courts here and elsewhere had been most lenient in extending time to law-breakers for paying these items and that as a result of this practice on the part of the courts the total amount of these uncollected items had piled up. He said that in most cases the judge on the bench permitted the defendants to go free without bond and that there was little or no chance to collect the item. When capias were issued and the defendants brought back into court if they could not pay they were permitted to go again, he said.

With reference to the present hearing and pending grand jury indictments against Sheriff Whitehurst he declared that the commissioners had been hypnotized, misinformed or ill-advised by investigators whose interest in the matter was the big pay they were receiving for their services.

He said that the first time the matter was ever discussed with him was during the January term of court when Woodus Kellum, attorney for the petitioners, came to his office and told him what was going on. He said he told Kellum that if there was any evidence of bribery against the sheriff he would go the limit to get him convicted but with the general character and reputation of the witnesses and the reputation of the investigators, no one would believe the sheriff guilty unless it was someone who wanted to believe him guilty anyway. "Certainly no impartial person would accept such evidence," he said, "and I don't blame him."

Clark said he was next approached by F. C. Harding, county attorney, and asked if he did not think it wise to have a conference with the commissioners. The witness said he told Harding he would be glad to confer with the commissioners anytime they wished him to. He said that during the noon recess of court he met with the commissioners in the court room and Chairman M. Lewis asked him if he wanted to talk with them. "If you don't want to talk with us, we don't want to talk with you," Clark said the chairman stated.

Clark said he advised the commissioners that if there was anything to the case the matter should be brought into the open at once but it appeared he commissioners desired neither his services nor his advice. He said in order to get the matter before the grand jury he drew a "John Doe" warrant, got the list of witnesses from Batson and placed the matter in the hands of the grand jury. He said he was called into the grand jury room during the investigation and that he drew the bills against the sheriff and returned them to the grand jury.

Questioned as to whether he was familiar with the fact that the sheriff had not paid certain fees to the county, he said that there was a yearly check-up and payment by the sheriff, register of deeds, and clerk of court at which time the officers settled any differences in account and that is the procedure that should have been followed in the sheriff's case. "Certainly he alone should not have been picked out for impeachment," the solicitor said.

When S. O. Worthington resumed his testimony at the afternoon session yesterday there was objection by prosecution counsel when the witness attempted to reveal that he had learned from the county auditor's office the amount of money paid A. S. Batson for services since October of last year. The objection was based on the contention that Batson had not

been on the stand. The witness testimony dealt with the reasons he had called a mass meeting in the court house and was for the purpose of showing that Sheriff Whitehurst had no part in calling the meeting. Defense counsel contended that since the petition specifically charged that the sheriff had instigated the mass meeting and the placing of advertisements in the newspapers to influence citizens in his behalf and against the commissioners, that this testimony was relevant. Judge Cowper ruled that since there had been no evidence presented by the prosecution to support this charge of the petition, it was not necessary for the defense to put on rebuttal testimony since the section of the petition was unsupported and therefore would have no bearing whatever on the rendering of a decision in the case.

L. G. Cooper, local attorney, testified to the good standing and reputation of Sheriff Whitehurst both as an officer and a man and stated that process delivered by him to the sheriff's office had always received prompt and efficient attention. He also testified that in certain homestead actions in which refunds were due him, he had received payment in full from the sheriff. This phase of his testimony was brought out by the de-

fense in view of prosecution testimony that tended to show that the sheriff's fee book revealed that certain of the amounts "due the county or others" were due to Cooper.

Prosecution counsel objected to this testimony on the grounds that it was a matter of record and the records and audits had been introduced into the evidence by the prosecution. The defense contended that it had the right to reveal that items appearing on the record as unpaid had been paid by the sheriff. The judge declared that it was a matter of correcting the record and this should have been done previous to introduction of same into the evidence. Defense counsel J. B. James agreed heartily with the judge that it was a matter of accounting and that the entire matter should have been heard on that basis instead of an outster proceeding against the sheriff. The judge sustained the objection of prosecution counsel and the defense took exception.

B. L. O'Brian, of Norfolk, captain of A. C. L. Railroad police force, testified that on many occasions his department had called on Sheriff Whitehurst for aid in detecting crime and apprehending criminals and that the sheriff's co-operation had been 100 per cent. The sheriff's reputation as an efficient officer was excellent, he said. Julius Brown, local attorney, testified to the good reputation and standing of the sheriff both as a man and an officer. He said that process delivered by him to the sheriff's office had always been handled promptly.

Charles Whedbee, solicitor of the county court, said the sheriff's reputation and standing was good. In connection with the service of process from the county court he said the sheriff's co-operation had been 100 per cent. He also testified that he knew Jesse Brewer, former defense witness, well and that his general character and reputation was good.

J. B. Eure, Ayden Recorder's court, testified as to the good reputation and standing of the sheriff. On cross examination he denied any knowledge of Sheriff Whitehurst having been "fired" from the Ayden police force. "I knew him there as a very efficient chief of police," the witness said.

W. J. Bundy, Thurman Kitchin, A. B. Corey, James L. Evans and A. S. Tyson, local attorneys, and R. T. Martin, Farmville attorney, testified to the good standing and reputation of the sheriff as an officer and a man and that process sent to his office had been served promptly and efficiently.

Eugene Hobgood, of Farmville, former chief of police, testified to the sheriff's good reputation and standing and declared that never had he called upon the sheriff for aid that the sheriff did not respond promptly and efficiently.

J. C. Smathers, of Washington, state parole supervisor, declared that his duties brought him into frequent contact with Sheriff Whitehurst and that in each case

the sheriff had given full cooperation.

Judge F. M. Wooten testified to Sheriff Whitehurst's good standing as an officer and a man in this community. On cross examination he stated that he was in conference with ABC officials and Sheriff Whitehurst when the sheriff declined to co-operate with the board on the grounds that the board had appointed D. M. Sellars as its special investigator and the sheriff contended that Sellars was "not reliable" and therefore he could not deputize him.

A STATEMENT

—By The—

Board Of County Commissioners

Due to the fact that reports are being circulated that the Board of County Commissioners have acted solely on their own initiative in their effort to stamp out vice and flagrant law violations in the County, and in employing certified accountants to make general and special audits of all the County offices, and thereby creating expense against the County, the members of the Board feel that the citizenship should be furnished the following facts:

FROM GRAND JURY REPORT OF NOVEMBER 5th, 1937.

"We wish to commend the County Commissioners, the A.B.C. Board, and their Enforcement Officers for the efforts they have made and are still following up to rid the county of the illicit whiskey traffic. We are pleased with the success they have made and we are pledging our full support and cooperation in the drive they are making to rid the county of this traffic."

FROM GRAND JURY REPORT OF NOVEMBER, 30, 1937.

"We wish to express our approval for the action taken by the County Commissioners, the A.B.C. Board, and all County and City Officials in their efforts to rid the County of the illicit whiskey traffic, and other forms of vice which now exist in the County. We realize that much good has been accomplished, and we ask all County and City Enforcement Officers and the citizens, as a whole to cooperate in this fight to the end that we may have a cleaner and more wholesome community in which to live."

FROM THE GRAND JURY REPORT MARCH 21, 1938.

"In line with the duty of the Grand Jury of Pitt County we have conducted a careful investigation into the affairs of the County and recommend:

2—That certain apparent discrepancies in the accounts of the various County offices, as shown by the audits of Williams and Wall, be immediately rectified, and that the County Board of Commissioners immediately take such steps as may be necessary to bring about a final and complete settlement of such differences as exist.

4—That a thorough and complete audit be made immediately of the financial conditions of Pitt County. That such audit delve into the interstices and ramifications of all the County's affairs."

FROM REPORT OF MEETING OF LAW & ORDER LEAGUE, PRESIDED OVER BY REV. W. A. RYAN, HELD IN COURT HOUSE NOVEMBER 18, 1937, AS PUBLISHED IN THE DAILY REFLECTOR:

"Campaign against vice explained at Mass Meeting. League commends action of two Boards. The Mass meeting passed off fairly well and resulted in the adoption of a Resolution that commended the A. B. C. Board and County Commissioners for their action in employing secret agents to attempt to enforce the laws, and at the same time endorsed efforts of the regularly constituted law enforcement agencies and pledge support to their enforcement of the law."

These reports of Grand Juries are specific and made clear the duty of the Board of County Commissioners. The action of the Law and Order League on November 18th, 1937, clearly stated the views of the large number of citizens present. The actions of both have been accepted by the Members of the Board as a mandate to act. Surely it should now be clear to all that the Members of the Board, regardless of what might have been their personal desires, had their duty defined for them by those who were in authority.

The Board has neither persecuted nor prosecuted any one; rather it has endeavored only to carry out the mandates of Grand Juries and the people as they understood them. From the information gathered from the investigation made by detectives and from the audits made upon recommendation by the Grand Jury, it was felt that it was our duty under oath to turn this information over to the Grand Jury and the Court. Every act of the Board of County Commissioners has been done as they sincerely believed to be their full duty to the Public and with the full knowledge and approval of the County Attorney.

FARMER IRKED OVER ACREAGE

Inaugurates "Back to PWA" Movement As Protest

Reflector Bureau.

Raleigh, June 2.—A Virginia tobacco grower has initiated a "Back to the W.P.A." movement as the result of the cut handed him in his tobacco acreage, if a letter printed in a Danville paper and which just came to this bureau's attention is to be taken as authentic.

After dealing his many woes and griefs, the correspondent ends thus: "If they want to they can send me my soil erosion and rental and par-

ity check right away and will not ask them to give me more acreage, as a matter of fact, if they will give me about \$5 per acre, they can have the land and we will move off of it and go back to w.p.a., where we should have stayed while we were there, in the first place."

Some of the relevant parts of his letter include:

"My tobacco acreage was cut down from 9 acres to 4 acres, and if it is left like they left it, I and my family will be ruined for life."

"...it seems that my farm was measured with a airplane, but they were too high and included Joe Moore's cow pasture. I want his stuff took off my map at once, and besides they include my watter million patch and the children's baseball diamond in my farm, but these improvements is on my wife's land which she inherited from her uncle engaged in this work, while the when he died with flies."

"We don't want no airplane meas-

urements, but send a short-legged government man down to step my acreage off, or let him measure it with a 5-foot rule. I can't stand this cut in our family, how can we exist without acreage?"

"One of my nabors was allotted 13 acres and last year he grew 12, we work adjoining farms, why this favoritism, he is no more dummer than I am, he voted for al smith as a matter of fact, I have stood by the new deal, but if I can't work but 4 acres, you mought as well not lookout for me at the poles when the next elecshun comes off. I won't be run over."

There are 10,000 jinrikishas on the streets of the International Settlement in Shanghai and each one furnishes employment to three coolies who work in eight-hour snuffs, making a total of 30,000 men engaged in this work, while the average number of dependents for each coolie is five.
