WHITEHURST REMOVED AS SHERIFF PITT COUNTY

Japs Desert War To Save Chinese In Path Of Flood

Waters of Yellow River Cover Much Of Honan Province

300,000 CHINESE MADE HOMELESS

Japanese Troops Forget Strife With China For Time Being To Turn to Life Saving

Shanghai, June 15—(AP)—Both Chinese and Japanese armies were fleeing today before a Yellow river flood that could not be stopped either by guns or bombs.

Spilling through immense breaches in the river dykes between Chengchow and Kaifeng, the flood waters rolled for miles across the flat plain of Honan province, recognizing no man-made barriers and carrying disaster to millions of Chinese peasants as well as to armies.

Japanese war dispatches said fully 300,000 Chinese civilians had been made homeless and estimated 150,000 civilians had drowned.

Although some reports were regarded as highly exaggerated, there no longer was doubt that property damage and loss of life would be widespread.

Hundreds of floating corpses were declared to be visible, and Japanese troops were turning from war to life-saving, participating feverishly in building rafts in an effort to save Chinese peasants stranded on high ground and house tops.

Tragedy long familiar to China, was being enacted as farmers fleeing before the relentless current were trapped and drowned in their homes and fields.

Delayed Japanese dispatches said the rapidly rising flood was coursing in a southeasterly direction from Chungking.

Japanese military spokesmen offered no information on exact whereabouts of their troops in the flood area although it was assumed most of them would be able to avoid the main course of the flood.

The Japanese army spokesmen said "more Chinese civilian lives than the Japanese could ever jeopardize by bombing are being placed in immediate danger."

Some Statistics On Race For United States Senate

Raleigh, June 15.—The answer to all the facts and figures, mostly figures, in this story might well be "So What?" as the nomination of Our Boy Reynolds over Frank Hancock was conceded by everybody long before the last unofficial returns were given out on the night of June 4, but for these of a statistical mind there may be some interest.

The Reynolds majority was 118-162 from his 315,316 votes, with 82 counties finally landing in the Reynolds, 18 in the Hancock, one of these by a slim 2-vote margin. That tight squeeze was in Warren where Frank got 1,584, Bob 1,582.

Reynolds banner county was his home unit, Buncombe, which gave him 19,849. The smallest Reynolds vote was in Avery, 423, but even there, Bob was a winner as Hancock captured only 126. Hancock's biggest vote was in Mecklenburg,

FOUND GUILTY OF KIDNAPING

Franklin McCall Convicted in Abduction of Cash Boy

Miami, Fla., June 15.—(AP)—Franklin P. McCall, 21, was found guilty of kidnaping James Bailey Cash, Jr., today by Circuit Judge H. F. Atkinson, who said he would impose sentence tomorrow morning.

Miami, Fla., June 15.—(AP)—Elaborate precautions were taken for the safety of Franklin P. McCall today at a hearing on the ransom kidnaping of James Bailey Cash, Jr., to which he pleaded guilty.

Two hundred or more persons, half of them women, thronged the corridors outside the court room, which holds only 150. Officials herded them into line for admittance singly.

Inside, two policemen searched each man and two matrons "frisked" the women, even removing their hats and peering into their handbags.

McCall came in with a serious expression, wearing a blue shirt and tie and a gray suit. His uncle, pastor of a Methodist church near Bradenton, Fla., and a brother from Valdosta, Ga., shook hands with him and sat near him at the defense table.

State's Attorney George Worley, suffering from boils, was accompanied by a nurse.

"Is the defense ready?" asked Circuit Judge H. P. Atkinson.

"Yes, Your Honor," replied Jack Kehoe, attorney assigned to defend the prisoner.

Worley led James Bailey Cash, Sr., the victim's father, through details of a search for the lad, leading to discovery of the first of three ransom notes at the home of a Negro, John Emanuel.

Cash said the note was turned over to the FBI and later returned to the kidnaper in the shoe box in which the \$10,000 ransom was paid.

A photostatic copy was identified by Cash and introduced in evidence.

Cash also identified the other two notes and the pajamas the boy was wearing when he was stolen from his bed.

Mrs. Wilson Cash followed the father to the stand.

Maryland Vehicle Dives Into River

Tarboro, June 15.—(AP)—Willie Fields, 22, of Salisbury, Md., and C. J. Boyd, 25, of Jacksonville, Fla., narrowly escaped death by drowning early this morning when their loaded truck crashed through a steel railing of the Roanoke river bridge between Scotland Neck and Rich Square and plunged into the river.

Fields rescued Boyd, who, asleep at the time of the accident, was pinned in the submerged truck.

They were rushed to a hospital here. Fields suffered from nervous shock and Boyd from leg and arm cuts and possible internal injuries.

PAYNE, TURNER LOSE APPEALS

Death Date Automatically Set for First Day of July

Raleigh, June 15.—(AP)—The State Supreme Court upheld today death sentences imposed on seven men, including William (Bill) Payne and John Washington (Wash) Turner, convicted in Buncombe county of the murder of Highway Patrolman George Penn, August 22, 1937.

The court's decision in the Payne Turner case was written by Justice Wallace Winborne.

Payner and Turner were escaped convicts at the time Penn was killed and had been widely sought in this state and South Carolina. The decision automatically set their death dates for July 1, unless Governor Hoyer intervenes.

Justice Winborne noted that 688 exceptions were filed by counsel for the condemned killers in an appeal record covering 342 pages. He wrote that the court "carefully examined" the exceptions and found no "reversible errors."

"Even if there be technical error in some of the rulings and in the course of the trial, this alone would not work a trial," he said.

"It is clear," wrote Judge Winborne, "that Patrolman George Penn, the deceased, was acting in the line and discharge of his duty and within his rights as an officer in attempting to arrest the defendants."

The court handed down 43 opinions in all.

The death sentence imposed in Forsyth county on Melvin Petree, convicted of the slaying of Ozzie Collins also was upheld, in an opinion by Judge M. V. Barnhill.

Remove Obstacle To Adjournment

Washington, June 15 (AP)—The Senate approved a compromise flood control bill today clearing away one major obstacle to adjournment tonight.

Washington, June 15.—(AP) Senator O'Mahoney (D-Wyo.) resumed a talking marathon on the \$375,000,000 flood control bill today.

His determination and that of some of his colleagues to force changes in the measure threatened to delay congressional adjournment beyond tonight.

Senate Majority Leader Barkley, asked when adjournment might be reached, would only say "wait and see."

O'Mahoney said he was "not concerned with a filibuster" against the bill, but asserted he did not know how long the speech-making might continue.

Meanwhile John Lewis, CIO chairman, made an apparently futile demand on the House leadership for consideration of a labor bill the House Rules Committee pigeonholed yesterday.

The labor leader said after conference with Speaker Bankhead that apparently no motion would be entertained on the House floor today to suspend the rules and consider the legislation.

After the conference Lewis bitterly told newsmen:

"We asked the Speaker to permit a mere motion to permit a roll call vote on this question. The Speaker was disinclined to grant the request."

"We think the Democratic House leadership should do something about it. We have so told the Speaker."

"He stated that he would give the matter additional consideration. What his decision will be, is for him to say."

Also, Josephus Daniels, American Ambassador to Mexico, said he did not believe there were "any foreign influences behind the recent troubles in Mexico."

"Many of the troubles in Mexico are home grown," he added in an interview.

Only President Roosevelt's signature was needed today to start an unprecedented federal program for nationwide regulation of industrial working hours and minimum pay.

The board of directors of the Greenville Merchants Association, in session last night, went on record as opposing the proposal of the Atlantic Coast Line to discontinue passenger-mail trains Nos. 38 and 39, operating between Kinston and Weldon.

The railroad has posted notices that it will appear before the Utilities Commissioner on June 18 to make application for the removal of the two daily trains. Under the proposal passengers would be accommodated on a mixed freight-passenger train. The notices state no accommodations for mail service.

The directors named C. T. Webb, manager of Efford's department store here, to the board to fill the vacancy created when K. L. Simpson was transferred from Greenville.

It was decided to set 12:30 as the standard hour for closing stores on Wednesday afternoons. It was originally planned to close at noon, but due to a misunderstanding, some of the stores remained open until 12:30 and last night that hour was set and a large number of stores are expected to remain open the additional 30 minutes.

Powell and Miss Imogene Ricks of the association's office staff, were instructed to attend the annual convention of the North Carolina Merchants Association, to be held in Blowing Rock on June 20-21. FRENCH CRAFT BOMBED, SUNK

Freighter Hit During Insurgent Attack On Valencia

Valencia, Spain, June 15.—(AP)—The French freighter Gaulois sank in Valencia harbor today after being bombed by insurgent war planes.

Valencia's port suffered two heavy bombings, at 10:30 a. m., and 12:30 p. m.

There were no casualties aboard the Gaulois, a 500-ton ship from Marseilles. Estimates from casualties elsewhere will not immediately be available.

Valencia was overwhelmed by an ever-swelling stream of hungry, war-impoorished refugees from Castalon de la Plana and Castalon province.

The bull ring, many theatres and every building that could be evacuated to make room for them was packed with the 15,000 already arrived.

They brought tragic stories of hours of terror spent in dodging bombs and machine gun bullets from insurgent war planes.

The road from Castalon to Valencia was a death highway.

Most of the refugees arrived afoot carrying their few worldly possessions, but a few more fortunate came by mule carts.

There was scarcely an able-bodied man among them.

Hendaye, France June 14, (AP)—A surprise insurgent offensive in southern Spain today imperiled Government defenses between two widely separated fronts.

While General Franco's forces pushed retreating Government militiamen south of the Mijares river, below Castalon de la Plana on the eastern coast, another insurgent army advanced on the southern Cordoba front.

Insurgent dispatches reporting virtual Government collapse on both fronts, indicated the two offensives were linked to divide the government's weakened resistance between two extremes of its territory.

Funeral services for Henry C. Jones, 43, who died suddenly Sunday, were conducted at the home in Ayden Monday afternoon by Rev. R. H. Mason of Ayden, and Rev. Walter Nobles of Winterville.

E. Jones of Plymouth, J. G. Jones of Stokes, and P. R. Jones of Chocoma; and one sister, Mrs. Herman Worthington of Winterville.

Consent Judgment Provides He Pay Part Costs

DEPUTIES ALSO OUT OF OFFICE

Coroner Ellwanger to Serve as Sheriff Until One is Appointed by Commissioners

In a consent judgment signed by counsel for both sides and approved by Judge G. Vernon Cowper, before whom the Sheriff Whitehurst ouster proceedings have been under way for the past six weeks, Sheriff Whitehurst this afternoon vacated his office as sheriff and resigned as the party's nominee for the office for the term beginning the first of next December. All of the sheriff's deputies likewise relinquished office with the sheriff upon acceptance of the judgment.

Upon appearing the judgment, the judge declared the office of sheriff of the county vacant from that moment and members of the county commissioners who were present in court, immediately went into session and requested that Coroner A. A. Ellwanger act as sheriff until such time as the board could appoint someone to fill the unexpired term. Coroner Ellwanger took over the duties of the office immediately.

Under the judgment the defendant is to pay the court costs proper as set out in the judgment, with other expenses pertaining to the trial being borne by the county.

The judgment likewise provides that same does not prejudice the rights of Pitt county nor of Whitehurst in any action that might follow pertaining to an accounting for any funds alleged, or which may be alleged to be due the county by the defendant.

HINTS TO HOUSEWIVES

To keep sliced peaches from darkening after they are peeled, sprinkle a little lemon juice over them. Then cover and store them in the refrigerator until time for serving.

Keep your electric light bulbs and lamp shades clean if you want to get the most light from them. A film of dust on a bulb will reduce the intensity of light. Dust or dirt on a shade will dim it.

Spicy Ideas: Sprinkle a little cinnamon over the top of cooked fruit or berry sauce. Add a touch of nutmeg to sliced bananas, apple sauce or sliced peaches. Mix a dash of ginger with baked peaches, pears or cherries.

Wash "washable" wall papers carefully. Make a heavy suds, using warm water and a mild soap. Apply the suds to the paper with a soft cloth. Quickly remove with a soft, clean cloth. Do not let the suds remain on the paper too long—it may loosen it.

Make "frosted" grapes for garnishing summer salads and desserts. Select firm grapes, dip them into slightly beaten egg whites, dust them with granulated sugar and then dry them on waxed paper. Use them, for example, as a filling for peach or cantaloupe halves.

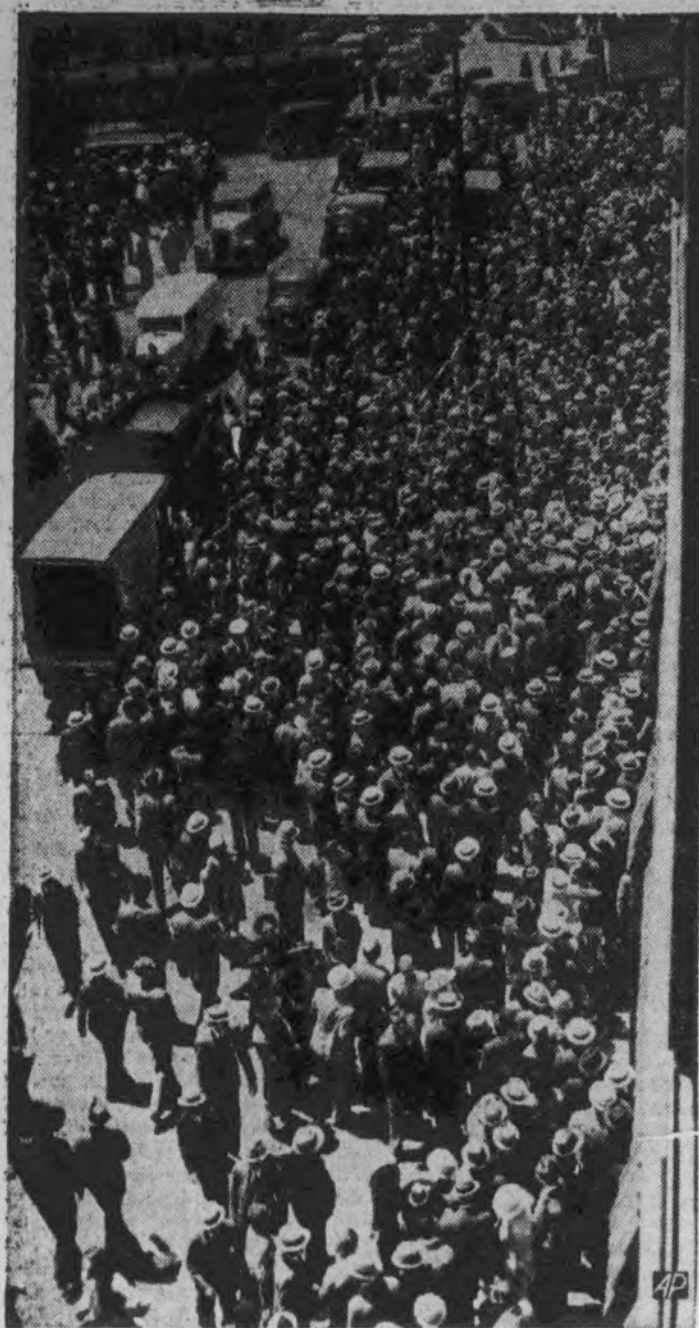

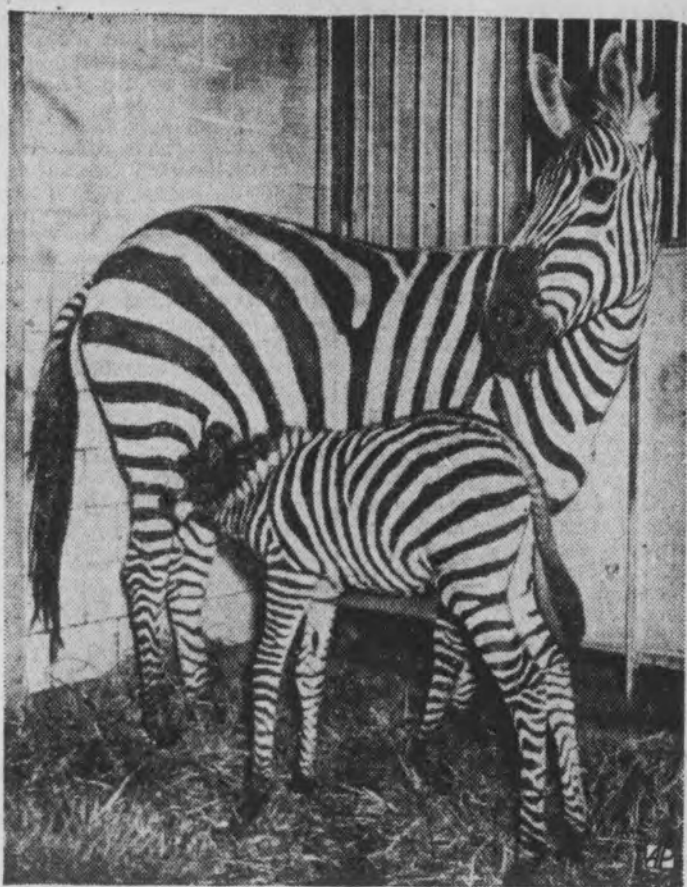

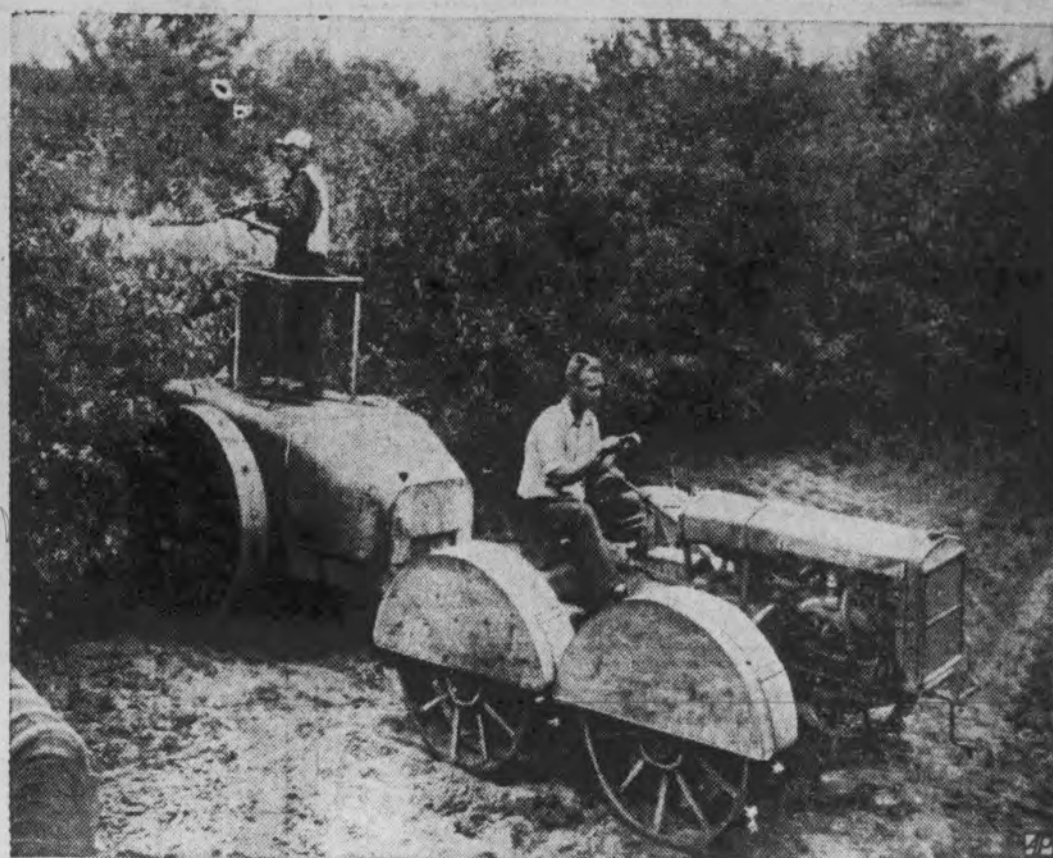

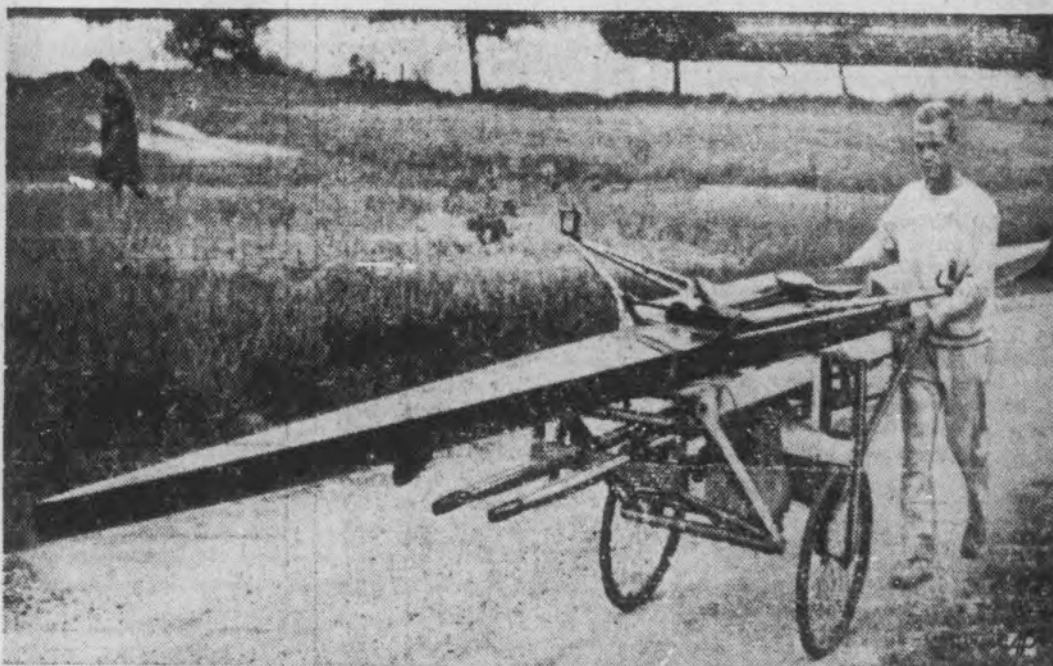

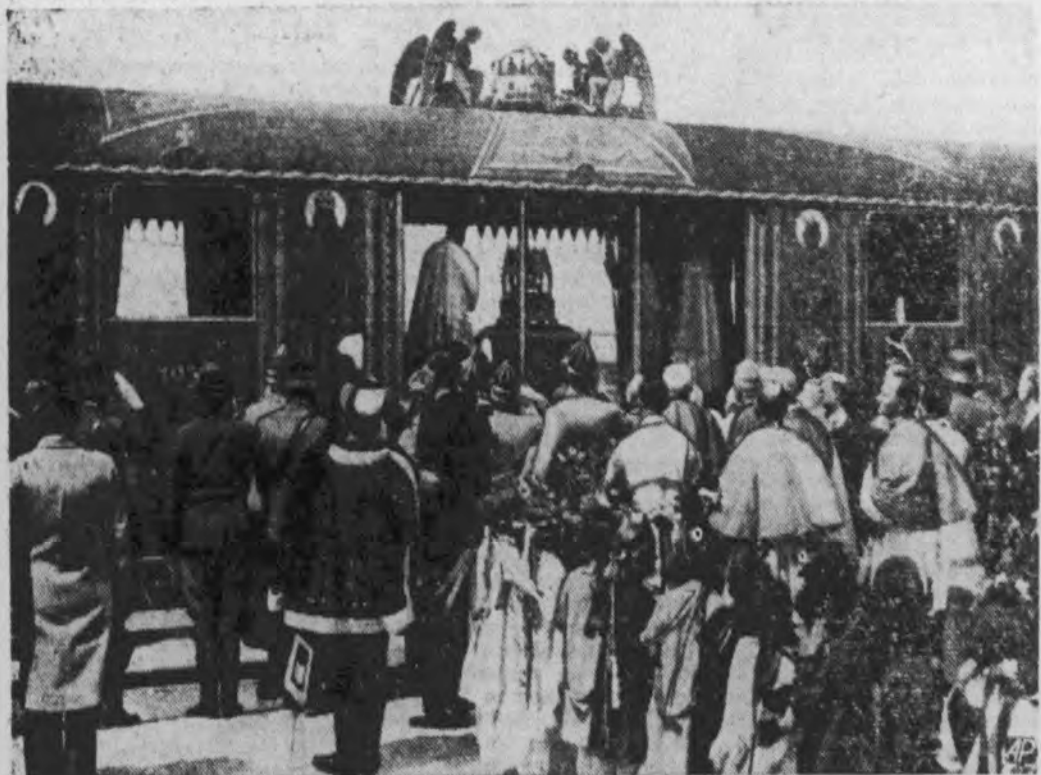

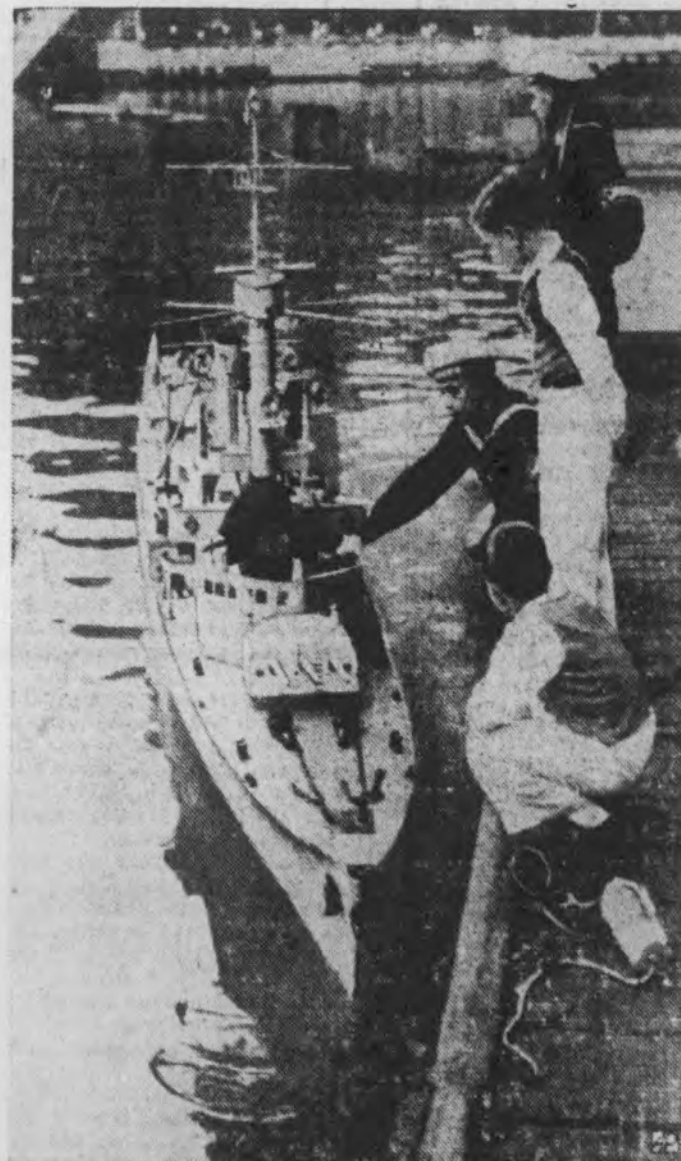

Washington Daybook
By Preston Grouer

Washington-In the very hour that President Roosevelt launched the "study" of the British labor system, an important labor organization began to look into prospects for peaceful settlement of future farm labor difficulties.

Louis J. Tabor, long time president of the National Grange, presumably initiated the proposal that in event of future farm labor trouble, he and William Green, president of the AFL, should work out the peaceful way before the strike stage arrived.

They are fellow Ohioans. When they meet it is "Lou" and "Bill" and they see eye to eye on many angles of the employer-labor problem. Neither is on the radical side. Labor and farm radicals would call them conservative.

Both were in town on a recent week-end-they are often here-and both were asked to speak at a casual little farm meeting. Neither said much at the meeting but some of the delegates got a good picture of what probably would come out of their informal peace plan.

Sitting Down Together
What distinguishes the Tabor-Green peace plan from others is that it is strictly informal and likely to be quite personal. The idea seems to be able to get the jump on labor trouble by coming to terms before hand. Before the berry harvest begins in a given section, the Grange and AFL representatives may discuss prices of berries, and costs that go into the farmers' load-so that labor can hike up or tone down its terms in proportion.

To a laissez-faire farmer or a get-it-or-leave-it leader the plan might sound just too idealistic for words. Much has to depend upon the good faith of both sides and more than a little of that has been disputed in the past.

Sitting down together, Green and Tabor might easily come to terms, each trusting implicitly the other's statements. But when a representative of a representative of a representative of Tabor meets a ditto of a ditto of Green, the situation could be wholly different.

All Quiet On Potomac
Washington-Notes on statesmanship:
One of our more excitable contemporaries wrote recently that the tension was so great in the War and Navy Departments these days that people could not walk about the corridors without being stopped at every turn by guards detailed to protect military secrets from seizure by spies.

That took us a bit by surprise, and we went immediately to try it out. Nothing happened. We tried it again later, with a companion, to learn if a change of days would bring a change of atmosphere. It didn't.

NITRO IS A BAD ACTOR.
ONE RIFLEMAN FINDS
Helena, Mont.-AP-The police weren't quite so nonchalant as their burglar-prisoner had been with his nitroglycerin.

When he was arrested after he blew open a drug store safe he carried an ounce bottle of the explosive in his hip pocket.

Gingerly taking it from him, the police explosive experts packed the bottle in a bucket of snow and carried it to an isolated hillside. There the bottle was removed and placed on an old rusted stove as a target for Patrolman Ingvald Young, expert rifleman.

Young retired as far as the range of his rifle would permit and then fired one shot.

"It appeared as though about half the hillside blew up," Young said. "The mountain shook. Try as we might, we were unable to find one piece of that stove that we could identify as such."

Explosive experts said the heat from the burglar's body was sufficient to have set off the nitro.

SHORT SHOTS

Raleigh, June 15.-North Carolina's 1,295 paroled prisoners in private employment are classified under 77 different heads with respect to the employment in which they are engaged, according to Parole facts, booklet issued this week by Commissioner of Paroles Edwin M. Gill.
Largest single occupation is listed as "Farmer," with 532 paroled engaged in tilling the soil. They are classified as landowners 9, small farm owners 84, tenants 105, sharecroppers 116, laborers 153, and family helper 65. At the other end of the list there are a number of occupations in which only one person is engaged-for instance, there is a professional ball player, an accountant, a boatman and several other "singletons."
Either "businessmen" don't get into prison, or not many of them get out on parole after they do, for there are listed only 43 of all types.
Common laborers number 153, industrial employees 120.
Congressional action in seating Democrat Roy from New Hampshire after Republican Jenks had done all the representing and got all the pay is, after all, nothing but a reversion to type, with a bit of reverse action.
Back in the days when the Republicans controlled Congress before the turn of the century, there used to be a South Carolina district in which each two years election returns solemnly showed a white Democrat to have been elected. Each time the House would spend practically two years hearing the matter and referring it back to committee. Then it would, with a straight face, declare the Negro elected and entitled to pay and contest fees. Everybody was thereby quite happy, the Democrat doing the duty and getting paid, the Negro getting paid.

Notable is the fact that the only true western county in this list is Cleveland, home county of Governor Clyde R. Hoey. Durham, of course, is technically west, and Union is listed that way, too, for political purposes.

Nell McK. Salmon, counsel for Bob Young in his election contest, started out Tuesday before the state board of elections by admitting that Johnston county election officials complied with the law in one respect-they did attend the polling places on primary day.

Otherwise, said Mr. Salmon (and he did a fair job of proving it) practically every other requirement of the law was scornfully flouted.

Libby Ward hasn't any seat assigned him yet, and it may be that the Craven representative is showing his confidence of sitting on the dais by not even asking Mr. Terry for a spot on the floor.

One House member nominated June 4 didn't even have to ask for his seat; "Uncle Dan" already had it picked out and listed. The seat very likely wouldn't be in any great demand anyway. It's number 13, and it goes, without a struggle, to Walter "Pete" Murphy, who has been coming to the legislature almost whenever he wanted to ever since 1897. "Uncle Dan" was here then and ever since he has carefully seen to it that nobody gets Number 13 when "Pete" is among those present.

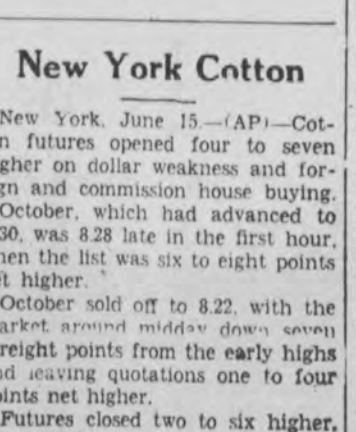

Bill Rollins was acquitted of a drunken driving charge, but convicted of driving careless and reckless and given a 60-day sentence, suspended upon payment of \$25, costs to be deducted and the balance to go as a fine. His driving license was ordered suspended for 60 days.

James Howell, Negro, pleaded guilty to driving without a license and judgment was suspended upon payment of half the costs of court in another case charging him and John Briley, white man, with transporting liquor for sale. Briley was ordered to pay \$40, costs to be deducted, the remainder going as a fine.

Michael Taft, Negro, was convicted of unlawful possession of whiskey and given a 90-day sentence, suspended upon payment of \$25, costs to be deducted and the remainder going as a fine. The judgment also provided for good behavior for two years.

Rosa Lee Lancaster and Novella Wilson, both white women, were acquitted of a charge of larceny of chickens.

SHERIFF S. A. WHITEHURST RELINQUISHES OFFICE

(Continued from page one) a copy of said resignation in duplicate being filed herewith, and having declared that he will not be a candidate to succeed himself.

IT IS NOW, THEREFORE, CONSIDERED, ORDERED AND ADJUDGED that the defendant, S. A. Whitehurst, be, and he is hereby forthwith removed from the office of Sheriff of Pitt County and said office is hereby declared vacant.

IT IS NOW, THEREFORE, CONSIDERED, ORDERED AND ADJUDGED and DECREED with respect to the court to be taxed in said action:

1. That the defendant shall pay the cost taxed for only such witnesses as shall have been subpoenaed for and in his behalf, and the cost incident to subpoenaing said witnesses.

2. That the defendant shall pay the Court cost proper, which shall include the filing fee for the institution of this proceeding, Court Reporter's fee of \$5.00 as provided by statute, and the cost of docketing this judgment, and shall not be liable for any further cost taxed in this proceeding.

3. That the County of Pitt shall pay all costs of this proceeding of whatever nature, except the costs herein specifically adjudged against the defendant.

This judgment is entered without prejudice to the rights of Pitt County, or to the defendant in any action that may be hereafter instituted against the defendant on account of any funds alleged, or which may be alleged to be due by the defendant to the County of Pitt.

IT IS NOW ORDERED AND ADJUDGED that this action go off the docket.

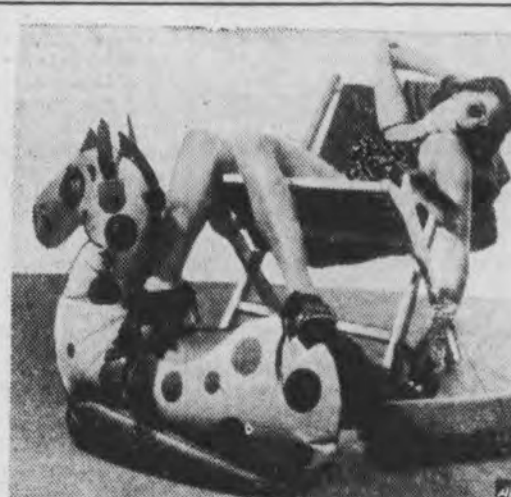

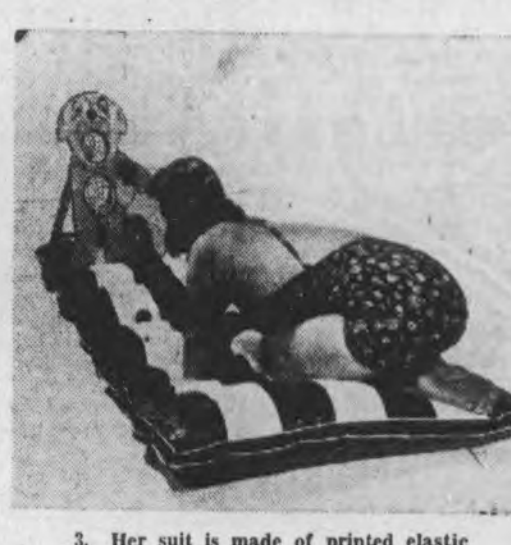

ty." Jesse Stanley, chairman of the Johnston county election board, said the registration books are "in mighty bad shape." Solicitor Candy showed a willingness to cooperate in thoroughly thrashing out the matter.

Reason for these condemnations

of the Johnston county election officials was the undetected portion that there has been absolute flouting of many of the laws and regulations regarding registration and voting.

For example, Neill McK. Salmon, of Mr. Young's counsel, cited his checkup of registration books in five precincts of the county. In these precincts there were registered a total of 909 voters, against whose

names party affiliation was shown in only 958 cases. North Carolina's law requires that registrars shall ask for and record the party affiliation of every voter who registers.

In most cases, Mr. Salmon said, the registration was merely a list of names and nothing more. The law requires, among other things, that the registrar list the age, address and date registered. He cited the Cleveland precinct where there were 638 persons registered, with nothing at all on the list except the names.

At Clayton, he charged, 2,300 names are on the registration lists

and 923 actually voted. In only 59 cases is party affiliation shown.

The Young petition charged, and Mr. Salmon argued, that as many cases known Republicans voted in the Democratic primary, and that these Republicans were actually solicited to take part.

As a bit of comedy relief, Salmon pointed out that some voters were shown on the list with "D" and "R" both in their party affiliation column, whereupon Chairman Lucas remarked—"They were Democrats for primary purposes, Republicans in the general elections, I guess."

The Young charges and petition were heard after the board had considered the case of E. J. Wellons, beaten by 23 votes majority for the State Senate by Benton. It was claimed that Wilder precinct returns should have been 220 for Wellons, 369 for Benton, while they showed officially 220 for Wellons, 369 for Benton.

This case paled into insignificance when the Young contest got underway.

Whether the board will interfere with the Canady-Young result is quite problematical, but a complete shakeup of Johnston county election methods is certain.
