\$10,000,000 ITEM HOLDS UP ADJOURNMENT

Conference Working on Last-Minute Appropriations

EXPECT SESSION TO END TONIGHT

Wage-Hour Bill And Controversial Flood Control Measure Already Enacted

Washington, June 16.—(AP)—Members of the first \$12,000,000 peace-time Congress fretted and fumed today over a \$10,000,000 barrier that stopped their pell-mell rush to adjourn.

A conference committee of Representatives and Senators struggled manfully to level the obstacle in time for final wind-up tonight. Some conferees said they were "making progress."

The barrier consisted of a handful of last-minute appropriations written into the third deficiency bill. The bill, as passed by the House, carried allotments totalling \$279,000,000. The Senate added \$10,000,000 to that.

When the two branches agree how much of that \$10,000,000 shall be left in the bill finally passed, the weary congressmen can go home.

Already out of the way were most major pieces of legislation. The wage-hour bill awaited President Roosevelt's consideration. Even controversial flood control legislation, over which a filibuster threatened yesterday, was at the White House.

Action on the \$3,753,000,000 spending bill was almost completed when the Senate approved a formula, previously passed by the House, for distribution of \$212,000,000 of farm benefit payments carried by the measure.

Subsequently the Senate agreed to a \$700,000 compromise of the rural electrification authority administrative allocation, also contained in the bill, and this was sent to the House for action.

The Senate joined the House in over-riding the President's veto of a bill containing lower interest rates on government farm loans. Its vote of 57 to 18 against the veto made the measure law.

Some legislators, weary after night and early morning sessions, were hopeful of adjournment by dinner time tonight. Others, cognizant of the possibility of a last-minute outbreak of speech-making, abandoned such hopes.

The roll call vote, by which the Senate over-ruled President Roosevelt's veto of the farm loan interest bill, included: to override—Reynolds; against over-riding, Bailey.

Money, Liquor, Car Allegedly Stolen

Corporal L. L. Jackson today quoted W. M. Fornes of near Vanceboro, as saying that he was held up at pistol point by two men and a woman on the Greenville-New Bern highway this week and left on the highway after the trio had taken his liquor-laden automobile and \$193 in currency.

Corporal Jackson declared Fornes at first did not reveal the car bore 180 gallons of whiskey, but later made the statement while being questioned regarding the hold-up.

The officer quoted Fornes as saying he stopped after the girl had "flirted" with him.

Says U. S. Would Be Pulled Into War

Chapel Hill, June 16.—(AP)—Dr. Henry R. Soffau, professor of European history at American University, Beirut, Syria, told the Carolina Institute of International Relations today there was no danger of a war involving England, France, Germany and Italy in the near future, but that "if war does come the United States almost certainly would be involved."

He said both Germany and Italy were short of raw materials and could not persevere a long war.

"Moreover, the whole of Western Europe, especially the Southern part, is suffering from drought and short crops," he said, "Italy has by no means conquered Ethiopia."

TIGHTEN BANS AGAINST JEWS

German Government Decreases More Severe Restrictions

Berlin, June 16.—(AP)—The government today decreed more severe restrictions on Jews commerce and finance in Nazi Germany.

A decree published in an official newspaper defined more closely than ever before what shops businesses or other commercial undertakings are to be regarded as Jewish.

Whereas the character of a one-man shop is easy to determine, it has been found this often is difficult in the case of a big department store or joint stock concern.

The decree aims to make certain that bans against Jewish or part-Jewish stores or concerns shall be observed to the fullest extent as far as members of the Nazi party and the entire German civil service are concerned.

Uncertainty as to whether an establishment is Jewish or not is to be eliminated.

Prepare Chamber For Asphyxiations

Raleigh, June 16.—(AP)—Warden H. H. Wilson said today all plans had been completed for the execution by gas tomorrow at State's prison of Lonnie Gardner and Apson Outlaw, Negroes, convicted in Duplin county of rape.

A third man convicted in the same case, Sylvester Outlaw, was executed April 29.

Convicted of criminal attack on Mrs. T. R. Coe, a white woman, he lost appeals to the Supreme court and Governor Hoey declined to intervene in their behalf.

The first execution tomorrow will take place shortly after 10:30, Wilson said.

Game, Fish Commissioner Prepares For Big Season

Reflector Bureau. Raleigh, June 16.—Commissioner John D. Chalk of the game and inland fisheries division of the Department of Conservation and Development, is already in Asheville completing arrangements for a convention which opens here Monday, June 20, which is expected to attract attention to North Carolina in every state in the union, also in Canada and Mexico and especially to what North Carolina is doing in the field of conservation and the renewal of its fish and game resources.

This is the thirty-second annual convention of the International Association of Game, Fish and Conservation Commissioners, meeting jointly with the sixty-eighth annual convention of the American Fisheries Society, which met last year in Mexico City and at which Commissioner Chalk was elected vice-president. It was almost solely to the efforts of Commissioner Chalk and some of his friends that the convention voted to meet in Asheville this summer.

Intimation Evidently Result of Speech By Sec. Hull

London, June 16.—(AP)—Prime Minister Chamberlain told the House of Commons today that the United States government had intimated it was preparing to make definite proposals to secure world disarmament.

Asked by Arthur Henderson, Labor member, if Britain were willing to "join with the United States government in making definite proposals with a view to securing a halt in the arms race," Chamberlain replied tersely:

"The United States government have suggested they are going to make an attempt."

The prime minister refused to elaborate on this brief statement. The discussion was opened when Henderson, son of the late Arthur Henderson, who was president of the World Disarmament conference, asked the prime minister whether the British government agreed with the recent speech of Secretary Hull favoring disarmament.

Chamberlain replied: "Yes, sir. His Majesty's government are in full agreement with the sentiment expressed by Mr. Cordell Hull in his recent speech; and they are always ready to co-operate with other nations on the subject."

Washington, June 16.—(AP)—The State Department said today no communications had passed between the United States and Great Britain on the question of world disarmament.

Officials expressed the belief Prime Minister Chamberlain's intimation in the House of Commons that definite disarmament proposals might be forthcoming from the United States were based entirely on a recent speech by Secretary Hull at Nashville, Tenn.

Hull said then: "With the world groaning under the burden of mounting armaments, we are prepared to join with other nations in moving resolutely toward bringing about an effective agreement on limitation and progressive reduction of armaments."

At least 300 delegates, from every state in the Union and from Mexico, Canada and probably Alaska, are expected to attend the convention which opens Monday morning, June 20, in the Battery Park Hotel, and will extend through Wednesday, closing with a banquet Wednesday night at which Senator Robert R. Reynolds will act as toastmaster.

One of the speakers at this banquet will be Congressman A. Willis Robertson of Virginia, former chief of the Virginia Game Commission and co-author of the Pittman-Robertson Act which levied a Federal tax on fire-arms and ammunition and earmarked the proceeds from this tax to be allotted to the states for game conservation purposes.

Another speaker at the banquet will be Dr. T. Gilbert Pearson, president emeritus of the Audubon Society, a former North Carolinian and a pioneer in conservation work in North Carolina.

Several interesting field trips are being arranged for the delegates to the convention.

ABC OFFICERS GET TWO MORE

Illicit Distilleries Located in Belvoir Township

J. M. Ward and J. L. Taylor, Pitt County ABC officers, assisted by S. T. Anderson and W. G. Newsome, Edgecombe County ABC officers, this morning located and destroyed two more illicit distilleries in Belvoir township, which brings the total to seven stills found in the same section within the past thirty days.

One of the stills, a 100-gallon capacity steam plant, and not in operation when located, was destroyed, together with 1,800 gallons of new beer.

The second still, also a 100-gallon capacity steam plant, was destroyed, together with 400 gallons of new beer. This still had not been ready for operation in two or three days, the officers said.

The first still was found in the Alpine woods and the other in the Lewis woods near the old Porter road in Belvoir township, Mr. Ward stated this afternoon.

Mrs. Sophie Jarvis Komp, 58, of 402 Greene Street, Greenville, died in Parkview hospital in Rocky Mount yesterday afternoon at 5:30 o'clock, following several days of critical illness.

Funeral services will be conducted Friday morning at 11 o'clock in the Memorial Baptist church by the pastor, Rev. L. P. Sodeman. Burial will follow in Cherry Hill cemetery, by the side of her late husband, who died March 4, this year.

Active pallbearers will be B. S. Warren, Jack Kittrell, C. B. Mayo, E. G. Flanagan, Francis Hardee, G. J. Woodward.

Mrs. Komp, the daughter of the late J. B. and Martha Anne Parker Jarvis, was born and spent her entire life in Greenville. DELAY NAMING SUCCESSOR TO PITT SHERIFF

Coroner A. A. Ellwanger, Meanwhile, Occupies Office

THREE DEPUTIES CONTINUE POSTS

Democratic Executive Committee Plans to Meet Soon to Select Party Nominee

Coroner A. A. Ellwanger continued in charge of the Pitt County Sheriff's office today, as the Board of County Commissioners discussed the appointment of a successor to fill the unexpired term of Sheriff S. A. Whitehurst, who was removed from office yesterday by consent judgment, and the county Democratic Executive Committee planned to call a meeting soon to discuss the nomination of someone to replace Whitehurst on the ticket for the November election for the term beginning the first Monday in December.

Miss Eleanor Barr, J. H. Harris and C. P. Pierce, deputies sheriff, who automatically went out of office with the removal of Sheriff Whitehurst, were immediately re-appointed deputies by Coroner Ellwanger to serve during the time that he is in charge of the office.

The consent judgment presented to the court shortly after three o'clock yesterday afternoon brought to an abrupt end the ouster proceedings against the sheriff which had been under way for nearly six weeks. Presentation of evidence in the case was completed about noon Tuesday and Judge G. Vernon Comper, presiding, had set two o'clock yesterday afternoon as the time for the beginning of arguments by counsel.

The attorneys did not appear in court until three o'clock and the consent judgment was immediately presented and signed by the judge. Under the consent judgment Sheriff Whitehurst was removed from office and was taxed with but a portion of the fixed court costs together with the costs of his own defense, the other costs of the case being borne by the county.

The judgment was accompanied by a letter of Sheriff Whitehurst, addressed to the County Democratic Executive Committee in which he resigned as the party's nominee for the office of sheriff in the coming November election.

Immediately after signing the removal order, court, was recessed while the commissioners discussed the matter of filling the vacancy.

EIGHTEEN GET PENSION FUND

Checks Here for Confederate Widows; No Living Vets

Pension payment checks for 18 widows of Confederate soldiers have been received at the office of Clerk of Court J. Frank Harrington and are ready for delivery to the eight class A and 10 class B widows.

There is not a single living Confederate veteran living in Pitt county. Several of the widows were removed from the pension rolls when they were entered on the rolls of Social Security, thereby receiving a greater sum than was available in pensions.

The class A widows receive \$150 each June and December. Class B widows are paid \$50 twice each year.

The eight class A widows in the county are: Fannie Brooks, widow of H. P. Brooks; Vene Blount Davis, widow of M. J. Davis; Melie Harris, widow of Henry F. Harris; Elizabeth Wilson, widow of Joe Wilson; Jennie Carney, widow of R. H. Carney; Nannie Little, widow of Francis M. Little; Victoria McGowan, put on the rolls under a special legislative act; and Mary E. Stocks, widow of J. A. Stocks.

Armies In Chinese War Flee In Face Of Flood

Death and Destruction Spread Over Fighting Zone

Shanghai, June 16.—(AP)—The Yellow river flood, fed by a steady downpour of rain, unraveled a ribbon of death and disaster 10 to 20 miles wide and 90 miles long across the flat plains of Honan province today. Chinese and Japanese armies, locked in combat on the Peiping-Hankow front, fled before the current, which Japanese now estimate will take a toll of 50,000 lives.

Advices from Hankow, a provisional Chinese capital, said the relentless flood, surging southwestward from torn dykes, had penetrated beyond a point 70 miles south of Kaileng on the Lunghai railway.

Contract Let For Leaf Warehouse

J. H. Blount, one of the owners of the tobacco warehouse which was recently destroyed by fire, said today the contract had been let for replacing the building with a larger, more modern and better equipped structure.

The contract was let to the Herman Site Company of High Point. Mr. Blount said the new building would cost between \$65,000 and \$75,000 and would be one of the largest warehouses in Greenville. It will be of steel construction and will be equipped with the most modern lighting effects.

The warehouse is expected to be completed by August 1, well in time for the opening of the 1938 marketing season. B. B. Sugg and G. V. Smith, who had leased the old building, will operate the new warehouse.

Antis Expected To Make Much Of Powell Incident

Raleigh, June 16.—Discovery that the mother of Charles G. Powell, \$5,500 a year Unemployment Compensation Commission chairman, has been on the WPA relief rolls in Greenville county is likely to provide the "Antis" with just the issue they have been looking for to use in the 1940 Governor's race.

Unless Governor Clyde R. Hoey takes immediate and drastic steps to do something about the matter—and from all appearances there is almost no possibility that he will—the "Antis" are going to make much of it against whomsoever eventually winds up with the Administration's blessings and support for the governor's chair.

Frankly, it's a great political baffle for those extremists who are constitutionally and habitually opposed to the State Administration and all its works. They are going to ring the changes on the "scandal" that has smitten the Administration as the result of exposure that one of its "darlings" (that's what Charlie Powell has been, there's no getting around the fact) either through ignorance or design has permitted himself to get into such an unenviable position.

For Powell, it's a tough break. Everybody in Raleigh seems to believe him when he says he didn't know anything about his mother's WPA employment; but everybody is just as frank in expressing the opinion it blows a sad, solemn "tap" for any hopes of political future for the U. C. chairman.

But above all, the generally prevailing opinion in the Capital City is that the incident shows the necessity for a thorough-going probe of what's going on in relief and WPA circles. If the mother of a high-salaried state official can get on the rolls, who can't, and what's the fault is it?

SENTENCED TO DIE IN CHAIR FOR KIDNAPING

McCall's Death Date To Be Set by Governor of Florida

DOOM ACCEPTED IN CALM MANNER

Confessed Kidnapers of Jimmie Cash Declines Opportunity To Address Court

Miami, June 16.—(AP)—Franklin Pierce McCall, 21, was sentenced today to die in the electric chair for the kidnapping of Jimmie Cash, Jr.

Cautioning the crowded court room to keep quiet, Circuit Judge H. F. Atkinson called the minister's son to the bench.

"You plead guilty to the offense as charged of kidnapping and holding James Bailey Cash, Jr., for ransom. What have you to say for yourself," he demanded.

McCall merely shook his head. "I find you guilty as charged in the indictment," the judge continued. "The same being a capital offense under the laws of Florida, and I sentence you to be held until such time as you shall be delivered to the superintendent of the state prison at Raiford, there to be held safely until a death sentence shall be carried out."

The judge said the governor would fix the date for the execution, specified the prisoner was to be put to death by electricity and concluded with the customary "may God have mercy on your soul."

He made no further comment in court on the \$10,000 ransom abduction McCall confessed to having perpetrated at Princeton May 28, but remarked privately that "it was the most cold-blooded thing I ever heard of—there were no mitigating circumstances in this case."

McCall heard his doom without flinching. His face was impassive and he looked straight ahead. Afterwards, under heavy guard, he was taken to an elevator and returned to his cell.

Jack Kehoe, the defense attorney appointed by the court, said he thought McCall had received a fair trial yesterday and there would be no appeal.

S. V. Sawyer Dies Working In Field

S. V. Sawyer, 34, died suddenly yesterday afternoon at 5:30 while working in the field near Cox's Mill. The funeral services will be held Friday afternoon at 2 o'clock at the home of Mr. and Mrs. F. A. McLawhorn, with whom he had made his home for the past nine years, moving here from Washington county.

Mr. Sawyer was a member of the Free Will Baptist Church in Washington county. Funeral services will be conducted by Elder Luther Jones and burial will follow in the Washington city cemetery, Washington, N. C.

Mr. Sawyer is survived by two sons, Johnnie Sawyer of Jamesville, and Herbert Sawyer of Roper; three daughters, Mrs. F. A. McLawhorn of Greenville route three, Mrs. Lila Mills, Greenville route one, Mrs. Bertie Sawyer of Norfolk, Va., and one adopted daughter, Mrs. Leon Buck, also of Norfolk, Va.

Dr. Meadows Speaks to Students. If you give your life to teaching, you will teach an average of thirty people, at least, each year for perhaps forty years; by the end of that period of service you will be living in the lives and influence of some twelve hundred people scattered throughout the nation. President Meadows told the summer session assembly at the college yesterday. And, said he, that is the chief reward of teaching.

President Meadows was speaking to the students of the summer school—between six and seven hundred of them—in their first assembly. He took as his theme "Teaching" (the need for it, the work demanded by it, and the reward of it).

There is a greater need now for teachers, said President Meadows, than ever before, and it exists throughout the nation. There are too many things to be taught in our complex civilization, and teachers must teach what not to do, as well as what to do.

When enough people have been taught, for example, the enormous waste of erosion, our people will not allow it to waste their land. When boys and girls have been taught to love trees and know their value, the problem of conservation will take care of itself.

Teachers are the most powerful group in the nation because of the need they fill, because they are shaping the lives right now of some 30,000,000 people.

As for the work of the teacher, commented Dr. Meadows, it is hard. It has no regard for an eight-hour day, but goes on all the waking hours in the day, 365 days in the year, for even when not in the schoolroom teachers must be preparing for the work there.

The reward of your teaching, he said, is admittedly not in dollars and cents, but in the contribution made to society.

For his conclusion the speaker summarized as follows: Teaching—Need, great; Work, heavy; Reward, the success of those you serve.

ARMIES IN CHINESE WAR FLEE IN FACE OF FLOOD

Sweeping over thousands of acres of farm land, driving peasants and armies before it, the flood was declared by Japanese war dispatches to have affected 2,000 villages with an aggregate population of 500,000.

Japanese bombing planes temporarily diverted from their death-dealing activities, dropped thousands of empty bombs, ordinarily used for trenches and machine-gun nests, into the flood area for use by Japan's army engineers in repairing dykes.

Food and tools also were being dropped to isolated Japanese troops fighting the new enemy.

While the main course of the flood was southward, another peril was reported north of the river, where Japanese said Chinese troops fleeing westward from Chengchow had cut new holes in the dyke of the river.

China invariably "swallows up" its invaders. The settlement of North China by the invading Hsuehs and Suenpans invaders began in the first century and by the end of the fifth century those tribes showed no appreciable difference from the Chinese.

SAILORS MUST DANCE TO ANOTHER TUNE

Gdynia, Poland—(AP)—Polish sailors have protested against paying the usual government license fee for operation of private radios in their cabins aboard ship.

When they are in the Polish seaport here they claim they do not use their sets because they spend their leisure time on shore, and when they are at sea they are unable to tune in Polish programs.

Representatives of the government-controlled Polish radio company would not accept this explanation from sailors aboard the "Batory" and confiscated a dozen radio sets, fining the owners.

The "Batory" is Polish liner plying between Gdynia and New York.

Man About Manhattan

New York—A world-roving newspaper reporter who eschewed the glamor of far ports to write a dramatic, swift-moving saga of an American family—a proud and sometimes murderous dynasty of the Old South—is attracting a lot of attention with his first novel, "Travelers Rest" (Cottonfield Publishers, Clamson, S. C.).

The author is Ben Robertson, a young man in his early 30's with blue eyes and unruly brown hair and a widely-spoken heritage of wanderlust derived from his great-grand-father, Daniel Boone.

Wherever he has traveled—on the scorching deck of a tramp steamer in the South Seas, in a fog-chilled basement in London—Nights after working as a reporter in Adelaide, South Australia... In Honolulu, in Moscow and Cape Cod, Robertson jotted notes for a strange, long story of a pioneer southern family.

Robertson sometimes speaks of "Business taking him to Australia." That isn't strictly true, as his friends know. The "business" was simply another attack of the itching foot, and so off he journeyed, with only the horizon as a destination, until he discovered himself one morning working on a newspaper in Adelaide.

The same thing might be said of his trip to Russia. He went there to work, it is true, but it occurred to him that it would be a lot more fun "bumbling" than traveling as a passenger. So he and a pal worked their way on a lumber boat.

He used to be here in this office, in New York, and then for a while he was in Washington, looking in on the President's press conferences, talking to Jack Garner, hanging around the Mayflower lobby, the Peacock Alley of Washington, where everybody always goes sooner or later.

And so, after a trick here and there he arrived somehow back in South Carolina, where all those notes began to take shape in the form of a novel. He went to work on it, and it's here, and as a result he has had some amazing experiences.

For instance he writes "Some of the papers have asked me to write reviews for them, without a by-line, so I guess that is the strangest break any writer ever got. I have been very modest, just saying it was a fine book and they ought to buy it. It has let loose a lot of skeletons—folks have been coming to me to say they have the same kind of stories in their Carolina background."

As to the story itself, it begins in a rude log cabin in pre-Revolutionary days, continues up to the present. It is the life of pioneers who planted the corn and fought off the "painted death" as the Indian scalp parties are called.

Richard Humber, who in addition to being a leading orchestra director is a crackjack magician, has been asked to try his hand at dramatic acting and will journey up to Warrensburg, N. Y., to play a role in a streamlined version of "Hamlet." Dick turns actor July 15.

SWINE-FEEDING ADVICE GIVEN

Experiment Recently Conducted at Agri- cultural Station

Raleigh, June 16.—Hogs thrive on a ration that includes a protein supplement composed of equal parts of soybean oil meal, fish meal, and cottonseed meal, according to swine-feeding experiments recently conducted by N. C. Agricultural Experiment Station.

Results of the experimental feedings have been published in technical bulletin No. 56, "Comparison of Protein Supplements for Fattening Pigs," prepared by Dr. J. E. Foster and Earl H. Hostetler, of the animal husbandry department. Free copies may be obtained from the Agricultural editor at State College.

In the experiment, various combinations of fish meal, soybean oil meal, peanut oil meal, crab meal, legume hay, tankage, whale meal, herring meal, and cottonseed meal were tried to ascertain which gave the best results. While the supplement with equal parts of soybean oil meal, fish meal, and cottonseed meal appeared to be best, other combinations also showed good results which are included in the bulletin.

The writers pointed out that when two-thirds of the fish meal that had been fed the hogs was replaced by cottonseed meal and soybean oil meal, each 100 pounds of supplement replaced 244 pounds of corn and 74 pounds of fish meal, thus reducing the feed cost for raising the pigs to a good market weight.

Although soybeans and peanuts make the pork soft and oily, it was explained, the meal left after the oil has been extracted, the meal left after the oil has been extracted, known as soybean oil meal and peanut oil meal, produces firm, hard pork that brings good prices.

Other events bidding for visitors to the state, will be resumption of the "Lost Colony" pageant at Manteo, commencing July 3, and the national Masonic Conclave in the Great Smoky Mountains, near Waynesville, scheduled 11-13.

July 31-August 4 has been set aside for Hendersonville's Centennial celebration.
A Coastal Festival is planned at Morehead City, August 8-14, and the South Atlantic Yachting Meet moves to Southport beginning August 11. Meantime, July will see the summer camp industry get underway throughout the state.

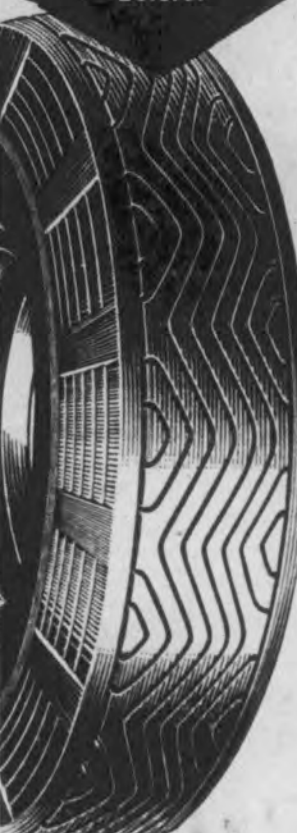

Washington Daybook

By Preston Grover

Washington.—To outward appear-
ance Congress snuffs out like a
candle at adjournment time, but
underneath the surface it simmers
and bubbles.

With few exceptions the House
members close their offices and
head for home, particularly in
election years such as the present
when the chieftain is busily gnawing
at election districts. House mem-
bers seldom have more than two
clerks and these have to return
with their boss to the office over
the First National Bank of Peebles
Corners from which the Representa-
tive will operate his cam-
paign.

A far larger number of senator-
ial offices are open during the
summer because each senator may
have four and sometimes more sec-
retaries and clerks. So one may
be left behind to answer the tele-
phone and send the Senator the
pipe he left in the upper left hand
drawer of his desk—or was it over
the fireplace?

A person would think that with
so much business at hand at clos-
ing time Congress would leave a
mass of tag-ends to be wound up,
but that is not so. All bills passed
must be signed by heavy legged
paper and typed on bills passed
before adjournment so they can go
to the White House.

They Can Make Trips

Weeks before adjournment, the
brain clerks of each house must
estimate which bills are likely to
pass so they can be engrossed for
hasty signatures.

But the business of special com-
mittees goes on and on to make
trouble, progress and headlines
during the summer and fall. A
joint committee of members of
both houses is investigating TVA.
Doubtless a few or perhaps all of
ect while the staff of investigators
them will take a trip over the pro-
ject nosing about for bad spots in
this first fruit of the planned econ-
omy.

Each chamber has a committee
to investigate the maritime situa-
tion, which will doubtless call for
jaunts to both seaboard to look at
the blank spaces on the ocean
where we used to have busy ships,
but don't any more.

Likewise each chamber has a
special committee "to investigate
and report on matters pertaining
to aquatic life in the United States,
its territories and waters adjacent
thereto." Under that resolution a
dozen senators and house mem-
or Guam and charge the bill to
bers could sail to the Philippines
Congress. Probably they won't
but the present plan calls for at
least a trip to Alaska to learn what
sailed as they are not only by our
own fishermen but reputedly by
squadrons of busy Japanese boats.

Reinder Problem Tough

Another senatorial committee also
is going to Alaska to decide what
to do about the reinder. The gov-
ernment has decided to buy all the
reinder for the Eskimos but the
Eskimos own most of them already
and Congress wants to see to it
that the government doesn't buy
them all over again. Military and
naval sub-committees may also have
to look in on "defenseless" Alaska.
Another special House commit-
tee is to investigate anti-American
activities, including Nazi, Fascist
and Communist organizations tear-
ing away at the country's vitals.
Representative Dickinson of New
York has raised most of the fuss
about such organizations but the
house bosses left him off the com-
mittee.

With a few exceptions, House
and Senate committees just fold
their doors and do nothing at all
until Congress meets again next
January. A few committee mem-
ber have to go home to help re-
elect the boss who got them their
jobs, but the others get an unad-
ulterated vacation—on full pay—
from the end of one Congress to
the beginning of the next. It's a
hard life.

SHORT SHOTS

By HENRY AVERILL

Raleigh, June 16.—A comparison
with the vote cast June 4 in the
Senate primary with the cast two
years ago in the hot-triangular
Hoey-Graham-McDonald feud pro-
duces a number of interesting, if
unimportant, angles.
For instance, the 1936 vote fell
off tremendously from 1936 in ten
counties—all but two of them in
the western sector, carried over-
whelmingly by Governor Clyde R.
Hoey in his campaign for nomina-
tion, and counties in which Repub-
licans abound.

In each of these eight units the
Hoey vote in 1936 was greater than
the total vote polled for Senator
in 1938. Here they are, with the
1938 total vote and the 1936 Hoey
vote and 1936 total vote:

Alexander, 1,010 in 1938, 1,474 for
Hoey and 2,253 total in 1936.
Ashe, 723 total 1938, 1,734 for
Hoey and 3,057 total in 1936.
Caldwell, 865 total in 1938, 2,694
for Hoey, 3,835 total in 1936.
Clay, 858 total in 1938, 969 for
Hoey and 1,231 total in 1936.

Davis, 978 total in 1938, 932 for
Hoey and 1,614 total in 1936.
McDowell, 2,808 total in 1938, 2-
805 for Hoey and 4,427 total 1936.
Wilkes, 2,209 total in 1938, 2,820
for Hoey and 4,086 total 1936.

Watauga, 1,209 total 1938, 1,381
for Hoey and 1,751, 1936 total.
The other two counties in which
the 1938 totals were far beneath
those of 1936 were Wake and New
Hanover. Wake's vote tumbled near-
ly 10,000 with only 13,000 (about
this time was caused by keen in-
terest in the "home" candidacies of
John J. Burney for Judge and David
D. Sinclair for solicitor. Two years
ago the best Graham and Hoey
managers could do was to get pro-
spective McDonald voters to stay
home. The result was a 5,500 poll in
the state's most exciting race in
years.

On the other side of the picture
Buncombe voters turned out en
masse to grab the big voting hon-
ors of the state, with 24,405 ballots
cast in the Senate race. Only one
other county in the state turned out
as many as 20,000 Mecklenburg
where Hancock got 12,198 and Rey-
nolds 10,958 for a grand total of
13,156. In 1936 Buncombe voted 19-
348 while Mecklenburgers cast 19-
754.

In both these counties there were
tremendous local battles to be de-
cided at the polls.
In about one-third the state's
counties the total Senatorial vote
in 1938 was so close to the 1936
gubernatorial primary's poll that there
may be said to have been practical-
ly no difference.
In 37 counties there were sub-
stantial increases over the 1936 vote
and in 32 there were sizeable de-
creases.

Burke and Surry were the only
"non-primary" counties in which
the 1938 races attracted as many
voters as did the 1937 governor's
sweepstakes. In Burke it must have
been the Congressional race—there
were no local contests of any sort,
while in Surry Favorite-Son Lon
Foiger was a candidate to succeed
Frank Hancock, which accounts for
the pickup there.

RHODODENDRON QUEEN CROWNED AT ASHEVILLE

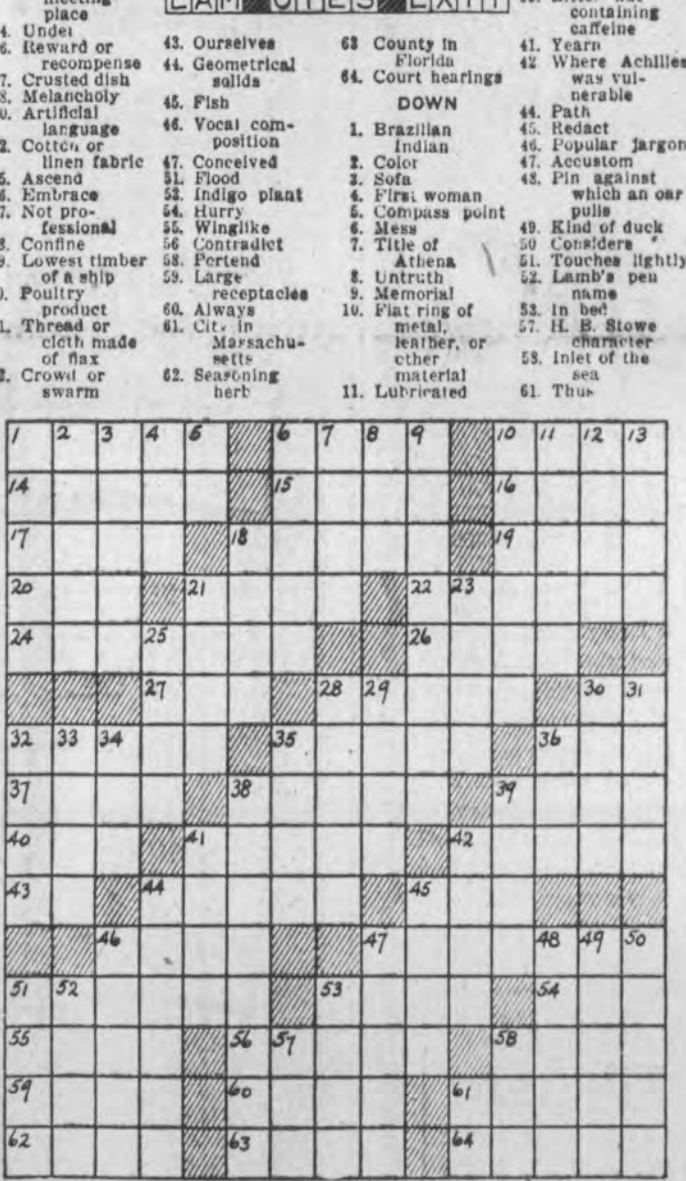

Former Piedmonter Pitches Second No-Hitter in Week

Brooklyn, June 16.—(AP)—Johnny Vander Meer, 23-year-old Cincinnati Reds southpaw, last night broke all major league pitching records by hurling his second straight no-hit no-run game. He blanked the Dodgers 6-0.

The fastballing youngster, in his first full year in the major leagues, pitched a no-hitter against the Boston Bees only last Saturday.

Eight Dodgers reached base last night, all by walks, but the 190-pounder from Midland Park, N. J., pitched his way out of the pinches on each occasion. In the ninth inning he loaded the bases on passes, with one out, but threw out one runner at the plate and then got Leo Durocher on a fly ball.

Never before in the history of the major leagues, ancient or modern, has any pitcher hurled two no-hitters in a single season, let alone in two consecutive games.

In fact, only eight have pitched two no-hitters over their entire career.

The victory was Vandermeer's seventh of the season, against two defeats.

In hurling his second no-hitter, Vandermeer also broke Dazzy Vance's National League record for consecutive hitless innings, coupled with nine against Boston Saturday, and the final one-third of an inning against the New York Giants in his previous start June 5, gave him a record of 18 1-3 innings, one full inning better than the listed mark of 17 1-3 set by Vance in 1925.

The major league record in this respect is held by Cy Young, for a 23-inning stretch in 1904, but Cy's mark was accomplished by pitching assignments of two, six, nine and six innings.

The Reds backed Vander Meer up with an 11-hit attack off three pitchers. The attack was featured by Buck McCormick's second homer of the season, with two mates aboard in a big four-run third inning. The Reds played errorless ball.

For eight innings, not a Dodger reached third base.

Vandermeer earned his second straight "hall-of-fame" berth before one of the largest crowds to see a game at Ebbets' Field in years. It was the first night game in the Dodger's home park, and 38,748 turned out for the occasion.

About 10,000 others were turned away from the ticket windows when the fire department ordered the gates closed a few minutes before game time.

WAGES POSTED AT FAST RATE

650,000 Accounts Entered Daily by Social Security

Rocky Mount, June 15.—In a statement received today by George N. Adams, manager of the Rocky Mount office of the Social Security Board, John J. Corson, acting director of the Bureau of Old-Age Insurance, announced that wages of men and women for whom the Social Security Board has established old-age insurance accounts were being posted during the last of May at an average rate of approximately 650,000 entries a day. The largest number of entries made in any one day was 1,221,259.

The wages now being posted, Mr. Corson explained, are from employers' wage reports for 1937, which were filed at the end of each 6-month period. Approximately 75,000,000 wage items reported by employers for 1937 have been received by the Social Security Board from the Bureau of Internal Revenue.

Under revised regulations effective January 1, 1938, employers now file a tax return every three months when they pay their taxes and their employees' taxes. On the same form they list the amount of wages paid to each employee during the quarter. Approximately 2,100,000 wage items reported by employers for the first three months of 1938 have been received by the Social Security Board. Employers' wage reports are filed with the Bureau of Internal Revenue and, after they have been checked against the employers' tax returns, are turned over to the Social Security Board where each employee's wages are recorded in his old-age insurance account.

Although there is a few months' lag between a worker's payday and the day his wages are recorded in his old-age insurance account, this will not cause delay in settling a claim for benefits, Mr. Corson explained. Lump-sum payments are now being made to workers reaching age 65 and to heirs and estate of workers who have died. Supplemental information concerning employees' wages needed in settling such claims is obtained from the worker's employer. Mr. Corson stated that in no instance had an employer denied this cooperation.

Increased Demand For N.C. Pulpwood Opens New Market

Farmers Collecting Millions of Dollars Each Year from Pulp Mills in and Out of State

Raleigh, June 16.—The increasing demand on North Carolina forests for pulpwood has opened up a vast market for large quantities of wood not suited for poles, piling and saw lumber. R. W. Graeber, extension forester at State College, declared today.

With four pulp mills already operating in the state and seven out-of-state mills drawing on Tar Heel forests for a part of their supply, North Carolina farmers are collecting millions of dollars each year from this source.

In a normal year, these mills use approximately 600,000 standard cords from State farms and timberlands, Graeber pointed out.

Recognizing the possibilities of this industry, the State College Extension Service has been assisting farmers in developing a program for the harvesting and marketing of pulpwood.

Market information has been supplied to thousands of farmers direct from the extension forester's office and through the county farm agents. Also hundreds of demonstrations in timber thinning, and selection, har-

vesting, and preparation of pulpwood for market have been held on individual farms. In most cases, large groups of farmers were in attendance at these demonstrations.

Graeber pointed out that the Extension Service can assist farmers interested in the harvest and sale of pulpwood in many ways. For instance, it can supply information on the location of pulp mills, the kind of each use, and the territory from which these mills purchase wood. Extension agents can make inspections or examinations of farmers' timber and give information on how this wood should be managed and harvested.

The State College forester said specialists and agents are also in a position to give the farmer practical information on the selection, scaling trees for either pulpwood or saw timber, and plans for cutting operations to give the greatest net returns.

The extension forester pointed out that the county farm agents can help farmers with their timber problems, or the information may be secured directly from his office at State College.

DELAY NAMING SUCCESSOR TO PITT SHERIFF

created by the removal, Coroner A. A. Ellwanger was called to take charge of the office pending final decision of the commissioners and this action was reported to the judge when he reconvened court about five o'clock.

Before final adjournment of the court Judge Cowper announced that the court had approved for payment by the county, petitioners attorney's fees totaling \$9,890 as follows: Woodus Kellum \$3,840; Jesse A. Jones, \$3,000; P. C. Harding \$1,500.

J. H. Harrell, \$1,250. In approving these fees the judge explained that the services of these attorneys included time spent in investigating the charges as well as their actual time in court and he felt that the

fees were "reasonable and just." In concluding the court the judge stated that on the basis of evidence in the case he would not have found the sheriff guilty of corruption but that he was undoubtedly guilty of habitual negligence as evidenced by records and his own admissions denoting carelessness and ignorance of the law in the handling of the affairs of the office.

He declared that the commissioners should in no wise be criticised for their action regarding the affair. "I hope that the matter will soon pass over," the judge said, "and I feel that this trial will prove a benefit to this county and the state."

Continuing their task of endeavoring to appoint a sheriff to fill the unexpired term, the commissioners were in session again today discussing the various candidates for the post. A spokesman for the commissioners stated that there were already a large number of applicants for the appointment and it was the desire of the board to give due and careful consideration before making the appointment. It was indicated that the process of study and elimination of candidates might take some time and no appointment would be made today. It was emphasized, however, that the commissioners want to complete their task in this matter just as quickly as it could be done in a manner that would prove the most beneficial to the county.

Meanwhile, Dr. Paul E. Jones, of Farmville, chairman of the county Democratic Executive Committee, stated today that his committee would be called to meet at an early date to accept the Whitehurst resignation and discuss the naming of a nominee to replace Whitehurst on the ticket for the next term.

It is probable that there may be informal discussions between the board of commissioners and the executive committee with a view to having the appointee and the new nominee as one and the same person.
