TEN KILLED IN NEW OUTBREAK IN PALESTINE

Members of Attacking Band Killed by British Troops

TOLL FOR WEEK MORE THAN 300

Police and Marines Tramp Streets Of Haifa, Where All Arab Shops Closed

Jerusalem, July 11.—(AP)—A patrol of British troops and Palestine police today killed 10 members of an attacking band and wounded many others as it beat off an ambush near Mount Tabor, Biblical home of the Prophetess Deborah.

One Jewish supernumerary constable was killed and another wounded and two British soldiers wounded in the battle waged in the village of Dabbourieh.

This clash brought total casualties in the week's bloody conflict beginning July 5, to more than 300.

A large band hidden in ditches alongside a road, opened fire on the patrol. The soldiers and constables returned the fire.

Country-wide reports reaching the Jerusalem central police headquarters showed five Jews were killed and eight wounded in outbreaks of violence Sunday.

The second week of the Holy Land's newest wave of bloodletting found telephone communication cut over the whole North Palestine.

Police and marines tramped the streets in Haifa. All Arab shops were closed. Night fires broke out in Jewish property near the Arab market area, but were quickly brought under control.

An Arab policeman was killed while sitting in a barber chair at Tulkarm. Four men entered the shop and riddled his body with bullets.

Armored cars of Britain's mechanized army rumbled back and forth through Jerusalem, which was tense on guard.

Macclesfield Man Highway Fatality

George Lucas, 65, of Macclesfield, was almost instantly killed Saturday night when he was run over by an automobile driven by Arthur Harrell, also of Macclesfield.

A coroner's jury today returned a verdict absolving Harrell of all blame. It was brought out at the hearing that Lucas was drunk and was lying in the road and that Harrell did not see the man in time to avoid running over him.

NOT SO HOT AS SOME THOUGHT

High of Only 94 Degrees Recorded Here Sunday

Although many people in Greenville expressed the opinion yesterday was the hottest day of the summer, the official record showed that the highest point reached during the day was 94 degrees, lower by several degrees than the highest mark reached this season.

Mrs. B. T. Clark, in announcing the official figures, said the heavy air was responsible for the uncomfortable weather to a large extent.

The lowest recorded for the 24 hours ending at 8 o'clock this morning was 73 degrees.

In comparison with the heavy rains during the latter part of June, only 60 of an inch has been recorded so far for July.

The original estimates of loss to the tobacco crop have been reduced sharply due to the fact that showers and cloudy weather prevailed after the downpours, which reached a climax with more than three inches in one day.

County Agent R. R. Bennett said that if the sun came out bright just after the heavy falls, the tobacco would wilt and die, but that if it remained cloudy, with a light rain now and then, the crop would come out.

The favorable condition prevailed and the farmers of Pitt county did not suffer anything like as much damage as was at first predicted.

Through Thursday of last week, \$14,121,194.94 had been collected in contributions and interest, \$5,057,468.83 had been paid in benefits and the balance in the fund was \$9,066,346.79.

FRANCE SHOWS BOLDER FRONT

Edouard Daladier In Role of Temporary Dictator

France's "temporary dictator" is Edouard Daladier. Three months ago, he was named premier and was granted large power that might enable France to meet the concentrated drives given to Germany and Italy by their real dictators. How has he succeeded? Here is the record:

Paris, July 11.—(AP)—When quick-tempered Edouard Daladier was named premier of France on April 10, his country faced another financial crisis, there was another outbreak of strikes and the foreign situation was reaching the crisis stage again because of the Austrian trouble.

"No one cherishes democracy more than I who come from the working classes," declared Daladier in one of his speeches. "But," he warned Frenchmen in another, "unless the nation goes to work, France may expect a dictator to make it work."

Three days after he took office he was voted power to rule by decree. That meant that the blue-eyed, stock Daladier, although he had little power in comparison with a Hitler or a Mussolini, was "temporary dictator" of France.

The premier went to work to restore the Frenchman's confidence in his country's ability to hold its place in the sun. He appealed to French patriotism in a way that Frenchmen could not ignore.

"War threatens Europe," he said in effect, "and France has been weakened. We must work to make a strong France, or France is lost."

He strengthened the nation's armed forces, solidified an alliance with Britain as an offset to the Berlin-Rome axis, laid the base for a

BEGIN HEARING LIQUOR CASES

Many Edcombe Defendants Request Trial by Jury

Tarboro, July 11.—(AP)—Judge W. Stamps Howard gave road sentences to defendants in the seven whiskey cases that were reached in Edcombe county recorder's court this morning.

As a result of the county-wide ABC crack-down 55 alleged bootleggers were brought into recorder's court here this morning under 100 warrants issued and served Saturday.

The Branch Detective Agency of Norfolk, Va., and representatives of the ABC county board have been working quietly for over two and a half months to round up the alleged bootleggers. County officials were taken by complete surprise.

Judge Howard ordered 23 Rocky Mount cases transferred to the Rocky Mount Recorder's court, granted continuances to all those represented by counsel or wishing a jury trial until July 18.

Judge Howard heard only those cases not represented by counsel nor wishing a jury trial and gave out sentences ranging from three months to nine months. No fines or costs of court were given the bootleggers.

Trip Made in Less Than Half Time of Lindbergh in '27

AIRMEN GREETED BY LARGE CROWD

Delayed in Take-Off for Moscow By Bad Weather and Slight Damage to Plane

Paris, July 11.—(AP)—Howard Hughes, after spanning the Atlantic New York to Paris non-stop in less than half of Colonel Charles A. Lindbergh's time, was delayed tonight on his globe-girdling flight by bad weather and slight damage to his big twin-motored monoplane.

He announced that he would not take off for Moscow on the second leg until tomorrow.

The American flier had hoped to be off within two hours after landing from his record-shattering crossing of 16 hours 35 minutes from New York.

But at the last minute a slight crack was discovered on the tail of his plane. He estimated repairs would require three hours.

Hughes himself was at the controls when the plane was wheeled off the runway late in the afternoon preparatory for the take-off for Moscow.

But he wheeled it back into the hangar for the repairs.

He landed here at 4:55 p. m. (10:55 A. M. EST). Lindbergh's time was 33 and one-half hours.

The big plane rolled to a gentle stop in front of the airfield's main building, where United States Ambassador William C. Bullitt headed a throng of French and Americans waiting to greet the aviator.

Hughes, however, did not cut the two motors for almost a full minute after rolling to a stop.

As soon as the propellers stopped turning, the Ambassador went to the door of the plane and opened it. He stuck his head in and shouted his congratulations.

Hughes said he was planning to take off for Russia "as quickly as possible." That means "in one of two hours," he added.

Hughes was the first of his crew to alight. He was followed by the other four airmen.

"We had a fine trip," Hughes said.

The plane took off from Floyd Bennett airport in New York at 6:20 last night.

President's Main Stop For Today At Amarillo

Chief Executive Rested After "Quiet Family Day"

Amarillo, Texas, July 11.—(AP)—The estimated 150,000 visitors who greeted the First Lady here on Mother-in-Law's Day on March 9, may be exceeded when President Roosevelt stops here late today.

Rested by a "nice, quiet family day," in Fort Worth, Texas, President Roosevelt routed his train through the Texas Panhandle bound for the Pacific coast.

He arranged three platform appearances en route to Amarillo, the scene of his biggest speech of the day. Arrangements called for a parade from the train to Elwood park in Amarillo.

Taking with him Senator Tom Conally, Governor James Alfred and a group of Texas congressmen, the President agreed to talk briefly to station crews at Wichita Falls, Childress and Clarendon.

Wichita Falls is in the district of Representative W. D. McFarlane, one of the President's train party for this portion of his trans-continental speaking and sight-seeing journey. Amarillo, Childress and Clarendon are in the district of Representative Marvin Jones, chairman of the House Agriculture Committee, who also came here to ride with Mr. Roosevelt.

Other Texas members of the House expected on the train are Maury Maverick, Hatton Sumners and Fritz Lehman.

All the representatives are seeking re-election.

FOREIGNERS IN SEVERAL CHINA CITIES WARNED

United States, Other Powers are Handled New Notes

URGED TO LEAVE YANGTZE VALLEY

Two Previous Notes Sent by Japs, First of Which Rejected by U. S.

Shanghai, July 11.—(AP)—The United States and other foreign powers were handed new notes by the Japanese today urging them to evacuate their citizens from a half dozen Yangtze valley cities listed as probable targets for further widespread bombings.

Two previous notes, one a month ago and the other last night asked that all foreign vessels and foreigners along the Yangtze river in the path of the Japanese advance to Hankow be removed. The United States rejected the first note and has not answered the second.

The new memorandums informed foreign diplomats that concentration of Chinese troops and military establishments in Hankow and other cities nearby necessitated a bombing campaign.

A Japanese spokesman said the neutrality of the French Concession in Hankow would be respected, but that he had no knowledge of any refugee zone in that area for Chinese civilians. He did not say when the threatened aerial campaign would begin.

Japanese planes already were active in the Yangtze valley, bombing Nanchang and Hangyang airfields and the boom across the river 3 miles upstream from Kiangsi. A Japanese report said five buildings were set afire at Nanchang and that four planes were destroyed and two damaged at Hangyang.

Peach Crop in N.C. Sells Below 1937

Growers Receiving 30 and 40 Per Cent Less Than Last Year Despite Good Quality

Raleigh, July 11.—Despite good quality and size of North Carolina peaches, growers are now receiving between 30 and 40 per cent less per bushel for this year's crop compared to last season, the State Department of Agriculture's markets division reported today.

A. B. Harlee, chief of the department's market news service, reports that U. S. No. 1 peaches, two-inch minimum size, were bringing from \$1 to \$2 per bushel July 7 in New York, while in July last year "virtually the same peaches" were bringing from \$3 to \$3.25 per bushel.

The North Carolina peach crop on June 1 was estimated at 2,480,000 bushels compared with 1937 production of 1,984,000 bushels and a past five-year average crop for the state of 1,813,000 bushels.

"North Carolina ranks ninth among the states of the Union in the production of peaches, California being the leading state," reports Chief Statistician W. H. Rhodes of the Department of Agriculture.

"There are approximately 26 counties in the state having commercial peach orchards of considerable size. Three counties have commercial orchards containing more than 100,000 trees—Montgomery county with 422,000 trees, Moore county with 383,000 and Richmond county with 523,000. Anson county reported 69,000 trees while all other counties were considerably less than 500,000."

With a season regarded as one week earlier than last year, Tar Heel growers had shipped 176 carloads of peaches to northern markets compared with 32 cars through July 7.

Man About Manhattan New York—Colonel Jacob Ruppert quite naturally takes pride in his baseball clubs and his brewery, because his world champion Yankees have proved themselves the most devastating machine in the major leagues, and his brewery sends millions of flagons of flaming suds down thirsty throats every day.

But there is a place where the Colonel goes when he tires of business and desires the sequestration that only a sanctuary affords. Go up to Garrison, New York and you will find it—a fine house built of stones from a pre-Revolutionary quarry. This is a place that will amaze you when you consider his mansions in Manhattan real estate. His opinion on holdings here are there.

But this is the Ruppert hide-away. One thinks of Mr. Ruppert as Big Business—the executive who is signing a \$36,000 contract for Lou Gehrig, or adding new subsidiaries to his beer empire. But consider this: at Garrison he has a strange retreat where 40-odd monkeys live. These fellows dwell in air-conditioned tiled houses, so that they get just the right temperature summer and winter. He has aviaries of rare tropical parrots; he has dozens of fancy pheasants from all over the world; he owns a flock of St. Bernard dogs, which he adores. On the grassy slope in contentment and sweet-smelling grass, are the old brewery horses which have been cared for old age. They used to haul his beer trucks through the city streets, but when their usefulness passed the Colonel didn't sell them to the glue factory. They're up at Garrison, flicking flies.

It seems to me that this very fact is a commentary on one of New York's most important executives. His activities are amazing. There aren't enough hours in the day for him to transact his business. Perhaps that is one reason you will find him, rain or shine, at his desk every morning at 7:45—wondering what's happened to the hired help.

At the moment he has his Yankees in a cafish with the Cleveland Indians. The Colonel is a champion of sport. Athletics have always fascinated him. He used to be a fine amateur boxer, and a baseball player. You always see him at the big fights, or up at the Stadium watching his Yankees do their stuff. Washington Daybook

By Preston Grover

Washington—The executive spotlight which switches from time to time on new agencies, has picked out one Lowell Mellett and his National Emergency Council for a period of prominence that shows signs of being far more than temporary.

Mellett was an editor of a Washington newspaper. He had New Deal ideas before 1933 and long has been one of the President's intimates. Now as N.E.C. director, he has been incorporated officially into the White House executive ring to take over a job second in importance only to emergency relief. The job is to manage the President's effort to rescue the South from the economic doldrums.

The Emergency Council, hiding in the obscurity of a thousand half-forgotten bureaus, has been marked for death time after time. Best omen here is that it was rescued lately mainly as an avenue down which the President could launch his southern enterprise.

Many Are Called—

It is a familiar trick of the President's to use first one agency and then another with the scintillating performance of a swing-bend trap drummer. He financed banks thru the Reconstruction Finance Corporation; took jobless boys off the streets with CCC, and corralled the unemployed with a half dozen relief agencies. And now N.E.C. is brought around for the invasion of the South. Its membership once included the entire cabinet, together with the heads of each of the new agencies created under the present administration.

Coordination of policy and elimination of overlapping were its main purposes and undoubtedly Mellett will continue in that capacity.

In addition, it has a whip-lash "advisory" power to eliminate duplication of effort among governmental agencies, although since 1935 it has been more in the doldrums than the South. It is expected to stimulate.

Current Washington opinion is that Mellett, soft-voiced and serious-minded, has been singled out to stage one of the big governmental spectacles of the President calls "the nation's Number 1 economic problem," the South.

Operator, The White House

The job under a General Hugh Johnson might be blown up to amazing proportions. Mellett is no General Johnson such as NRA knew and his attack on the new phase of his job was un-Johnsonian. He called a conference of southern industrial, labor and economic leaders, as requested by the President. But he read them no orders.

Instead, he asked their opinions on Dixie's troubles with regard to freight rates, cotton surpluses, population surpluses, poorly financed industry and racial conflicts. He promised no immediate solutions, but the President has never been satisfied with a mere report—with-out recommendations.

Eighth Congressional—Nobody knows yet whether W. O. Burgin of Davidson or C. B. Deane of Richmond is going to get the Democratic nomination in this district, though Burgin has the pole position by virtue of a majority of something like 100 votes on the fact of the returns. Nearly 40,000 votes were cast in the runoff which is the subject of controversy.

Burgin has asked for, and is getting a recount of absentee ballots in Richmond. Deane has asked for, and hasn't yet been granted, a recount in Davidson. The candidates also see, or profess to see, inequities of one sort or other in other counties—notably Deans in Union and Wilkes.

An appeal by Deane is pending before the State Board of Elections from the action of the county board of Union in refusing a recount. Burgin has former Governor J. C. B. Ehringhaus as his counsel; Deane has the Ehringhaus campaign manager of 1932, Major L. P. McLendon of Greensboro, a former chairman of the State Board of Elections. One man's guess is as good as another as to what's going to happen here.

Sixth Solicitorial—Rivers Johnson of Duplin, asserts at the top of his lungs that in Sampson county hundreds of Republicans were permitted to vote for his opponent, J. Abner Barker of Roseboro, who apparently won the nomination by something better than 200 votes. The Sampson county board will meet Tuesday to act on the protest. It will probably dismiss it, which will almost automatically result in a Johnson appeal to the State Board of Elections.

Halifax Howling—In Halifax Julian Allbrook lost, on the face of returns, to Dr. T. W. M. Long for State Senate by between 100 and 200. There has been filed a petition charging Long partisans with everything but murder and conspiracy to commit forcible trespass, but nothing has been done lately and the whole matter is likely to be dropped without further fanfare.

Mecklenburg Mixup—In Mecklenburg's second primary, Vance Howard showed a one-vote majority over E. A. Hiker for county recorder. Constable Charlie Thornburg was nosed out for his post by two others, Candidates Dan Brantley and W. G. Bell.

Formal charges of fraud and irregularities were filed by the defeated candidates; and this afternoon has been set by the county board of elections for a hearing of the charges and for a full and complete recount.

Johnston Jumble—After the first primary loud wails of anguish came from E. J. Wellons, apparently defeated for Johnston county's seat in the State Senate—also from J. R. (Bob) Young, of Harnett, who had apparently taken a thorough whaling from Solicitor C. C. Canaday of Benson.

Probing the matter the State Board of Elections found an awful mess, with the Johnston county registration books improperly kept in practically every precinct.

A recount under the state board direction reversed the State Senate race, ousting J. B. Benton as the apparent nominee and giving the honor to Wellons.

The board isn't through with the Solicitor tangle, but is slated to meet again July 13, in Smithfield, to go into the Young challenge further. It seems that all Young will have to do to get the solicitor's nomination is to present affidavits showing that as many as 3,100 Republicans voted for Canaday in the primary. Slim chance.

The state board, however, ousted two precinct officials at Wilders, and the same pair have been indicted by a Johnston grand jury.

Alamance Allegations—The first primary brought out a heavy vote in Alamance county and thereafter brought charges that there had been numerous irregularities.

Investigation by the state board resulted in recounts in four precincts, and subsequent removal of a couple of registrars for permitting Republicans to vote in the Democratic primary.

Battle in Brunswick—Brunswick county's first primary passed off peacefully, but the second voting has resulted in a contest probably unique in the state's history.

Eight candidates ran for county commissioner nomination by the Democrats. Only one received a majority in the first voting, with three seats at stake.

For some reason, peculiar to itself the county board declared not only No. 1, but No. 2 in the list nominated and put the names of 3 and 4 only on the runoff primary ballot. No. 2 called attention to this and asked that he be put on the ballot also. The board declined.

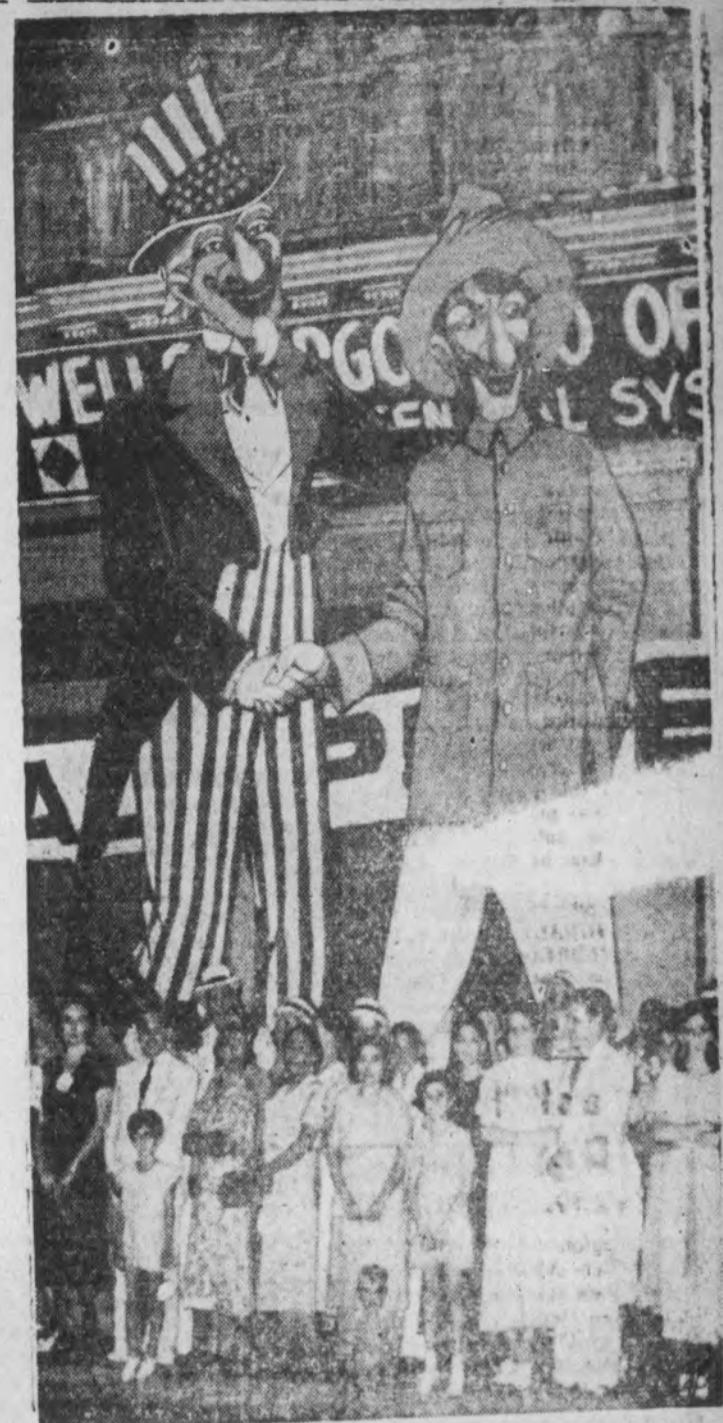

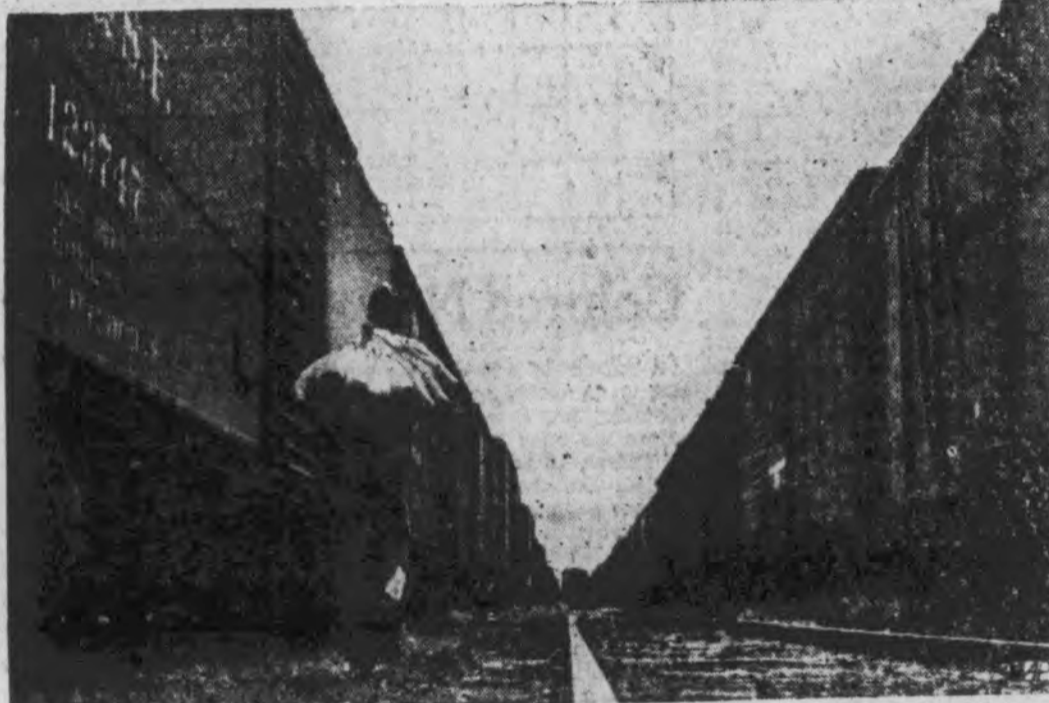

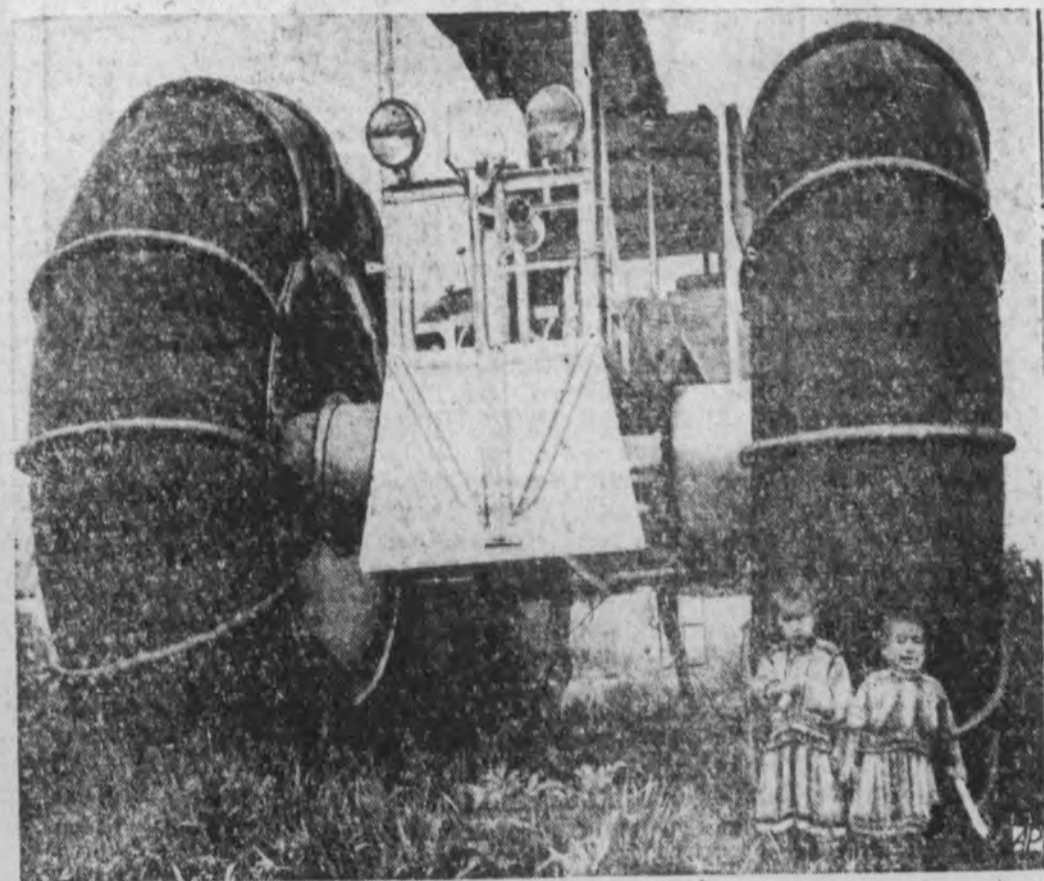

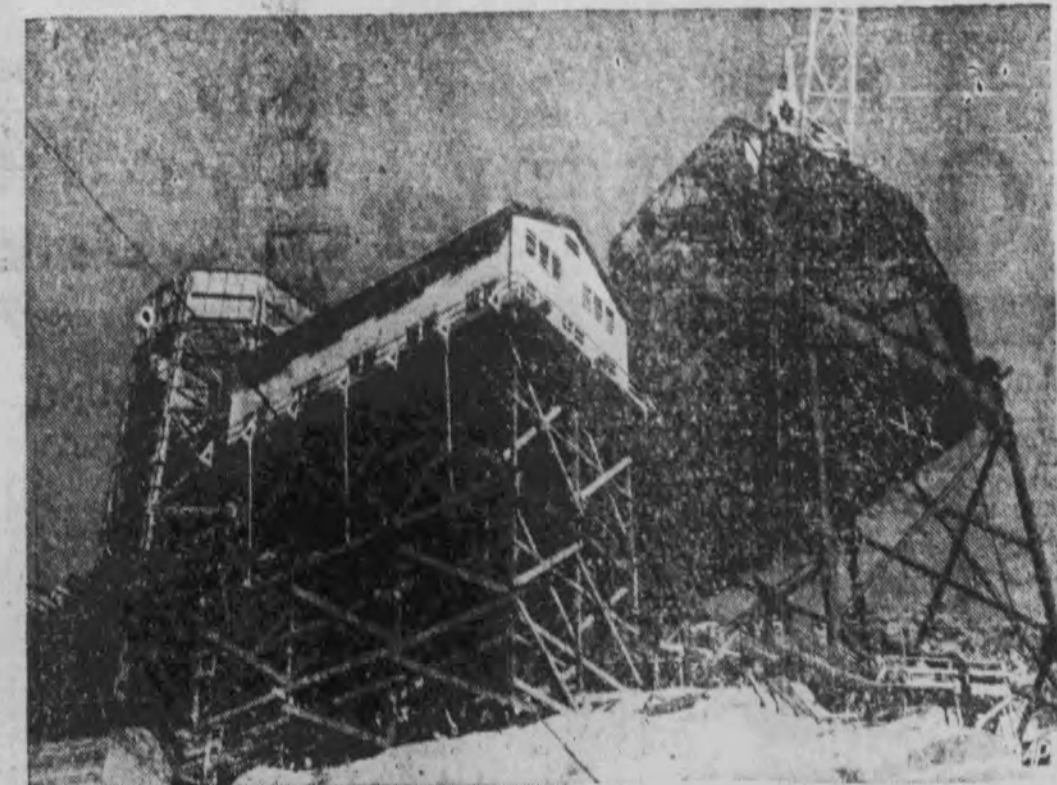

(Continued from page one) three-year economic program and brought about at least temporary peace between capital and labor.

He also developed the franc nine per cent and raised all taxes eight per cent. Both actions were unpopular with Frenchmen, but he seems to have convinced the nation that both were necessary. And he has cut tourists' costs to help bring money into the country.

Daladier played no favorites. His increased tax decree hit capital hard, but he hit labor, too, when he told it the 40-hour week law could not be carried out to the letter.

On May 14 a defense loan of \$140,000,000 was announced. The next day the government reported that the French people had over-subscribed the loan. On May 24 the government came through with a \$304,000,000 public works program to speed industrial production.

"Wild bull of the Camargue," Daladier is sometimes called. For he is a fighter. His worst political enemies admit it, and his political career since 1932, when he was hooted out of the premiership as the Stavisky scandal led to riots, shows it.

The "wild bull" emerged from Parliament's 18-day session in June with his government firmly in power. Adjourning of Parliament gave him a free hand to rule by decree until November. So he and his "national defense cabinet" continue to match their wits and French patriotism against the power of totalitarian governments.

"If he fails," said many a politician, as Daladier took office, "there is nobody left—no known leader." After he had gone into action, the same group echoed the words of Frenchmen in Paris cafe terraces: "We have a strong government. Now let the enemies of France watch their step."

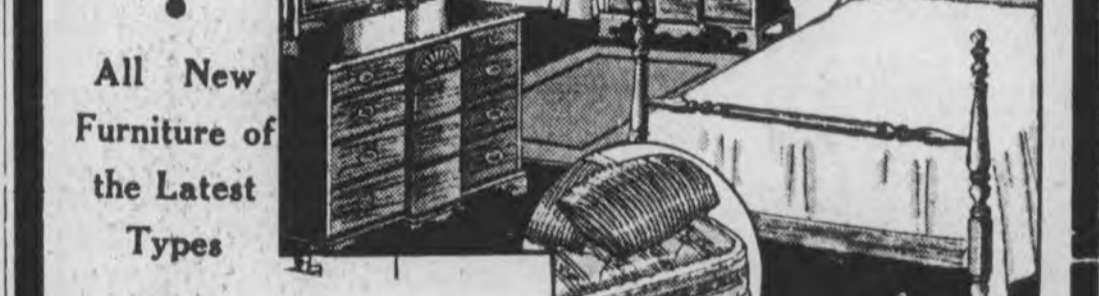

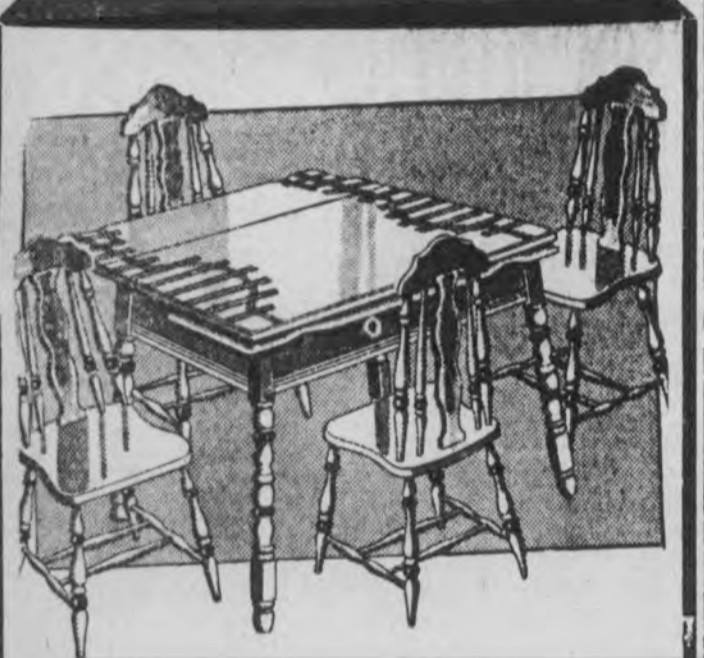
