DARING AMERICAN FLIER 'SNEAKS' ACROSS OCEAN

1938 PROGRAM FOR POTATOES IS ABANDONED

Not To Undertake Marketing Quotas For This Year

SEVERAL STATES VOTE DOWN PLAN

Declared not Feasible to Make Program Applicable in Some Areas; Not Others

Washington, July 18. (AP) — The Agricultural Adjustment Administration announced today it would not undertake a marketing program designed to control interstate shipments of potatoes in 13 states because of lack of uniformity in the vote of growers who participated in the referendum.

The states, comprising eight early and intermediate producing areas, were Alabama, Arkansas, California, Florida, Georgia, Maryland, Mississippi, North and South Carolina, Texas and Virginia.

Lawrence Myers, marketing section chief, said the vote of 7,000 producers who participated was about 75 per cent in favor of the program, but that growers in California, Maryland and South Carolina voted unfavorably and in six other states the vote was less than two-thirds favorable.

He said it would not be feasible to make the program applicable in some areas and not in others.

Still Located In Belvoir Township

Two members of the Sheriff's office and two Pitt County ABC enforcement officers yesterday morning located and destroyed a 100-gallon capacity still in Belvoir township.

The plant, near the old Parker place, was in operation when the officers came upon it, but the men got away. The officers said the still was surrounded by a reed thicket and the operators heard them coming and fled.

About 25 gallons of whiskey was found about the still. Five hundred gallons of beer also was found.

Sixteen sticks of dynamite were used to destroy the still and equipment.

Officers taking part in the raid were D. M. R. W. King and R. W. Tyson and ABC Officers J. M. Ward and J. L. Taylor.

COURT HELD BY JUDGE DARDEN

Jurist Declares Tribunal is No Collecting Agency

City Recorder W. A. Darden served notice this morning that his court was not to be used as a collecting agency for persons claiming damage in automobile wrecks.

Judge Darden made the statement after it developed that one of two defendants in a case growing out of a collision had called officers for the purpose of forcing the other person involved to pay for property damage. The charges against each of the defendants, S. E. Vanders and Marshall Cox, were dismissed.

Judge Darden explained, however, that when traffic laws were violated the defendants would be held guilty and justice meted out accordingly.

A nolle prosequi was taken against defendants involved in another wreck. The two charged with careless and reckless driving were Earl Britley and Joseph A. Baker.

Two members of the Greenville baseball team, Sam Lankford and Phil Morris, were taxed with the costs of court on charges of being drunk and engaging in riotous and disorderly conduct and with assault. The two already had been released by the club.

Tom Williams, Negro, was acquitted of a charge of being drunk and disorderly. Robert Teel, Negro, was bound over to Superior court under bond of \$200 on charges of breaking and entering and destroying personal property.

George Hodges was ordered to pay the costs of court upon conviction. (Continued on page two)

Southwest To Try Wells In War On Dust Storms

Goodwell, Okla., July 18. (AP) — Deep wells may some day help deliver the Southwestern high plains farmer from dust.

Here at Panhandle A. and M. College, where experimenters toil with deep well irrigation, crops flourish without the aid of rainfall.

Deep well irrigation is not new. But what President Ed Morrison and his staff at Panhandle College seek to learn by experiment is:

Can deep wells be used profitably in subsistence farming on dusty wastes that in the last few years of drought have yielded little but ruined crops.

Sufficient information, Morrison said, "has not yet been gathered relative to the possibility of extending deep well irrigation in any

GROUNDING CHINA CRAFT ARE FIRED

Meanwhile Artillery Duels Continue Between Jap Ships and Chinese Batteries

Shanghai, July 18. (AP) — Japanese naval fliers today carried out what a Japanese naval communication described as the "most daring attack in the history of military aviation."

During a large-scale attack upon Chinese airdrome at Nanchang a squadron of Japanese bombers landed at the airport despite rifle and machine-gun fire from the Chinese defenders, the communication stated.

Then the bombers crews jumped out of their planes. It was said, and with torches set fire the seven grounded Chinese planes, seizing two machine-gun magazines as war booty, chased Chinese fleeing in a gasoline truck into a neighboring rice field and returned to their base unscathed.

Long range artillery duels between Japanese warships and Chinese land batteries continued along the Yangtze river, but war maps showed that the Japanese had made little progress during the past two weeks in the Yangtze sector.

The main concentration of Japanese warships still was at the Matowchen boom, 175 miles down the river from Hankow, while land forces were held below Kiukiang, 135 miles below the provincial capital.

The warships reached Matowchen July 5 after three weeks of hard fighting.

An attempt to advance overland from the north banks of the river in conjunction with the naval advance was meeting similar resistance.

BATTERY A IN TOP CONDITION

National Guard Unit Leaves for Maneuvers July 28th

William S. Tyson, acting commanding officer of Battery A, 113th Field Artillery, North Carolina National Guard, declared today the local unit was in first-class condition for the annual encampment at DeSoto National Park, in Mississippi, the latter part of the month.

Sixty-four men and four officers will make the trip and join in maneuvers, declared to be the greatest in the South since the civil war. The regular army, reserve officers and National Guard from eight Southern states will participate in the maneuvers at the national park near Hattisburg.

Battery A will leave here at 5 a. m. on the morning of Thursday, July 28. The first stop will be at the South Carolina State park at Cheraw, where Captain L. A. Brock, who recently left here to go to South Carolina, will join the unit and assume control during the maneuvers. Capt. Brock will resign as commanding officer following the return of the unit, since he has been transferred to South Carolina.

The second night will be spent near Louisville, Ga., the third night at Auburn, Ala., and the fourth night at Meridian, Miss. The unit will arrive at the DeSoto park on the fifth day out, August 1st, and will leave on August 10th, arriving back in Greenville on August 14.

The four officers of the local unit are Capt. Brock, First Lieutenant Tyson and Second Lieutenants J. H. Mays and J. E. Waldrop. Tyson said the battery has been undergoing extensive training and would be in "fine shape" for the annual encampment.

The announced reason for the maneuvers is to determine the ability of troops of the third army to assemble at their home stations, move to an area of concentration by various means, rail, motor or air, participate in a tactical exercise under field conditions, and then return to their home stations. It is not a test, but rather a means where better training can be secured through coordinated effort over unfamiliar terrain, and comes as a culmination of previous summer trainings at separate encampments.

Bucharest, July 18. (AP) — Dowager Queen Marie, of Rumania, who helped shape the destiny of her country for a generation, died today in her 63rd year.

The queen mother, famed for her beauty, died at her palace at Sinaia, the royal summer residence, at 11:25 a. m. EST.

King Carol, her son, and Crown Prince Michael and Princess Elizabeth of Greece, were at the queen's bedside. Her husband, King Ferdinand, died in 1927.

The queen had been dangerously ill for most of the past year.

TAR HEEL GIRL AWARDED SUM

Mrs. Martha Barkley Ryan Gets \$833.33 Monthly Alimony

New York, July 18. (AP) — Mrs. Martha Barkley Ryan today was granted a separation and \$833.33 monthly permanent alimony from her husband, Dr. J. Allen Ryan, who she divorced in 1927.

The separation and alimony were granted in Supreme Court by Justice Salvatore Cottino.

Ryan did not defend his wife's suit.

Justice Cottino called Ryan "a perfect example of pampered youth who is the recipient of a very large income."

Mrs. Ryan and her husband were married in North Carolina and Ryan left her almost immediately after the ceremony. Ryan then insisted he had no recollection of marrying the Morganton, N. C. girl.

Mrs. Ryan is the mother of a son born to her six weeks before she married Ryan.

Mrs. Ryan later charged Ned Sparks, a soda fountain attendant, of Washington, D. C., was the father of the child.

Her counsel was awarded \$7,500 in fees.

Ryan's failure to contest his wife's suit moved Justice Cottino to further criticism of him, remarking that he displayed "no manliness."

RADIO STATION STILL SOUGHT

New Bern, However, Favored in Report of Examiner

Local sponsors of a radio station for Greenville declared today hope for securing a permit had not been abandoned and explained that the report of an examiner recommending a station for New Bern was not final.

It was declared that a board of six judges will have to pass on the recommendation of the examiner. This board is expected to render its decision in 30 days or so. Meantime, it was declared here, local efforts would be continued in the hopes of having the board overrule the examiner.

A corporation headed by J. J. White of Greenville is seeking a permit to operate a station on the same frequency being sought by New Bern.

The examiner's report recommended that Nathan Frank of New Bern be granted the permit and that the application of the Greenville group be denied.

The principal finding of fact on which the recommendation was based follows:

"Evidence was offered by each applicant to establish a need for the additional radio broadcast service proposed to be rendered to the cities of New Bern and Greenville, North Carolina. Evidence was offered concerning the radio service available to each city, and in each case this service is secondary. However, it appears that Greenville enjoys considerably more broadcast service than does New Bern. Evidence was also adduced concerning the population of each city involved, and shows that New Bern is approximately 30 per cent larger than Greenville. The evidence shows that Greenville is one of the leading tobacco markets of the world, but this industry is inactive approximately eight months of the year, while the industries in New Bern are more diversified, and the advertising patronage of a station in New Bern would be more constant from the various businesses and industries. Consequently, it appears that a greater need for the service proposed has been shown to exist in New Bern than in Greenville."

Flight Made in Antiquated Ship in 28 Hours, 13 Mins.

PERMIT REFUSED FOR TRIP IN 1937

Unexpected Arrival In Ireland first News from Flier Since He Left New York

Dublin, Ireland, July 18. (AP) — Douglas Corrigan, the American flier who took off from New York on a flight to "California," dropped unexpectedly from the skies today at Baldonnel, Ireland.

He made the flight in an antiquated single-motored plane of the vintage of Col Charles A. Lindbergh's Spirit of St. Louis in 28 hours and 13 minutes.

He took off from Floyd Bennett field Sunday at 4:17 a. m. EST and landed at Baldonnel airport from Dublin at 8:30 a. m. EST.

Although a watch had been kept for the lone flier in Ireland after news of his "mystery flight" from New York, his landing here caused the greatest surprise.

Corrigan last year was refused a United States permit to attempt the trans-Atlantic flight to Ireland.

Nothing had been heard from him since his take off. He had no radio and only the barest navigating equipment.

Most airmen on this side of the Atlantic had not conceded the daring American one chance in a hundred of making the Atlantic crossing after reading cabled accounts of his "disappeared" craft.

Because of the Department of Commerce's rejection last year of his application for a permission to make such a flight and because strict regulations cover such ocean trips, officials at Floyd Bennett field had doubted he would try a "sneak" hop.

The officials had believed he carried only a navigating map of the United States with optional northern and southern routes across the continent.

Before he arrived unheralded in New York slightly more than a week ago, his name was known only to pilots and west coast aviation experts. They ranked him as a line craftsman and a man who knew airplanes, thoroughly.

CORRIGAN MAKES TRANS-ATLANTIC FLIGHT ON \$69.60

(Continued from page one) nance Ends Here" is a red flag to North Carolina municipalities and the League. In 1933 a man-sized war broke out in the legislature to have part of the gasoline tax returned to towns and cities to keep up state highways within incorporated limits. The munis lost.

Two years later the effort was renewed, this time with success, the Munis getting a half million dollar annual refund, which they were to use in maintaining state highway system roads running over municipal streets. In 1937 the Leaguers launched another offensive, trying for a still greater appropriation, but were repulsed, with Rockingham's Clarence Stone leading ga counter-attack in which he termed the League of Municipalities "the Liberty League in North Carolina." They did, however, keep the half million annual refund. It's an entirely open secret that the League will be back to the wars again next January, prepared to fight harder than ever.

The main contention of the city officials, who make up the League membership, is that urban dwellers pay an estimated 65 per cent of the total highway fund. Hence, they contend, it is utterly unfair to spend none of the gasoline tax collections on city street construction and maintenance. Even the half-million annual subsidy is nothing like what the municipalities should get in fairness and equity, the League contends.

And so the politicians eye the League meeting. They know, in general, the stand of the Munis and they know, in general, what set to expect. They are keenly interested, nevertheless, in finding out details of the coming campaign and learning the personnel of committees which will have charge of pushing it.

Although the League is non-political and non-partisan in theory, and generally speaking, in practice, the politicians realize that the League is composed of chosen representatives of about 85 per cent of the state's population. Naturally, they do not want to antagonize this kind of group.

The League is likely to offer a pre-view of the 1940 gubernatorial field—what with Commissioner of Revenue A. J. Maxwell and State Treasurer Charles M. Johnson already on the list of "speakers." Both these gentlemen are much talked of as 1940-likes and there may be others on the Asheville program before the meeting is called to order.

JUNE CLINICS HELD IN PITT

(Continued from page one) ing cough 7 cases, no scarlet fever and no infantile paralysis though as you recall, we had one case of infantile paralysis reported in the month of May.

"While we have had no case of Rocky Mountain Spotted Fever reported in Pitt County this year it might be well to call to your attention the present situation in Virginia. Tuesday's papers quoted Dr. Riffin, Virginia State Health Officer, to the effect that there had already been 35 cases reported in Virginia this season with 3 deaths.

"Typhoid Clinics were held in more than 60 centers throughout the county and the number receiving complete treatment was 2092 white and 1342 colored, making a total of 3434. The number of diphtheria vaccinations was 427.

"The treatment at the several Venereal Disease clinics is holding up well when we take into consideration that this is a very busy time of the year for the rural citizens; the treatments for May were 1253, treatments for June 1135, a decrease of 118 treatments. The number of Wassermanns taken in June, for diagnosis was 271 giving a total attendance at the Clinic for the month of June of 1406.

"The attendance at the Maternal and Infant Welfare Clinics for May was 83 and for June was 73, a decrease of 10. It is probable that this decrease, as in the case of the decreased attendance at the Venereal Disease Clinics, is due to the fact that this is a very busy time of year of the farm.

"The State Orthopedic Clinic, held every first Friday in the Greenville Health offices continues to serve a large number of crippled. This Clinic, as you know, serves not only Pitt County but Carteret, Pamlico, Beaufort and Hyde as well. It is conducted by Dr. Hugh A. Thompson of Raleigh and is sponsored by the Rotary Club of Greenville.

"The Community Sanitation program is meeting with reasonable success when we consider that this is the time of the year when the farmers income is very low. The number of privies installed in the past two months was 89. We are confident that with the opening of the tobacco market there will be a marked increase in the number of privy placements, but may I add that this increase can be markedly accelerated if we have the active cooperation of the members of this Society. By active co-operation we mean that you urge your landlord tenant to provide a sanitary privy for his tenant. It is our settled opinion that here, as everywhere else in the Health Department's program we can move no faster and go no further than is represented by the support and the active co-operation of the medical profession. Since the family physician is, as he should be, the court of last resort in all health matters, he is still the most potent factor in the promotion of preventive medicine and health education.

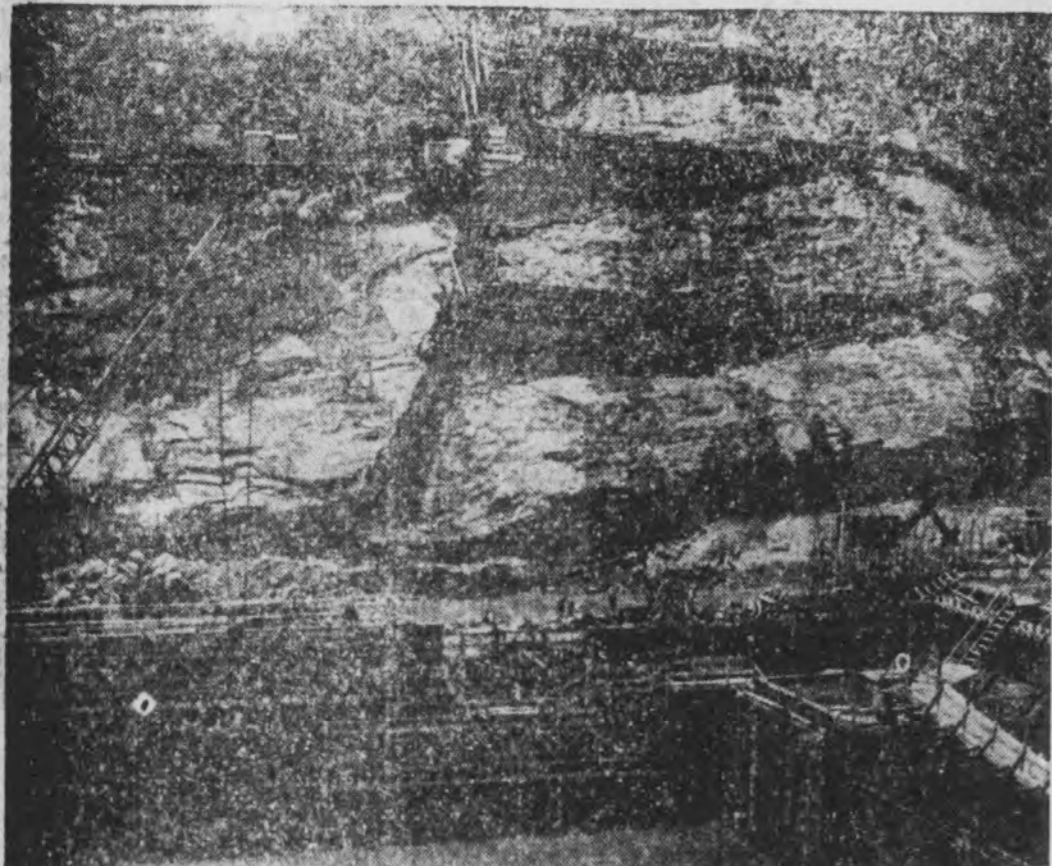

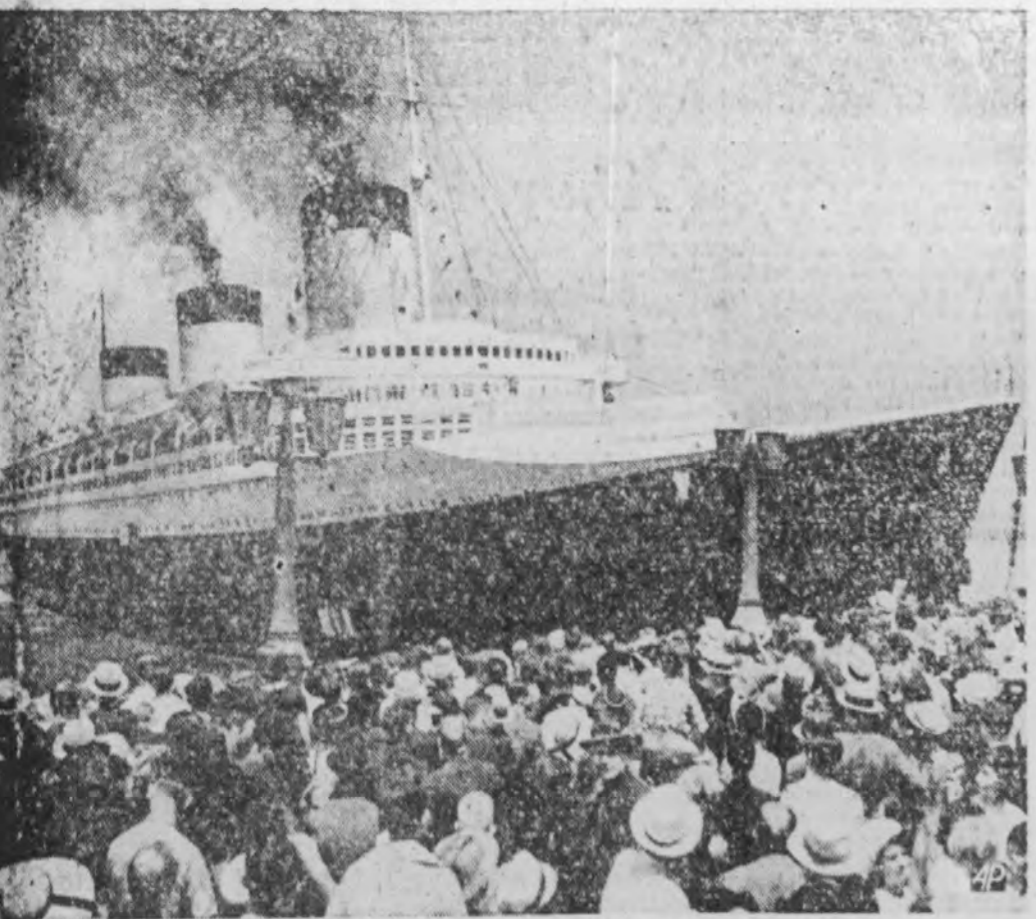

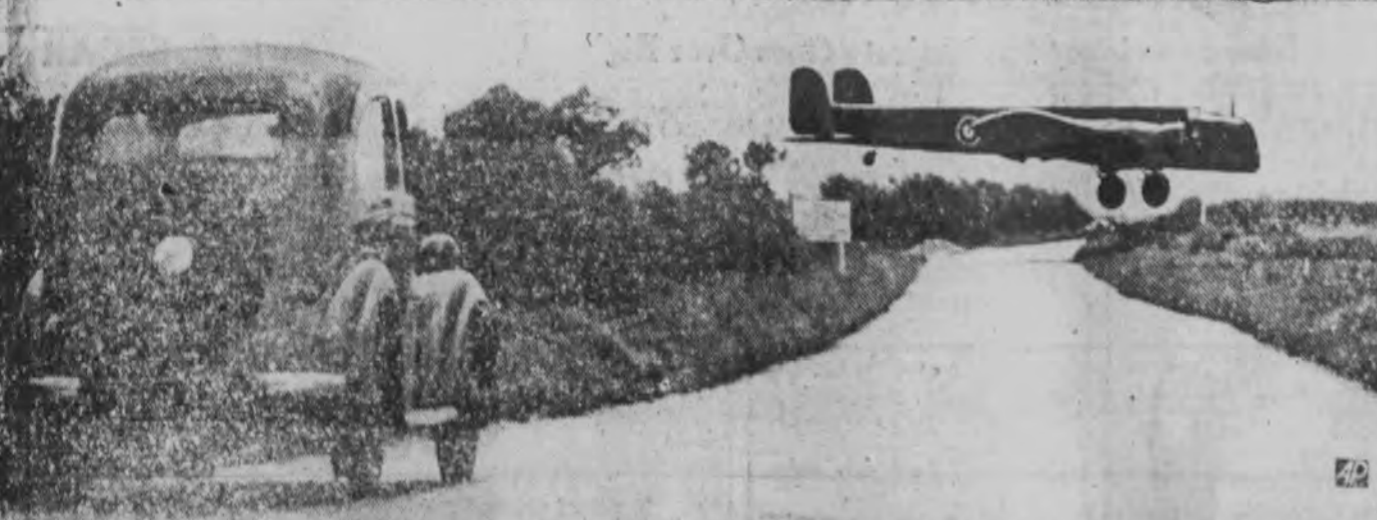

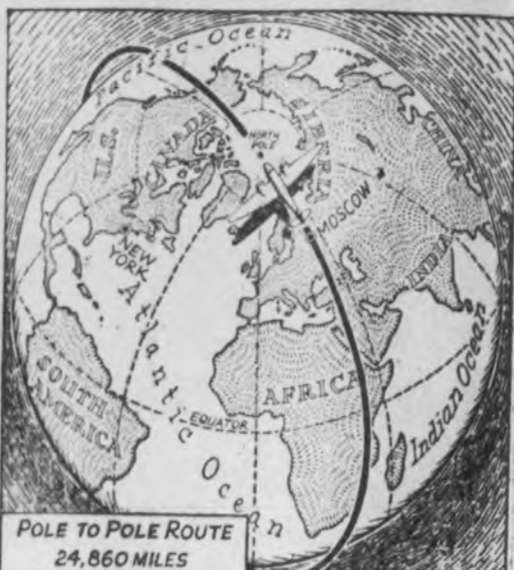

Now that Howard Hughes has gone and done it—at a cost of \$300,000—what will it get him?

The answer probably is—nothing tangible. Wiley Post got little enough besides fleeting fame. Other pioneers have had less.

But on the other hand, if history repeats, the world at large may get untold benefits from this newest, fastest circling of the globe. For by rocketing around the world in less than four days, the shy and wealthy Texan joined the mythical fellowship of the few humans who have hitched their wagon to the star of geographical conquest through the centuries.

They Had An 'Urge'

Like the others, his exploit represents a mythical urge with a capital "U". There's no other explanation for it. While stay-at-homes have thought that the earth conquerors wanted only fun, fame or fortune, the record does not bear that out.

A few, like Sir Francis Drake, did bring back gold, but even he said later that a "secret instinct" drove him on. Most found fame, but almost never a great profit. Some, like Magellan and Cook, found death. But many of them, from Columbus and De Gama on down, opened the way to freesea navigators for fabulous profits and to humanity great advances.

Men Knew; They Did

The nub of the situation here is the same as it was in Columbus' day; the same as it was in Lindbergh's.

Wise men knew in Columbus' time that ocean could be crossed, but it took Columbus to prove it and win the new world. Aviators knew in Lindbergh's youth that the Atlantic could be flown, but it took Lindbergh to do it and open up the field of experimentation that will soon lead to establishment of transatlantic lines. Scientists last week knew that the world could be rounded in four days or less, but it took Hughes to do it.

What new field will be opened up? Round-the-world commercial flights or round-the-world war flights?

History can't answer, but it can tell what has become of the great geographical ventures of the past. Then Came Planes.

Earth conquest was seemingly completed when the airplane came along with the turn of the century. With a score of years, the United States Army had sent a daring crew of its fliers around the world. Com-

pared with Wiley Post, and Hughes, these men might have been flying in a blond box. They had to stand up in the cockpit and fly almost against the waves in fog-infested seas. They hedge-hopped over icebergs in the North Atlantic. The science of aeronautics had not yet produced the power and the gadgets to lift planes above these surface dangers.

To Knowledge: Addition

The Army fliers spent 175 days on their world voyage in 1924. Then the Graf Zeppelin in 1929 sailed around the world in 20 days and four hours, with comfortable passengers. Wiley Post and Harold Gatty followed in their plane two years later, making an eight-day trip. Post made it alone in 1931 in 7 days and a few odd hours.

And now Howard Hughes!

Each flight around the world added scientific and practical knowledge to aviation. Only once before had a world voyage produced scientific knowledge of immediate value to civilization. In 1775, Captain Cook, painstaking English navigator, discovered the remedy for scurvy.

The Gadgets Multiply

Now, each year produces its new gadgets to make voyaging safer. Hughes has his altimeters, air speed indicators, turn and bank indicators, temperature gauges, and engine performance indicators. He had drift indicators, magnetic compasses, gyro compasses, the new automatic pilots, and radio.

Columbus, Magellan, Drake and Cook had none of these things. Even Lindbergh had few of them. In addition these men had the terror of the unknown ahead of them. But it matters little about the degree of courage each of the pioneer world voyagers has shown. Their real value is their pioneering. It has never failed to inspire their set of humanity to follow.

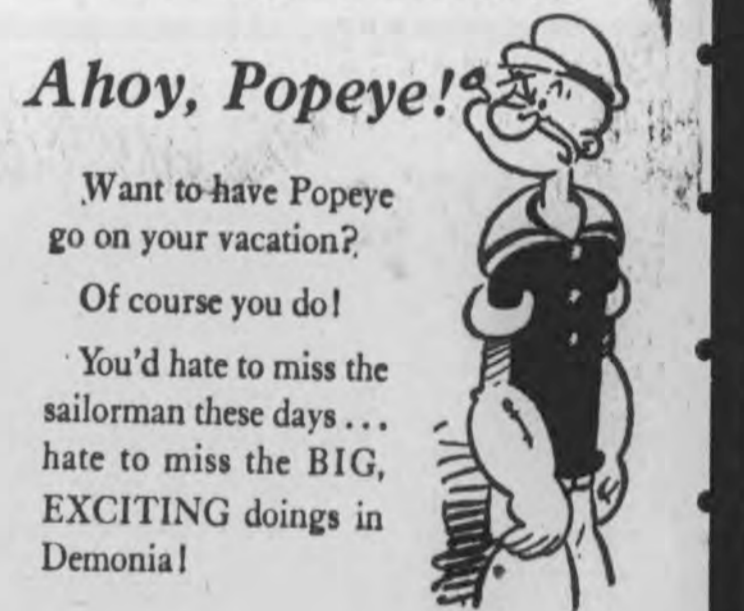

Easiest Signal Is Best, Says Hemsley, Whose Catching aided Feller's Pitching



Bob and Rollie Talk Over Their Signals

When Hemsley's calloused right hand overlaps the front of his glove he may be signaling Feller: "We're changing our signals. The runner on second base is getting on to them."

"About the only man you have to watch is the runner on second. Your legs and your glove keep the coaches on first and third from stealing them. The same goes for the dugout."

Feller's battery-mate is a good psychologist.
"It's a gamble you take, when you're in a tight spot, deciding whether to pitch to the batter's strength or weakness. I've seen batters frequently hit a ball on which they're supposed to be weak—just because they're looking for it. I've seen a lot of pitchers throw the ball right to the batter's strength because of that."

Gehringner Tough
"But Charlie Gehringner—You have to outguess him. He's liable to go up and take three straight curve balls, waiting for a fast one. The next time he might take three fast ones, waiting for a curve."

Just as the pitch is about ready to start and the batter must infently watch the pitcher, Hemsley pushes out his glove to tell Feller where the ball should go—inside, outside low or high.

"You can even signal with your feet or by getting up and down," says Hemsley, "but the easiest signal is the best. It allows the pitcher to concentrate on the batter—instead of the signs."

Baseball men call Hemsley one of the smartest receivers in the business. Joe Doaks, the loud-voiced guy with the bag of peanuts up in the stands, isn't much more surprised when Hemsley picks a man off base than the man himself.

"Bob's greatest trouble is his wildness—and that's about all," says Hemsley.

Tar Heel Farmers To Make Hay Crop While Sun Shines

State and Federal Departments Predictions on July 1 Call For Biggest Crop in History

Reflector Bureau.

Raleigh, July 18.—North Carolina's farmers will this summer make more hay while the sun shines than ever before. If estimates of the State and Federal Departments of Agriculture materialize.

Prospects as of July 1, were for the greatest crop in the state's history, the crop reporting service forecast.

Setting an all-time record, growers have planted 1,028,000 acres of hay this year, a six per cent increase over the 1937 crop, which amounted to 997,000 acres.

Growing conditions this year have been almost ideal, according to W. H. Rhodes, the state Department of Agriculture's chief statistician, and if there is no setback between now and cutting time the 1938 crop will likely exceed the 1937 by some 50,000 tons, he predicts.

"The July 1 crop survey indicates a hay production of 874,000 tons, with an average yield of .85 ton per acre," said Mr. Rhodes. "This production, if realized, will be greater by 50,000 tons than that harvested last year, although the yield per acre in prospect is about the same as in 1937."

"Last month was ideal for the growth of all grasses and grass type crops, as abundance of moisture is a most favorable factor in its development."

"The condition of pastures as of July 1, averaging 92 per cent of normal for the state (represents an improvement of eight per cent over pasture conditions a month previous to that date, and was ten per cent above July conditions last year."

Rhodes said that while it is too early to forecast yields of some hay crops, present prospects for all types of hays are excellent.

STATE PATROL WELL TRAINED

Tourists Responsive to Helpfulness Of Officers

We have found that tourists are most responsive and appreciative of friendliness and helpfulness of the patrolmen. There is no doubt but that we are in a position to do much to the pleasure of the visitors to our section. We can do this by being especially courteous to out-of-state tourists and that courtesy can be shown most effectively by our feeling and expressing a real interest in these guests as we come in contact with them and have numerous opportunities to assist them; thereby, giving these strangers concrete evidence that they are welcome and make them realize that this is a wonderful section and people, which will prolong their stay and cause them to return year after year.

While our main job is to see that the highways are properly used that the dangers of automobile travel

are lessened as much as possible, we have a further duty as uniformed representatives of the State of North Carolina, to properly represent the State in our contacts with guests from outside the borders of North Carolina. We cannot be true to the obligation unless we create a desire for other visits by them and visits by their friends and express to every visitor something of the welcome that North Carolina feels toward them.

We can express that welcome and hospitality in many ways. By doing unusual, and at times, very insignificant things (for tourists) we can be of service at times of distress. We can cheerfully give information about roads and maps to be taken in this section. We can see to it that when we have parted from every visitor that we contact, unless our duty has required stern measures against them, that he has received personal good will from us and that he has had extended to him our expression of North Carolina hospitality.

Measles Epidemic Apparently Ended As Schools Closed

Twenty-Four Deaths From Disease during June Less than Half Number of M. Victims

Raleigh, July 18.—End of the 1937-38 school term apparently was the beginning of the end for the measles epidemic which has raged in North Carolina during the first half of 1938.

At least, vital statistics for June showed only 24 deaths from the disease, less than one-half the number of victims in May, when a high of 51 was touched after a steadily increasing number of deaths each

month of the year. January had 16 deaths, the first month to show a startling prevalence of measles in serious form. December, 1937 had had but 5 deaths and November only 2.

Therefore the deaths jumped to 21 in February, 48 in March, 46 in April and 51 in May; which with the June total of 24 no less than 206 for the first half of this year as compared with 25 in the first half of 1937, and only four in the entire first six months of 1936.

Health officials have not had a great deal to say about the measles outbreak, but it is known that they anticipated a sharp decline both in cases and deaths as soon as school ended, as the close association of children in the class rooms is particularly favorable to spread of the disease.

But while measles deaths declined sharply in June was no let up in the deaths from whooping cough, which has also been prevalent, something like epidemic form. Last month there were 32 whooping cough deaths, one more than in May, and six above last June's 26. Total whooping cough deaths for the first six months of 1938 was 124 exactly twice as many as in the corresponding period of 1937 when there were 62 such deaths. Through June, 1938 showed only 15 whooping cough deaths.
