

WILL CORRECT INEQUITIES IN WEED QUOTAS

Secretary Wallace Orders Study Of Allotments

ACTION FOLLOWS GEORGIA REVIEW

Minimum Allotments to Small Producers Not Taken Consideration in Some Cases

Washington, Aug. 10. (AP) — Secretary Wallace today directed the AAA to review flue-cured tobacco marketing quotas in all producing states to eliminate inequities.

His action followed a finding from a similar review in Georgia that some growers there had received inequitable quotas because sufficient allowance had not been made for minimum allotments to small producers.

The farm act, under which the marketing quota was invoked, established a minimum poundage for small growers at least equal to their average sales during the past three years.

Wallace has ordered adjustments in Georgia, where the markets opened in July.

North Carolina and South Carolina border markets now are open and other North Carolina markets open later this month.

In announcing adjustment for Georgia growers, Wallace said later opening dates in the other states "had afforded more time in which to bring together complete information with respect to the quotas for individual farms."

Other developments: The Coast Guard awarded contracts for improvements at two of its stations.

They were Oak Island station, at Southport, N. C., equipment, buildings and accessories; the William Multhead Construction Company of Durham, N. C., \$12,800; and Fort Macon station, Beaufort, N. C., equipment, buildings and accessories, William Multhead Construction Co., \$11,700.

Dispose Of Cases In County Court

Only a few cases were heard yesterday afternoon to conclude a regular session of County court presided over by Judge Dink James.

A case charging Charles L. Bland with operating a motor vehicle after his license had been revoked was continued until Sept. 8.

Rufus Steps, Willie Oakley and Joannie Tyson were convicted on a larceny charge and each was sentenced to serve a 60-day road sentence. Tyson appealed to Superior court and bond was set at \$200.

Judgment as to Oakley and Steps was to pay one-third of the costs each and \$4.70 to their surety.

Alfred Peyton, charged with carrying a concealed weapon, was adjudged not guilty, and William McCarn, charged with operating a motor vehicle in a careless and reckless manner, was adjudged not guilty.

Marvin Tyson, convicted on a charge of careless and reckless driving, was given a 90-day road sentence, suspended upon condition that the defendant pay \$25, costs to be deducted, and balance go as fine.

James Gardner, convicted on an assault charge, was given a 90-day road sentence, suspended if costs and a \$17 doctor's bill is paid.

Ficklen To Leave W.&L. Commission

James S. Ficklen last night tendered his resignation as member of the Water and Light Commission to the Board of Aldermen, but acceptance was deferred until the September meeting.

The board declined to act on the resignation last night when it was pointed out that the question of a successor would require much study.

In his letter of resignation, Mr. Ficklen stated that it was with regrets that he felt forced to leave the commission because of press of other business. He said his affiliation with the commission and other members had been a great pleasure, but added he felt he should resign to devote more time to his own business.

HOUSE PASSES TWO PWA BILLS

Convenience Certificate to be Required of Units

Raleigh, Aug. 10.—(AP)—The House passed and sent to the Senate today the two Hoey-sponsored bills to permit state and local units to participate in federal PWA loans and grants.

The state bond issue bill, to authorize \$4,620,000 for a permanent improvement program, estimated to cost about \$8,240,510, including expected PWA funds, passed 95-0.

Before passing the measure to permit counties and municipalities to issue revenue bonds for PWA-aided projects, the House put in a compromise amendment to require certificates of convenience and necessity from the Utilities Commissioner for electric and gas projects.

Farm Boy Escapes Caledonia Prison

Rocky Mount, Aug. 10.—(AP)—Nash County Sheriff C. V. Faulkner said today he had been notified that Alfred Denton, Nash county farm boy, who at the age of 14 was convicted of killing a man at a whiskey still, escaped this morning from the Caledonia prison farm.

Young Denton was serving a sentence imposed after being convicted of engaging in a gun battle with Nash officers in 1935. He previously had been released in the custody of welfare officers following his conviction of murder.

Sheriff Faulkner said he had been informed that Denton had slipped away from a corn field where he had been working.

Courts Alone Can Keep Deane Out Of Nomination

By HENRY AVERILL. Raleigh, Aug. 10.—Only the action of North Carolina's courts can keep C. B. Lane of Richmond county from the Democratic nomination for Congress from the Eighth District, and the unsolved question is whether or not W. O. Burrow of Davidson will ask the judiciary to reverse action of the State Board of Elections which yesterday declared Deane a 23 vote winner over Burgin, 19,182 to 19,159.

Former Governor J. C. B. Ehringhaus, leading counsel for Burgin, told this Bureau late Tuesday the board's decision that he could say nothing whatever about Burgin's future course. He did not know that himself, he said. Decision, he indicated, will be made in Davidson rather than in Raleigh.

Whatever is to be done will almost certainly be started before Friday morning at ten o'clock, as the Election Board ordered its secretary, Raymond Maxwell, to withhold certificate of nomination for all contested posts until that hour. This order was specifically made in order to allow defeated contestants to go into court before the certificates are actually filed in the Secretary of State's office.

Chairman W. A. Lucas said the board's authority had been challenged particularly by Governor Ehringhaus, adding that he would welcome a court test.

LOYAL TROOPS SPLIT FORCES OF INSURGENTS

Wedge Is Driven Between Main Rebel Strongholds

THIRD LOSS FOR GENERAL FRANCO

Government Lines Reported Established on West Bank of Segrele River

Hendaye, France, Aug. 10. (AP)—Spanish Government troops drove a deep wedge between the Insurgent strongholds of Balaguer and Lerida, in Catalonia today in a sudden shift of the offensive to a new sector.

Barcelona dispatches said the Segrele river had been crossed between the two centers and a new government line established on the west bank of the wide stream, which flows south.

The offensive is the third triphammer Government troops have dealt Insurgent General Franco's forces in two weeks.

The first blow fell July 25 when the militiamen crossed the Ebro and advanced to Franco's one-time regional headquarters at Gandesa, just as Franco concentrated the main masses of his armies far to the south for an offensive against Valencia.

No sooner had Franco shifted his main power to the Gandesa sector, 12 miles southwest of the Ebro, than the Government jabbed at his extreme right flank west of Teruel and rolled him back for a nine-mile advance.

During all this time, and unnoticed in the general surprise over the sudden Government aggressiveness, troops along the Segrele were carrying out "feeler attacks."

For the first time since Battery "A" has been in the Army maneuvers in the De Sota National Forest, they faced the invading Brown army this morning at 7 o'clock.

The war began this morning with the firing of a number of rounds of ammunition in record time. Breakfast was at six o'clock and still no one had any idea that we would soon have one of the most thrilling experiences of our lives within a short time.

Camped on Bluff Creek about a half mile from Battery "A" was the 113th P. A., G. A., N. G. The invading army came up the creek and completely surrounded the regiment. Only five trucks and two seventy five millimeter guns were able to escape. A number of men on these trucks were "killed" as they passed the Brown machine gun forces. Administration Foe Leads James Pope By Wide Margin In Idaho Senatorial Race

NEW DEALER DEFEATED IN IDAHO

Pro-Roosevelt senators held a two-to-one lead in Ohio and a slender margin in Arkansas today, but it was a different story in Idaho.

Returns from 605 of Idaho's 802 precincts placed Rep. Worth Clark 2,494 votes ahead of Senator James Pope, ardent New Dealer. Clark, a self-styled conservative, fought the Government reorganization bill and various other White House measures.

The vote: Clark 36,504; Pope, 34,010.

The Idaho fight provided the only clear-cut New Deal issue in yesterday's senatorial primaries, but administration lieutenants, nevertheless, were gratified by the wide advantage of Senator Robert Bulkley of Ohio over former Governor George White.

Bulkley had been praised last month by President Roosevelt, his Harvard classmate, for backing social legislation. White, trailing by about 250,000 votes in seven-eighths of the state, had expressed approval of New Deal principles, but said he wouldn't be a "yes man."

The only woman senator, Mrs. Hattie Caraway of Arkansas, was about 800 votes ahead of Representative John McClellan after about three-fourths of the state had reported. Mrs. Caraway had received the accolade of "old friend" from the President, but McClellan said that wasn't an endorsement.

He had told the Arkansas voters he, too, favored Roosevelt policies. (Continued on page four)

AGENCY READY TO COOPERATE IN PREPARATION OF APPLICATIONS

Raleigh, Aug. 10.—The PWA is ready and anxious to help all North Carolina units in preparing their applications for PWA grants, and will arrange to have one of its engineers available at convenient points, E. Leigh Stevens, administrative assistant of the National Emergency Council for Virginia and North Carolina has written every member of the North Carolina General Assembly.

Through July 25 allotments have been made on 55 projects in North Carolina. He wrote, with grants for these projects totalling \$3,898,492 in addition to loans of \$844,000.

"Applications are given priority in the order in which they are received, and the deadline for filing is September 30, 1938. Construction work must be started by January 1, 1939," said his letter.

PRESIDENT AT SECOND HOME, WARM SPRINGS

Arrives After Overnight Trip From Pensacola, Fla.

INTEREST HIGH IN GEORGIA TALKS

Chief Executive Expected to Put in Kind Word for Foe of Senator George

Warm Springs, Ga., Aug. 10. — (AP) — President Roosevelt arrived at Warm Springs, his "second home," at 9 a. m., CST, today to discuss, if he chooses, the state's Democratic senatorial primary campaign.

The President's special train pulled in after an overnight run from Pensacola, Fla., where Mr. Roosevelt disembarked yesterday after a three weeks' fishing cruise.

He was greeted by officials of the Warm Springs Foundation, institute for infantile paralysis treatment and research.

Interest in the visit reached a high pitch several weeks ago when he accepted an invitation to receive an honorary degree from the University of Georgia at Athens tomorrow morning and to dedicate a rural electrification project at Barnesville tomorrow afternoon.

Lawrence Camp, United States District Attorney of Atlanta, and an opponent of Senator Walter George, administration foe in several legislative matters, was a member of a delegation which invited the President to make the Barnesville address.

It was considered probable at the time, and the feeling has grown in this state, that the chief executive would have a kind word to say for Camp's candidacy. So far he has given no indication, however, as to the line of thought he will follow.

Camp and George have been invited to sit with the President during the Barnesville address.

The presidential special train will stop at Greenville, S. C., Thursday evening. Mr. Roosevelt stating he would say hello in that state, where Senator E. D. Smith, a frequent administration opponent, is seeking renomination.

Carroll Attempts To Set Up Alibi

South Paris, Me., Aug. 10.—(AP)—Francis Carroll, former deputy sheriff, took the stand today and sought through an alibi to prove his innocence of the murder of Dr. James Littlefield, of which he was accused by Paul Dwyer, 19, the state's star witness who previously pleaded guilty and is serving a life sentence for the crime.

Counsel for Carroll, Clyde Chapman, read a list of 36 defense witnesses, but the name of the former deputy's daughter, Barbara, 18, was not included. Dwyer, in his testimony, had asserted Dr. Littlefield's knowledge of letters in which Barbara accused her father of "improper conduct" was a motive for the murder.

Carroll is on trial only for the physician's murder, but the bodies of both the doctor and his wife were found in an automobile driven by Dwyer in New Jersey last autumn.

Stolen Bicycle Found Before Report Filed

McCLUER CASE BIG QUESTION

Atty. General May Be Called On To Solve Problem

Raleigh, Aug. 10.—(AP)—Dr. J. W. Ashby, superintendent of the State Hospital for the insane here, said today he had not decided what course he would follow in the case of James McCluer of Washington, who was sent to the institution under a court order, but is now adjudged sane.

Judge Walter Bone ordered an inquiry into McCluer's mental condition after he had been acquitted of second degree murder charges in the slaying of Arch Doughty last May at Washington. He ordered McCluer, former fire chief in Washington, sent to the insane hospital as a man dangerous to himself and others.

Dr. Ashby said it was the "first case of its kind to come up here so far as I can recall. Frankly, I'm puzzled as to what to do. McClellan is not insane, yet it appears we must hold him under Judge Bone's order, but if he is sane there is nothing we can do for him."

Is Legislature Handing Blank Check To Governor

By HENRY AVERILL. Raleigh, Aug. 10.—Some of the legislators who whooped the Special Session Bond Act bill through the House are now beginning to wonder if they handed Governor Clyde R. Hoey and his Council of State something in the nature of a blank check.

Suspensions of this sort were at first allayed and quieted by the fact that each and every purpose was set out by name and specification and amount, and it appeared to all that there was no earthly chance of using the money for anything not so diagrammed and specified in the act.

Careful reading and re-reading of Sec. 8 of the bill, however, has put at least some to thinking somewhat differently. They are beginning to believe that under certain circumstances Governor Clyde R. Hoey and with the consent of his Council, will be able to spend the money for almost anything he sees fit.

It is true that the section is full of "provided" and "provided further" clauses; but this fact is an additional source of worry, rather than a pacifier for those who are uneasy in their minds.

Here's what Sec. 8 says: "That the Governor, with the advice of the Council of State is hereby authorized and empowered to re-allocate the sums appropriated in the foregoing section of this act, and to provide that the same may be used and employed by the several institutions, departments and agencies of the State for purposes other than those defined and described in this act, if such purposes are approved by the Governor."

That's how the section starts. So far there's no doubt that the Governor and Council would have plenty of authority to do just about what they please with the money.

Now come the "provided" etc., and the question is what do they really mean when they have been interpreted perhaps by hair-splitting legalists?

Chicago — How far can a flea jump and what it does when a dog walks through the room are questions science has finally answered.

Measuring a flea's jump is not so silly as it sounds, says Dr. George A. Skinner. It really has become an important point in the handling of bubonic plague, a flea-borne disease appearing in the United States. "All sorts of statements have been made as to the distance a flea can jump," Dr. Skinner wrote in Hygiene, the American Medical Association publication. "They varied so markedly that an investigator decided to find out for himself.

# RALEIGH GETS U. C. C. OFFICES

## Bond Issue Likely To Settle Long-Pending Problem

Reflector Bureau.  
Raleigh, Aug. 10.—A \$200,000 item in the "Special Session Bond Act of 1938" is likely to settle one of the problems which has for months and months vexed state officials and set several cities of the state to work in efforts to pry Raleigh loose from one of its governmental agencies—the joint federal-state Unemployment Compensation Commission.

The \$200,000 is listed as for the purpose of State office building on Caswell Square for Unemployment Compensation Commission. It will go through with the rest of the bond issue—that much is already assured by the utter lack of organized opposition to any part of the act.

Of course the mere authorization of \$200,000 with which to build the U.C.C. will not end the matter. Even after this there will be the question of negotiating with the Federal officials over the matter of leasing the building by the State to the U. S. government.

That will be complicated by the fact that the Federal government itself will put up 45 per cent of the \$200,000 by way of PWA grant, and accordingly there may be some difficulty in arriving at a basis upon which rental is to be paid.

Governor Clyde R. Hoey has said, however, that there seems little doubt that the government would rent the state's part of the building, at any rate. He added that the rental from the federal authorities would be, in his opinion, sufficient to do more than pay interest on the state's investment in the building. He expects that in due course of time, the rent would be enough to repay the state for the money it put into the construction.

The U.C.C. home problem has been a live one, in which there have been many and varied criticisms and recriminations about rent "hold-ups" by Raleigh real estate interests and counter claims of unreasonable conditions asked by the U.C.C. people. Meanwhile the staff has sweated through most of a hot summer in fearfully inadequate space now occupied. It seems they will continue to sweat for several months more, but eventual relief and adequate quarters are in sight.

## THE WORLD IS CURIOUS ABOUT A HAY DRIER

Baton Rouge, La. (AP)—Louisiana State University experts who developed a mechanical hay drier are getting requests for blue prints of it from all over the world.

They found that white fleas will wander from animals to man and back again. They really prefer to stick to something warm and long-haired, such as a cat or dog.

The poor flea is handicapped by short-sightedness, which Dr. Skinner says probably accounts for his hetero-skeeter jumps toward any moving body.

The side of a flea's life of concern to scientists is the comparatively recent discovery that certain species carry bubonic plague from host to host. Plague is ordinarily a disease of rodents. Fleas feed on rats, jump to cats, dogs or man, and transmit the germ.

# State To Finance World's Fair Fund Under House Bill

North Carolina's Appropriation For Exposition at New York Will End Private Subscriptions

Reflector Bureau.  
Raleigh, Aug. 10.—Appropriation of \$75,000 for North Carolina's part in the New York Worlds Fair of 1939—an appropriation which was unanimously voted by the House Tuesday and the Senate today—will mean the end of all chance to cur private subscriptions for the same purpose.

That was made clear in the brief statement of facts made in the legislature in connection with the bill making the appropriation—there was no date on the subject.

W. E. Fenner, Nash representative and chairman of the committee which has been soliciting subscriptions for the state's participation in the Fair, and who with Guilford's John Caffey introduced the appropriation measure, said as much from the floor. He reported that a total of something like \$22,000 had been paid in or pledged by private subscribers to a Fair fund.

Libby Ward, appropriations chairman, said that Mr. Fenner had travelled more than 5,000 miles in seeking the subscriptions and had never asked a cent for his travel expenses although payment of them was authorized by the last Assembly.

Both Fenner and Ward showed no sign they thought any more private subscriptions can be secured.

And so the State's participation will be financed to the extent of no more than \$97,000, perhaps less, as there is always the possibility that the pledges will not be collected one hundred per cent.

Necessarily for action at the extra session was brought about by the fact that all space for the Fair must be contracted for and exhibits ready for opening by April 1, 1939—something it would have been an impossibility to accomplish had North Carolina's appropriation be deferred to the regular session meeting in January.

# DEFER ACTION ON N. C. ROADS

## Highways "Out" So Far As Present Spending Goes

Reflector Bureau  
Raleigh, Aug. 9.—The Administration's legislative machinery is functioning perfectly so far and on Tuesday it was able to squelch an incipient revolt which had for its objective inclusion of roads—particularly secondary roads—in the projects for which the state will issue bonds and for which it is hoped there will be PWA grants.

Defeat of the Giles amendment to divert five per cent of the total appropriation of nearly \$9,000,000 for use on secondary roads was accomplished with consummate ease and dispatch, but a survey of House sentiment after the battle revealed that practically all members are rather disappointed that roads were not included in the program. It seemed, too, that the regular 1939 session is sure to see a hot fight made to slow down the rate at which the present road indebtedness is being paid off.

Con C. Johnston, of Iredell, chairman of the House Roads committee, placed responsibility for leaving roads out of the present program squarely on the shoulders of Governor Clyde R. Hoey.

He told your correspondent that the Budget Bureau, after hearing Chairman Frank Dunlap of the Highway Commission, was clearly in favor of deferring payment of some \$8,000,000 of the present highway debt and applying this sum, together with the accompanying PWA grant to road use. This would have given the state something like \$13,000,000 or perhaps \$14,000,000 to spend for road improvement, he said.

Members of the Budget Bureau however, deferred to the expressed wishes of the Governor, he said, and passed up the roads without a penny in the Special Session Bond Act.

The Iredell representative will not be a member of the 1939 House but he said he knew enough of its composition to predict that there will be a trench-war battle made for more money to be spent in improving and repairing the state's roads, both primary and secondary.

"So I play 'Taps,' 'Reveille' or 'Pay Day.' But usually I play 'Pay Day.'"

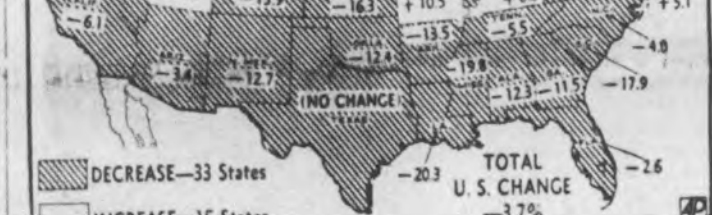
His bugle consists of a mouth-piece, a five-foot rubber hose and a funnel. The music comes out of the funnel, and by using a larger funnel he gets louder notes.

"I call it a trench horn," he said. "If you stand in a trench and blow one of those regular bugles, someone will be you."

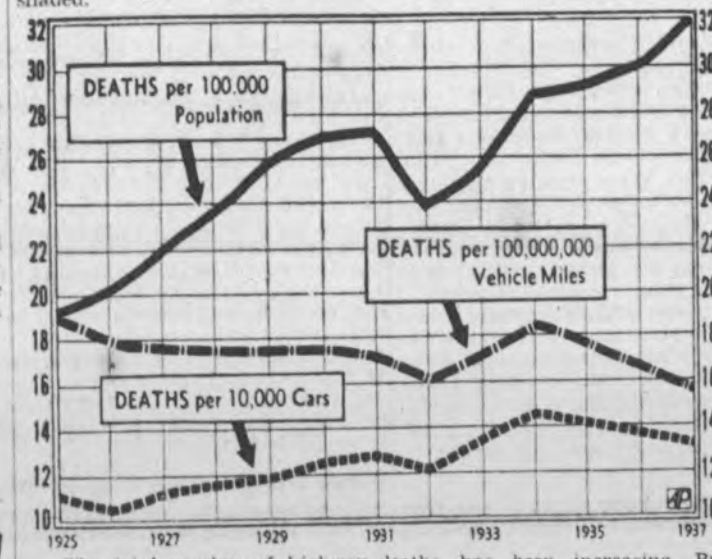
"But you can put one end of this outside, and blow your calls from a dugout and be perfectly safe."

... provided, it shall be found by reason of additional grants in aid made available through applications to any agency or agencies of the United States of America, or by funds otherwise provided, or by savings made, funds may be provided to complete the specific projects out of appropriations mentioned in this act and without requiring the full use of the funds herein provided for such purposes: Provided further, that no expenditures by or for the State shall be approved or authorized by the Governor which shall exceed the total amounts provided in this act for the respective institutions, departments and agencies as herein mentioned.

Turn two or three good lawyers loose on that phraseology and there's no telling what would be the interpretation—and the trouble is there would probably be two or three meanings given by the two or three attorneys, some of the legislators are beginning to feel.

But most of them, even those who have doubts of the meaning, seem pretty well satisfied to let the Governor have the authority, if it is, in fact, being given him and the Council.

As a matter of fact, the only surprising feature about the whole bill is that it was introduced with such plentiful detail in the specific appropriations. It had been freely predicted that the measure would come in in somewhat blanket form, with more than a modicum of discretion left in the allocation of funds appropriated through the bond issue and PWA grants in aid.

## Peaces Are Ripe Weeks Early From 'Million \$ Branch'



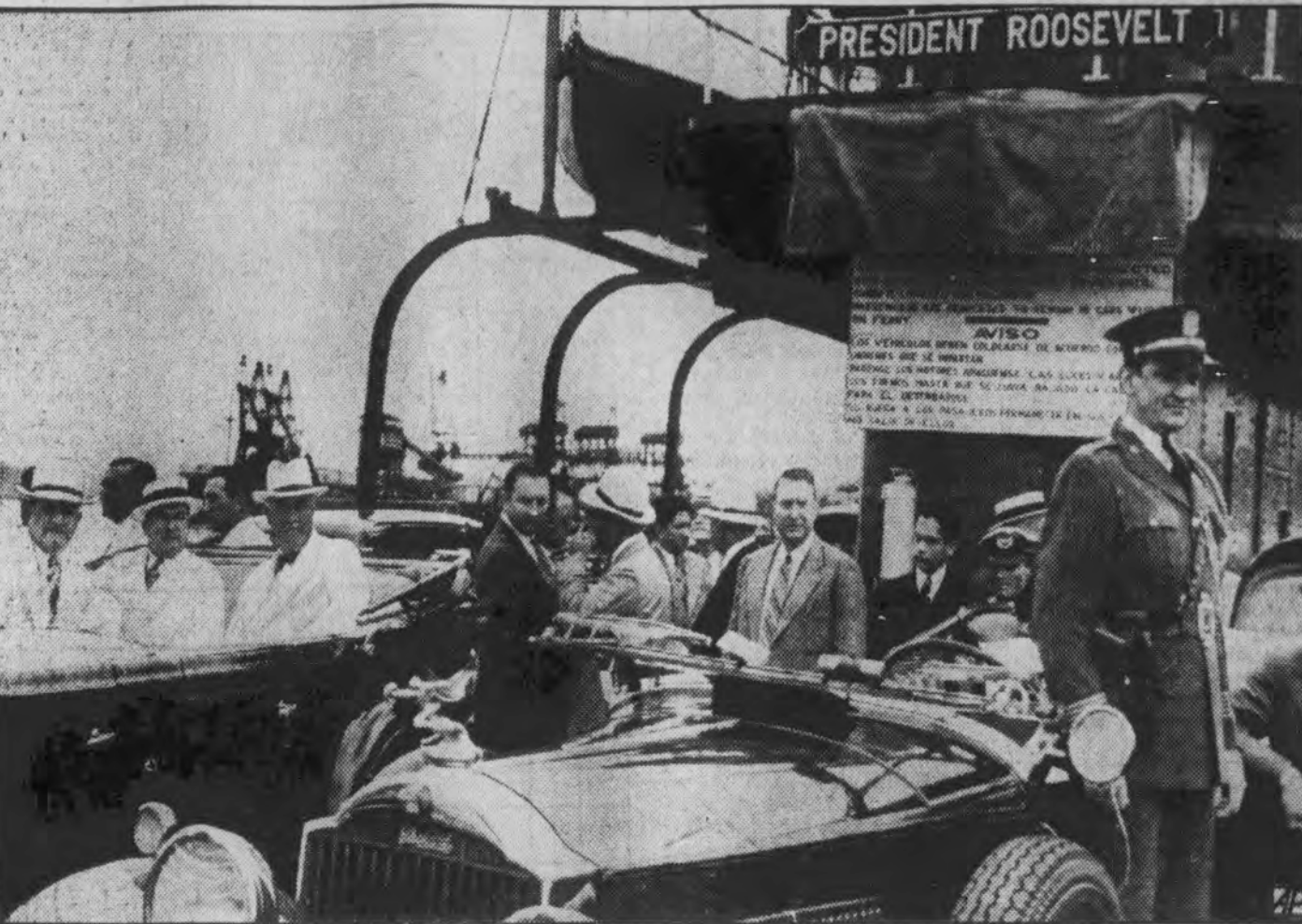

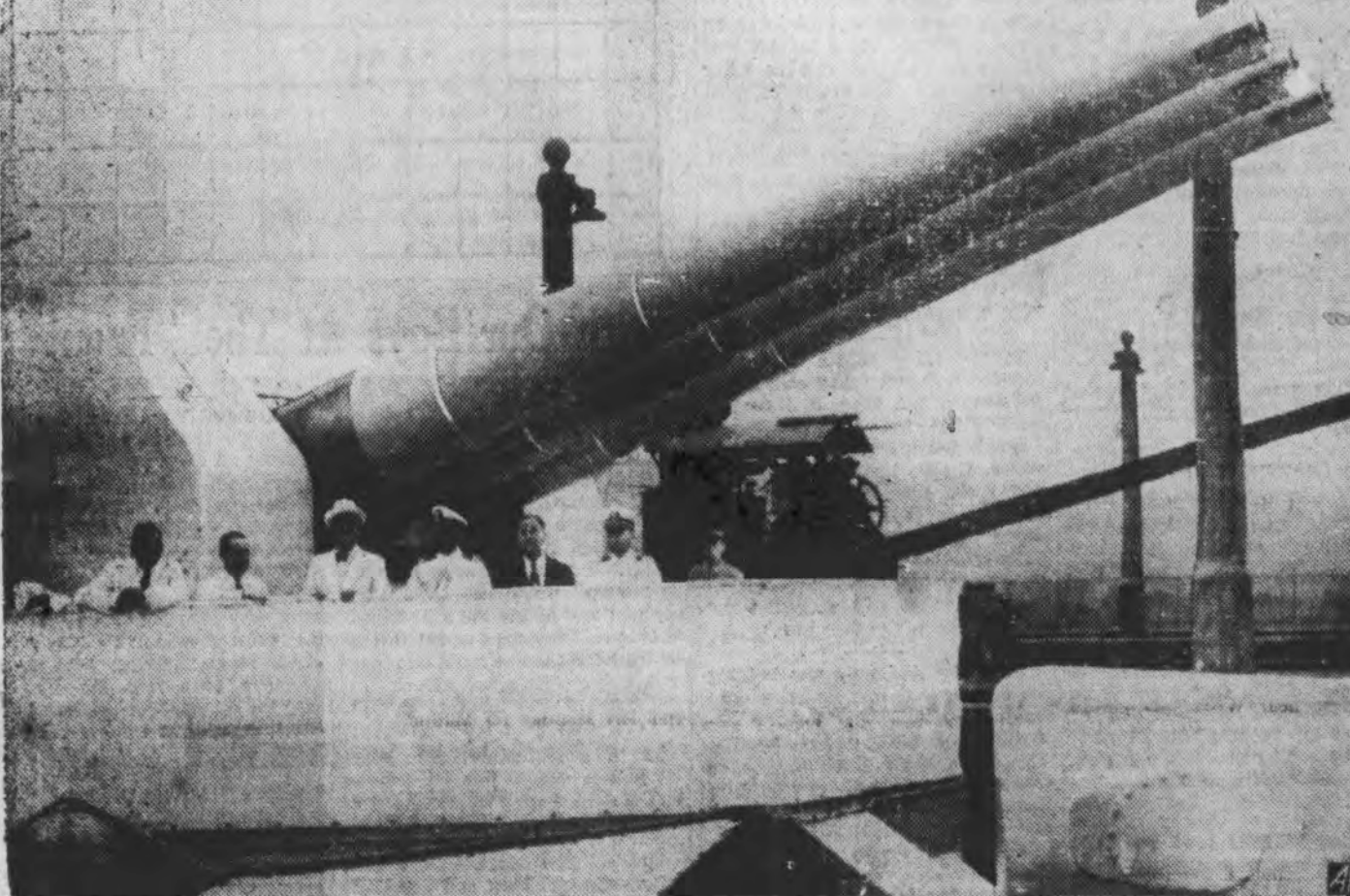
The peaches on the branch had ripened 21 days ahead of time and Fisher's find has since become known as "the million dollar peach limb."

Washington Daybook

By Preston Grover

Washington—Once upon a time there was a famous statesman who wished in vain that his enemy had written a book. Then he would have had an opportunity to confound his enemy with inconsistencies, with glaring mis-statements, with changes of front, and with everything that can happen to a man who has written a book.

But the Republican National Committee has beaten that idea to a shell. The committee has written a book for their enemy—President Roosevelt. It is a trim little affair bound in green paper and labeled "Quotations From Franklin Delano Roosevelt."

As a foretaste of what is inside, there is a quotation from Benjamin Franklin: "Saying and doing have quarreled and parted."

Now President Roosevelt had had "book trouble" before. When the Supreme Court fight was in progress, Senator Wheeler picked up a book the President published in 1933 entitled "On Our Way." From it he extracted condemnation of any idea of "packing" the Supreme Court by adding new members with a view to obtaining a change of decisions.

Senator Wheeler read quantities from the book into the record in launching his attack against the court revision bill.

Aimed At Campaigners

The new book put out by the Republican National Committee helps out those who might not have been so well posted on these things as Senator Wheeler. It has an index and a cross-index on where to find what the President said on this and that, on any asserted changes of attitude, and the like.

"Some quotations were selected which appear to be excellent arguments for the New Deal," says a note in preface. "They set forth in ringing terms social objectives which no man could honorably disavow. They can be used by skillful campaigners as arguments for New Deal promises by which to gauge the performance of the New Deal in its many and varied fields of experimentation."

"Other quotations were selected for use in refuting the arguments of the allies of the President in his own language. Thus we have included statements of the soundness and permanence of the economic recovery of 1933 and 1934 so heavily relied on by the administration in its successful battle for votes in the last presidential election. Administrative claims for credit for recovery are especially useful in fixing responsibility for the Roosevelt depression, for in the words of the President, 'We planned it that way.' (The book probably was on the press before there was time to get a few quotations to explain the current upturn on the stock market.)"

One For The Partisan

Here is a knick-knack, also from the preface: "Statements are included which show administration favor to special groups, disfavor to others, all instilling class hatred, formerly unknown in this country."

And another:

"Many manifestly misleading or unfair statements will be found in the record." Reading the thing, you get a picture of some harried partisan poring over it in a hot hotel room around midnight. Raleigh, Aug. 10—Administration strategy regarding introduction of the "Special Session Bond Act of 1934" was practically perfect. Knowing full well that there would be many disappointed advocates of local projects, the exact recommendations of the Budget Bureau and the provisions of the bill were kept a deep, dark secret right up to the time of introduction.

News men who usually get copies of important measures of this kind at least 24 hours ahead of time, were not handed the printed bill until just about an hour before the opening of the extra session—and they were pledged to show their copies to "absolutely no one."

As a result every advocate of a particular project hoped right up to the last minute that his pet was "in" and there was absolutely no time for these left out to get together and form a log rolling bloc on the "principle of you help me an I'll help you."

This representative J. S. Moore, of Pitt, who felt that E. C. T. C. at Greenville should have had \$100,000 for a gymnasium, got no support from John Caffey of Greensboro, who later tried to put in a \$10,000 Recreation Hall item for the Women's Unit of U. N. C. at Greensboro.

This Clarence Stone, of Rockingham, is one of the best rough and tumble debaters in the House. During the stormy discussion of his efforts to reduce or strike out an item of \$692,000 for a Department of Justice Building, speaker after speaker placed his oratorical trust in the wisdom of Governor Clyde R. Hoey and the Budget Bureau which had recommended the item. But this didn't shake the Stoneville gentleman in the least.

"I'm not a rubber stamp or a me, too, man for anybody," he shouted as he reasserted his right to an individual opinion and the further right to express it.

In this same debate there was revealed an outstanding convert to the opinion that Clyde R. Hoey has made a fine Governor.

Quoth Bertie's spreadeagle-style orator, C. Wayland Spruill: "I spoke against Clyde R. Hoey in fourteen counties. Nobody can accuse me of being one of his blind followers. But he has made good on every promise to the people of North Carolina and we ought not to slap him in the face now."

While the Assembly was holding its opening sessions, fresh trouble for the regular 1939 sitting was being hatched up down Wilmington way, as the North Carolina Federation of Labor condemned the Sales Tax, calling for its absolute repeal, and endorsed Major A. L. Fletcher's proposal for a state Wage-Hour law.

On the tax issue, the Federation was wasting breath and the paper on which its resolution was written; but on the other issue there's sure to be a real battle royal come next January.

To Carl Goersch, radio commentator, much credit for one of the best cracks connected with the session. In his Sunday night broadcast Carl referred to the fact that the Mule Dealers Association was organized last week. Then he added: "And did you know there are more than 300,000 mules in North Carolina—not counting the legislators."

Mecklenburg's Representative M. J. Blankenship, who ran for the Senate on a bone dry platform, apparently isn't so sure that legal prohibition is the best solution of the liquor problem. In a lobby discussion Monday he appeared almost on the verge of conversion to the control idea.

hour when we received a radio message that the "enemy" was within 300 yards to the left of our gun position. Immediately Lieut. Tyson gave orders to remove all marks of identification from our clothing so that in the event we were captured, the "enemy" would not know that they had any of the Field Artillery. He ordered the guns coupled to the gun trucks so that we could be ready for a quick withdrawal. Back at camp immediately upon receipt of the radio message, a scout was sent out to see who the invaders were and whom they were attacking. Guards with automatic rifles were posted to guard the camp area while preparations for withdrawal was being made. The scout, Pvt. Henry P. Brewer, came back and reported that the Browns were attacking the 118th FS-Ga-NG, who were in the rear of us. We received extra guards from Captain Sheppard who sent a detachment of men with rifles to guard the camp until we could withdraw. All this time gun-fire could be heard as if in actual warfare, and we were getting the thrill of our lives. By this time the Browns had captured ten of the 118th FA-Ga-Guardsmen and the rest of them had escaped. Now the invaders were advancing on us! We received orders to withdraw as soon as possible! Sgt. Carpenter, gun sergeant of No. 1 gun, got his crew organized and had the gun coupled to the truck and was out in record time. Gun Sgt. Mobley of No. 2 gun, did not have time to withdraw before the Browns were upon them. Lt. Foye, who was at No. 2 gun at that time, ordered the gun uncoupled and turned on the enemy, who by that time were less than 100 yards away. When the gun was turned on the enemy at such close range, they turned and fled down the hill. Immediately the gun was re-coupled to the truck and the crew made its withdrawal without the capture of one man!

While all this was going on at G.P.C.P. (commander's post) was having it's own excitement. The kitchen equipment had to be loaded, tents taken up, instruments packed, and all the other work connected with breaking camp that would ordinarily take at least a half hour. Everything was packed and ready for withdrawal in less than 10 minutes! The skirmish was not without its fun as the officer's orderly, Private Fred Whitfield, hid in the ice-box and remained there until we were well out of range of the invaders.

We withdrew approximately one mile and stopped for about 15 minutes—long enough to count our men to see if all were present—when we got orders to withdraw still further. Down a long, narrow, dusty road we fled to a scrub oak and pine thicket where we stopped and ate lunch, which consisted of chicken loaf sandwich, jam sandwich and an orange and water. We also had some fun of our own, as the old enlisted men in the Battery formed a belt line and hazed the "fresh meats." We'll be located here until further orders come from Division Headquarters.

cial returns in the Eighth Congressional, where Burgin was shown in the lead on every count; made prior to revision by the Board. Decisive of the result was the State Board's decision on absentee balloting in Davidson, Burgin's home county.

This decision was reached, the board said in its findings despite the fact that "in every instance where there could be any reasonable doubt concerning the validity of a challenged ballot, such doubt has been resolved in favor of the validity of the ballot."

The findings continued: "This board has found, however, that if the absentee ballots challenged were received by the precinct officials, counted and returned by the Board of Elections of Davidson County, then there are, in the returns of Davidson County to this board, a number of fraudulent, void, irregular and illegal ballots."

The fraud and invalidity consisted of (a) absentee ballots having been voted in the name of qualified voters who did not authorize the use of their names, but who knew nothing about their names thus being used; (b) in the failure of many electors to be sworn to facts authorizing the use of the absentee ballots; and also in their failure to even acknowledge the genuineness of their signatures before the Notaries Public who had certified that they had sworn such voters; (c) in the fraudulent statement of some absent voters that they were sick and physically unable to attend the polling place; (d) in the fraudulent statement of some voters who were in fact in Davidson county on the day of the primary that they expected to be absent therefrom on said day.

The board also said it could not accept the contention that enrollees in a CCC Camp in Davidson are, or were, qualified voters. In conclusion it directed the Davidson County Board to revise its figures as directed by the state board and to purge the county's registration books of the names of CCC members not bona fide residents of the county.

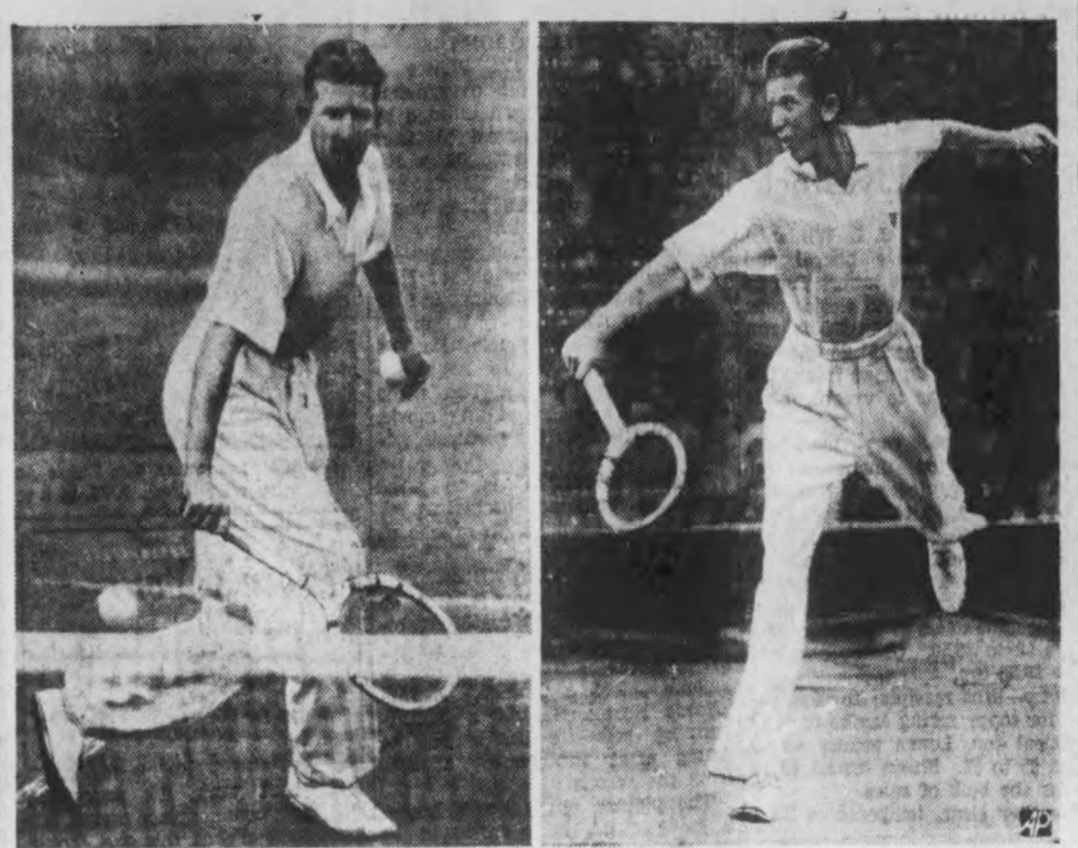

# Coons Tosses Orchid To 'Marie Antoinette'—Picks Robert Morley For Acting Honors

(As Hollywood correspondent of the AP Feature Service and Name of Paper Robin Coons herewith names another movie of the month with reasons.)

Hollywood—I've been overwhelmed by bigness. I've been blinded by glitter. I haven't learned to sneer at approximately \$2,500,000 worth of movie. I'm calling "Marie Antoinette" the month's prize package.

I doubt if anything bigger—or longer—has ever come out of Hollywood. Running 2 hours and 40 minutes, it isn't likely to bump into double-feature trouble. For its own sake, I hope it's shortened before general release. That's too long to sit and look at any movie.

But to turn to the picture's virtues: "Marie Antoinette" is on the whole, a brilliant chronicle of the life, loves, and death of one of history's most tragic queens.

Based on Zweig's Book

Based with some fidelity on Stefan Zweig's sympathetic biography of the Austrian princess whose great misfortune it was to become Queen of France, the film affords Norma Shearer a gamut-running role—for her return to acting after two years' absence from the screen.

The picture opens with Marie, a giddy child, being informed by her mother, the Empress Marie Theresa, of her betrothal for reasons of state to the Dauphin of France. Arrived at the glittering French court, Marie runs helplessly into two major problems: the domination of the throne by the courtesan DuBarry, and the stupidity of her prospective husband. After the marriage—staged on the grand M-G-M scale like the whole production—she learns that stupidity is not her spouse's only shortcoming.

Eventually, egged on by DuBarry's taunts, by her loneliness, and by the urgings of the comely Duc d'Orleans (Joseph Schildkraut), Marie embarks that career of extravagance and wantonness which later, as queen, is to make her hated by the oppressed and hungry people. At this time she meets her true love, the Count Axel de Fersen (Tyronne Power), a love forewarned when Louis XV (John Barrymore) dies and his son, Marie's husband, accedes simultaneously to the throne and to the power of fatherhood.

Faster Pace At End

Although the queen now becomes a dutiful wife and mother, her road to the guillotine is already clearly marked. The fabulous incident of the necklace—Zweig and the movie acquit Marie of blame—is made the firebrand of revolt.

"Marie Antoinette" is as rich in incident as it is in physical trappings. Its costumes and its settings are lavish and the attention to technical accuracies is detailed. W. S. Van Dyke, noted for "speed" in direction, gives the picture as much pace as its biographical nature will permit. And happily, the latter stages gain acceleration.

Miss Shearer's "Marie" is her most ambitious performance, and she approaches it with admirable, often telling, sincerity. The shining star, however, is Robert Morley, English actor who plays the doltish Louis XVI with remarkable insight for a memorable characterization.

The excellent cast includes Gladys George, Anita Louise, Henry Stephenson, Cora Witherspoon, Henry Daniell, and Leonard Penn.

## How's Your Health?

Edited for the New York Academy of Medicine

"It isn't work, it's worry that kills," is a commonplace saying. Like most such cliches, this one, though, vague in meaning, expresses a good idea.

The difficulty in arriving at the substance of this saw lies in the precise definition of what is meant by work, and what by worry.

Work, as men perform it, is part of some occupation or profession. And in practical life most occupations are associated with certain grades of social and economic existence.

Hence, when we try to determine the effects of a given type of work upon health or the length of life, it is extremely difficult to separate them from the effects of the other phases of living.

Farmers, for example, are usually required to do hard physical labor. And yet their average length of life is greater than that of the general urban population.

Bar tenders seldom are called on to do physically exacting work and yet as a group they are substantially shorter lived than farmers.

Certain occupations expose their workers to noxious agents which tend to shorten life. These, however, are what may be termed the accidental factors of work, rather than inescapable features.

To the extent then that work is taken to mean activity, business, purposeful occupation, it is correctly said that work does not kill.

When work is excessively exacting, when it involves exposure to poisonous fumes and liquids, to harmful dusts, when it must be performed under insanitary and unhygienic circumstances, then such work must be considered "killing work."

In the general industrial picture, however, the hazardous occupations are not prominent.

This is revealed in an interesting way. The mortality rates of the wives of men belonging to certain industrial groups and social classes are compared with the rates of their husbands.

The comparison shows that the contribution to mortality made by the actual work done by men is very small compared with the contributions made by the accompanying economic and environmental factors.

Perhaps it is these economic and environmental factors that are meant in the saying that it's worry, not work, that kills.

# Martin Statement Sounded Knell Of Whiskey Question

Cale K. Burgess, Dry Leader, Quoted as Saying Wets Will Have Wider Margin in '38 Assembly

Raleigh, Aug. 10—A Cale K. Burgess statement, as quoted by Senator L. A. Martin of Davidson, seems to have sounded the death knell of any possible liquor fight in the 1939 General Assembly.

Adoption of the "gag" rule over Martin's vigorous protest gave the coup de grace to any possibility the perennial struggle might be revived at the extra session, even though the Lexington man had no intention of introducing any prohibition bill even without the gag.

Martin said "Cale Burgess told me that the wets will have even more of a margin in the next legislature."

Inasmuch as the control forces won with three votes to share in the 1937 Senate that seems to put the clincher on the wet-dry matter for the next two years, as far as general statewide legislation goes; but it does not mean that the fight is over or that the controllers can sit back from now on and take it easy.

The Drys are undoubtedly much heartened by the result in Catawba, where ABC stores lost in a landslide of dry votes. Under the "now it can be told" head it can be pointed out that Mr. Burgess knew just what was coming over there and probably has his 1939 Assembly well sized up. Some days before the Catawba county vote the United Dry leader told your correspondent "off the record" that the noly danger to the Drys of Catawba was overconfidence. "We've got them licked thoroughly," he said.

It follows that with Burgess clearly realizing the impossibility of jamming any referendum bill thru in 1939, the fight will be to make as many counties and townships as possible bounte dry by local legislation prohibiting the sale of wine and beer within their limits.

## Funds Sought For 'Hazardous' Roads

Raleigh, Aug. 10—(AP)—The State Highway and Public Works Commission drew up a request for Governor Hoy today to allocate money from its surplus to correct "hazardous conditions" on North Carolina roads, Chairman Frank Dunlap said.

Dunlap explained any release of its contents would come from Hoy's office.

The commission's unencumbered surplus as of July 1 totalled about \$3,500,000.

Dunlap said the commission would draw up a list of roads and bridges needing attention, but neither he nor commission members would say whether they set a specific amount in the request.

It will not include further prison projects already in progress under a \$1,000,000-backed program.

not authorized by previous legislation.

The final vote was 72 to 13 after the amendment was adopted 51 to 40.

Both measures now must pass three readings on three separate days in the Senate. Governor Hoy called the legislators into extraordinary session to enact them and a bill which was made law yesterday, to appropriate \$75,000 for state participation in the 1939 New York World's Fair.

The convenience certificate amendment brought forth heated opposition from Brooks of Johnston and Lumpkin of Franklin. It was favored by Pickens of Guilford, who led the fight Monday against the general requirement that certificates be secured for all projects authorized by the bill.

Brooks urged the House to reject the compromise "and say to the Senate that the killing of this bill is squarely up to the Senate, the House is not surrendering to the power companies."

The Senate in 1937 refused to pass such a bill without requirement of such a certificate.

Both divisions adjourned to meet at noon tomorrow.

The House has passed and sent to the Senate the Hobbs bill to permit municipalities to issue bonds for beach erosion projects and the Seeley measure to permit Carteret county to refinance its indebtedness.
