

BRITISH ENVOY REPORTS AS TO NAZI ATTITUDE

States German Intentions in Dangerous Czech Dispute

CABINET CALLED TO MEET TUESDAY

Link Steps to British Fear "Conflict Anywhere May Mean Strife Everywhere"

London, Aug. 29.—(AP)—The British Ambassador to Germany, Sir Neville Henderson, handed to Premier Chamberlain today a personal report on Berlin's present attitude and intentions in the increasingly dangerous Czechoslovak minority dispute.

The Ambassador's sudden return to London and a summons to cabinet ministers to meet here Tuesday were foremost in the crescendo of events over the week-end.

These steps were keyed to the fear that conflict anywhere may mean conflict everywhere, as the Times put it, and to the British policy to contribute to control of events before they take charge of us.

The tone of Sir Neville's reports today to the prime minister, to Viscount Halifax, the foreign secretary and to Sir John Simon, chancellor of the exchequer, may determine whether the cabinet ministers tomorrow shall decide some action is necessary.

Officials in Berlin privately already had shown dislike for Sir John's speech Saturday, warning that conflict might be limited at the start, but could spread like fire in a high wind.

Berlin disliked equally a foreign office statement appealing to "all quarters" to avoid anything which might "heighten the tension." German political circles saw this as a spur to Czechoslovakia to resist her Sudeten-German minorities demand for autonomy.

Work On Stadium Reveals Progress

TWO KILLED IN AUTO ACCIDENT

Miss Alma Daney Worthington, 29, daughter of Mr. and Mrs. G. C. Worthington of Winterville, Route 2, was killed in a head-on automobile collision last night around 1:30 o'clock at Askins, eight miles south of New Bern on the New Bern-Vanceboro highway.

Miss Worthington died on the scene of the crash. Thurman Jones, 33-year-old Kinston resident, with whom Miss Worthington was riding, sustained lacerations of the scalp, forehead, and chin. Fifteen stitches were required to close his wounds.

Miss Reta Helen Stubbs, 18, of Askins, died shortly after reaching the New Bern hospital. Miss Betty Stubbs, sister of the wreck victim, suffered dislocation of the right hip and abrasions of the neck. They were riding with Irving Jones and Monroe Ippock of Bridgetown. Jones sustained lacerations of left eyebrow and possibly a fractured pelvis. Ippock is believed to have a broken leg.

Funeral services for Miss Worthington will be conducted from the late home Tuesday afternoon at 3 o'clock by the Rev. W. M. Brunson, pastor of the Ayden Christian church. Burial will be in the family cemetery near the home.

Miss Worthington was graduated from East Carolina Teachers College in 1928, and had been secretary to C. D. Ward, principal of Winterville high school, for the past two years. She also filled the unexpired teaching term of the late Miss Geneva Exum in the Winterville school. Miss Exum had also worked in the office of County Agent R. R. Bennett this summer. She was a member of the Eighth Street Christian church of Greenville.

Besides her parents, surviving are six brothers, Lloyd B., Carl, Norman, Bryan, Adrian, and Gurman Worthington; one small sister, Rose Worthington; one niece, Miss Elaine Worthington and a nephew, Burt Worthington.

Active pallbearers will be Wadell Wilbur, Glenn, Edward, and Clifford Worthington, and Elmer Tucker, cousins of the deceased.

Boosters Declare State Going Into Fifth Season

GOV. JOHNSTON ASKS SENATOR STATE CHOICE

Calls on Brown Come Out Publicly For Favorite

SOUTH CAROLINA SEES BIG VOTE

Democratic Primary Tomorrow To Test Strength of Appeal By Roosevelt

Columbia, S. C., Aug. 29.—(AP)—Governor Olin Johnston, opposing United States Senator Ed Smith in tomorrow's Democratic primary, called today on State Senator Edgar Brown, erstwhile third candidate, to declare between them.

The Governor inferentially endorsed yesterday by President Roosevelt sent the following telegram to Brown, who withdrew unexpectedly from the race Saturday.

"In view of the President's statement in the morning papers, it is evident that if you want to help him in carrying forward his policies you will vote for me for the United States Senate.

"On the other hand, if you have only a stalking horse in this campaign for the Liberty League, Republican and Roosevelt-haters you will vote for Smith.

"Under which flag do you fight. Answer for publication in afternoon papers for today."

Columbia, S. C., Aug. 29.—(AP)—A Democratic primary which has brought a record registration of 422,000 will decide tomorrow the political future of Senator Smith, veteran of five terms, who is regarded as being on the New Deal's "purge" list.

Seeking to unseat the 74-year-old Democratic dean of the Senate is 41-year-old Governor Olin Johnston, who rose from a textile mill worker to the Governor's chair. Johnston campaigned as a 100 per cent New Dealer.

President Roosevelt lent his influence to the contest yesterday when at Hyde Park, N. Y. he said South Carolina voters have the responsibility of selecting a Senator to play a part in legislation to carry out administration objectives.

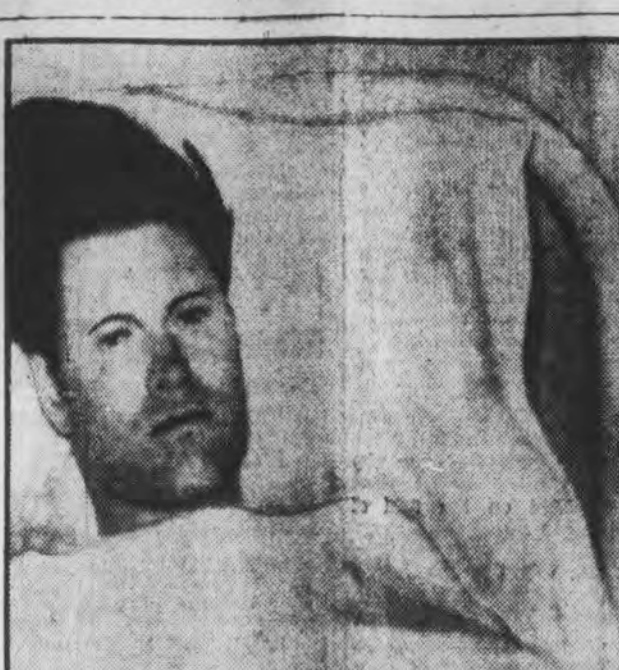

MAKING STUDY OF ALLOTMENT

Local Committee Is Seeking to Adjust Leaf Quotas

Members of the County Agricultural Conservation Association were busy today working in cooperation with the AAA and state officials in an effort to iron out purported inequities in the tobacco marketing allotments.

The group is seeking to have adjustments made where errors exist or where quota inequalities are in evidence.

The allotments were made in Washington and the local association is merely preparing data in an effort to have revisions made where the quotas are believed to be too low.

Local officials said it was realized that the quotas in some instances do not reflect the true productivity of some farms in Pitt county.

All farmers who feel that their quotas are not sufficient are urged to file a written statement requesting the allotment be studied by the review committee in order that the proper adjustments may be made. It was explained that it is also (Continued on page six)

Seeking To Break Old Flight Record

Kansas City, Aug. 29.—(AP)—Mayor Alexander Seversky, airplane manufacturer, landed at Kansas City in his low-wing plane at 9:52 a. m. today, after a flight of 15 hours and 15 minutes after he left Floyd Bennett field, New York, on an east-west experimental flight.

He continued his flight at 10:22 a. m. (11:22 EST).

His average speed approximately 1,150 miles at more than 250 miles an hour and expressed confidence he would set a new east-west record of nine and a half hours. The present record is 11 hours and 30 minutes held by Roscoe Turner.

Judge Frizzelle, in concluding his charge, declared that there were two specific things he wanted to call to the attention of the jurors. The first was "the extreme importance" of enforcing observance of the motor vehicle law to "the end that life, limb and property may be made safer." He referred particularly to drunken driving.

TEST FOR TAX SEEMS LIKELY

Winston-Salem Store Ordered Pay Sales Levy

Raleigh, Aug. 29.—(AP)—A Supreme court test of the validity of North Carolina's three per cent retail sales tax appeared assured today when Revenue Commissioner A. S. Maxwell ruled that the Community Variety Store of Winston-Salem must pay the levy.

The variety store is operated by Paul Leonard of Statesville, who set up the shop to test the validity of the tax, which nets the state about \$11,000,000 annually.

Leonard, secretary of the North Carolina Fair Tax Association, said he would pay the tax under protest and take his case immediately to court.

Maxwell's decision was announced at the conclusion of a two-hour hearing, at which the levy was assailed as dictatorial and unconstitutional.

Fred Parrish of Winston-Salem, attorney for the Fair Tax Association, asserted that "even Hitler wouldn't do much worse than some of the arbitrary provisions" in the sales tax law.

The association, on a brief filed with Maxwell, also alleged that the tax was unconstitutional because it was passed by an illegally constituted legislature. Since 1930 Leonard pointed out, the legislature has refused to reappoint its members on a population basis, as prescribed by the state constitution.

Maxwell pointed out that this argument, if upheld by the Supreme court, automatically would void all laws passed by the General Assembly since 1929.

DISPUTE OVER AUTHORITY IN CHINA WATERS

Commander of U. S. Gunboat Holds Japs Responsible

MINES EXPLODE CLOSE TO CRAFT

Meanwhile Conflicting Reports Made Regarding Jap Advances on Hankow

Hongkong, Aug. 29.—(AP)—A serious dispute over the right of a U. S. gunboat in China waters under Japanese control was reported today from Kiukiang by authoritative sources.

The dispute concerns the gunboat Monocacy, which was shaken and showered with water, but not damaged by the explosion of two mines 80 yards from the gunboat anchored at Kiukiang Saturday.

A protest by Commander Lieut. C. V. Conlan, a reliable informant said, was rejected by the Japanese consul who, in effect, contended that foreign warships were in battle areas at their own risk.

Lieut. Conlan was understood to have countered that he was holding the Japanese responsible for any mishap resulting from Japanese operations or from mine explosions.

Shanghai, Aug. 29.—(AP)—Chinese asserted today they had cracked the Japanese offensive on the north bank of the upper Yangtze river, recapturing three important towns the invaders won in six weeks of bloody fighting.

The towns were north of Kiukiang and about 135 miles down river from Hankow, China's provisional capital.

The Chinese also said they had cut off Japanese advance forces at the spearhead of the Japanese drive up the north bank and were attacking a town there.

The Japanese on the other hand reported they were advancing on the Peiping-Hankow railway after having captured two planes near the Honan-Anhui border.

They said one town was completely occupied during the night.

PILOT SIGHTS CARS AND MEN

Party Believed to Be Texans Marooned By Hurricane

Brownsville, Texas, Aug. 29.—(AP)—A Pan-American Airlines pilot radioed here today he had sighted two automobiles and several men on Fourth Path off the Mexican coast, near where 10 Texans were marooned yesterday by a hurricane.

The men were running around the island, waving sheets, the pilot said. The plane continued on to Tampico without making an attempt to land. The pilot did not mention the number of men counted.

Les Mauldin, aviator, planned to take off after lunch for the sand dune area in search of the missing men.

The Texans went fishing Friday and are believed marooned on low islands that were almost directly in the path of the gale.

High tides, pushed up by hurricane winds, rolled over portions of the sand dunes off the Texas coast, leading to the belief the islands, six miles off the Texas coast, were hard hit.

NEW EVIDENCE AGAINST HINES

Hotel Employee Says Defendant Seen With Schultz

New York, Aug. 29.—(AP)—Charles W. Hughes of Brooklyn, Mass. former assistant manager of the Hotel Barham at Bridgeport, Conn., testified today that he saw Tammany District Leader James J. Hines sitting in the lobby hotel with the late Dutch Schultz, gangster, and some of his mobsters in 1935.

Hughes said he saw Hines with Schultz twice, as well as with Schultz's henchmen, including "Lulu" Rosenkrantz, George Weinberg and J. Richard Davis, the mob's lawyer.

The witness, testifying in Hines trial on conspiracy charges in connection with the multi-million-dollar Schultz policy racket, said he saw the Tammany chieftain in the same month that another witness, Dudley Brothwell, Fair field, Conn., riding master, swore he saw Hines with the "Dutchman" at his stable.

The prosecution contends Schultz was reducing expenses at that time and wanted to see Hines personally to tell him that his weekly fee as alleged political "fixer" for the policy's syndicate was being cut from \$500 to \$250.

Hughes dramatically confronted Hines in the courtroom and pointing him out said crisply, "that is the man I saw with Dutch Schultz."

"The man," he added, "with the glasses."

Hines started at him unblinkingly through his horned-rimmed spectacles.

Hughes said he knew Schultz was "a nationally known criminal" and that he remembered Hines in the mobster's company because anyone visiting Schultz made a "stronger impression" on him than an ordinary guest at the hotel.

Meanwhile in Washington Federal Reserve Officials Express Confidence

Hyde Park, N. Y., Aug. 29.—(AP)—President Roosevelt took a new step forward today in his drive to "purge" Congress of anti-administration Democrats.

The President suggested the nomination of a New Deal supporter in the South Carolina Democratic primary tomorrow. Simultaneously he arranged a Labor Day talk in Denton, Maryland, against Senator Tydings, an administration foe seeking renomination.

At Washington meanwhile, Navy Department dispatches disclosed that for days the United States gunboat district and mines in the Yangtze river in China.

The dispatches said 15 mines had exploded in the neighborhood of the boat. On Saturday two burst simultaneously only 80 yards from the boat.

Other Washington developments: High officials of the Federal Reserve Board expressed confidence that the vast credit expansion sought by the Roosevelt administration has begun.

The trend of bank loans to finance business and industry, they said, has definitely turned upward for the first time since last November. The last three weeks showed higher reports of commercial, industrial and agricultural loans in banks of 101 leading cities.

Chairman Sheppard (D-Texas), of the Senate Campaign Expenditures Committee, questioned the legality of Treasury employees making voluntary contributions to political campaigns as permitted in an order issued by Secretary Morgenthau four years ago.

Aged Farmer Dies By His Own Hand

Washington, N. C., Aug. 29.—(AP)—Nathaniel A. Ebron, 72 years-old retired farmer of Yokesville, died almost immediately after he shot himself through the abdomen with a single-barrel shotgun at the home of Aaron Russell, at Yokesville, about 6:30 o'clock this morning, according to a report here by Coroner Penner P. Paul.

Ebron's body, the coroner said, was found by members of his family in a small house behind the home after they had become alarmed when, upon arising, they missed the elderly man.

## Man About Manhattan

New Orleans—I like to read inscriptions on statues and grave-stones. Sometimes they are funny. Often they are sad. Frequently they say nothing beyond the fact that here lie the remains of someone who was born and now is dead.

This is a good town for inscription readers because there are so many statues here. All of them commemorate heroic deeds. There never was a time when New Orleans wasn't a rendezvous for heroes, anyway. And there are many, many cemeteries. But they are unlike most cemeteries. Here they are "cities of the dead," for most of the burials are by vault, and instead of graves you see row after row of little white-washed houses. Like miniature cities they glisten in the sun. Burial above ground is important here because the land is so near sea-level.

As you stroll through these communities of the dead you frequently come upon the names of men who fell in duels: "Mort sur le champ d'honneur"—"Died on the field of honor. Another reads "Pour garder intact le nom de famille"—"To keep unspilled the name of the family. And again, "Victime de son honneur"—"Victim of his honor."

In Girod cemetery there is an inscription that lovers and romantics sing, because it was written by the lover of a famous actress, Jane Placide. His name was James Caldwell, and when his sweetheart died he chose this lyric lament for her grave:

"There's not an hour Of day or dreaming night but I am with thee There's not a breeze but whispers of thy name, And not a flower that sleeps beneath the moon But in its hues or fragrances tells a tale of thee."

Perhaps the most arresting burial place in the city is the Chinese Mausoleum. It is a plain square structure with vaults opening on a covered courtyard, but all the slabs are identified with Arabic numerals and Oriental symbols. Incense is burned here for the benefit of those who have joined their ancestors. This place is but a temporary resting place, for all Chinese are returned to China for burial. About every ten years the vaults are opened and remains packed in steel boxes and returned to China.

# MIGHT SELECT LABOR LEADER

## Political Trouble May Follow Fletcher's Leave

Reflector Bureau. Raleigh, Aug. 29.—Complications political might arise should Major Arthur L. Fletcher leave the commission of labor to go to Washington to help administer the wage and hour law.

Should a resignation be turned in either Governor Hoy would have to make an appointment of the Democratic state executive committee a nomination. The time element would figure there. Major Fletcher defeated Roy Lawrence while the head of the federation worked with that organization. The unionists felt that they should have had one major office, though Major Fletcher was not unacceptable to them.

Friends of W. O. Burgin insist that the nomination of C. B. Dean was compassed by C.I.O. members,

that they furnished the balance that finally broke against Burgin. It is feared by some of the old timers that should Major Fletcher leave and open the labor issue anew it might result less happily than once it did. President Roosevelt is on the march and the C.I.O. doesn't appear to be going in the opposite direction. The State Federation of Labor doesn't appear now to have a man of suitable stature to race Lawrence though T. A. Wilson, former state federation head and member of the commission which administers the workmen's compensation act, is very generally promoted for the Fletcher vacancy if it occurs.

Mr. Wilson was named a member of the commission by Governor O. Max Gardner who was the first of the governors who had power enough to push through a workmen's compensation act. Governor Hoy is being urged to promote him if Wilson is willing to take the Fletcher post.

Politically Roy Lawrence has been very active and affronted Governor Hoy no little in the 1936 campaign, but lost. He was very close to Dr. Ralph W. McDonald who was Governor Hoy's opponent in two primaries.

### JUDGES EXPECTS TO DECIDE ELECTION CASE THIS WEEK

Justice William R. Allen, Judge Frank A. Daniels and numerous friends thought it his duty to stop Abernethy. Colonel Dorich had had a brief time to race. He made a magnificent try and by a narrow margin got the nomination. Abernethy undertook every legal restraint. He moved in sundry places and succeeded in a slight interruption; but in every instance the courts were finally against him and he lost the nomination. Colonel Dorich died before election day, died, it seems, on the day that his Gaston was killed in action with the Germans.

The odd thing is the time. Exactly 20 years ago this Abernethy-Dorich war was raging. The World conflict quite backed it off the board, but even with a World war and a victorious American participation in it, Abernethy made news. It is interesting to recall that the Dorich position in that fight was the exact predicament which Ehringhaus chose in presenting the case for Burgin. The power of the State Board to go into the primary was denied and the board did not try. In that view the Supreme Court on that day undoubtedly agreed and one of the amusing aspects of the fight was the position of the Raleigh News and Observer. It ridiculed Abernethy world without end and demanded that he come into court and tell where he got the money on which he made his race for the nomination. The paper stood squarely against him in the courts. It was dead against the aspersions which Abernethy cast upon the official in the primary.

The paper has declared Chairman W. A. Lucas to be a man of great courage in going into the conduct of the recent primary and has stung Governor Ehringhaus for making arguments that sounded mighty like the ratiocinations of the Old Reliable in those by-gone days.

More recently, however, the paper has spoken of the power of the Ehringhaus argument in the present case. Editorially it doubts that the issue should have been raised as to the board's power. Quite amusingly it was lifted by the great Raleigh daily back in those world war days.

And Judge Harris is having something to decide. There are no precedents which seem to be helping him.

**Washington Daybook**

Washington—The expenditure of any public money is a responsibility. When the amount involved reaches \$50,000,000 the responsibility is definitely great. But when the \$50,000,000 or more is to be used to purchase a battleship there is a dual responsibility—first to see that the public gets a dollar's worth of ship for each dollar of the purchase price, and second, to be certain that the battleship purchased has all the desirable characteristics to make it of maximum usefulness in the defense of our country throughout its 26 or more years of service.

This responsibility is divided. The general board composed of experienced flag officers, determines the characteristics which include tonnage, armament, cruising radius, speed, vulnerability, etc. The technical bureau study the general board characteristics, work up general and detailed specifications, provide plans and conduct various tests in the model basins, at the boiler and other laboratories, in ordnance plants and in outside commercial plants. This work crystallizes in the form of plans and specifications which are furnished to the prospective bidders several months in advance of bid opening, to enable them to make proper estimates.

**Buying A Battleship**

In the actual buying of a battleship the basic law which governs is the Vinson-Trammel act of March 27, 1924. In any contract in excess of \$10,000, this law provides for reports in detail to the secretary of the Navy on costs and for payment into the Treasury of profits in excess of 10 per cent of the contract price. It further provides against subdivision to avoid the restrictions of the act. The act was amended June 24, 1936, to allow the losses of one year to be carried over for the next succeeding income taxable year in determining excess profit, if any.

In addition to the Vinson-Trammel act, there are incorporated in all building contracts the provisions of the Walsh-Healey act of 1936.

# FALL PICTURES ARE REVEALED

## First All-Industry Product Announcement Made

Ninety-four productions, covering the feature pictures of nine movie companies for August, September and October, are listed in the first all-Industry Fall announcement ever issued from Hollywood. The announcement is made today in connection with the Motion Pictures' Greatest Year campaign, sponsored by all branches of the industry, to stimulate business.

The industry feels that, inasmuch as motion pictures are a barometer to prosperity, the success of its drive is bound to be beneficial to the nation at large leading to an upswing in business, bringing more jobs and putting more money into general circulation.

Comprehensive preparations have been made, according to the announcement, to insure the quality of production living up to advance notices and justifying campaign claims. The quality and success of such pre-release pictures as "Alexander's Ragtime Band," "Algers," "Marie Antoinette," "Four Daughters," "Mother Carey's Chickens," "The Texans," "Letter of Introduction" and "Barefoot Boy," do in fact indicate, the producers feel, that the season of 1938-39 will be "Motion Pictures' Greatest Year."

Attention is also called to certain noticeable trends in the Fall product which, it is felt, reflect a healthy reaction on the part of the studios to the public demand for varied and intelligent entertainment. There is a noticeable absence of cynical realism, and a return to wholesome and often humorously romantic themes. There are fewer crime pictures and those on the list indicate a more serious, sociological approach to the theme. 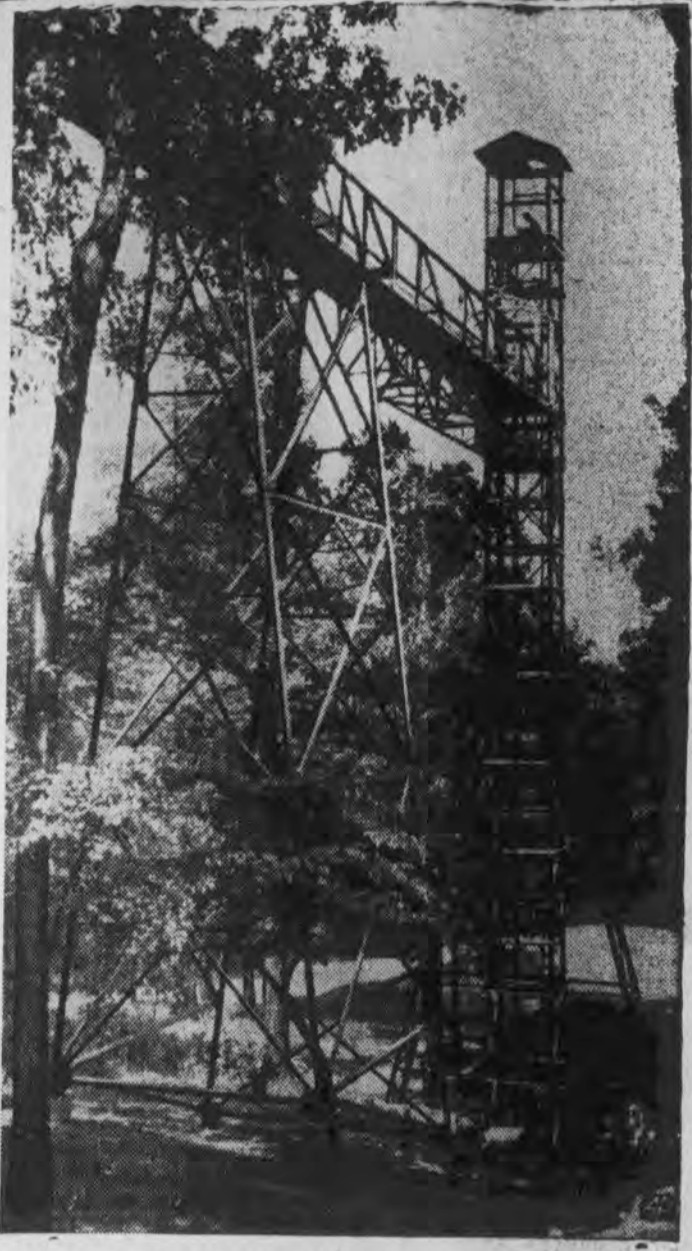
## N. Y. Stock Market

**Sleeping Sickness Attacks Horses.**  
Washington.—(AP)—Uncle Sam's veterinarians are conducting experiments to curb an epidemic of sleeping sickness among horses which affected 170,000 animals in this country last year.  
It is believed the disease is a virus spread by biting insects, especially mosquitoes. The sickness is prevalent in the central west.

**IT'S ODD, But It's Science**

Saranac Lake, N. Y.—To take dust out of the air throw more dust into it.

This paradoxical treatment is the newest way of attacking the industrial dust health hazard. The experiments come from the laboratory here of the Mellon Institute's Air Hygiene Foundation. They are reported by Dr. LeRoy U. Gardner.

The worst dust is silica, responsible for silicosis. When gypsum, a different kind of dust, is thrown into the air with silica dust, its particles unite with the silica. The union adds to weight so that many of the particles drop to the floor.

But even if the heavy particles continue to float in the air, the health hazard is less. For the big particles do not so readily get past the natural barriers of the nose.

Silicosis comes partly from the dust and partly from chemical reactions in the lungs. But the size and shape of the particles themselves is an important part in causing the disease.

The Mellon Institute discovery about putting in more dust complicated an already knotty problem of defining how much dust makes the air dusty. The New York state code says it is 100,000,000 particles in a cubic foot of air.

But the code makes an exception. If the dust is from rocks containing more than 10 per cent of silica, then it is legally dusty when the air has only 10,000,000 particles a cubic foot.
