CONFIDENCE IN POLICY VOTED FOR MINISTER

Chamberlain Followers Defeat Motion By Labor Party

ADJO'RNMENT OF HOUSE APPROVED

Government Opposition Declares Commons Treated More As A Reichstag

London, Oct. 6.—(AP)—Prime Minister Chamberlain's followers today defeated a Labor motion expressing disapproval of his foreign policy as expressed in the "peace of Munich." The vote was 369 to 150.

Earlier Chamberlain won, by 313 votes to 150, the first House of Commons vote in the closing hours of debate on the four-power "peace of Munich."

The house approved his motion for adjournment this afternoon until November 1.

Harold McMillan, a conservative, joined the opposition, declaring he was afraid Commons was being treated "more and more as a kind of Reichstag (German diet) just because it has to hear orations and register decrees."

The vote on the question of confidence revolves about Chamberlain's part in the decision to cede parts of Czechoslovakia to Germany.

Winston Churchill, conservative opponent of Chamberlain's foreign policy, also opposed adjournment.

He compared the move for adjournment with the "situation in other countries where impatience with the parliamentary machine has swept it away and led to one man rule."

Grifton Man Dies Of Heart Attack

R. C. McCotter, prominent Grifton man about 65 years old, died suddenly in a store there this morning about 6:30 o'clock from a heart attack.

Mr. McCotter, who had been in his usual health, was in the store when he was stricken. He died immediately.

He was a farmer and a retired merchant, a Mason and a member of the Christian church.

Funeral services will be conducted at 2:30 o'clock tomorrow afternoon at the Garner funeral home in Grifton, with Rev. Perry Case of Wilson and Rev. G. B. Stirling of Grifton in charge. Burial will be in Maple wood cemetery, Kingston.

Mr. McCotter, who was born and reared in Grifton, was the son of the late Mr. and Mrs. R. B. McCotter. He is survived by his wife, Mrs. Addie Coward McCotter and daughter, Miss Mary Dawson McCotter, a student at Peace Institute Raleigh, one brother, J. K. McCotter of Hopewell, Va., and two sisters, Mrs. Annie Rasmussen of Maury and Mrs. Mabel Adams of Grifton.

Pallbearers will be Patrick, Robert and Norman McCotter, Frederick Cox, Cecil Cobb and R. E. and R. E. Barwick.

Application Made For Project Fund

J. O. Duval, city clerk, said today that an application for 25 per cent of the cost of the street improvement program now under way here had been approved by the Atlanta WPA office and sent to Washington.

The original project called for expenditure of \$103,000. The contract price, however, was only \$79,000. Additional streets probably will be added to the program to use the money available.

The PWA will release 25 per cent of the cost of the project if the sponsoring agency has its money already in hand. An additional 10 per cent is sent when the work is about 70 per cent completed and the remaining 10 per cent of the PWA's share of 45 per cent is released upon completion and acceptance of the project.

Mr. Duval also said that as soon as the architect completed his plans and specifications for the new city hall and fire station and the purchase of the site had been approved by the PWA, he would make application for 15 per cent of the total cost of the two projects. The city has not sold its bonds for the projects and therefore only 15 per cent of the PWA's share will be available now.

TO WAGE FIGHT FOR FARM VOTE

Democrats Feel Safer In Nation's Industrial Areas

Washington, Oct. 6.—(AP)—Informed persons forecast today that the Democrats would make an extraordinarily intensive fight this fall to retain their political strength in the mid-west farm belt.

This was the significance read into James Farley's cautious press conference statement yesterday that the Democrats traditionally have been stronger in the industrial states because of their labor policy.

Thus, the Democratic national chairman replied to a question as to whether the Democrats were losing ground in the farm states.

It was believed that as a result of the conditions his statement implied, there would be a determined Democratic effort to hold all congressional offices which the party now holds in the section.

Other developments: A flood of last minute registrations of agents of foreign governments poured into the State Department as the deadline—midnight tonight—approached for complying with the law passed at the last congressional session.

Under the law foreign agents must register with the State Department. The penalty for non-compliance is a fine of \$1,000 or imprisonment of not more than two years, or both.

TENANT FREED BY S. C. JUDGE

Says He Had To Sell Liquor When Cotton Crop Cut

Greenville, S. C., Oct. 6.—(AP)—Judge H. H. Watkins of Anderson, presiding at the current term of Federal court here, today again inferentially condemned the government's crop reduction program as he passed sentence on a defendant who admitted operating an illicit whiskey distillery, but asked for mercy because "I couldn't make a living after the government cut down my cotton crop."

The defendant, T. R. Garland, a share cropper on a farm near Newberry, told the court that in the current crop control program, he had been forbidden to raise any cotton. His story was corroborated by the Newberry officer who arrested him.

"It's unbelievable," Judge Watkins said, "but then there are many unbelievable things happening in this country today."

He turned to the open court: "Gentlemen," he said, "I ask you to consider this case. The government has forbidden this man to raise a crop to feed his family."

"I can not find it in my heart to send this man to the penitentiary. I sentence you to one year probation," the judge concluded.

American League Entry Takes Second Straight in World Series, 6-3, After Great Dizzy Weakens in Eighth and Blows Up in Ninth

Wrigley Field, Chicago, Oct. 6.—(AP)—Dizzy Dean, after holding the New York Yanks to three hits, two runs for seven innings, weakened in the eighth frame and completely blew up in the ninth, and the American Leaguers defeated the National League Chicago Cubs 6-3 in the second game of the world's series this afternoon.

With the Cubs leading 3-2 as the eighth started, the Yank's batting power went to work and Crossetti homered with Hoag, who had batted for Gomez, and reached first on a fielder's choice, trotting home ahead of him to give the Yanks a lead of 4-3.

Adouble play cut a threatened Cub rally short in their half of the eighth.

MANY PLACED ON PAY ROLLS

Service Reports 5,451 Placements During September

Raleigh, Oct. 6.—(AP)—The state employment service reported today that placements during the last two weeks of September aggregated 5,451, with 68 per cent being in private employment, for a gain over the preceding two weeks of upwards of 300 persons.

Kinston led in placements with 623, Charlotte had 474 and Raleigh 408. At Charlotte replacements exceeded the registrants seeking jobs.

There were 10,311 registrations during the period and 150,835 persons wanting jobs or changes in occupation were listed by the service September 30.

The service said 945,000 unemployment compensation checks for more than 200,000 persons had been paid in the state in nine months, but payments now average from \$15,000 to \$30,000 a day, as compared with a peak some months ago of \$90,000 to \$90,000 daily.

Highway and other construction underway at Greenville, Goldsboro, Dunn, Williamston, Washington and in Hyde county has helped relieve unemployment there, the service said.

Godwin Captured After Being Peppered With Birdshot

Hickory, Oct. (AP)—James Godwin and Bill Wilson, who escaped from the Davidson county jail at Lexington last Monday with the aid of the jailer's daughter, were re-arrested here today.

Godwin, 19-year-old youth facing capital charges of murder and first degree burglary, was slightly wounded by a load of bird shot fired at him as he came running out of a barn with a pistol in his hand, officers said.

Wilson gave himself up voluntarily a few minutes before a large posse of officers converged upon the barn where Godwin was trapped.

Wilson, 21 and Godwin were charged with murder in a warrant issued by High Point police after the fatal shooting of Donald Moss in that city by occupants of a taxi cab shortly after the men had escaped.

After receiving treatment for a dozen number eight shotgun wounds at a hospital here, Godwin was transferred to the Hickory jail.

Desk Sergeant R. W. Gettner of the Hickory police said arrangements were being made to remove him to High Point and to send Wilson back to Lexington.

Wilson approached Earl Yoder, by whom he was once employed, early today and arranged to surrender the desk sergeant said. They walked into the police station about 8:50 and Wilson was immediately locked up.

The name of the officer who opened fire when Godwin ran from the barn was not revealed immediately, Godwin did not shooting, it was said.

S. J. Everett, prominent attorney of Greenville, died this morning at 7 o'clock at his home, 1308 Dickinson avenue, after having been confined to his bed four months with a coronary thrombosis.

Funeral services will be conducted from the home at 3 o'clock Friday afternoon, with Rev. Clarence H. Patrick, pastor of Immanuel Baptist church, in charge. Burial will follow in Greenwood cemetery.

Mr. Everett was born in Hamilton, N. C. March 4, 1878, son of Simon Justus and Bettie Purvis Everett. He was educated in the private school of Hamilton and received his preparatory training for college in a private school in Scotland Neck, taught by the late C. W. Wilson. He entered the University of North Carolina in 1898 and was graduated in 1902 with the A. B. and LL. B. degrees. He received his license to practice law in August, 1902, and located in Williamston, forming a partnership with Judge Francis D. Winston and Everett. In 1907 he was married to Miss Margaret Whitmore Shields of Scotland Neck. To this union were born four children, S. J. Everett, deceased; Margaret Shields, Elizabeth E. and R. O. Everett, II.

While living in Williamston he took an active interest in all local, civic, political and religious affairs.

In 1910 he moved to Greenville and continued to practice his profession. He was interested in both educational and political activities of the county. He represented Pitt county in the State Legislature as senator for two terms. In this capacity he helped secure the large appropriation for the enlargement of East Carolina Teachers College. His interest and love for this institution were only exceeded by his love for the Immanuel Baptist Church, of which he was a charter member.

He is survived by his wife and three children, Mrs. Ralph Howland of Charlotte, Elizabeth and R. O. Everett, of Greenville, and the following brothers and sisters: Miss Hatlie Everett, Miss Margaret Everett, Mrs. Ethel Leggett of Martin county; Mrs. B. D. Harrison of Palmyra, R. O. Everett of Durham; B. B. Everett, J. A. Everett and W. R. Everett of Palmyra.

JAIL IS FILLED IN WILMINGTON

Crack Down on Violators of Compensation Law

Raleigh, Oct. 6.—(AP)—The Wilmington jail was filled today and yesterday by fertilizer plant workers and clock hands who had violated the unemployment compensation law; the Unemployment Compensation Commission announced here.

Fifty-eight warrants were drawn and mostly served on claimants for unemployment benefits who allegedly made false statements as to their earnings, in order to draw benefits, it said. The cases were continued until October 12, but defendants were brought into court and finger printed.

A court order released them pending trial.

LION'S OWNER HELD IN DEATH

Animal Used in 'Wall of Death' Escapes From Cage

Wildwood, N. J., Oct. 6.—(AP)—A boardwalk sideshow operator whose circus lion escaped, killed a man and terrorized this city for nearly three hours before a policeman's bullet killed it, it was released under \$5,000 bail today on a charge of manslaughter.

Joseph Dobish, 31, the lion's owner, was arraigned before Recorder L. Byrne in connection with the death last night of Thomas Saito, 37, of Philadelphia, a Japanese auction room employee, whose mangled body was found under the ocean-front boardwalk.

Police said they had not yet learned how the beast, one of the two owned by Dobish, had escaped. Until five weeks ago the 300-pound killer, known as "Tuffy," was one of two lions strapped to a motorcycle sidecar while the driver roared around a steep-walled bowl called the "wall of death." Since then "Tuffy" has been inactive.

Some time last night, in a manner as yet undetermined, the animal escaped from the cage and roamed the boardwalk.

Saito was about to enter his parked automobile when the lion pounced from the elevated boardwalk upon the man's back and dragged him into the darkest recesses under the walk. There Saito's body was found, clad only a ripped shirt.

WOULD EXCEED MUNICH LINES

Communique Issued by Czech Delegation at League of Nations States Germans Asking Additional Industrial and Communication Areas

Geneva, Oct. 6.—(AP)—The Czech delegation to the League of Nations announced today that the German members of the International Sudetenland Commission at Berlin had drawn up new demands for the cession of territory beyond that contemplated by the accord of Munich.

A communique issued by the delegation said that the Germans were demanding that industrial and communication centers with a total Czech population of 815,000 either be occupied immediately by German troops or made subject to plebiscites.

In Berlin yesterday the International commission, bowing to German demands, decided to hand over to Germany a fifth cede zone, to be occupied by October 10, which took in half as much territory all the first four zones of occupation.

(The Munich accord left delimitation of this fifth zone to the International commission, leaving it to decide what were areas of "predominantly German population.")

The Czech communique said that included in the territory which Germany demands for immediate occupation are cities and towns in which the population is ethnically "purely Czech."

It asserted that the German members of the commission demanded that plebiscites be held in areas in which Germans represent only two-tenths to six and a half per cent of the population.

"To support their thesis," the communique continued, "the Germans are using statistics established before the world war by the Austro-Hungarian Empire." (The commission agreed to accept population figures of October 28, 1918, date of Czechoslovakia's foundation, but many observers said this actually meant reverting to the census of 1910.)

HINTS TO HOUSEWIVES

Deviled ham gives creamed eggs a tangy flavor. Add about a fourth of a cup of ham to two cups of the creamed mixture. The ham also blends well with creamed peas, asparagus, beans or cabbage.

When you use mayonnaise or salad dressing on sandwiches see that it is quite thick, so it will not run over the edges of the bread. Butter both slices of bread to seal it so that the filling or relish won't soak in.

Bubbles sometimes appear on the top of hot jelly when it is poured into glasses. They should be removed as quickly as possible with a small spoon dipped frequently into warm water. Do not move the jelly until it is firm.

When adding nuts to preserves, slice or cut them into pieces of uniform size so they will be distributed evenly through the mixture. Nuts do not need much cooking, so don't add them until about ten minutes before the conserves are to be taken from the fire.

GOP SUPPORTS 4-YEAR TERMS

Larkin Says Party for Extending Sheriff Office Terms

Reflector Bureau.
Raleigh, Oct. 5.—The Constitutional amendment increasing to 4 years the terms of North Carolina sheriffs and coroners will receive the support of Republicans as well as Democrats. James D. Larkin, State Senator, today after returning from a trip which took him into the West.

"This campaign is completely non-partisan," the Jones county legislator stressed, "and we are going to carry the counties in which Republicans predominate or are numerous just as well as the staunch Democratic strongholds." Senator Larkin, who is in charge of headquarters for the amendment here, attended the three Democratic rallies in Gastonia, Statesville and Asheville last week, but he took no active part in the partisan maneuverings. He made contact with leading G. O. P. members as well as with Democrats.

"My impression is that the amendment will carry in practically all the counties I visited on the trip," he said. "It was well received at the three rallies and those leaders with whom I talked told me that they are confident of the result."

Among the prominent Republican leaders who have endorsed the four-year term project is Dr. James W. Davis of the Davis Hospital at Statesville, Senator Larkin said.

In a letter to Senator Larkin, Dr. Davis said: "Every sheriff should have a four-

year term of office. To force sheriffs to go out for re-election every two years is a great mistake. A change to a four-year term would enable them to serve much more efficiently.

NEW BOARD ON REAL HOT SPOT

Davidson County's Election Body Faces Tough Job

Reflector Bureau.
By HENRY AVERILL

Raleigh, Oct. 5—Davidson county's newly appointed election board is on the hottest spot in North Carolina today.

Of course nobody knows exactly what the new board has been told to do—whether it has been directed to make a pro forma or nominal investigation of the Deane-Burgin vote there in the July primary or whether it has really been granted full and free rein to use its own discretion as to the "final" and "legal" returns it will make to the State Board of Elections.

If the former is the case, the new members possibly aren't doing much worrying, all they'll have to do is write out a nice little report saying that the State Board's previous findings of fact were entirely correct. They'll then certify the Davidson vote in totals which will give C. B. Deane of Richmond county the Eighth Congressional nomination by 23 votes.

On the other hand, if they are supposed to make an independent investigation, think of the pressure they'll have to withstand in Davidson county. . . They'll be besieged to "Save the Party" and to "Save the Good Name of our County."

The pressure will come from all sides and from people with real influence in the very highest governmental circles. Davidson's leaders apparently are sincerely convinced that their county's 25 per cent absentee ballot in July doesn't smell to heaven as fraudulent on its face. They're still in their battle for the fellow citizen and losing no opportunity to take a smack at the State Board of Elections, particularly its chairman, Will Lucas.

IT'S ODD
But It's Science

By HOWARD W. BLAKESLEE (AP Science Editor)

New York—An unidentified chemical in citrus fruit is reported to the American College of Surgeons as largely stopping the bad effects of infantile paralysis in monkeys.

The experiments are described by Claus W. Jungblut, M.D. The unknown chemical is something intimately associated with the vitamin C that comes from oranges, grapefruit and lemons. It may be part of the vitamin.

Dr. Jungblut discovered it by giving two kinds of vitamin C to monkeys suffering from infantile paralysis. One was the artificial vitamin C, known as ascorbic acid, manufactured by chemists. The other was the natural vitamin extracted from citrus fruit.

It had not been believed that there was any difference between these two forms of the vitamin. Both kinds kept down the paralysis in the sick monkeys.

But the artificial vitamin only cut down the paralysis by one-half, while the natural product did three times as well. It cut the paralysis to one-sixth of normal. This meant that it took nearly all the deadliness out of the disease.

Dr. Jungblut said the fruit vitamin may have contained something, either not fully removed from the vitamin during extraction, or actually a part of the vitamin, which enhanced the anti-paralysis effect. This sort of difference between artificial and natural products has been found occasionally in other vitamins.

But the chemical job of discovering and isolating the extra "factor" in the natural vitamins has been so difficult that it sometimes required years.

Hartford, 82 percent is paid to government in taxes; in the case of John A. Hartford, 85 percent is paid to government in taxes. As neither of the brothers has any children, any monies left out of their earnings would accrue to their estates, and in the event of their death, inheritance taxes would probably amount to two-thirds of such accrued earnings, leaving approximately 6 cents on the dollar as a motive for continued personal service.

It is therefore apparent that the interests of management need hardly be taken into consideration in arriving at a decision.

2. The Interests of the Employees

The interests of the employees of the company are, however, a matter of very grave concern. It is simply a statement of fact to say that the employees of The Great Atlantic & Pacific Tea Company generally throughout the United States receive the highest wages and have the shortest working hours of any workers in the grocery business, whether chain store or individual grocer. Many of them have devoted all of their working lives to the interests of this company.

The management, therefore, has a definite obligation and duty to defend the interests of these 85,600 employees against legislation intended to throw all of them out of work.

3. The Interests of the Consumer

Since this business has been built by the voluntary patronage of millions of American families, we believe that we must give consideration to their interests in this matter. Millions of women know how acute is the present problem of providing food, clothing and shelter for themselves, their husbands and their children out of their present income. When food prices go up it is not a question of paying more for the same food. They do not have the additional money with which to pay. Therefore, they must buy less and eat less. A & P Food Stores last year distributed at retail \$881,700,000 worth of food at a net profit of 1%.

This food was sold to the public at prices averaging from eight to ten percent lower than the prices of the average individual grocer. Literally, millions of sales were made at prices twenty-five percent lower than those of the average individual grocer. This saving of eight to twenty-five cents on each dollar is of vital importance to these millions of families. If they were denied the opportunity to buy at these lower prices it would simply mean that in millions of homes they would have to leave meat off the table another day a week, eat less fresh fruits and vegetables, give the growing child one bottle of milk less every week or stint on butter, cheese, poultry, eggs and many other of the most nourishing foods.

In the last 10 years during the greatest period of chain store growth, the number of individual dealers has increased rather than decreased. We maintain that there is nothing wrong when these dealers charge more than we charge. They must charge these prices in order to make a fair profit. The average grocer will, upon request, deliver the groceries to the customer's door and in many cases extends credit to some of his customers. Delivery service costs money. The grocer must put this added cost in the prices to his customers. In the same way the extension of credit involves the expense of bookkeeping, the tying up of capital, and credit losses. There is nothing wrong in the higher mark up of the individual grocer, because he is rendering a service that justifies his prices.

If some customers can afford and voluntarily elect to pay a higher price for groceries and meats because they want credit or because they want delivery to their homes it is quite proper that they should pay an additional price for such service. However, the millions of families in this country whose income is limited and who can have more and better food because they are willing to pay cash and carry home their own purchases, should not be denied this opportunity. Millions of families of limited incomes can only enjoy their present standard of living through these economies and savings. These millions of American families have helped us build a great business because they believe we have rendered them a great service. The company, therefore, has an obligation and a duty to protect the interests of these customers.

4. The Interests of the Farmer

Eight million farm families are engaged in producing the food consumed by the American people. All of the farm homes in America, therefore, comprising one-fourth of all of the population of the United States, have a direct interest in the methods of distribution by which the products of their labor and of the soil are marketed.

Approximately 30% of their production is marketed through the chain food stores; about 70% through individual grocers. Their fruits, vegetables and other foodstuffs are sold through the chain stores at prices averaging 8% to 10% cheaper than the prices at which they are sold by many grocers. If the farmer sells a given product to both at the same price, the individual grocer must charge the public more to take care of his higher costs. Thus 30% of the farmer's products reach the public at low prices and 70% of his products reach the public at higher prices.

If the public cannot consume a given crop of apples, potatoes, berries or any other product, at the prices at which they are offered, these goods do not move from the grocer's shelves; a surplus accumulates and the farmer finds that he either cannot sell the balance of his crop or must sell it at a substantial loss. Only too often a situation arises when it is literally cheaper for the farmer to let his apples or his peaches rot on the ground than to expend the labor costs necessary to pack and ship them. Every farm economist knows that a 10% surplus does not mean 10% less return to the farmer but often more than 20% less return.

In other words, the farmer's problem is to sell his products at the cost of production plus a fair profit and to get them to the public with as few intermediate costs and profits as possible. It is therefore obviously unfair to the farmer to propose legislation which would, at a single blow, wipe out 30% of his distributing machinery—and that 30% the part which maintains the price to the farmer yet reaches the public at low cost because of economical distribution. It would be just as unfair to the farmer to propose putting out of business all of the individual grocers of the country who distribute 70% of his produce. Both chain food stores and individual grocers perform a distributive function vital to the interests of the farmer. If either failed to function the farmer would be faced with tremendous surpluses and heartbreaking losses.

For years the A & P has dealt with the farmers both as producers and consumers. We feel that we have a definite obligation and duty to oppose any legislative attack upon their best interests.

5. The Interests of Labor

Every business in this country has a vital interest in the purchasing power of labor. When labor has high wages and great purchasing power, everyone is prosperous. When labor's purchasing power is curtailed, all business suffers and the American standard of living is impaired. For many years it has been the wise policy of the national government to protect real wages and the purchasing power of the worker's dollar. Combinations or agreements to raise prices, thus reducing real wages, have been declared illegal.

It certainly seems strange that it should now be proposed to destroy a group of businesses for the frankly admitted reason that they furnish the necessities of life to the wage earner and his family at low prices. There are approximately 900,000 workers directly employed in the chain store industry. What course is open to us but to oppose the action of a man who, at a time when more than 11,000,000 wage earners are already out of work and 3,000,000 families on relief, proposes a bill that would add almost another million to the roll of unemployed, wipe out 30% of the distributing machinery of all of the farmers of the United States, and raise the cost of living of the wage earners of the United States.

We believe that our organization has rendered a great service to the American people and that it is as a result of that service that we have prospered. If we consulted our own interest it would be very easy to stop and enjoy whatever leisure we have earned. No one is dependent upon us except our fellow workers. However, after the fullest consideration of all interests, we have arrived at the decision that we would be doing less than our full duty if we failed to oppose, by every fair means, legislation proposed by the Honorable Wright Patman.

As we have said, Mr. Patman is an able politician, an able lobbyist and an able propagandist. In that field he is an expert. We are experts only in the grocery business. We believe the chain stores have a right to present their case to the American people. We will not go into politics, nor will we establish a lobby in Washington for the purpose of attempting to influence the vote of any member of the Congress. We expect only a full and fair opportunity to present the case for the chain stores as a great service organization for the American people.

Since the task we have set before us is one involving the widest dissemination of complete information to all of the American people, and since this is a profession in which we are not expert, we have engaged Carl Byoir & Associates, public relations counsel, to do this work. We realize that our views are seldom news. We know, therefore, that we must be prepared to spend a substantial sum of money in telling our story to all of the American people. We declare now that this money will be spent in the dissemination of information through paid advertising and every medium available to us, and in cooperating in the work or formation of study groups among consumers, farmers and workers, which provide open forums for a discussion of all measures affecting the cost of living.

We believe that when the American people have all of the facts they will make their decision known to their representatives in Congress. As Americans we will be content with that decision.

Washington Daybook

Washington—By actual measure-
ment the "war zone" occupies only
about 10 per cent of Washington.
During the past tense days, how-
ever, it has been almost impossible
to remember that the other 90 per
cent of the government has some-
thing to do, too.

For instance, in the very hour
that President Roosevelt appealed
to Hitler to keep his finger off the
trigger, the bureau of public health
came out with an engaging study
designed to prove—as far as lim-
ited tests could—that alcoholics are
not especially subject to suggestion.

It has been believed a long time
that chronic drunks were easy vic-
tims of suggestion. Not so, says the
bureau, at least during their sober
intervals. (Darn it, they didn't
test 'em while they were high).
The bureau tested 100 hospital at-
tendants who were not alcoholics,
and then tested 46 patients com-
mitted for chronic alcoholism. They
all came out the same, no differ-
ence between the groups.

It was the famous "sway" test.
The subject, blindfolded, is told
he is "falling, falling forward, fall-
ing forward, feel the weight shift
from your heels to your toes." But
the alcoholics were as much in-
clined to say "phooey" as the tem-
peralaries.

That Roundup In The Sky
The department of the interior
found airplanes good not for
bombing but for rounding up 500
wild horses on the desert ranges of
southeastern Oregon. The horses,
mostly useless wasters of gattling
range, are canned for dog meat or
shipped to Europeans who find a
good horse steak not so bad.

From the Department of Agri-
culture we learn that Europeans
though tempted to reach for a
cigar, have reached for a cigarette
instead. "Consumption of tobacco
products," solemnly reports the
department, "has continued to ex-
pand in most European countries
in recent months in spite of a gen-
eral decline in business activity.
The increase has been accom-
panied by a shift to cigarettes."

The same department hand-
out reprints an editorial from the
North American Veterinarian sug-
gesting that veterinarians should
be required to take a one year in-
ternship, the way physicians do in
regular hospitals. Imagine a
veterinary intern patting the cheek
of the pretty little blonde horse-
nurse.

Affectionate Fox Foundlings
While talk of death and disaster
were on all hands, the rangers
in Sequoia national park found a

They found them, too, and each
took one of the five youngsters

tended."

TERMINAL FOR ENTIRE STATE

Wilmington Project Declared to be For Benefit of All

Raleigh, Oct. 6.—Wilmington's bid
for PWA funds for construction of
port terminals is not a local but a
statewide project. State Senator-
nominee Emmet H. Bellamy said
today after calling at the office of
Governor Clyde R. Hoey to express
appreciation of the Council of
State's recent endorsement of the
plan.

"North Carolina will never be a
great state until its three prin-
cipal industrial products—textiles,
furniture and tobacco—are exported
through its own port," he said. "We
feel that in seeking adequate fa-
cilities for handling these products
through Wilmington we are work-
ing not solely for the benefit of
our city, but for the state as a
whole."

"It is something of a fulfillment
of Cameron Morrison's dream of a
state port some years ago."

Prospects for the project are
thought excellent by Mr. Bellamy,
who has taken an active part in the
campaign for the PWA grant.

"I am sure that the Council of
State's endorsement has helped us
tremendously," he said. "Talking to
an Atlanta official of the PWA I
was told that the federal authorities
are quite anxious to co-operate in
any project recommended by Gov-
ernor Hoey because they realize
that it was his calling of an extra
legislative session which made pos-
sible any grants to North Caro-
lina."

Under the proposal as submitted,
the federal government would put
up all the money actually used in
construction of the terminals—45
per cent as an outright PWA grant
and the rest as purchase price of
the bonds which would be issued
by Wilmington and New Hanover
county to cover the local govern-
ment's 55 per cent of the cost.

SHORT SHOTS

Raleigh, Oct. 6.—If you want to
find someone in a state office who
is always busy doing something,
just drop in the Governor's ante-
room and cast your eyes in the di-
rection of Miss Mamie Turner, who
has worked there for years.

Your correspondent spied her
typing on some long, partly printed
sheets the other day and dropped
over casually to see what it was
all about.
She was filling in the blanks on
certificates to special judges to hold
terms of court for regular judges
who will be unable, for one reason
or another, to be on hand for their
regular terms.

Some of them were for courts as
far off, in point of time, as June
of next year.
Miss Mamie explained she didn't
have anything pressing to do, and
therefore followed a custom of hers
in taking time by the forelock and
disposing of future business.

Major Sidney Ridge, an unsuccess-
ful aspirant for the Sixth Dis-
trict Congressional nomination last
summer, is being boosted for ap-
pointment as Wage-Hour adminis-
trator for the area composed of
North Carolina, West Virginia, Mary-
land and the District of Columbia.
Senator Robert R. Reynolds is
backing the Greensboro man for
the post, but few believe that the
vacancy will go to any North Car-
olinian.

The Major is one of the state's
really colorful figures. He finished
third in the first Congressional
primary in the Sixth, but he man-
aged to put most of the life there
by his strident support for Pres-
ident Roosevelt.

There are plenty of people in
Raleigh who will tell you that the
protracted Deane-Burgin Congres-
sional contest could have and would
have been avoided but for efforts
to "save the name of the Demo-
cratic party."

These folks insist that the State
Board of Elections should have
gone into Davidson county as soon
as the controversy arose. There
they should have taken up seri-
ous and in full detail every charge
of fraud and irregularity.

This, it is contended, would
have resulted not in the tossing out
of just enough votes to give Deane
the nomination by 23, but in the
ash-canning of a minimum of 1,000
of the absentee ballots cast in Dav-
idson.

The wisecracks say the Burgin
backers would have been more cau-
tious in seeking court action if the
State Board's action had shown
Deane with a majority of nearly
1,000 rather than a scant 23.

They back their contentions by
pointing out that the 24 per cent
Davidson absentee vote is practi-
cally conclusive proof of rotten
conditions. No county had, last July
or any other time, a quarter of its
electorate either absent from the
county or so sick as to be unable
to get to the polls.

They strengthen this argument
with the point that one notary pub-
lic certified she took the oath of
nearly 400 absentee voters in one
day. Here again the very physical
facts speak loudly of fraud, they
say.

What with the World Series in
progress and football fans busy-
ing themselves with predicting the re-
sults of Saturday's North Carolina
Tulane there isn't any great amount
of work being done in Raleigh of-
fices this week.

No Signs Of Compromise In Deane-Burgin Dispute

Raleigh, Oct. 6.—Peace in Europe
hasn't meant peace in the Eighth
Congressional District, where the
embattled forces of C. B. Deane and
W. O. Burgin become daily more
and more embittered and uncompromis-
ing.

The campaign has developed, how-
ever, to the point where it seems
more a bitter tussle between Burgin
and the State Board of Elections
than one in which the Rich-
monder Deane has any part. In all
the mud that's being slung, the
State Board seems to be the target
of Burgin partisans while the Dav-
idson county board of elections and
Davidson's minor politicians are
bearing the brunt of the verbal
thunder of those who defend the
State Board.

Meanwhile the affair is back in
the courts with a vengeance, the
point at issue this time being ap-
parently whether or not the State
Board acted arbitrarily in first re-
fusing to accept "final" returns at-
tempted to be submitted by the old
Davidson board and in substituting
a new board of its own choosing.

It is on this issue that Burgin
counsel is seeking a peremptory writ
of mandamus forcing the State
Board to certify the Davidson man
as the nominee.

There's nothing concrete or de-
finite on which to base such an op-
inion, but there is a distinct feel-
ing in the air that the State Board's
legal staff is convinced Judge W. C.
Harris will find against them on
any hearing; and that they will
reserve their heaviest artillery for
another journey to the Superior
Court, where they won't everything
theoretical, but nothing practical,
on the previous appeal.

There is still much talk of a mu-
tual withdrawal of both candi-
dates and substitution of incumbent
Walter Lambeth on the ticket, but
no sign that it's anything but talk.
