LAWYERS HOLD ACCUSED SPIES WERE FRAMED

Prosecutor Says U. S. Innermost Secrets Penetrated

ALL DEFENDANTS GERMAN-BORN

Members of Spy Ring Alleged Have Forged President's Name to Navy Order

New York, Oct. 17.—(AP)—Attorneys for three alleged German spies described their clients as "framed" and "innocent" today after United States Attorney Lamar Hardy told a Federal court jury they had penetrated into some of the innermost secrets of this country's military defense.

The prosecutor occupied an hour and 20 minutes in outlining the government's case against Johanna Hoffman, 26, former beautician in the German liner Europa, and Otto Hermann Voss, 36; Eric Glaser, 28, both naturalized citizens born in Germany. Glaser is a former United States army soldier.

Hardy said that German spies had transmitted to the Berlin government data on the American artillery forces in the Panama Canal Zone, the strength of the American navy on the east coast, and the specifications of two American aircraft carriers.

Members of this spy ring, he asserted, were the three prisoners. Hardy told the jury that the spy ring had forged President Roosevelt's signature to a fictitious order to the navy for the aircraft carrier's specifications.

A fourth prisoner Guenther Gustave Rummich, pleaded guilty at the opening of the trial Friday and will testify as a government witness.

Hardy described the alleged conspiracy as directed from Germany with contact men transferring messages back and forth to agents of German extraction in this country.

He said two officials of German steamship lines in the United States aided in establishing the contact between agents in this country and their directors abroad.

Little Change In Tobacco Averages

Average prices quoted this week remained about the same as last week for Type 12 fine-leaf tobacco on the Eastern North Carolina markets, according to the United States and North Carolina Departments of Agriculture.

Offerings were composed mainly of low to good leaf and fair to fine leaf. Offerings also contained a fairly good volume of smoking leaf and cutters. Only small quantities of primings were offered. Volume of sales decreased from previous week.

Markets selling the bulk of tobacco in the Type 12 area, reported a general average for the week of \$26.26 per hundred pounds. For the season to date, sales averaged \$23.32 per hundred pounds.

Hospital Is Kept On Approved List

Official announcement has been received here that the Pitt General hospital of Greenville again has been placed on the approved list of the American College of Surgeons.

The local hospital has a capacity of 60 patients. Several requirements are necessary to be placed on the accredited list.

Full or provisional approval, which is accorded by the College to hospitals which meet specific minimum standards, has been granted this year to 2,664 hospitals in the United States, Canada and other countries.

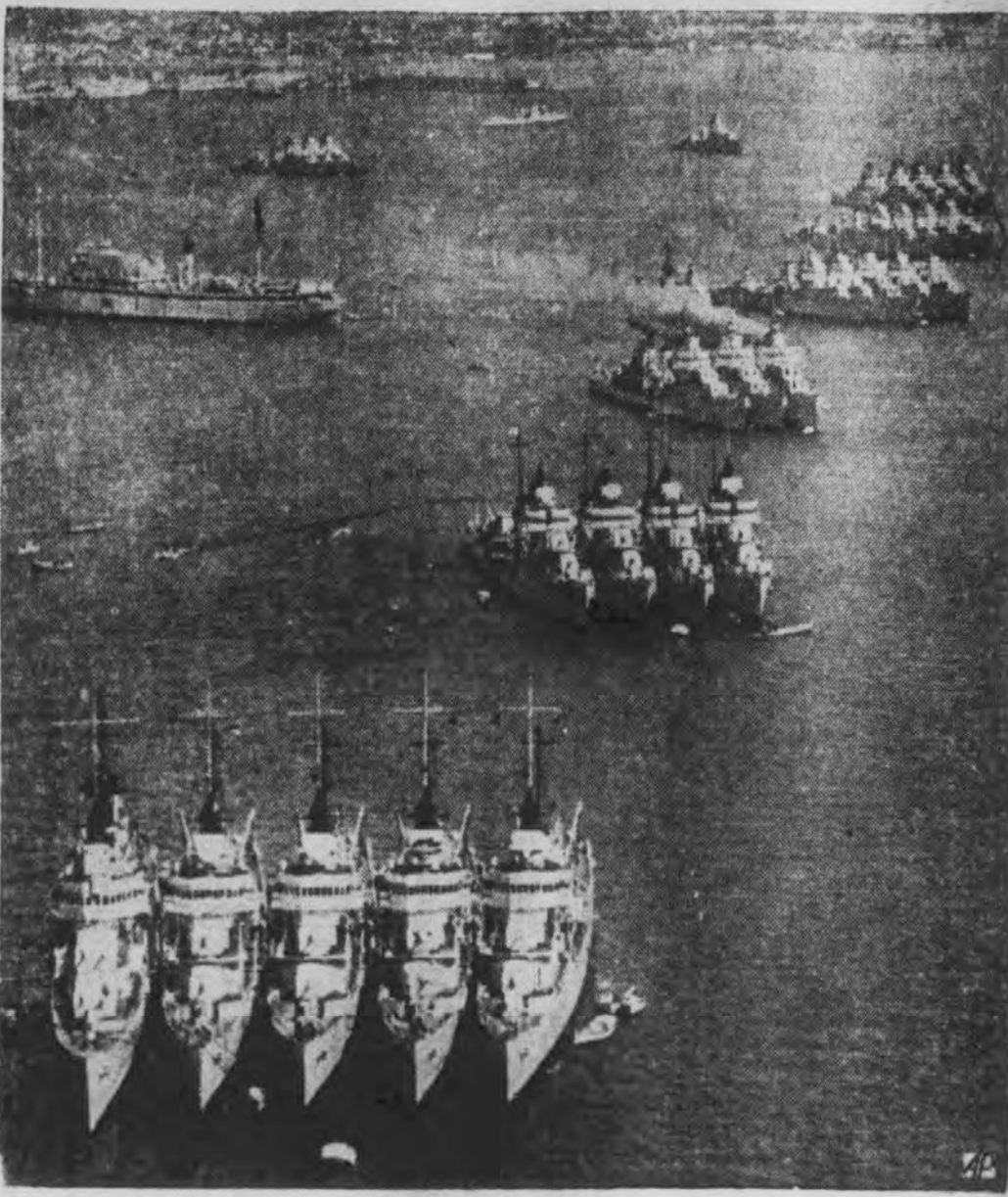
Local Woman's Uncle Is Claimed By Death

BUSY SESSION OF CITY COURT

Twenty-Four Defendants Tried During Morning Here

Twenty-four defendants faced Recorder L. C. Skinner in Municipal court this morning and the Monday session was completed by noon hour.

Mrs. Minnie Wittenberger, convicted of drunkenness, was given a 30-day sentence, suspended upon condition the defendant pay the costs of court and leave town within three days and stay out of the city for nine months.

Hubert Dupree, alias Monk Dupree, was given a 60-day sentence upon conviction of assault with a deadly weapon.

Theodore Anderson, convicted of drunkenness, was given a 30-day sentence, suspended upon payment of costs.

Richard Teel was given a 30-day sentence, suspended upon payment of costs, on a charge of being drunk.

John Smith, Theodore Harris, white, and James Edwards, Negro also were convicted or entered pleas of guilty to drunkenness and each defendant was given a 30-day road sentence, suspended upon payment of costs.

Bill Harris, charged with drunkenness, forfeited a \$14 bond when he failed to appear to answer the charge.

A. J. Jones and Paul Hill, Jr. were bound over to Superior court on charges of breaking, entering and larceny, and C. R. Fleming and J. Sam Fleming were ordered for trial in Superior court on charges of receiving stolen property.

It was originally stated that Wilton Fleming was charged with purchasing copper pipe stolen by the two boys, but it was later revealed that he was not involved and the charges were brought against J. Sam and C. R. Fleming.

TALK SALE OF N. C. RAILROAD

Governor Hoey Confers With Officials Of Southern

Raleigh, Oct. 17.—(AP)—Governor Hoey held preliminary conferences with officials of the Southern Railway System today on plans for possible operation by the Southern of the State-controlled Atlantic and North Carolina Railroad.

The Governor said no definite suggestion as to what the Southern might be able to do was made and added he now plans to confer with representatives of two different groups who have made proposals to lease the line.

Vice-President John Hyde of the Southern, along with R. H. Debutts, Jr., general traffic manager, and F. S. Collins, chairman of a committee which made a thorough survey of the A. and N. C., from Goldsboro to Morehead City, talked with the Governor.

It was made clear, Hoey said, that operation costs must go up if the Southern takes over the line and the A. and N. C. would lose at once \$15,000 a year it now gets in mail revenues as this would receive less as a part of the Southern than it does as an independent line.

The big question which has not been answered, Hoey said, was where would increased revenue come from to match the increased cost if the Southern agreed to operate the line.

Berlin, Oct. 17.—(AP)—Baron Gottfried von Cram, German tennis ace, is free on parole after serving seven months of a one-year sentence on a moral charge.

September Sales In Pitt County Total \$44,429

Raleigh, Oct. 7.—(AP)—Liquor sales in county-operated stores in the 27 wet units during September totaled \$604,178.10 an increase of \$4,493.75 over September, 1937.

Chairman Cutler Moore of the State ABC Board released the report today showing that Durham county led in sales with \$89,235.15. Last month sales also included Beaufort county, \$19,015.20; Edgecombe, \$33,820.10; Nash, \$22,100.55; Pitt, \$44,429; Vance, \$18,276.20; Wilson, \$32,033.05; Lenoir, \$31,533; Warren, \$9,103.80; Franklin, \$11,021.45; Greene, \$5,311.40; Johnston, \$26,864.

Two Negro Women Injured In Wreck

Two Negro women were seriously injured in a collision of two automobiles yesterday afternoon about 2 o'clock on the Bethel highway at the intersection of the Pactolus road.

Mattie Hampton of Ohio and Aurelia Blanchard of Bethel, RFD, were the two injured, the former suffering a back injury and the latter a broken collar bone. They were riding in a car driven by Joseph Highsmith which, according to Patrolman C. R. Williams, drove into the highway from a rural dirt road and struck an automobile being operated by Thomas G. Basnight, Jr., of Stokes.

Patrolman Williams said no charges had been made, pending the outcome of injuries suffered by the two women.

Riding with Basnight were his wife and two other persons, none of which received serious injuries. The Basnight car was traveling south.

RESTRICT ACTIVITY OF VIENNA BISHOP

Vienna, Oct. 17.—(AP)—Dr. Sigismund Waltz, Catholic archbishop of Salzburg, today was relieved by official order of supervision over religious education in the Salzburg district elementary schools.

This was the latest Nazi move against the Catholic clergy and followed the breakdown of church-state peace negotiations announced in a Vienna speech last Thursday by Joseph Buerckel, Nazi commissioner for Austria.

Hitherto Archbishop Waltz has enjoyed the special privilege of visiting obligatory religious classes in the lower schools and making suggestions as to instructions.

Henceforth such supervision, according to the order issued by the Salzburg district school council, will be carried out solely by state and school officials.

HUNGARY ASKS NEW PROPOSAL IN CZECH ROW

Interrupted Negotiations Expected To Be Resumed

HOPES HEIGHTEN FOR SETTLEMENT

Men and Equipment, However, Being Sent to Czechoslovakian Frontier

Budapest, Oct. 17.—(AP)—Baron Bothmer of the foreign office declared today that Czechoslovakia must make a new proposal before Hungary takes further action in her demands for Hungarian populated regions of Czechoslovakia.

Such an offer to lay a basis for renewing the interrupted Komarom conversation is expected shortly, the Baron said, but he added any new plan would be made more difficult to accept because of increased Czechoslovakia atrocities in Hungarian minority regions.

Hungary, despite a general feeling that chances for a peaceful settlement have brightened considerably, still moved men and equipment to the Czechoslovak frontier. The cabinet meanwhile met to consider suggestions of Reichsfuehrer Hitler and Premier Mussolini of Italy for settling the dispute.

The choice of methods was believed to lie between these two: either the Hitler-Mussolini plan to make Prague accept a new, more acceptable Hungarian plan with the approval of other western powers as a basis for resuming negotiations, or a four power conference for the same members to be called by Hitler or Mussolini.

The first plan was regarded here as the more likely to be adopted.

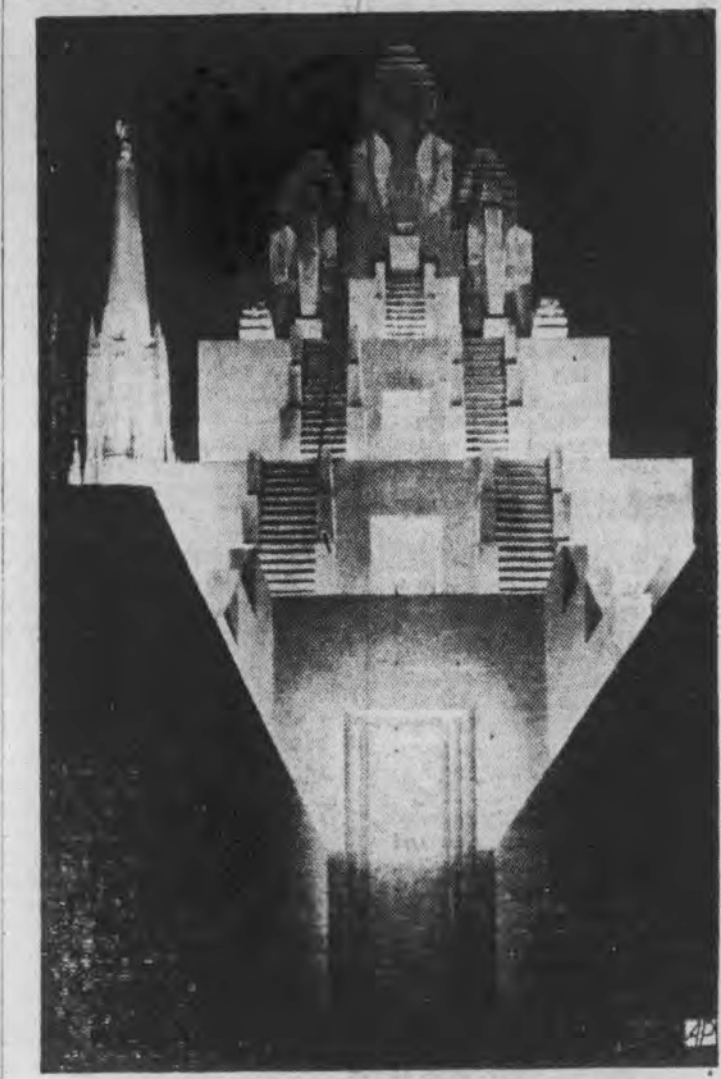
Deputy Fire Marshal Charles Schwartz says the system was perfected to help authorities trace arsonists.

Vital Chinese Railway Cut By Invading Japs

Nippon Forces Sweep On With Amazing Rapidity

Hongkong, Oct. 17.—(AP)—Japan's invasion of south China swept on today with what military observers considered amazing rapidity.

The vital Canton-Kowloon railway was cut at two points. One column landed on the Pearl river delta and raced overland to sever the line 15 miles north of Hongkong. Another drove westward and cut it midway between Canton and Hongkong.

Other forces crossed the East river after the capture of Waihow and fought their way up the Waihow-Canton highway to within 50 miles of Canton.

Indications that the Japanese intended to drive straight on to the South China metropolis was seen in the fact that Japanese warplanes heavily bombed Teungsing, Chinese troop concentration point 45 miles east of Canton.

Canton was placed under martial law.

Henry J. Paradan Passes At Wilson

Wilson, Oct. 17.—Henry Jules Paradan, 56, moving picture theatre owner in business here for 31 years, died Sunday morning at his home.

Mr. Paradan was born in Moussee, France. At the age of three, he was brought to America. His family lived in New Jersey and Philadelphia until he was 17. He then moved to Norfolk, where he entered the theatre business.

Following business reverses in Norfolk, he came to Wilson and went into business with R. W. McFarland. At one time he operated a chain of 11 theatres in the State. At the time of his death he was operating theatres in Tarboro and Wilson.

Surviving are his widow, his father, Joseph Paradan, and a half-brother, Joe Paradan of Kingston.

Funeral services will be held from the home this afternoon at 3 o'clock, conducted by Rev. E. J. Hobbs, Methodist, and Rev. E. C. Lynch, Presbyterian. Burial will be in Maplewood cemetery.

Mr. Paradan operated all of Greenville's picture theatres from July, 1924 to July, 1929. He sold his interests here to the company which now operates theatres here and at scores of other cities in the state.

CZECHS ADOPT NEW ATTITUDE TOWARD NAZIS

Little Republic Turns Now To Course of Cooperation

NATION ASSURED BY ADOLF HITLER

German Newspapermen Returning to Prague Ordered To Write Kindly

Prague, Oct. 17.—(AP)—Czechoslovakia appeared today to have switched her gigantic reconstruction task to a new course—cooperation with Germany.

Chancellor Adolf Hitler, it was learned, has assured her that the country now is on a sounder basis and that it can retain its culture and achieve greater prosperity by co-operation within the German orbit.

Czechoslovaks, if not convinced by the rosy German picture, are, according to all indications, resigned to the necessity of looking to Germany for support.

The past few days have seen a striking change in German-Czechoslovak relations, constricting sharply with the strained situation when Europe seemed on the verge of war over the Sudeten problem.

While the controlled German press now speaks of help for Czechoslovakia, the controlled Czechoslovakia press speaks of co-operation with Germany.

German correspondents returning to Prague have been ordered to write only "kindly" of Czechoslovakia and have ceased their attacks on the little republic.

UNC-DAVIDSON TILT SATURDAY

Tar Heels Start Preparations For Next Contest

Chapel Hill, Oct. 17.—North Carolina's football squad today began to prepare for the third defense this season of its State and Southern Conference titles—the Davidson game at Davidson next Saturday—following its 7-0 victory over N. Y. U. last week.

The contest, 36th between the two institutions since the rivalry was inaugurated 40 years ago, headlines Davidson's annual Homecoming program. History shows that the Tar Heels have won a big majority of the games although most of the contests have been decided by one and two touchdown margins.

Carolina successfully got past the first defenses of its two titles. Wake Forest was defeated 14 to 6 in a hard-fought engagement. N. C. State was beaten 20 to 0 in another closely contested affair. The game was much closer than the score indicated.

Davidson's 1938 football edition, comparatively light but possessing a great deal of scrap and determination, has played good ball this season despite losing three of four contests. The Wildcats routed Esplanade 33 to 0. Losses have come at the hands of N. C. State, Duke, and South Carolina.

The Presbyterians will present one of the best passing teams in the Southern Conference. In four games they have completed nearly 50 per cent of their passes. The figures show 25 hits in 52 attempts for a total gain of 324 yards. The net rushing total for the four games shows 559 yards.

In Bill Davis, triple-threat half-back, Davidson will offer one of the South's best passers. Davis, head man in the Cats air circus, has tossed two direct touchdown passes and his pitchers have been indirectly responsible for four other scores.

On the receiving end of Davis' passes are such noted catchers as Fred Stair, halfbacks; Ned Iverson and Bobby Benfield, ends. Stair caught both touchdown passes in the N. C. State and Esplanade games.

TO DISTRIBUTE FOREST TREES

Seedlings Raised in Johnston Nursery Available

Raleigh, Oct. 17.—Approximately 4,500,000 baby forest trees have been raised in the forest nursery near Clayton, in Johnston county, this year and will be ready for distribution this winter, according to P. H. Claridge, assistant forester in charge of forest management for the Forestry Division of the Department of Conservation and Development.

In addition to the seedling from the Clayton nursery, approximately 100,000 seedlings will be available from the Crab Creek Nursery, between Hendersonville and Brevard. These seedlings consist for the most part of black locust and yellow poplar.

Of the 4,500,000 seedlings that will be available from the Clayton nursery, 2,000,000 are loblolly pine, 1,000,000 longleaf pine, 500,000 shortleaf pine while the balance consist of yellow poplar, black locust, white ash, black walnut and a few cypress.

Last year this nursery produced only about 2,500,000 baby trees with the result that it could not begin to meet the demand for seedlings. As a result, approximately 5,000,000 plantings were made this spring of which at least 4,500,000 trees survived. Work has been under way all summer and fall preparing additional seed beds and nursery space so that the capacity can be still further enlarged next spring. The new mountain nursery is also being enlarged as rapidly as possible with the assistance of side camp from the Civilian Conservation Corps camp in Brevard.

Reflector Bureau. By HENRY AVERILL. Raleigh, Oct. 17.—C. B. Deane, Richmond county contender for the Eighth Congressional nomination, is exceedingly unlikely to accept the proffer of his rival, W. O. Burgin, that the two get together and work out some plan for settling the dispute.

Mr. Deane, most observers agree, is even more unlikely to approve any part of Burgin's suggestion that the matter be left to a sort of arbitration committee, composed of an equal number of members appointed by the rivals, with the deciding vote in the hands of a member to be named by Governor Clyde R. Hoey. The immediate Deane reaction, a polite telegram to Burgin pointing out that the matter is in the hands of the courts in an action to which Deane isn't even a party—and the suggestion that the Davidson man do all he can to "expedite" court decision, seem to have been cannily reached.

For it is an obvious fact that it has been the dilatory tactics and frequent change of front of the Burgin forces which have kept the

SALES TAX UP ON TWO SIDES

Blistering Attack By Paul Leonard Loosed at State

Reflector Bureau. By HENRY AVERILL.

Raleigh, Oct. 17.—The sales tax issue, quieter of late than a Czech cheering for Hitler, flared on two fronts here in the last day or two as Paul Leonard, driving force of the Fair Tax Association, loosed a blistering attack on what he termed "racketeering" methods used by Department of Revenue auditors, and the board of directors of the North Carolina Food Dealers Association met to launch a vigorous drive for exemption from the levy of all foods and fuels for home consumption. "Letters which come to my desk every week and conversations I have with merchants almost daily convince me that the State of North Carolina, through its representatives sent out by the Revenue Department in the conduct of a get-what-you-can-out-of-merchants racket are engaging in methods and practices to extract taxes from honest citizens which constitute a disgrace equally shameful as the election frauds which are now being so widely paraded before the public," said the Statesville man who has for five years conducted a continuous, bitter campaign against the levy enacted as an "emergency" measure, but now generally regarded as a settled state policy.

He minced no words in speaking of practices he charges auditors with following: "The general public has slight knowledge of the deplorable tactics being used in auditing merchants' accounts, and the settlement of levies for sales taxes simply because so many merchants are cowards when it comes to fighting for their rights in a manner which might get publicity or create court records," he continued. "But now we are taking a case to court to test the constitutionality of the sales tax laws, many merchants who have been victims of the State's holdup game are mustering enough courage to speak out against the outrages being perpetrated upon them," he added. Interest in the Fair Tax Association has been greatly increased by its court action, Leonard said. The organization added more new members during September than in any month since it was organized, he cited as proof of this assertion. "I am also getting more invitations to address civic organizations than ever before," he said, "because the mounting tax load is causing general concern." He expressed grave concern for the future of North Carolina and the nation, declaring his belief that "unless the taxpayers band together and put a check on the tax spenders we may soon find ourselves victims of a form of slavery to our government."

"Retailers of the state," he said, "have already been forced as a special class into involuntary servitude as tax collectors, but due to the rebellion of the people against payment of the sales tax, literally thousands of rural merchants and those located along our state borders are having to pay the sales tax themselves."

Action of the Food Dealers was less spectacular, but perhaps more effective. With 14 or 17 directors present, they agreed to push vigorously their efforts to exempt from the sales tax all foods and all fuels used for home consumption. Their active drive will be headed by O. A. Swearingen, of Concord, chairman of the legislative committee. R. B. Roebuck, Wilmington, president of the association, presided at the directors meeting. J. B. Volger, executive secretary and a Mecklenburg member of the General Assembly, was also present.

IT'S ODD, But It's Science

TREE 'DENTISTRY' HELPS IN HURRICANE

By HOWARD W. BLAKESLEE. New York—George Van Yahres, tree surgeon says the New England hurricane proved the value of "dental fillings" for trees. These fillings are a combination of wax with a rubber cap placed in cavities formed by rot or injury. They are slightly flexible. Van Yahres says examination of 6,000 of these dental trees showed only two broken by the storm. Flexibility of the filling, he ex-

plains, allowed the tree to sway. Hard, rigid fillings caused some trees to splinter. The rubber-wax fillings follow dental practices. The cavity is first cleaned of debris. Next it is flushed with an antiseptic, which is intended both to kill germs and molds, and also to waterproof the sides of the hole. After that a crown of rubber is made to fit the top of the cavity. Steel supports fasten it over the hole in the tree. The rubber crown has a valve through which hot wax is run into the cavity. The wax is forced in under steam pressure to make a completely tight filling. SHORT SHOTS

Raleigh, Oct. 17.—Kerr Scott's opponents—and there are not a few of North Carolina's politicians who aren't particularly fond of the outspoken, hard-hitting Alamance Commissioner of Agriculture—will certainly have one less count in their bill of indictment against him when it comes time for the 1939 session of the General Assembly.

They will not be able to view with alarm his proposal that the State operate its own State Fair. Success of the two has staged since his accession to office will quite effectively silence any artillery of that sort.

When the 1937 Fair cleared some \$7,500 in cold, hard cash, in addition to putting about that much into permanent improvements, there was mild praise for the Commissioner.

When this year's figures show an even greater profit, as there is every reason to believe they will, the applause should be louder.

But while passing out bouquets to Commissioner Scott, there are at least two others who deserve citations for faithful and efficient performance of duty.

First there is Dr. J. S. Dorton, real field marshal and director of all the many details of the Fair. He perhaps more than Scott himself has made the thing go—but then, it must be remembered, Scott picked him.

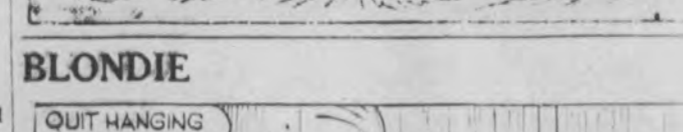

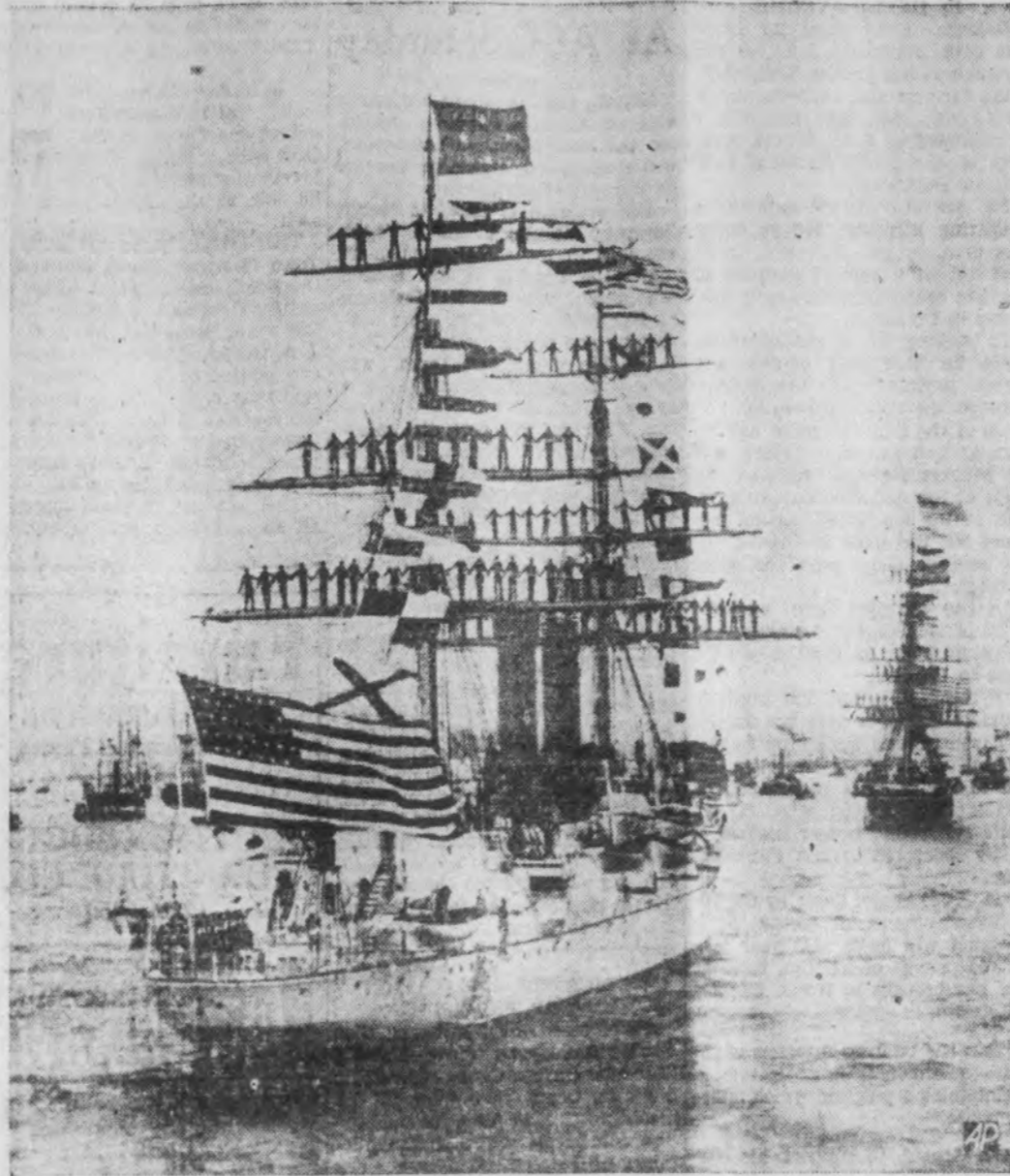

Says Crop Control Worth \$100,000,000 To Farmers

Reflector Bureau. By HENRY AVERILL

Raleigh, Oct. 17.-Crop control has been worth one hundred million dollars this year to North Carolina's farmers and, consequently, to its business men and industries, it is estimated by E. F. Arnold, secretary of the North Carolina Farm Bureau Federation.

Mr. Arnold made the estimates in preparing literature for an intensive drive by the Bureau to insure approval of a control program by farmers when control voting time comes in December.

In making his \$100,000,000 estimate he took into consideration direct payments to the farmers through the Soil Conservation program of the Department of Agriculture as well as the increased price he believes farmers received for their cotton and tobacco as the result of the marketing control program for the flue-cured weed and the acreage quota plan for cotton growers.

Of the principal item, increased value of tobacco, Mr. Arnold says in literature being distributed over the state to farmers:

"I think it is not too much to estimate that if it were not for this law (control and marketing quotas) tobacco would today be selling for ten to twelve cents per pound. If this is true, tobacco is selling ten cents per pound higher because of a law sponsored by the Farm Bureau.

"If the estimates made by the Department of Agriculture that North Carolina will make this year 539,800,000 pounds of tobacco, then the law has brought to North Carolina \$53,980,000.

"Can the business interests of the state afford not to co-operate in maintaining a program which means so much?"

Mr. Arnold, to support his contention that the control law has held up the price of tobacco this year, cited the fact that in no year since 1928 when the market was unaffected by control has the weed's price average been as much as 20 cents, while in every year in which control was a factor throughout the year the average was above the 20-cent level.

He admitted he is likely to run into argument on his figures for 1933 and for 1937, but gave a ready explanation of these two years.

The '33 average was only 16.1 cents, he said, but that was because the markets opened with no control of any shape, form or fashion and it was not until there was an agreement on marketing quotas that the prices began to go up above 10 to 12 cents. This was the year the sales were actually stopped and warehouses closed because of low prices paid until some form of control was a certainty.

Anti-controllers will argue, he said, that there was no program in 1937, but the answer is, he maintains, that when the crop was marketed late in the year there was practically absolute certainty that there would no control of the 1938 crop. This, he maintains, is what held up last year's prices.

He estimated that the cotton growers of North Carolina received benefits of \$31,820,000 this year through the program sponsored and backed by the Bureau - \$7,340,000 from soil conservation payments, \$3,180,000 from the "adjustment" fund of \$130,000,000 voted last year by Congress, \$6,120,000 in payments to be made next spring from the \$121,000,000 parity fund voted this year, and \$4,180,000 from an increase in cotton prices due to the control law.

He further estimated that the peanut growers of the state benefited this year to the extent of \$421,850 from the control program.
