Military Control Placed Over Public Services As Daladier Invokes Powers

TROOPS GUARD VITAL CENTERS

French Premier Applies Decree Power in Effort to Break Scheduled General Strike; Army Detachments Sent To Paris to Swell 25,000 Soldiers in Capital

Paris, Nov. 29.—(AP)—Premier Daladier, warning that "the fate of the regime in the nation may be at stake," marched troops to vital centers today and placed all public services under military control in an effort to break the scheduled general strike.

Posters announcing decrees which transfer public service workers from civil to military control were put up this morning all over the capital.

Army detachments rode into Paris by truck and rail to swell the ranks of 25,000 soldiers already garrisoned in the capital districts, while thousands of mobile guards were massed in labor centers ready for duty.

The 24-hour strike, called by the powerful General Confederation of Labor, was scheduled to start at 4 a. m. tomorrow.

In a report to President Lebrun, Daladier said "harmful propaganda of which the government knows was the hidden goal and the inspiration is attending by rising against the laws of the republic to create in the country a state of agitation which threatens not only to compromise public order, but to influence the external situation of France in a most dangerous way.

Four Freed Under Nolle Pros Route

Solicitor Charles Whedbee, in County court this morning, took a nolle pro in each of four cases charging the defendants with having liquor for sale.

The defendants were John Moore, Annie Lee Fields, James Cook and Robert Arnold.

Harvey Cole, convicted of assault, was given a 30-day sentence, suspended upon condition the defendant not molest the prosecuting attorneys and pay the costs of court. The defendant appealed to Superior court.

Ellen Rogers Newton, Negro, was acquitted of abduction.

W. F. Whitehead was convicted of driving while under the influence of whiskey and was ordered to pay a \$50 fine, court costs and had his license revoked for 12 months. Notice of appeal was given and bond was set at \$100.

Clifton Riddick and Louis Wilson were convicted of larceny and Anthony Coward, all Negroes, pleaded guilty to the charge and each was given a 90-day road sentence.

WILL DISCUSS CITY PLANNING

Citizens Invited Hear Expert Here Thursday Night

Mayor M. K. Blount today issued a general invitation to all persons interested in the future of Greenville to attend the regular meeting of the Board of Aldermen Thursday night, at which time High Pomeroy, field consultant of the American Society of Planning Officials, Chicago, will discuss the possibilities of city planning.

Mayor Blount declared that in his opinion city planning for the future was one of the most important things a city can do.

"Any town which does not look to the future and make plans accordingly cannot hope for much progress," declared the mayor. He added that many city charters had provisions for a planning commission.

"It is the desire of the board to have present for its meeting Thursday night as many citizens as possible in order that they may hear Mr. Pomeroy and get an idea of the importance of a planning program," the Mayor said in announcing the invitation.

The speaker will come to Greenville at no cost to the city. The North Carolina League of Municipalities sponsoring the movement to encourage cities to make plans for future years.

Mr. Pomeroy has the enthusiastic endorsement of Patrick Healey, Jr., executive secretary of the North Carolina Municipal League. Mayor Blount is first vice president of the organization.

LUXURY PLANE FORCED DOWN IN ROUGH SEA

Airliner Is Smashed To Pieces Against Rocky Beach

FATE OF SEVEN STILL UNKNOWN

Two Figures Sighted on Beach Leads To Belief at Least Two Escaped Death

San Francisco, Nov. 29.—(AP)—A luxury airliner was smashed to pieces on a rocky ocean beach near here today after it had fought an 84-mile-an-hour wind en route from Seattle to Oakland and finally was forced down on the rough sea when its fuel tank ran dry.

The fate of the seven persons aboard the United Air Lines 14-passenger sky-lounge was unknown several hours later. Huge waves had carried the craft rapidly to the rocky shore.

Two figures were later sighted on the beach by Coast Guardsmen and people at the Point Reyes lighthouse, who believed at least two aboard the plane escaped death.

Carnegie Tech has accepted the invitation, Benson announced, and T. C. U. will accept upon receiving the approval of the Southwest Conference which he said was expected today.

Results Of Elections Officially Declared

Raleigh, Nov. 29.—(AP)—The State Election Board today declared official the result of the November 8 election and directed the Polk County Board to determine how many votes were cast in Salduda precinct in a close race for county commissioner.

The declaration that the Democrats won all contests except three, which were presented the State Board for certification were perfunctory, as the figures were released last week.

Uniforms Arrive For Schoolboy Patrolmen

Only part of the uniforms ordered for the School Boy Safety Patrol have arrived, but a number of the members went on active duty this morning.

The City Board of Aldermen appropriated money enough to buy 30 uniforms, but only enough have arrived to equip 19 patrolmen and that number took up their duties this morning at various white schools in the city.

Marketing Quota Fixed For Burley

Washington, Nov. 29.—(AP)—Secretary of Agriculture Wallace set this year's marketing quota of 356,700,000 pounds. This year's dark tobacco quota was 147,835,000 pounds.

If approved at the referendum national quotas will be divided among growers on the basis of a formula set up in the crop law. Growers selling in excess of their individual quotas would be subjected to penalties of half the market value of surplus sales.

A 1939 quota of 754,000,000 pounds already had been established for blue-cured tobacco. Growers will vote on it December 10.

ALL PROTESTS TO BE IGNORED

United States, Britain and France Expected to Offer Objections; China, Meanwhile, Reports Successes in Fighting With Recapture Of Several Towns

Shanghai, Nov. 29.—(AP)—Japan's armed forces tonight served notice on the world that the great Yangtze river, China's main trade artery, would remain closed to all but Japanese shipping until China is conquered and reconstructed under Japanese control.

A communique indicated the protests of foreign powers, chiefly the United States, Britain and France, against the closing of the river to their commerce would be unavailing.

Chinese reported today they had recaptured the towns of Loshan and Kwangshan, 120 miles north of Hankow, forcing the Japanese to reorganize their force before pushing farther into the interior.

They also said that these attacks had forced the Japanese to give up a large area in the Anwei provinces.

In addition the Chinese reported they had recaptured Yentsing, 30 miles north of Kaifeng, which the invaders had held for six months.

In Hongkong 11 Chinese were killed on the British side of the crown colony's border with south China while fleeing Japanese troops.

It was reported a protest was made to Tokyo against an incident Saturday when Japanese forces were said to have occupied a frontier military post. They withdrew after a British officer produced a war office map identifying the war area.

The 34 Americans at Kuling, where they have remained since summer despite the war, are safe and have sufficient food, a British naval officer reported after going there to check.

More than 20 foreigners in all are in Kuling, 120 miles southeast of Hankow, where they were frequently endangered by fighting during the Hankow campaign.

Wife of President To Come to State

Chapel Hill, Nov. 29.—(AP) Mrs. Eleanor Roosevelt, it was announced today, will accompany the President when he comes here next Monday afternoon to speak under the auspices of the Carolina Political Union.

It will be Mrs. Roosevelt's second visit to the University of North Carolina since her husband has been President. She delivered the commencement address to the graduating class of the University in 1935.

ROADSIDE MEN IN MEET TODAY

Committee Considering More Restrictions on Signs

Reflector Bureau Raleigh, Nov. 29.—The executive committee of the Governor's Committee on Roadside Control and Improvement is in session here this afternoon. Considering proposed legislation which would give the highway department greater authority over highway rights-of-way and which would impose greater restrictions on erection of signs along the highway.

The committee is expected to recommend, also, legislation which would give the State greater control over roadside tourist camps, eating places, tourist homes and wayside stands.

These recommendations are expected to include authority for county health departments and the State Board of Health to inspect and regulate strictly all places which serve food or which come in contact with the general traveling public. Dr. Carl V. Reynolds, head of the State Board of Health, has repeatedly pointed out the dangers of unregulated and unrestricted tourist camps and eating places, and a general tightening of regulations will be sought.

The proposed legislation which the committee will consider was prepared by a special sub-committee composed of Capus Waynick, editor of the High Point Enterprise who is chairman of the executive committee; Charles Ross, counsel for the State Highway and Public Works Commission; and Commissioner of Revenue A. J. Maxwell.

The executive committee which is meeting today is composed of Mr. Waynick, Coleman W. Roberts, Charlotte, chairman of the entire committee, Professor T. S. Johnson, State College, chairman of the sub-committee which prepared the program of work; Dr. Jane S. McKinnon, State College Home Demonstration Division; Dr. Reynolds and Mr. Ross.

CLAIMS MADE FOR DAMAGES

Foreign Underwriters Called On by German Companies

Berlin, Nov. 29.—(AP)—German insurance companies presented claims today to foreign underwriters for damages done Jewish property during the violence of November 10.

This the question of who is to pay for the burned synagogues, smashed windows and looted stores became international.

Jews themselves had been ordered to repair the damages, but the government has seized all insurance claims to be applied to a \$400,000,000 levy of Jews for the slaying of the diplomat, Ernst von Rath, by a Jewish boy in Paris, and enforcing the insurance companies to pay.

Nearly all large German insurance companies carry foreign re-insurance and therefore presented claims to British and other foreign companies which had their re-insurance.

The claims were based on the ground that "civil commotion" occurred in mid-November in Germany.

It was learned some foreign companies refused to pay the re-insurance claims because the "civil commotion" clauses were struck out of contracts by Germans themselves who had argued such developments were impossible in an authoritarian state.

Other firms, it was understood, planned to reply that they would prove the November 10 outbreaks were organized with connivance of the government, and therefore, represent an act of sovereignty not covered by the insurance laws.

Responsible Jewish quarters estimated 520 synagogues were burned or demolished the night of November 9-10.

Fewer Indictments Shown For Month

Of the 107 indictments, 61 defendants were convicted, 27 were acquitted, 19 were nolle prossed and probable cause was found in five.

Dale Carnegie To Appear Here.

Dale Carnegie, noted writer, speaker and teacher of thousands of business and professional men and women in the art of public speaking, will give his popular lecture at the college Wednesday night, Dec. 7, on "How To Win Friends and Influence People." SAYS MAN'S BEEN HERE FOR 18,000 YEARS

Chicago (AP)—Prof. Fay-Cooper Cole of the University of Chicago has expressed belief that the first inhabitants of North America migrated here 18,000 years ago.

"Since no traces of either Stone Age men or the higher primates have been found in America it is apparent," he said, "that the earliest men in the new world were immigrants who arrived approximately 18,000 years ago.

HINTS TO HOUSEWIVES

To make paper thin sandwich slices, use a very sharp knife and cut with a sawing motion. Cream the butter until soft, then place a dab on the bread and spread it with a silver knife. Add filling and arrange sandwich fashion. Buttering both slices of bread helps prevent the filling from soaking in.

Holiday cookies and cakes in which honey is used need about two weeks for ripening. They improve with age, provided, of course, they are stored in covered jars in a cool place. Regular fruit jars with rubber rings make good containers.

Apples stuffed with mince meat and baked make a delicious winter dessert. Wash, peel and core the apples and stuff them an inch from the top. Bake as usual. Lemon sauce goes well with this combination.

Wild rice expands about twice in bulk. Overcooking will darken it as well as decrease the flavor. Wild rice combines nicely with creamed mushrooms, served plain or escaloped.

To make your popovers really pop over, be sure to have the baking pans well greased and very hot. The pans should "sizzle" when you quickly touch them with fingers dipped in cold water.

Use a fork for stirring rice while cooking. When done rinse well in hot water. Cover pan with cloth and set in pan of hot water over low heat until serving time. One tablespoon for each cup of rice added to the boiling water when cooking will help keep the rice white.

If you have an inner spring mattress handle it carefully to prevent any of the springs from loosening. Turn it quickly and lay it on a flat surface to air. Never hang it over the end of the bed as the springs in the center could then easily get out of condition.

Too much water makes pie crust tough and also makes it hard to roll out. Add water about a teaspoonful at a time and use as little flour as possible on rolling pin and board.

When planning your meals aim for a balance in soft and solid, strong and mild-flavored, and a variety of colors as well as watching out for nutrient values.

When placing serving dishes directly on the table have them within easy reach. Also put the silver needed for serving on the table at the right of the dish.

Use a soft eraser to remove marks made by tin-foil.



REA IS FACED BY OBSTACLES

Eighty Per Cent Of Tar Heel Farms as Yet Not Served

Reflector Bureau Raleigh, Nov. 29—Basic obstacles to rural electrification in North Carolina through federally-organized and aided co-operatives have been brought out prominently in discussion resulting from the recent meeting here of managers of the co-ops so far formed and in operation.

After this meeting there was more than a little criticism of progress of rural electrification in the state, although statistics for the past three years indicate that it has made greater advances in North Carolina than in any other Southern state and more progress than in most others of the Union, Southern or otherwise.

The point was made, both at the meeting and in resulting discussions, that practically 80 per cent of Tar Heel farms are as yet unserved by electric lines of any kind and the conclusion was drawn, inferentially at least, that there has been a lagging on the part of those charged with extension of Rural lines.

It is an undeniable fact that the Federal REA authorities at Washington and the state REA administration have not seen eye to eye on the problem, with the Washington group objecting violently to any co-operation of compromise with private utilities, while Dudley Bagley, State REA director, has consistently maintained the position that it is his duty to extend rural electrification through every possible medium, whether thru existing private utilities, municipal plants or co-operative formed under Federal aid and auspices.

The result has been friction which has doubtless been a hindrance to rural extensions, but over and beyond this friction, there are at least three basic obstacles to the co-ops.

Recently a federal REA official came into North Carolina to make a survey of the entire situation and to try to find appropriate places in which to spend the something more than \$5,000,000 the Federal REA has for allocation in North Carolina.

After looking the whole state over through use of maps and such information as he could assemble he still couldn't decide where the money could be put to good use.

In a frank discussion with one of the state REA officials he was told that there are at least three basic reasons for the difficulty found in organizing co-operatives in North Carolina—this absolutely disregarding all personalities and all friction caused by jealousies or inability to see things in the same light.

The three were:

1. The experience of North Carolina farmers with co-operatives of other sorts have been such that the very mention of the word "co-operative" is to them like waving a red flag at a bull. There is scarcely a farmer in eastern North Carolina who didn't get "bit" by the famous tobacco co-operative fiasco. They just don't like the term, and it's almost impossible to sell them on the idea of a "co-operative."
2. The rates of private utilities are lower than those the co-operatives are able to offer. A survey of rates of the co-ops which have been organized so far and which are now operating shows clearly that their rates are higher than those of any power company in North Carolina with the possible exception of the Tide Water Power Company.
3. It takes the federal REA about

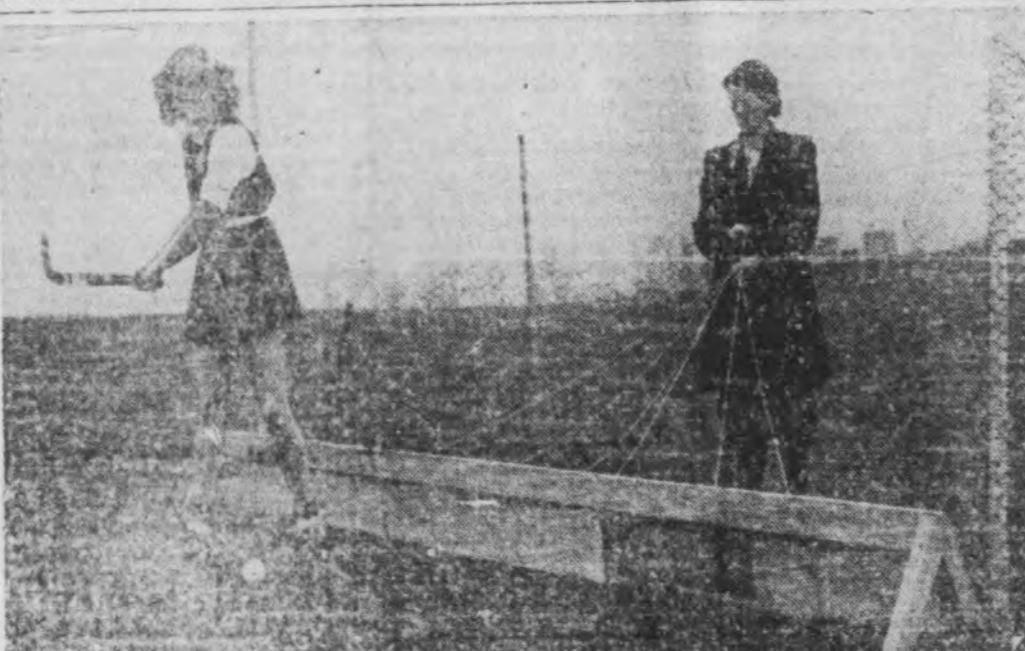

WILL CERTIFY 4-YEAR TERM

Amendment Says Act To Be In Force From Tuesday

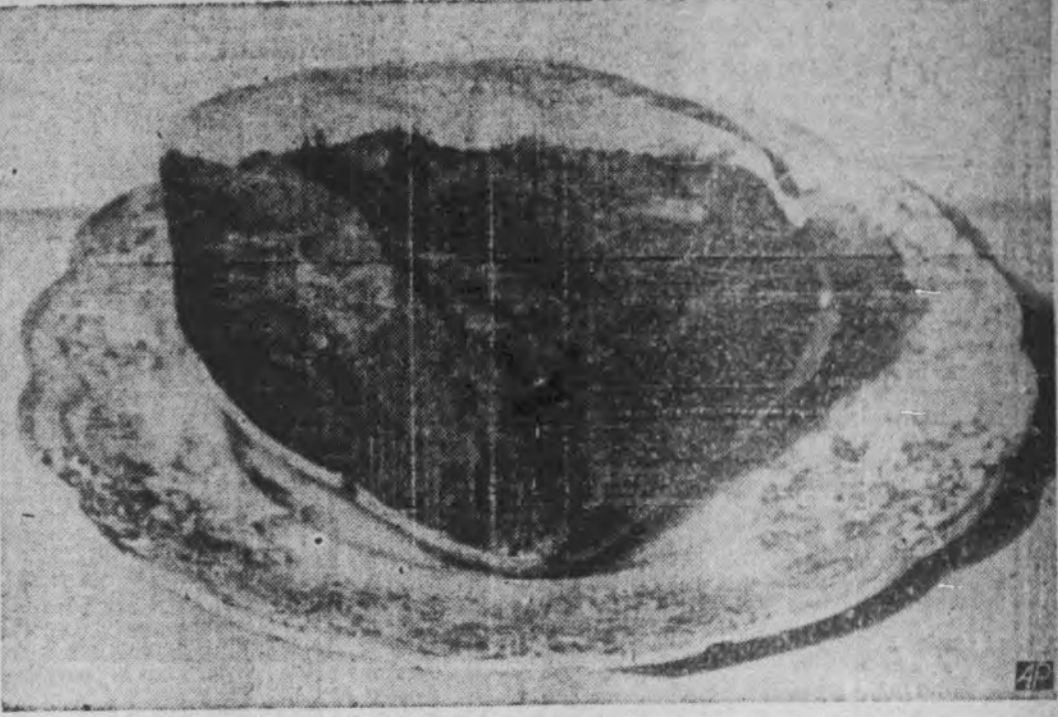
Referred Bureau Raleigh, Nov. 28—Governor Hoy will tomorrow certify popular approval of the Four-Year Term for Sheriffs amendment; and with filing of that certificate in the office of Secretary of State Thad Eure the fun will begin. According to the terms of the amendment it will be in full force and effect from tomorrow, the date of its filing with Mr. Eure. So far nobody knows who will be beneficiaries of the extension of term, but at least one incumbent sheriff who was beaten as far back as the primaries this year has announced his intention to stay in office until they put him out—they meaning the Supreme court of North Carolina. The chap who will try to take

advantage of the ambiguous situation is Sheriff Jasper Rife of Brunswick county who was defeated for the Democratic nomination last June by Dillen Galney, successful candidate in the general election. Ruff will contend that the "full force and effect from and after the date of certification" means that those sheriffs now in office are entitled to serve two more years. There will be numerous arguments in rebuttal, among them that the Constitution forbids the increase of decrease of the "emoluments" of a constitutional officer during his term of office, which would forbid pay for a longer period than that to which he was elected. The answer will be that the Constitution can be changed by Constitutional amendments such as that adopted November 8. Russ is a next county neighbor of John R. Morris, N.W. Hanover man who is secretary of the North Carolina Sheriffs' Association. Johnny said a few days ago the association planned a test of the law. It's a good, though not certain, assumption, that Russ was "regretted" to his action by the association.

day, which is the opening day, a
good look at the calendar reveals.

The veterans' service division of

Carolina and will support the 1939
legislature in continuing this ap-
propriation for this purpose," it
concludes in peroration. "However,
proper advertising of the pottery in-
dustry would be much appreciated.
Misleading publicity such as that
put out where pottery is made
should be corrected because it is
robbing short of an insult to native
potters and citizens of Upper Moore
county."

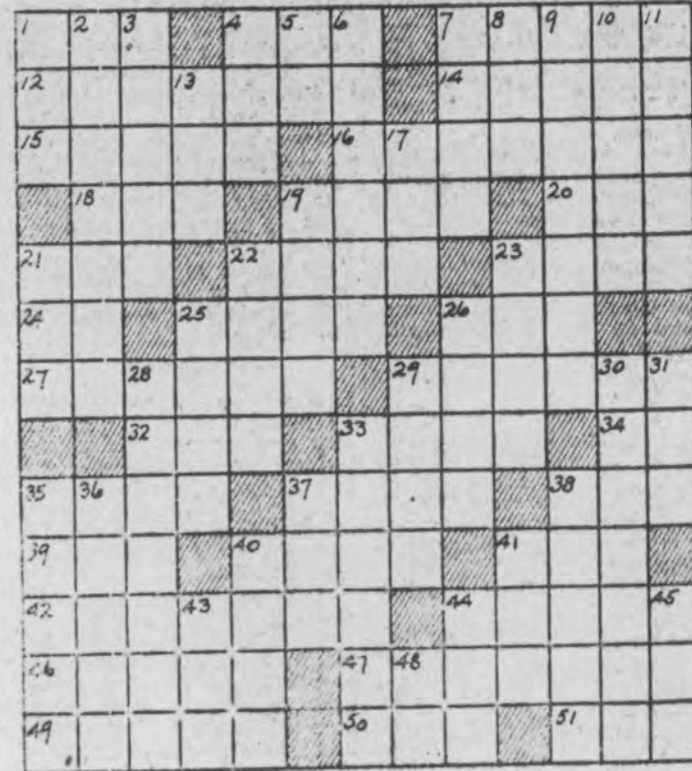

Duke Accepts Invitation To Play in Rose Bowl Tilt

USC BE HOST TO WADE'S DEVILS

Durham Team to Play in Famous Football Classic Jan. 2

Los Angeles, Nov. 29.—(AP)—Duke last night was invited to play the University of Southern California in the Rose Bowl football classic January 2—and Duke accepted.

Director of Athletics Willis O. Hunter of U. S. C. made the formal announcement. Earlier yesterday the Trojans had been selected by the Pacific Coast Conference to represent the Far West in the traditional battle.

The sudden announcement broke all recent records in deciding on the Rose Bowl candidates, and brings together two of the finest teams of their respective sections of the nation.

It will be Duke's first trip to the Rose Bowl, but the fourth time the Blue Devils' coach, Wallace Wade, has come to the Pasadena game.

Wade, as in the case of Coach Howard Jones of U. S. C., has an "unbeaten" record in the big bowl. He brought Alabama out in 1926 and won over Washington, 20-19; came with Alabama in 1927 and tied Stanford, and in 1931 he guided Alabama to a 24-0 victory over Washington State.

Sentiment was high in Los Angeles for Texas Christian or Tennessee to get the bid, and the selection failed by a good deal to meet universal approval.

An informal canvass of downtown hotel men brought unreserved sentiment for Texas Christian.

The annual "Postcard Poll" conducted by Bill Henry, Los Angeles sports editor, found the vote standing as follows:

Tennessee, 904; Texas Christian, 855; Duke, 811; Oklahoma, 798; and Carnegie Tech, 367, to make the leaders.

Popularity of the North Carolina Dukes gained momentum over the week-end after they defeated Pittsburgh, 7 to 0, keeping intact an amazing record of never having been scored upon all season.

Southern California's record falls short of the Duke lads. Alabama posted them, 19 to 7, in the opening game of the season, but the Trojans came back to win six straight games, including victories over Ohio State and California, and then Washington won a 7-6 decision over the Trojan Warhorse.

With neither Duke nor U. S. C. geared for high scoring, the wild touchdown maneuvers of Texas Christian held the public's interest up to last night's announcement.

Director Hunter closed negotiations with Duke officials and later issued a statement. It read:

"The University of Southern California appreciates the honor conferred upon it by the Pacific Coast Conference in being selected for the Rose Bowl game in Pasadena January 2. We are proud of the record made by our teams there and I am sure Coach Howard Jones and the Trojan players will do their level best to see that the Far West makes a strong showing at Pasadena.

"The general athletic committee of the university is pleased to announce that Duke University of Durham, N. C. has been selected to represent the East. It has always been the aim of the Pacific Coast conference and Tournament of Roses officials to perpetuate the East-West idea, which was born with the origin of this annual classic.

"Duke's football record of being undefeated, untied, and unscored on in nine games is unequalled by that of any other major team in the nation.

"Coach Wallace Wade has brought teams to the Rose Bowl before and the University of Southern California considers it an honor to play one of his eleven.

"In making its selection an Eastern opponent, the athletic committee took cognizance of the fact that a majority of players on the Southern California squad voiced a desire to meet the Duke team."

HORNED FROGS REGRET MISSING ROSE BOWL BID

Fort Worth, Tex., Nov. 28.—(AP)—Coach Leo (Dutch) Meyer of Texas Christian University's undefeated, untied Horned Frogs expressed deep regret last night over his team not being invited to the Rose Bowl.

"I am deeply sorry we couldn't go to the Rose Bowl," he told the Associated Press. "my boys wanted it so badly."

The squad voted after the game with Southern Methodist Saturday when the Frogs clinched the Southwest Conference title, to go to the Rose Bowl in preference to other bowl games if invited.

T. C. U. played in the Sugar Bowl game at New Orleans in 1936 and in the Cotton Bowl at Dallas in 1937.

In opening its initial game, the locals will be matched with a galaxy of former high school and college stars. The opposing contingent feature a roster of players including Al Miller,ouis Perzkow, and Bob Spessard. Bob, in case you don't know, was the former top scorer of the Southern Conference.

Scoring tactics of the businessmen are centered around a fast break offense. Another difficult situation for the Teachers to overcome rests in the fact that their opponents have superior height and are skilled in handling the ball.

Bill Shelton, speedy quarterback of the football team at East Carolina Teachers College, which has recently completed its 1938 grid schedule, is also expected to shine with the locals' basketball squad.

WHAT IT MEANS: TRADE PACTS

By MORGAN M. BEATTE AP Feature Service Writer

Washington—Scrape those new trade treaties with Canada and the British Empire down to their economic bones, and you have left a fairly simple agreement that will test out two opposing principles of international trade—regular tariffs vs. rigged tariffs.

It's really a small-scale experiment for the great bulk of trade between the two nations will remain its great burden of tariff duties. A few outstanding reductions in duties will provide the basis for the experiment.

Practically all nations today are high tariff nations. Most have gone a lot farther; they restrict imports by imposing quotas, and prohibit the exchange of money between foreign sellers and domestic buyers.

Germany is the outstanding exponent of these "rigged" tariffs, hating foreign sellers with higher prices, and at the same time protecting important industries with subsidies.

Foreign sellers, however, must spend in Germany most of the money they collect for the goods they sell there.

Meanwhile, Cordell Hull, the American Secretary of State, has insisted that the whole scheme of things is heading to a ruinous economic war that eventually will deadlock world trade.

High Tariff Principles Fixed Mr. Hull agrees that the principle of high tariffs is too well established everywhere, especially in the United States, to throw overboard. It would be like yanking the roof off your greenhouse in mid-winter to let in more air and sunlight. But he insists a little tariff window should be opened here and there to encourage trade and, above all, tariffs should be equal to all comers.

On that principle the secretary struck bargains with 18 minor nations between 1934 and 1938. The idea was, "You lower a few duties, and I'll lower a few," and—most important of all—share the benefits of the reduced tariffs with all nations except Germany, the only trader refusing equal treatment to the United States.

The treaties with Canada and the United Kingdom (the British Isles and colonial possessions) represent his crowning achievement because Great Britain and the United States together do almost half of the world's 40 billions of dollars worth of swapping every year.

Two questions remain: "What have our first 18 treaties done to stimulate trade?" "What will the British agreements do?"

With figures galore to play with, there are almost as many answers as economists, but gradually economists have been dividing into the pro-Hull school and the anti-Hull school.

Inspire Of Beliefs Here is how the two schools of thought line up on the major treaty points:

1. World Peace Hull School—Orderly trade based on the principle of fair play and equal treatment for all is necessary for world stability. "Live and let live." Any other way leads to misunderstanding, cut-throat competition, dumping, savage economic feuds, and ultimately, war. Set your tariffs high or low, but leave them there for everybody.

Anti-Hull School—Trade is now and always has been the subject of dispute among nations. Those having advanced standards of living must protect them, else seek the world's lowest level. For example, both peaceful rivalry and war established the British Empire, the greatest trading nation of all time. Free trade was an afterthought.

2. Trade Increases Hull School—During the nearly four years of the trade agreements program, the volume of American exports and imports has been on the upgrade. Although this phenomenon is not due alone to the

treaties, our exports have shown a consistently greater growth with treaty nations. For example, exports to trade agreement countries in 1937 increased 72 per cent over 1934.

Anti-Hull School—Our imports from foreign countries have increased 90 per cent during the trade program, while exports were increasing only 50 per cent. That's like putting out 10 cents to get a nickel's worth of business, and the new treaties will intensify the evil.

3. Domestic Benefits Hull School—Trade agreements mean better times for everybody. They bring more trade, and more trade puts more workers into jobs. These workers will have money to buy farmers' products, and the farmers in turn will have more money to buy industrial output.

Furthermore, the new Canadian and British treaties offer the farmer direct concessions on such important items as wheat, land, apples, pears and other domestic products.

Anti-Hull School—The average price of all American imports during the treaty period, 1934-38, increased 20 per cent. The average price of items on which the United States reduced duty as a concession to other nations, dropped 10 per cent. Manufacturers of articles suffering from skidding prices could not continue to raise wages, and occasionally were unable to maintain their scales. Some curtailed production, and thereby increased unemployment. Those who couldn't meet foreign competition complained that the quantity of all articles come in under reduced duties increased 123 per cent, while imports generally were increasing only 52 per cent.

SAYS UNC GRID YEAR SUCCESS

University Completes Third Season Under Ray Wolf

Chapel Hill, Nov. 29.—The University of North Carolina has just completed its third successful football season under Coach Ray Wolf. The three-year record of Wolf-coached teams shows victories 81 per cent of the time. The combined total is 21 conquests compared to five defeats and two ties.

The 1938 Tar Heels contributed six of those 21 victories. They defeated Wake Forest 14-6, N.C. State 21-0, NYU 7-0, Davidson 34-0, Virginia Tech 7-0 and Virginia 20-0. Only losses this season were a hipper-dipper 17-14 decision to Tulane and a 14-0 beating at the hands of the Dukes of Durham. A scoreless tie with the highly favored Fordham Rams is the brightest spot on the record this fall.

Coach Wolf's 1936 and 1937 football editions at the University won a total of 15 games, lost three and tied one. Last fall the Tar Heels lost only to Fordham. They were tied by South Carolina.

Probably the biggest achievements in the remarkable three-year record have been made against intercollegiate opposition. The Tar Heels turned back NYU thrice by scores, respectively, of 14-13, 19-6 and 7-0, tied Fordham this fall and lost only to the Rams 14-0 a year ago.

Co-captains Steve Maronic and George Watson, Jim Woodson, George Stirnweiss, George Radman and Jack Kraynick highlighted the play of the team this fall.

Maronic, who has already been chosen on first All-America teams selected by captains from the nation's leading teams for the Central Press Association and Eddie Dooley, well known New York Sun sports writer and radio commentator, turned in superlative performances at tackle throughout the season.

Maronic's specialty was place-kicking and he converted 13 times on the extra point in as many attempts. A spectacular 28-yard field goal by Maronic against Virginia on a snow-covered field brought his career to a brilliant close.

Stirnweiss, a triple-threat quarterback, led the Tar Heels in ground gaining with a 3.8 average. He gained 309 yards (net) in rushes and scored three touchdowns.

Watson, senior fullback, excelled in blocking, running and pass receiving. He set up the chips for a majority of the ground advances with superb interference. Watson averaged 3.2 per rush, scored two touchdowns and caught 6 passes for 85 yards.

Kraynick, Radman and Woodson were also standouts. Kraynick with 262 yards (net) piled up more yardage than any other player on the squad and was powerful on defense. Radman led the scoring with 36 points and averaged 3.6 per rush—174 yards in 48 plays. Excluding Maronic, Woodson, agile guard, was the Tar Heels' best lineman. His play was particularly impressive in the Tulane, NYU, Fordham and Virginia Tech games.

PENALTY SUMS ARE ASSESSED

Nearly \$10,000 Collected on Fertilizer and Feed

Reflector Bureau Raleigh, Nov. 28.—The North Carolina Department of Agriculture assessed and collected nearly \$10,000 in penalties for violations of the fertilizer and feed purity laws during the last biennium, according to D. S. Coltrane, assistant commissioner.

Exact amount of assessment on fertilizer was \$7,995.29 and on feed \$1,326.50 for a total of \$9,321.79.

Improvement in the quality of fertilizer sold in the state, however, is indicated by the fact that the manufacturers were penalized on only 24 per cent of the samples drawn. Mr. Coltrane said.

A total of 10,447 samples of fertilizer were collected (approximately one for each 200 tons sold). These samples represented an aggregate of 108,144 bags officially sampled for analysis. Inspectors also secured 395 special samples.

Of the 4,854 samples reported in 1937, a total of 4,650 were equal to or above the guaranteed value; 638 samples were below guarantee but within the tolerance allowed by law.

Of feed, inspectors collected 2,196 official samples from all sections of the state, 483 miscellaneous feed samples and 164 cotton seed meal samples. A reasonable number of samples was sought from each feed company and extra precaution was taken to secure samples of brands previously found below guarantee. Coltrane declared:

Six hundred lots of feed were seized and held for satisfactory adjustment and in most cases the feed was released after penalties were paid and the product re-tagged to show the correct analysis in conformity with the laboratory report.
