COLD WAVE HEADS TOWARD ATLANTIC COAST

REBELS FORCE SLOWLY AHEAD AGAINST FOES

Drive Spurred by Fear Government Counter Attacks

MOVE EASTWARD IN RUGGED AREA

Fifth Day of Insurgent Offensive Finds Casualties Each Side Well Over 10,000

Hendaye, France, Dec. 27 (AP) — Powerful insurgent fighting columns, badgered everywhere by fear of Catalonian counter attacks, forged their way slowly eastward today over rugged territory toward the heart of the Government stronghold in northwestern Spain.

On the fifth day of Insurgent General Franco's offensive, aimed ultimately at Barcelona, the Government capital, casualties on both sides were well above 10,000 of the 500,000 total of fighters.

An exact record of ground won by the drive was obscured by communications flatly contradicting each other.

In the north, however, Franco's resident mountain troops appeared to have taken a town at the end of an improved highway leading to Artesa, "the key to Catalonia."

In southern Lerida province, according to insurgent radio bulletins issued under strict censorship, the Franco command was said to have announced the capture of a village about 35 air miles from Tarragona.

This village, unimportant in itself, would give Franco a foothold on the broad national highway between Lerida and Tarragona, thereby disrupting government communications and supply lines.

Expressing regrets in behalf of the school board and the town, Supt. Rose declared that Mrs. Utley has been outstanding as a teacher in the high school.

Miss England has been teaching mathematics in Central high school at Nashville for the past seven years. She has done much work in the George Peabody demonstration school and is therefore to become a member of the teachers-training staff of East Carolina Teachers College, a position held by every teacher in the high school. Miss England received her M. A. degree from George Peabody College.

Mrs. Utley was grad from Atlantic Christian college, where she received her A. B. degree. Her M. A. degree was obtained at the University of North Carolina. She has taught in the local high school for several years. She also has taught at Wilson Mills, N. C. before coming to Greenville.

ONLY ONE HURT IN ACCIDENTS

Few Traffic Mishaps Reported During Holidays

Only one person was known to have been seriously injured in traffic accidents in this vicinity during the Christmas holidays, and the various law enforcement officers reported an unusually small number of wrecks.

Lieut. Lester Jones, head of Troop A of the State Highway Patrol, said no serious or fatal accidents were reported in the entire division.

Bernice Tyson, daughter of Mr. and Mrs. Tom S. Tyson of near Greenville, is in Pitt General Hospital suffering a painful hip injury sustained Sunday night in an automobile accident on the New Bern highway while riding with her parents.

Tyson's automobile was involved in a collision with another motor vehicle operated by Vestis Hegan, of Maryland. Hegan was lodged in the county jail by sheriff's officers, who investigated. County Jailor W. G. Leggett said the amount of the bond had not been determined.

Hegan's car plunged head-on into a ditch and Tyson's car landed upside down in a ditch on the opposite side of the road. Both cars were badly damaged. Neither of the several Negroes riding with Hegan were injured. Mrs. Tyson was injured, but not seriously.

William M. Coles, Jr., and Edward Fleming, both of Grifton route one, were arrested by Highway Patrolmen last night on a charge of being drunk on the highway after having been found in a car which had run off the highway into a ditch between Greenville and Stokes. Corporal L. L. Jackson of the patrol force, who made the investigation, declared that both men were in a drunken condition when he found them in the car. He said he denied having been driving. The car was said to have been registered in Cole's name, however. Several other traffic accidents were investigated by members of the patrol, but none of them were considered serious, with no injuries and no arrests made.

Dees is an alumnus of the University of North Carolina and a pupil of Frank Hurty of Norfolk, Va. Sayez was an exchange student last year in piano from the University of Heidelberg and a pupil of Adolph Schmitt.

Both Dees and Sayez have done work over the various North Carolina radio stations. The Asheville concert will consist of the same program that thrilled an audience at the Student Union in Chapel Hill November 20.

STATE PROBES DRUG SCANDAL

Indicated One Firm Had Only Twenty-Five Customers

New York, Dec. 26 (AP) — Assistant State Attorney General A. McCall indicated today that Girard and Company, the drug concern operated by the late F. Donald Coster-Musica before he got control of McKessons and Robbins, Inc., had only 25 customers.

McCall suggested this while questioning John H. McGloin of Fairfield, Conn., vice president in charge of accounting for McKessons and Robbins in the State's investigation of the financial affairs of the corporation.

Federal and New York county authorities also are investigating the corporation's affairs as a result of disclosures that about \$18,000,000 in crude drug assets were missing or never existed.

Before he joined the giant drug corporation, McGloin said he was an accountant with Price-Waterhouse and Company, the firm which handled McKessons and Robbins' auditing. He met Coster-Musica in 1926 when he went over the books of the Girard company.

McCall expressed concern over the methods of auditing of Girard and Company, asserting that the accounts receivable represented more than one-third of the firm's \$650,000 assets. The McGloin conceded the sum was "exceedingly large."

He said he could not recall how the "test-checked" the accounts receivable.

"It's not true that Girard and Company had only 25 customers," asked McCall.

McGloin said he didn't know.

KILLS HIMSELF WITH SHOTGUN

Craven Citizen Blows Away Rear Half of Skull

Washington, N. C., Dec. 27 (AP) — Acting Craven County Coroner U. W. Daugherty was advised in a telephone communication from New Bern today of the death of Karl Chadwick, 40, a woodworker and former Washington resident, who died instantly about 8:30 this morning when a blast from a single barrel shotgun tore away the rear half of his skull in what the coroner asserted "seems a plain case of suicide."

Daugherty said Chadwick, a native of Pollockville, had been "dependent" for the "past 60 days", indicating the man's family and friends recently had expressed fear he might attempt to take his own life.

Survivors, in addition to his wife and a small son, Karl, Jr., about 7 years of age, are three sisters, Mrs. H. Askew of Pollockville, Mrs. Geo. Taylor of Phoebus, Va., and Miss Nellie Chadwick of Tarboro; three brothers John Chadwick of La-Grange, Agnew and Walter Chadwick, both of Fort Bragg.

Hams and Other Meat Stolen Monday Night

The smokehouse on the farm of A. P. Cayto who lives on route four Greenville, was practically cleaned out by a robber or robbers last night. Eleven hams, 10 shoulders, six heads, four sides and a quantity of backbone were taken early last night. Officers are investigating the theft but so far have uncovered no definite clues.

WHAT IT MEANS: TRADE WAR

By MORGAN M. BEATTY (AP Feature Service Writer) Washington — The extension of new American credit to China and discussion of American loans for Latin American nations is evidence of a new phase in a ten-year-long world war over trade.

The battlefields are the ports of the world. Ammunition is the goods exchanged between them. The soldiers are the dollars, pounds, marks, francs and all other international units of money.

In one camp are the nations that favor a more or less free flow of trade and settlement of international accounts with gold. The United States, having a tremendous supply of gold, is the standard-bearer of this group.

Ranked against them are nations with so little gold they must control its flow out of the country. Germany leads the column, Japan and Italy are close behind. They had led in setting up controls over foreign exchange gold. They buy from nations willing to accept goods in payments. Germany, for in-

MUCH TRADING PREDICTED FOR NEW CONGRESS

Set-Up Betokens Session Filled With Compromises

PREDICT PEACE WITHIN PARTY

Sen. Wheeler Confers With Roosevelt On Findings by R. R. Rehabilitation Group

Washington, Dec. 27 (AP) — The set-up of the new congress and its committees betokens a session filled with compromises.

At many turns toward expansion and bolstering of his problem, the President will run into a committee chairman or other influential senate or house Democrat whose views do not exactly agree with his own.

The power of these men, in the opinion of many returning legislators, has been augmented by the November election returns. The reinforced strength of the Republicans has given a new talking point to Democratic conservatives. Members say it tends to turn the mind of all Democrats, conservative and liberal, more sharply toward compromise than toward intra-party fights.

How soon a show-down will come scarcely can be estimated, but it probably will occur before the session is very old.

Other developments:

Chairman Wheeler (D-Mont) of the Senate Interstate Commerce committee said after a White House conference he believed that a report of the President's railroad rehabilitation committee would constitute a "working basis" for legislation.

Wheeler said he and Mr. Roosevelt discussed the committee's findings generally and further conferences would be held next week with Chairman Lee (D-Calif.) of the House Interstate Commerce Committee and others.

A non-partisan group of Senators and Representatives from agricultural states is being formed to sponsor a "cost of production" farm program in the new congress.

Senator Frazier (R-N.D.) said members had suggested that this group, including Democrats and Republicans, agree on a specific program and then confer with Secretary Wallace before offering the legislation.

Secretary of Commerce Hopkins, it was learned, is considering a nationality drive to put millions of unemployed men and women back to work in private industry.

The man who formerly directed the government's vast work relief program has discussed the possibilities of such a campaign with business leaders here and in New York.

The drive, according to reports in business and government circles, would be carried on by the Commerce Department in conjunction with the business advisory council and probably with other business organizations.

France To Demonstrate Her Tunisian Strength

Fears Italy May Attempt To Seize Djibouti by Force

Paris, Dec. 27 (AP) — Dispatches from North Africa today reported that Italy was massing troops on the frontiers of French Somaliland.

French colonial officials expressed fears that this might be the start of a campaign to threaten Djibouti, French Somaliland port on the Red Sea, which is the only rail outlet for Italy's Ethiopian Empire.

Travelers reaching Egypt from Djibouti said dispatches to the French press, reported that the governor at Djibouti had demanded and obtained troops and naval reinforcement from France.

Foreign office officials said they were unable to confirm or deny these reports.

Paris, Dec. 27 (AP) — French fears that Premier Mussolini may try to seize Djibouti by force were reported today to have inspired a plan to show the power of France's Tunisian forces.

The French general staff, informed of sources said, has arranged a powerful display of fast French motorized forces for an inspection trip next month by Premier Daladier in Tunisia, French North African protectorate.

These units, military sources said, would serve to remind Mussolini that he must count on the defense of Tripoli, capital of Italian Libya, should he threaten Djibouti, Red sea port in French Somaliland, and terminus of the railway to Italian Ethiopia.

A large part of the French Mediterranean fleet is scheduled to greet the premier when he goes to Corsica and Tunisia early in January.

Italians started agitation for Tunisia, Corsica, Nice and Savoy November 30.

Yesterday France told Italy she accepted an Italian note denouncing an Italian-French accord of 1935 regarding Italian rights in Tunisia, but that the accord must remain the basis for Italian-French negotiations.

Accident Is Fatal to Nashville Youth

Rocky Mount, Dec. 27 (AP) — Philip Astor Hedgepeth, 17, of Nashville, died in a local hospital early today of injuries sustained in an automobile accident which claimed the life of his companion, Alton Strickland, 20, of Henderson, Saturday afternoon.

Sheriff C. V. Faulkner said Strickland was driver of the car which was in a head-on collision with a car driven by W. B. Taylor, Nashville county farmer.

EXPECTED HIT ON SEABOARD IN FULL FORCE

Described as Most Severe Wave of This Season

FAIR AND COLD SEEN FOR N. C.

Bitter Weather Expected prevail Along Atlantic Seaboard for Several Days

Chicago, Dec. 27 (AP) — The most severe cold wave of the season advanced across the northern half of the nation today.

Temperatures ranging to 10 below zero prevailed from the Pacific northwest to the Great Lakes region as the frigid blasts moved eastward.

Temperatures fell below freezing over a wide expanse of the continent after comparatively mild Christmas holidays.

Weather observers predicted the full force of the cold wave would reach the Atlantic seaboard tonight or tomorrow and that the bitter weather would stay for several days.

Snow and sleet accompanied the Arctic winds into the midwest and northwest. The cold dipped into Oklahoma and forecasters said it would be felt as far south as Florida.

Sub-zero weather plagued the Dakotas, Minnesota, Montana and Wyoming with lower temperatures in prospect. Snow, rain and stiff winds heralded the approach of the cold wave in the east.

Helena, Mont., shivered in 10 below zero weather and the same temperature was forecast for the entire state of Nebraska.

Several inches of snow fell in western North Carolina and Southwest Virginia. A heavy rain hit New York City, while up-state New York received a heavy fall of snow. Many fatal automobile accidents in Ohio were attributed to icy, wet ground and rain.

Charlotte, Dec. 27 (AP) — The U. S. Weather bureau here announced today it expected "much colder" weather tonight, with a cold wave and minimum temperatures of 20 degrees in this vicinity by tomorrow morning. The forecast was for generally fair weather.

Winston-Salem reported snow, the heaviest of the winter, blanketed the mountains of northwestern North Carolina.

The snow began falling yesterday and rains from several inches at North Wilkesboro, to nearly half a foot at Boone and West Jefferson.

Police Investigate Shooting Of Negro

Minnie Slade, Greenville Negro, was seriously injured Sunday afternoon around 6:30 o'clock when shot by an unknown assailant in Skinner's Ravine.

The Negro was said to have been sitting in a home with another Negro woman and child. The person doing the shooting fired through a window and made a hasty retreat.

The Negro woman is confined to Pitt General hospital, where she was taken after the city's only Christmas Day shooting affray. She has been given an even chance to recover, barring complications.

Officers H. E. Wooten and Herbert Harris investigated. Officer Wooten said the woman was shot in the back, and part of the charge penetrated to her lungs.

Randolph Bueck, Greenville Negro, is being held for investigation in connection with the shooting. Several suspects have been questioned, but blame has not been placed on any of them.

Germany revolted. Not until then did the German army crack. The decision of the United States to extend more credit to the Chinese against their gold hoard in this country is a double-edged weapon. Not only does it increase American sales of trucks and other supplies, but also is reinforces a nation fighting one of Germany's economic allies—Japan.

Gives Traders A Choice The same thing is true of Secretary Morgenthau's announcement that the United States treasury is studying plans to lend money to Latin American nations. With money in hand, traders in Latin America can buy in a market of free exchange. They won't have to make any old deal for exchange of goods.

In effect, you have in these credit arrangements the latest American answer to the German system of controlled trade. They are a logical sequence to the Hull program of reciprocal trade: an effort to lower tariff barriers all along the line in all nations to revive world trade.

The root of the problem, financially, is the gold standard. About 10 years ago, gold began flying from capital to capital in flight, upsetting balances in the banks of the world. Until then the gold standards had been sufficient measure of value for international trade. But it fell under the strains of unpaid international debts and post-war confusion. Gold is no longer an absolute necessity in international trade.

The trade war would be a comparatively polite affair without serious casualties, if governments had not intervened to alter the free flow of trade.

Then there is the all important item of military and political advantage. Germany, Italy—even Japan—are deficient in certain raw materials, particularly oil, wheat and cotton. In the event of war, the blockade, they would have to depend on stored supplies.

Therefore, they are trying to extend their domination of nearby states in order to guarantee those supplies. Germany is looking toward oil-filled Rumania, and the wheat-laden Ukraine. Italy is glancing toward Africa, and Japan is conquering China.

This is economic warfare turning into military war and threats of war. The question is, How long can the world stand the strain.

Our Bob and WPA-man Coan will get what the Romans used to get—ingly call a quid pro quo, which roughly corresponds to the hat you give your wife to keep her from demanding a fur coat.

But returning to the main theme it is evident that the President and his advisers realize full well that Senator Reynolds will a mighty power in his own right and name, can't hold a candle to such men as "Farmer Bob" Doughton, Governor Clyde R. Hoey, Lindsay Warren and other of their ilk in the important matter of selecting and controlling the votes, after they are selected of North Carolina delegates to the 1940 convention. In short "Our Bob" can carry the state for himself, but not for others.

Also it must be borne in mind that the Roosevelt Administration needs, and needs mightily, continued support in the coming Congress of such men as "Farmer Bob", who is one of the four most powerful men in the House. Up to now he has had this support, but if the President had turned down the Hancock appointment, preferring the Reynolds recommendation over the Doughton, et al., there conceivably might have followed a marked cooling the loyalty of Doughton, Warren and others to New Deal measures.

In other words, "Our Bob" was just outgrown politically. The Administration has given repeated indications of late that it is after North Carolina's vote in 1940—and the Administration knows it can't get them through either Reynolds or the other Senator, Josiah W. Bailey who hates the New Deal and all its works with an implacable hatred he manages to conceal only in pre-election statements.

Therefore, it quite naturally turned to the people who can, and will control the 1940 delegation.

Finally, this bid for 1940 convention votes came as the obvious and logical sequence to other repeated indications that North Carolina is being wooed with all the ardor of a young Romeo chasing after his first Juliet.

For instance, North Carolina has been promised all manner of Federal favors. The government is going to establish a huge Coastal National Forest in the unspoiled pine-forests which have been lost to the Heels vision of a TVA replica over about half-acre—the project to be of huge expense and vast cost. The FSA is begging the state to take over—free of cost and for nothing—a big recreation center in the Sand Hills, which has already been largely developed.

It's all a pattern. The Administration wants those votes and if snubbing "Our Bob" is necessary to get them, then it's just so good as the F. D. R. scheme.

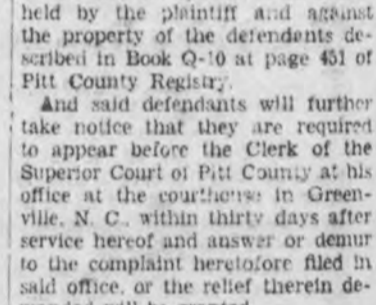

Washington Daybook

By Preston Grover

Washington—In the background of the current trust-busting suit against the American Medical Association and its Washington affiliate is a common human problem, long disregarded in the main. It is the desire of Mr. Average John Jupes to be able to:

Have daughter Martha's eyes examined and fitted with glasses.

Find out for sure the meaning of that pain in his side.

Look for the next baby with love instead of dread.

To have all this without fear of punishing doctor bills.

The medical profession in recent years has made progress toward this with group hospitalization and various semi-charitable clinics to which low income groups have access.

But average John Jupes came in between. He was not rich enough to laugh at doctor bills, not poor enough to feel comfortable about going to public clinics.

In Washington, leaders in the profession recognized this gap and recommended that their fellows work out a pooling or pre-payment system for middle and low income groups which would give them a more comfortable feeling about medical bills.

Medical Leaders Stuck Back
Medical leaders here were resentful on two fronts. They had been "scooped" by a non-professional group. And they could only blame the rank and file of their own profession for not supporting their own plan earlier. They began fighting back, against the Group Health Association, and bestirring their laggard associates.

Group Health Association, supported by an H.O.L.C. grant of \$40,000, opened its own clinic early in 1937, hired its own physicians, began collecting monthly dues, and promised full medical and clinical services, including surgery, for subscribers. Its ranks of a few hundred swelled to thousands of Federal employes, and outsiders looked on enviously.

The principal medical men of Washington, largely members of the American Medical Association, pressed their own laggard members to work out a plan.

A.M.A. members in Washington, assisted by the national organization and its major executive, Dr. Morris Fishbein of Chicago, attacked the Group Health proposition as dangerous to the health of the country.

Twenty-One Indicted
But it was next step attributed to the medical fraternity here which became the basis for the grand jury indictments of 16 Washington physicians and five A.M.A. leaders in other cities, including Dr. Fishbein.

The indictment charged that A.M.A. physicians conspired to deny use of Washington hospitals to Group Health members or their patients.

Meanwhile there is evidence that average John Jupes will get at least part of his dream, even while the doctors battle. Shortly before the Federal indictment was issued in Washington, the Washington A.M.A. branch got its own plan in order and announced it. Fees were roughly comparable to the \$3 a month charged by Group Health.

This Washington A.M.A. plan, with modifications, likely will be pushed in other cities.

SHORT SHOTS

Raleigh, Dec. 26—The House which assembles January 4 for opening session of the 1939 General Assembly will contain 43 who are repeaters from the 1937 session. ANNEXATION IS LIVELIEST ISSUE

Federal Census Of 1940 To Create Problems

Reflector Bureau

Raleigh, Dec. 26.—The Federal census to be taken in 1940 is quite likely to give great impetus to one sort of legislation in the 1939 General Assembly, while putting an absolute quietus on one problem which has vexed the law makers ever since 1930.

Annexation of suburban areas will prove one of the liveliest issues, in all likelihood; while on the other hand there is hardly a chance to even a feeble "peep" out of the hoary reappointment question.

The United States Bureau of Census has warned that all cities and towns should be prepared to notify the bureau of annexations not later than July 1, 1939, which means that those desiring to make annexations will have to get the approval of the Assembly which meets next month.

At the present time the only method for extending city limits in North Carolina is by a special act of the Legislature. This question is a vexing and heated one in several cities, among which can be listed Raleigh and Wilmington—and there are probably many others.

Naturally there will be more local than general fighting in the Assembly over these annexation questions, but there will be some rumormongers with losers locally trying to get enough legislative help to win anyhow.

As for reappointment, it seems quite likely that a measure which has been defeated four times in a row will even be raised now that it could affect the membership of only one future Assembly. The contention has been that reappointment should have been reappointed in the basis of the 1930 census, but only the 1941 Assembly remains to be elected before there will be new census figures for consideration.

Officers Get Man After Chase Here

Pitt County ABC officers Saturday night arrested "Big Will" Clark, Negro, on charges of transporting illegal liquor for sale and also on a charge of driving careless and reckless, following a chase through Greenville and across the river.

The officers started chasing Clark on Tenth street and followed him down Evans to Fourth, thence down Washington to First street to Greene street and across the river. They caught him on the Bethel highway between Pactolus road and House station.

The officers reported that Clark had poured out the whiskey in the car, but indicated they had sufficient evidence to secure a conviction on both the charges of hauling illegal whiskey and driving careless and reckless.

Clark is being held under \$500 bond.

Craven Negro Nabbed By Greenville Police

Lester Wark, Negro, was nabbed yesterday morning by Officers H. E. Wooten and S. Bowen Dorsey after Greenville police had been requested to be on the lookout for the Negro.

New Bern police came to Greenville last night to return the Negro to Craven county for trial. He is facing a murder charge, details of which are not known here.
